INTRODUCTION OF RESOLUTION (FLOOR PRESENTATION)

The following resolution (H.R. No. 295) was announced by the Clerk and the following action taken:

"HOUSE RESOLUTION H.R. No. 295. entitled: COMMENDING HAWAII COVERING KIDS FOR ITS ACCOMPLISHMENTS IN REDUCING THE NUMBER OF UNINSURED CHILDREN AND YOUTH IN HAWAII AND EXPRESSING APPRECIATION FOR ITS ASSISTANCE IN ENROLLING HAWAII'S CHILDREN AND YOUTH IN QUEST AND MEDICAID FEE-FOR-SERVICE PROGRAMS," was jointly offered by Representatives Green, Awana, Berg, Bertram, Brower, Hanohano, Har, Karamatsu, Mizuno, Shimabukuro, Tokioka, Belatti, Chong, Evans, Lee, Magaoay, Nishimoto, Rhoads, Sagum and Yamashita.

Representative Takumi rose to speak in support of both measures with reservations, stating:

"With reservations. I'd like the next Committee to take a look at this one. While I'm not opposed in principle to Free Trade Agreements, this particular Resolution looks like it was written by the Chamber of Commerce. And when I see the testimony, the only testimony from an organization was from the Chinese Chamber of Commerce.

"I think we need to take a look at, just as an example, the recently concluded U.S., Korea Free Trade Agreement which was just concluded today and the impact that it will definitely have on our State as it relates to preferred drug lists in our Medicaid program. I would also prefer that the title not be simply Urging President of the United States. I certainly don't want the current President to get the idea the State of Hawaii's in favor of fast tracking this particular trade agreement.

"And lastly, Mr. Speaker, I do believe that the U.S. Congress ought to have some say in this matter. Thank you, Mr. Speaker."

Representative Berg rose and asked that the Clerk record an aye vote with reservations for her on both measures, and the Chair "so ordered."

Representative Evans rose and asked that the Clerk record an aye vote with reservations for her on both measures, and the Chair "so ordered."

Representative Har rose and asked that the Clerk record an aye vote with reservations for her on both measures, and the Chair "so ordered."

Representative Awana rose and asked that the Clerk record an aye vote with reservations for her on both measures, and the Chair "so ordered."

Representative Cabanilla rose to speak in support of both measures, stating:

"In strong support, Mr. Speaker. The Taiwan delegation, the acting Ambassador came and testified on this matter. And he eloquently pointed out in the Committee that there are certain products of Hawaii that will do good in the Taiwan markets, mainly papaya, macadamia nuts, and a lot more agricultural products they can bring into their market.

"Right now we bring in flowers and whatnot to our country. And the balance of trade right now is in favor of Taiwan. By having a Free Trade Agreement with them, it allows us to bring more of Hawaii's products to their markets. I also note that Taiwan is not a member of the United Nations so their delegation is very, very aggressive in opening trade agreements with other countries so they will be supported in the world market.

"And yes, I agree that we should look at the Free Trade Agreement. This is not a 'free pass' for them. But I think that this matter should be discussed in this House as far as their equivalency and their fairness. The trade agreement with us needs to be discussed."

The motion was put to vote by the Chair and carried, and the reports of the Committee were adopted and H.R. No. 231, entitled: "HOUSE RESOLUTION URGING THE PRESIDENT OF THE UNITED STATES TO ENTER INTO A FREE TRADE AGREEMENT WITH TAIWAN," was referred to the Committee on Economic Development & Business Concerns with Representative Evans voting no, and with Representative Thielen being excused; and

Representative Caldwell moved that the reports of the Committee be adopted, and that H.R. No. 105 and H.C.R. No. 131, be referred to the Committee on Health, seconded by Representative B. Oshiro. Representative Lee rose to speak in support of both measures, stating:

"In support of these measures and I briefly wanted to explain a little bit about what it's about. The National Council of State Boards of Nursing is comprised of the 59 state and territorial boards of nursing who regulate nurses in the United States. It's the Board of Nursing who issues licenses to all nurses to practice in their respective jurisdictions. The NCSBN Board of Directors has approved a position regarding the shortage of nurses and affirms the need to maintain the standards of practice to best protect the public and uphold U.S. state and territorial licensure standards regardless of whether the nurse is domestically or internationally educated. And these Resolutions encourage our State to adopt standards. And I'd also like to enter some written comments in the Journal."

Representative Lee's written remarks are as follows:

"Mr. Speaker, I am in support of this measure. Mr. Speaker, every employer should exhibit ethical practices when recruiting for vacant positions. This is especially true when the vacancy is in the field of nursing. As we speak, Hawaii is in the midst of a nursing shortage. This, however, should not detract from ethically recruiting qualified nurses to fill much needed positions within our community. These Resolutions, requesting the Governor to support the ethical recruitment of nurses, keeps Hawaii's standards high and protects our citizens as well.

"The National Council of State Boards of Nursing (NCSBN), which is composed of the 59 state and territorial boards of nursing who regulate nurses in the U.S. and issues licenses to all nurses to practice, supports the ethical recruitment of nurses. In its 2006 Ethical Recruitment of Nurses for Licensure policy statement, the NCSBN stated that they support "the lawful entry of nurses from other countries provided they meet U.S. federal immigration and labor requirements, and obtain and maintain a valid state or territorial license to practice." They also state that ethical recruitment includes: transparency in all communications and any offers of employment; making available all information necessary for an informed decision concerning the circumstances and laws bearing on crossing borders, immigration, labor environment, and the potential new living and working conditions; full disclosure of requirements for nurse competency in the workplace; adoption of high ethical standards in nurse recruiting; and development of sanctions for those engaging in unethical practices.

"It is extremely important that Hawaii keeps its standards high even when facing a nursing shortage and I urge my colleagues to vote in favor of these Resolutions. Thank you."

Representative Cabanilla rose to speak in support of the measure, stating:

"I am speaking on Stand. Com. Rep. Nos 1629 and 1630, and I would like to elaborate more on what the previous speaker said. In strong support on the ethical recruitment of nurses. I've heard a lot of anecdotes. I didn't go to school in the Philippines, but I've heard a lot of anecdotes about illegal recruitment in that country.

"The honoree that I had today came in on a work visa and she tells me that when she was recruited to come to work in New York, she was shown pictures of a beautiful place to live that came with a swimming pool and other amenities. But upon arriving to work for Bellevue Hospital, she was brought to a room about the size of a three by eight foot room with just a cot in there. There was no refrigerator. The bathroom was down the hall. They were given twelve hour shifts to work every day. So what she's showing me is that what is said during recruitment is not the same standard or the same situation as when they arrived. So I strongly support this measure, Mr. Speaker."

Representative Ward rose to speak in support of both measures, stating:

"Mr. Speaker, a comment in support of the Resolutions which I entirely agree with the intent and the purpose which are well done. The only thing is its title. It suggests, implies, imputes that the Governor is supporting unethical recruitment behavior. I know that's not the intent, but it's worded, I would say poorly, improperly and we should be able to do better."

There are two specific companies that presented their testimony in support. I have no idea who they are. The Department of Health opposed this Resolution, and the Department of Taxation, while it didn't oppose it, had brief comments that were less than supportive. So those are the problems I have. Thank you."

Representative Meyer's written remarks are as follows:

"I am in support of HCR281, but with some reservations. This Resolution would effectively give a specific company, Eurus Genomics, Inc., a narrowly tailored \$15 million tax break not available to other companies in different industries. While the product this company is trying to develop appears worthwhile and of benefit to society – a better way of testing for diseases such as hepatitis C -- so are most products sold by most companies. By giving a few companies a free ride on taxes, all other companies must assume a larger tax load.

"This is fundamentally unfair, and distorts and politicizes the competitive process so essential to a vibrant economy. Government should not be in the business of picking and choosing which companies they would like to succeed or fail – such a collectivist approach toward the economy has been demonstrated over and over again to be inferior to letting the free market sort out the most efficient and rational allocation of scarce resources."

THIRD READING

S.B. No. 1509, SD 1, HD 1:

On motion by Representative Caldwell, seconded by Representative B. Oshiro and carried, S.B. No. 1509, SD 1, HD 1, entitled: "A BILL FOR AN ACT RELATING TO HIGH OCCUPANCY VEHICLE (HOV) LANES," passed Third Reading by a vote of 50 ayes, with Representative Thielen being excused.

S.B. No. 228, SD 1, HD 1:

Representative Caldwell moved that S.B. No. 228, SD 1, HD 1, pass Third Reading, seconded by Representative B. Oshiro.

Representative Ching rose in support of the measure and asked that her written remarks be inserted in the Journal, and the Chair "so ordered."

Representative Ching's written remarks are as follows:

"I strongly support S.B. 228—Relating to Graffiti, which would require minors who commit graffiti to remove their graffiti from the affected property and to perform community service to remove graffiti from other properties.

"This bill is an important step towards assisting in combating the graffiti problem many of our local communities face. Graffiti severely blights many neighborhoods in our State and wastes thousands of dollars aimed at its removal. This is particularly troublesome for small business and private property owners. Residents in certain neighborhoods are unable to walk from one block to another without coming upon graffiti in one form or another. As Hawaii relies on tourism and natural beauty, graffiti seriously detracts from our State's success.

"By enforcing stricter penalties for Hawaii's Criminal Property Damage law we can help decrease the graffiti rate, assist many communities in combating their graffiti problem and preserve Hawaii's beauty for future generations to come. Further, perhaps with public input, we can explore the option to require that paint and supplies required for removal be provided for at the expense of parents and the minor."

Representative Manahan rose in support of the measure and asked that his written remarks be inserted in the Journal, and the Chair "so ordered."

Representative Manahan's written remarks are as follows:

This issue is very close to my district's heart. Graffiti in our neighborhoods is not merely an eyesore. It decreases community morale, and ultimately hits the taxpayers in our already slim pocketbooks. With the introduction of this program to the Judiciary, we will be able to bear the costs of these offenses by passing them on to the offenders. More importantly, we must remember that oftentimes these offenders are not career felons or lifetime criminals, but our children, our neighbor's children, or our community's children that simply need a little guidance. This program will allow them to realize how their behavior affects communities, and experience the recognition they sought to gain through their actions."

The motion was put to vote by the Chair and carried, and S.B. No. 228, SD 1, HD 1, entitled: "A BILL FOR AN ACT RELATING TO GRAFFITI," passed Third Reading by a vote of 50 ayes, with Representative Thielen being excused.

S.B. No. 755, SD 1, HD 1:

On motion by Representative Caldwell, seconded by Representative B. Oshiro and carried, S.B. No. 755, SD 1, HD 1, entitled: "A BILL FOR AN ACT RELATING TO COUNTY ETHICS COMMISSIONS," passed Third Reading by a vote of 49 ayes to 1 no, with Representative McKelvey voting no, and with Representative Thielen being excused.

S.B. No. 1750, SD 1, HD 1:

On motion by Representative Caldwell, seconded by Representative B. Oshiro and carried, S.B. No. 1750, SD 1, HD 1, entitled: "A BILL FOR AN ACT RELATING TO HEALTH," passed Third Reading by a vote of 50 ayes, with Representative Thielen being excused.

S.B. No. 46, SD 1, HD 1:

Representative Caldwell moved that S.B. No. 46, SD 1, HD 1, pass Third Reading, seconded by Representative B. Oshiro.

Representative Ward rose to speak in opposition to the measure, stating:

"I rise in opposition to Stand. Com. Rep. No. 1611. This bill is related to government operations, but it probably should be called 'Related to a lack of trust in the Board of Regents in the University of Hawaii to set compensation levels.'

"The bill attempts to make public the salaries of the best and the brightest. Those who we were honoring on the Floor a few days ago, those who we applaud when we see something good come out of the University. The difficulty is that salaries are personnel matters and all personnel matters are private. Even the lawyers who attend to those things are not public. As we know with all the other departments, that is the case.

"The difficulty is that with the commentating note, that we only have to, as the amended bill says, give ten days of the notice to talk about compensation. The Board of Regents already has to give the Lieutenant Governor's office ten days notice to have a meeting. So in effect, it's redundant and in effect, it's private and in an executive session. I'm not sure what this bill does. If anything, the bottom line I guess, is the old adage, Mr. Speaker. If it ain't broke, let's not fix it. Thank you."

Representative Marumoto rose to speak in support of the measure, stating:

"Mr. Speaker, I rise in favor of this bill. I'm not quite sure I understand it correctly, but it refers to the compensation of newly hired employees. And I would take that to mean that literally and that these employees are not prospective members. That was my only query on this bill. If I am reading this incorrectly, I would like to be corrected. Thank you."

Representative Takai rose to speak in support of the measure, stating:

"In strong support. Thank you, Mr. Speaker. This bill in fact amends the law to require the University of Hawaii Board of Regents to produce, no later than ten days, the compensation for newly hired employees, as well as existing employees that will be receiving additional compensation.

"Mr. Speaker, in the year 2000, the voters of this State passed the constitutional amendment providing the University with some additional fiscal and administrative flexibility. That amendment did not give the University the full rights and responsibilities of pretending to be, or giving it the rights to be a private university. The University of Hawaii still exists today as a publicly funded institution of higher education. And I think it's incumbent upon us as policymakers that the request of groups like the University of Hawaii Professional Assembly, to consider the concern of having or allowing the Board of Regents to pass compensation levels, as well as approve newly hired employees for positions like the President, or Chancellors of the various campuses, or any other executive or managerial position.

"In the past, this data was available. In fact, the Legislature used to approve through the budget, the salary levels of each of these employees. What we've done now is we've given that to the University. And with that, I believe, comes some responsibility, one of which is to provide the public with fair notice of what the compensation level is going to be. And to allow the public, including the University of Hawaii Professional Assembly, if they choose, the chance to testify for and against not only the person being considered, but also the salary compensation. So unfortunately, the University has not done that. So through this bill, we're going to require them to do that. Thank you, Mr. Speaker."

Representative Ward rose to respond, stating:

"Just a footnote to the previous speaker. And I know he believes very, very, very strongly in autonomy and this body very wisely did grant autonomy a number of years ago. But if we really mean it, we want to make it autonomous, we probably don't want to keep taking it back. You don't want to tell somebody they're free, but by the way check with me on everything that you do before you do it.

"So I think it's one of those areas that eventually the slippery slope of autonomy may go back to where in another five years, repeating what we're doing this year, we may come back to where the University of Hawaii in effect is handcuffed. And I'm not sure that that is the intention of any of us in this body."

Representative Meyer rose to speak in opposition to the measure, stating:

"Thank you, Mr. Speaker. I'm rising in opposition to this measure. I have some of the very same concerns as the Representative from Hawaii Kai. In any given year we will give the University more autonomy, and then something happens and then we want to take it back. You cannot run a University through consensus of every group there.

"In Committee, people from the University talked about certain positions that are very hard to fill. There are lots of faculty members that are aware that real people get hired at a higher wage than they're getting even though they've been there for twenty years, and they understand the underlying reasons for it. I think this sets up something that is much more of a political situation. The Board of Regents with the President is the Executive Branch, and now you're going to have people coming into this public meeting. It's like advise and consent that's going on in the Senate, probably right this moment, tearing people apart. I don't think that serves our University well. Thank you, Mr. Speaker."

Representative B. Oshiro rose to speak in support of the measure, stating:

"Mr. Speaker, I rise in support. Just very briefly. I think people are confusing the word 'autonomy' with 'accountability'. Really this is about accountability. This currently is about the proposed salaries that will be coming. Currently under the Uniform Information and Practices Act, Chapter 92 of the Hawaii Revised Statues, we're already provided or have the right to get the actual compensation of these individuals.

"But what this bill is doing is saying that when there's going to be a proposed salary increase for what we want to see our public monies going towards, whether we feel that these individuals are worth that amount of money or not, that's something that the public should have some say in. And that's about accountability. This is not about autonomy. We in this body are not doing anything to diminish that autonomy. But what we are requiring is accountability."

Representative Takai rose to respond, stating:

"Mr. Speaker. Second time, in favor. I just wanted to mention that I never called the constitutional amendment that we passed in 2000, a constitutional amendment for autonomy. I've always called it, 'fiscal flexibility'. In fact, I've written probably for the last five years, an explanation of what the voters of this State passed in 2000. I would be more than happy to give that letter to the Representative from Hawaii Kai because I think many people misunderstood as to what in fact the voters of this State passed in 2000.

"It's not a constitutional autonomy amendment. It provides for flexibility. It codifies in the Constitution some of the things that the Legislature had at that time given to the University. It allows the University to do some things right now before even asking us for permission. That's what it does. But this bill does not erode that particular provision passed by the voters in 2000.

"Mr. Speaker, I think people should start taking a look at this bill and understand that the issue that we had a few years ago when the Regents selected a prior President at the compensation level of \$442,000, that the public, including the University faculty, did not have a chance to discuss or debate with the Regents that particular individual and more importantly, that particular compensation level until after the Regents adopted the level of compensation, and more importantly, hired that particular individual."

The motion was put to vote by the Chair and carried, and S.B. No. 46, SD 1, HD 1, entitled: "A BILL FOR AN ACT RELATING TO GOVERNMENT OPERATIONS," passed Third Reading by a vote of 48 ayes to 2 noes, with Representatives Meyer and Ward voting no, and with Representative Thielen being excused.

S.B. No. 1011, SD 1, HD 1:

On motion by Representative Caldwell, seconded by Representative B. Oshiro and carried, S.B. No. 1011, SD 1, HD 1, entitled: "A BILL FOR AN ACT RELATING TO MOTOR VEHICLE KEY INFORMATION ACCESS," passed Third Reading by a vote of 42 ayes to 8 noes, with Representatives Chang, Finnegan, Hanohano, Har, Meyer, Pine, Sagum and Tokioka voting no, and with Representative Thielen being excused.

S.B. No. 1954, SD 1, HD 1:

On motion by Representative Caldwell, seconded by Representative B. Oshiro and carried, S.B. No. 1954, SD 1, HD 1, entitled: "A BILL FOR AN ACT RELATING TO JUSTICES AND JUDGES," passed Third Reading by a vote of 50 ayes, with Representative Thielen being excused.

S.B. No. 1957, SD 1, HD 1:

On motion by Representative Caldwell, seconded by Representative B. Oshiro and carried, S.B. No. 1957, SD 1, HD 1, entitled: "A BILL FOR AN ACT RELATING TO CODE OF

ETHICS," passed Third Reading by a vote of 50 ayes, with Representative Thielen being excused.

S.B. No. 149, SD 1, HD 1:

On motion by Representative Caldwell, seconded by Representative B. Oshiro and carried, S.B. No. 149, SD 1, HD 1, entitled: "A BILL FOR AN ACT RELATING TO STATE BONDS," passed Third Reading by a vote of 50 ayes, with Representative Thielen being excused.

S.B. No. 1370, SD 1, HD 1:

Representative Caldwell moved that S.B. No. 1370, SD 1, HD 1, pass Third Reading, seconded by Representative B. Oshiro.

Representative Marumoto rose to speak in support of the measure with reservations, stating:

"Mr. Speaker, I am rising on the last bill, expressing reservations. While I have no problem with the Department of Budget and Finance assessing fees for the due diligence it performs for commercial entities seeking special purpose revenue bonds, I fear that large fees could adversely affect small non-profits such as independent schools. I would hope that Budget and Finance would exempt small nonprofits, especially schools. Thank you."

The motion was put to vote by the Chair and carried, and S.B. No. 1370, SD 1, HD 1, entitled: "A BILL FOR AN ACT RELATING TO SPECIAL PURPOSE REVENUE BONDS," passed Third Reading by a vote of 50 ayes, with Representative Thielen being excused.
