The House of Representatives of the Twenty-Fourth Legislature of the State of Hawaii, Regular Session of 2007, convened at 9:36 o'clock a.m., with the Speaker presiding.

The invocation was delivered in song by Miss Marie Sonson, second-grade student at Hanalani School and daughter of Representative Alex M. Sonson, after which the Roll was called showing all members present with the exception of Representatives Bertram, Hanohano, Herkes, Karamatsu, Luke, McKelvey, Meyer, Morita, M. Oshiro, Pine and Takamine, who were excused.

By unanimous consent, reading and approval of the Journal of the House of Representatives of the Forty-Eighth Day was deferred.

STATEMENT OF OBJECTIONS TO HOUSE BILL NO. 853

Pursuant to Section 16 of Article III of the Constitution of the State of Hawaii, I am returning herewith, without my approval, House Bill No. 853, entitled "A Bill for an Act Relating to Public Work Projects."

This bill is objectionable because it would require the State to cite a contractor for each individual construction project for which work is performed, no matter how minor the infraction and whether the violation was committed knowingly or not. If violations were discovered in one investigation involving multiple construction projects, the contractor would receive multiple citations.

Upon the receipt of a third violation, a contractor would be precluded from performing any new public work construction for a three-year period. Considering the complexity of the law and the difficulties it poses for a contractor to successfully navigate, this result is too harsh. This rigid violation structure fails to take into account the severity of the violations found and the willfulness of the contractor in committing the violation.

The mandatory, progressive penalty structure in current law allows firms to correct errors as soon as they are identified and ensures that the Department of Labor and Industrial Relations is able to work

with affected contractors to provide fair wages pursuant to the wage schedules, benefit formula, and applicable overtime rules in place.

The changing of the manner of issuing violations from one based on investigations to one based on projects will likely result in potential litigation. Further, the number of firms bidding on and accepting State and county projects is likely to diminish if the rigid penalty structure imposed by this bill is enacted.

Diminishing the number of firms that can bid on State and county projects, and passing measures that further discourage qualified firms from bidding, will inevitably result in higher costs for public works projects. This will adversely impact the State's ability to fund and execute construction and repair of schools, highways, parks, harbors, and the entire spectrum of public facilities operated by the State of Hawaii. It will also negatively impact the ability of the counties to repair and rebuild our sewer systems, upgrade wastewater treatment plants, and expand police and fire facilities and similar local government structures.

The prevailing wage should be paid when applicable and no contractor should be allowed to ignore the law. However, this bill is unreasonable in imposing a rigid approach that fails to take into account the severity of violations found and the willfulness of the contractor in committing the violation.

For the foregoing reasons, I am returning House Bill No. 853 without my approval.

The purpose of this bill is to clarify that the State, and not the individual county fire departments, is responsible for the fire inspection of State-owned airport facilities required by law.

A substantially identical bill, House Bill No. 1138, was also passed by the Legislature. Because I approved House Bill No. 1138, as Act 10 of 2007, which accomplished the same purpose as this bill, there is no necessity to also approve this bill.

For the foregoing reason, I am returning Senate Bill No. 776 without my approval.

Pursuant to Section 16 of Article III of the Constitution of the State of Hawaii, I am returning herewith, without my approval, Senate Bill No. 1513, entitled "A Bill for an Act Relating to Motor Vehicles."

The purpose of this bill is to conform State motor vehicle equipment specifications to the federal and automobile manufacturers' specifications by: (1) changing the minimum headlamp height requirement from twenty-four inches to twenty-two inches above the road surface and (2) deleting the requirement that a license plate be attached no lower than twelve inches above the ground.

An identical bill, House Bill No. 1427, was also passed by the Legislature. Because I approved House Bill No. 1427, as Act 7 on April 9, 2007, which accomplished the purpose of this bill, there is no necessity to also approve this measure.

For the foregoing reason, I am returning Senate Bill No. 1513 without my approval.

ANNOUNCEMENTS

The Chair then announced:

"This House will stand in recess for the purpose of convening in Joint Session in the Senate Chamber at 10:00 a.m. We will reconvene the House session this afternoon at 2:30 p.m."

At 9:46 o'clock a.m., the Chair declared a recess and the House of Representatives stood in recess, subject to the call of the Chair, and in accordance with House Concurrent Resolution No. 329, met in Joint Session with the Senate, for the Hawaii Medal of Honor Ceremony.

JOINT SESSION

The Joint Session of the House of Representatives and the Senate of the Twenty-Third Legislature was called to order at 10:13 o'clock a.m. by the Honorable Colleen Hanabusa, President of the Senate.

Senate President Hanabusa addressed the Members and audience, stating:

"This is indeed a momentous occasion. We honor members of the Armed Forces of the United States, with ties to Hawaii, who fought and died bravely, in a combat zone designated by Presidential Order.

"On behalf of the House Speaker and all of the Members of the Hawaii State Legislature, I convey our deepest condolences to our very special guests—the family, friends and colleagues of loved ones, who have lost their lives overseas in the Middle East. Our prayers are with you, and we are honored by your presence."

The members of the House, guests, and audience rose for the presentation of our Nation's and our State's Colors by the Joint Service Color Guard and the Hawaii Air National Guard, Royal Guard. The singing of the National Anthem and *Hawaii Pono'i* was led by Mr. Randall Hongo, Mrs. Gay Hongo, and their son, Mr. Andrew Hongo, thereafter the invocation was delivered by Mr. Ray Ganotise.

At this time, Senate President Hanabusa delivered the following remarks:

"Mahalo Joint Service Color Guard, Reverend and Mrs. Randall Hongo, and son, Andrew, and Mr. Raymond Ganotise your participation in today's ceremony is greatly appreciated.

"Courage, that rare and indefinable character that propels a few among us to do what is difficult and dangerous; to take on challenges that so many of us find beyond our grasp. Duty, the drive to serve country, community, and family; that will carry daughter from Washington, a son from Delaware, or a husband from Hilo across the

world to stand for their nation in a time of war. Honor, the result when that uncommon valor and unshakable duty combine in action that awes us, inspires us, humbles us and shows us the height to which human endeavor can aspire.

"Today, we gather in Joint Session to honor those who have made a sacrifice for which we cannot ask and we shall not forget. We honor the family, friends and colleagues who have also sacrificed. Who have themselves paid a price and who helped make today's honorees the brave, strong individuals that we called on and counted on to serve our nation. We offer this honor as a small token that we can never in itself repay the honor that has been given us. An honor borne of courage, driven by duty, and paid for in loss, the highest price ever.

"The roll of heroes that we call today is more than a list of names. It is an acknowledgement of community. The Hawaii Medal of Honor is reserved for those who have touched our islands and have felt the touch of our people. And in offering to those gathered here in memory of those who have fallen, we recognize that they are part of us. For each and every one of you, your tears are our tears. Your loss, our loss. Your pride, our pride.

"Wherever each of these medals finds its final home, a piece of our heart goes with you. You will always be part of our *ohana*, our family, because you have brought us honor and allowed us to share these lives. These medals symbolize our aloha. Our farewell to those we have lost. But also our love for those who have lived among us, touched us and sacrificed for us. And our enduring welcome for all represented here today, the fallen and their families who will be counted among us forever. Mahalo."

At this time, the President of the Senate introduced the following dignitaries seated on the floor of the Senate:

Ms. Jennifer Sabas, representing the Honorable Daniel K. Inouye, United States Senator;

Mr. Kekoa Kaluhiwa, representing the Honorable Daniel K. Akaka, United States Senator; and

Mr. Carl Takamura, representing the Honorable Mazie K. Hirono, United States Congresswoman.

The President then called upon Major General Robert Lee to deliver his remarks as follows:

"Thank you, Senator Hanabusa. Good morning and aloha. I want to thank everyone for coming to this Medal of Honor Ceremony today. Your presence here is strong testimony to the support Hawaii has for our military personnel, our veterans, and their families.

"We are once again involved in hostilities in foreign lands. Our armed forces are once again fighting and dying for the ideals that our nation holds so dear. America's sons and daughters bravely go into harm's way to protect us and to defend our way of life.

"Losing a loved one is never easy. It is difficult to say goodbye to a parent or grandparent who has lived a long and fruitful life. But it is so much more difficult to witness the passing of a loved one who was in the prime of life and whose full potential did not yet have an opportunity to blossom. Such is the case of our heroes from the armed forces who we lost too soon.

"We will lament the missed birthdays, anniversaries, holidays, and really thousands of other daily events that could have been. We will continue to mourn this premature passing of our brothers and sisters in arms.

"The State Medal of Honor is Hawaii's way in which we can remember that ultimate sacrifice. To show our appreciation to the families and to assure them that they will always be part of the State's *ohana* or family.

"A circle of *kalo* or taro leaves is part of the Hawaii Medal of Honor. The word *ohana* was derived from *kalo* and the circle is emblematic of the embrace of the people of Hawaii. Whether a fallen soldier, marine, or sailor grew up in Hawaii, or were members of units based in Hawaii, he is still embraced as part of our *ohana*.

"The star in the coat of arms of the medal represents the fiftieth state star on the American flag and also represents the person who is being honored. But the star also evokes a symbol of America's past. During World Wars I and II, families that had a member serving in the armed forces would display a blue star on a banner or flag in front of their home. If a service member from that family was killed in action, a gold star was often displayed in a window facing the street to let the neighborhood know that the life of a hero who had grown up there had been taken.

"Today this medal is a token of our gratitude from the State of Hawaii proclaiming to all that this is a family of a fallen hero. There is no greater sacrifice a family can make than the loss of a soldier, sailor, marine or airman while in service to our nation. And there is no greater honor which we the people of Hawaii can bestow upon them to symbolize that sacrifice.

"There's an attachment device in the middle of the red and yellow ribbon which is a rendering of the ancient *puela* or flag. And this was raised at sea above the sail of their canoes. All who saw the *puela* from afar, knew that a person of the highest rank or honor was coming.

"Today, this service ribbon and its *puela* will remind us that these families are of the highest rank and honor. We appreciate even more President Abraham Lincoln's humble wisdom at Gettysburg: "When brave men die, it is their deeds, and not our words that are remembered. It is their sacrifice and not our brief recollection that offers everlasting testimony to their love for others and their love for us".

"To the families of our fallen heroes, I humbly ask that you accept this Hawaii Medal of Honor on behalf of the people of Hawaii, who are today, and forever shall be, your devoted *ohana*. May God bless all of you, and may he continue to bless the United States of America."

At this time, the President of the Senate and Speaker of the House presented the Hawaii Medal of Honor. The Clerk of the Senate

announced the names of the Hawaii Medal of Honor recipients, which was followed by the ringing of the memorial bell.

At this time, Members of the United States Air Force proceeded with a 21-gun Salute and the playing of Taps outside the Senate Chamber in the Capitol Rotunda. The Members of the Senate and the House of Representatives, honored families, special guests and audience then stood for a moment of silence.

House Speaker Say then delivered closing remarks as follows:

"We have all just participated in a most somber and touching ceremony. We -- family and friends, colleagues and strangers -- all mourn together. And we all, have an abundance of thoughts and emotions to contemplate and put to rest.

"We should not, however, consider this day as a completely somber occasion. There are some very positive lessons to be derived from this ceremony.

"First, we have honored 67 young men and women for the ultimate sacrifice one can give to his or her country. The Medals awarded today, will help us here -- and this generation -- to remember these courageous individuals. More importantly, by placing these names in the permanent record of Hawaii's legislative history, we are assured that these warriors will be remembered in perpetuity, by generations to follow.

"Second, this ceremony has brought us together. Family members and friends of the fallen ones have come from locations across the State, and across the Nation, to participate in this ceremony, and to commemorate the memory of their loved ones and comrades in arms. We, the participants from Hawaii, welcome the opportunity to make new friends -- to reminisce with our honored families and to listen to their stories -- and to share our aloha.

"Third, this ceremony reminds us of the importance of dignity and tradition, and the strength and resolve of America's armed forces. Without the protection of our uniformed men and women, we civilians would probably not be able to reap the benefits of a free and democratic society. The military is the unseen force that protects us from threats far and near, and allows us to exercise our democratic rights of speech, liberty and peace. As civilians, we should show our appreciation to our military personnel more often.

"And finally, this ceremony reminds us that we must be deserving of the sacrifices of these brave men and women honored today. For them, we must live our lives honorably. For them, we must be unselfish, and willing to serve and share with others. And for them, we must work towards progress for the betterment of society and mankind -- not for personal award or acclaim. In sum, we must live in a manner that proves -- that we are worthy of their sacrifice. Aloha and mahalo."

The Speaker of the House then called on the Joint Service Color Guard and the Hawaii Air National Guard, Royal Guard for the retiring of the Colors, and at 11:12 o'clock a.m., declared the Joint Session of the House of Representatives and the Senate adjourned.

Representative Awana: "Thank you, Mr. Speaker. I rise to request a point of personal privilege. Thank you, Mr. Speaker. Earlier today we were privileged to honor the families of servicemen who lost their lives sacrificing for our country. It is ironic that this memorial came on the same day when families on the East Coast were grieving at the tragic loss of lives at the Virginia Tech University this morning. Thirty-three college students working to educate themselves so they could go on to serve their country were helplessly gunned down. The needless loss of life was incomprehensible.

"We have come to expect that there will be casualties on the battlefield, but our County's schools and universities are supposed to be our safe havens. Mr. Speaker, on behalf of my constituents and all of us in this Chamber, I ask for a moment of silence in memory of the friends, families and individuals who are directly affected by this tragedy. Thank you, Mr. Speaker."

At this time, the House of Representatives stood for a moment of silence in memory of the friends, family and individuals affected by the Virginia Tech University campus incident of this date which resulted in 33 deaths.

Representative Takai: "Thank you, Mr. Speaker. With your permission I'd like to acknowledge some of the people that participated and assisted with this morning's ceremony.

"Thank you, Mr. Speaker. First of all, Mr. Speaker, thank you for giving me the opportunity to once again coordinate the Hawaii Medal of Honor Ceremony, as well as all the preparations prior. But it took many, many people and I'd like to acknowledge the people who made this all happen.

"First, I'd like to thank all of our staff here and in the Senate. Senate Chief Clerk, Carol Taniguchi and her staff; House Chief Clerk Pat Mau-Shimizu and her staff; Senate Sergeant-at-Arms Ben Villaflor and his staff; House Sergeant-at-Arms Kevin Kuroda and his staff; and Linda Oamilda and the House Majority Staff Office.

"We did get a lot of support and assistance from the military. And I would like to recognize Dennis Fujii from the US Pacific Command, and Leighton Siu from the Governor's office, who helped us with protocol.

"I also wanted to mention three individuals who helped us very early on to identifying the people that we recognized today. From the Army, we had Mr. Mark Van Doorne. From the Marines, we had Captain Mark Nicholson and Master Sergeant Antonio Sears.

"In addition Mr. Speaker, as all of you noticed, the Medal itself is a beautiful recognition of the State of Hawaii's appreciation for our fallen comrades. I wanted to acknowledge Sergeant First Class Aaron Pollick once again, for he was the one that originally designed the medal.

"In addition Mr. Speaker, we all knew this was going to turn into a much bigger event than we all ever imagined especially after last year. And because of this we worked very closely with the Pearl Harbor Historic Sites, including the USS Bowfin, the USS Missouri, and the USS Arizona. They all came through with support for the families. In addition Mr. Speaker, the Hale Koa Hotel came through, and the Polynesian Cultural Center came through, again. And we

worked specifically with the Hawaii Hotel Association who provided excellent, excellent hotel rates for families.

"Many people were asking about the 'Olelo Broadcast and I wanted to mention again, Mr. Speaker, this year as last year, Capitol TV will be providing a DVD for each family, both present and not present at today's ceremony. In addition, there are additional copies available for anyone in our Chamber who is interested.

"Mr. Speaker, I wanted to recognize the Planning Committee. Many people in this Chamber, as well as the Senate, and a few other individuals really put in the hard work over the past year to make today's event a reality. Senate President Colleen Hanabusa, you Mr. Speaker, Senator Lorraine Inouye, and Representative Cindy Evans, who served as Co-Chairs of our Planning Committee, helped to make today's event a reality. In addition, we got support from Major General Robert Lee and Colonel Retired Emerick Kaneshi, from the Hawaii National Guard.

"We all know as Representatives that much of our success and the things that we do in this Chamber, as well as in our communities, are the direct results of our staff. And I wanted to at this time, acknowledge the staff people who made this all possible. From Senate President Hanabusa's office, Rod Tanonaka and Eric Hamakawa and her other staff members. Richard Rapoza from Senate Communications. Georgette Deemer and Kim Fassler from our House Communications office. From Senator Lorraine Inouye's office, Arlina Agbayani, Trina Ishii and her other staff members. And from Representative Cindy Evan's office, Tommie Sukanuma, Micah Young and her other staff members. And from my staff in particular, I wanted to recognize Chrysalis Reyna, Sandra Kim and Marnelli Joy Basilio.

"And finally Mr. Speaker, as I did last year, I saved her for last because she really did a lot of work and without her, we would not have had what we did today. And as I said before, our staff makes us what we are. But more importantly, Lisa Vargas, my office manager made us, the State of Hawaii, and the House of Representatives, the Senate, the entire Legislature, made us all look good. She did the due diligence, and covered all of our bases and contacted all of the service members and those who were deserving of the award.

"This award went and continues to go families with Hawaii ties. So far, as of February 28, a total of 186 medals have been awarded. And I believe we have all the families. So Mr. Speaker, at this time I'd like to ask the Members of our body to once again thank all of the people involved in the planning and preparation of today's activities. And I'd like to ask for a round of applause please.

"Thank you, Mr. Speaker. I'd like to at this point, defer to Representative Cindy Evans who has some other acknowledgements to give."

Representative Evans: "Thank you, Mr. Speaker. I would like to thank this body, the House of Representatives, and the staff. Many of you allowed your staff to help in today's event. I believe there was over 45 staff members coming from the different offices. Mr. Speaker, would it be all right if we submit their names in the Journal for record?"

"I think it was exemplary how I think the Sergeant-of-Arms and the National Guard, the ones that volunteered to direct people to the library and how they stood around the Chamber and really took care of the people that were visiting our Capitol today. I think we should thank them and make sure their names are also in the Journal, if that's all right.

"And members, I think just being present and acknowledging them really helped the families deal with their loss and it was a time and a moment for them to reflect and it's so important to deal with loss and grief and they need to move on with their lives. But it's very

appropriate to take a moment and stop and I really want to thank all of you in participating in making this a special event. Thank you."

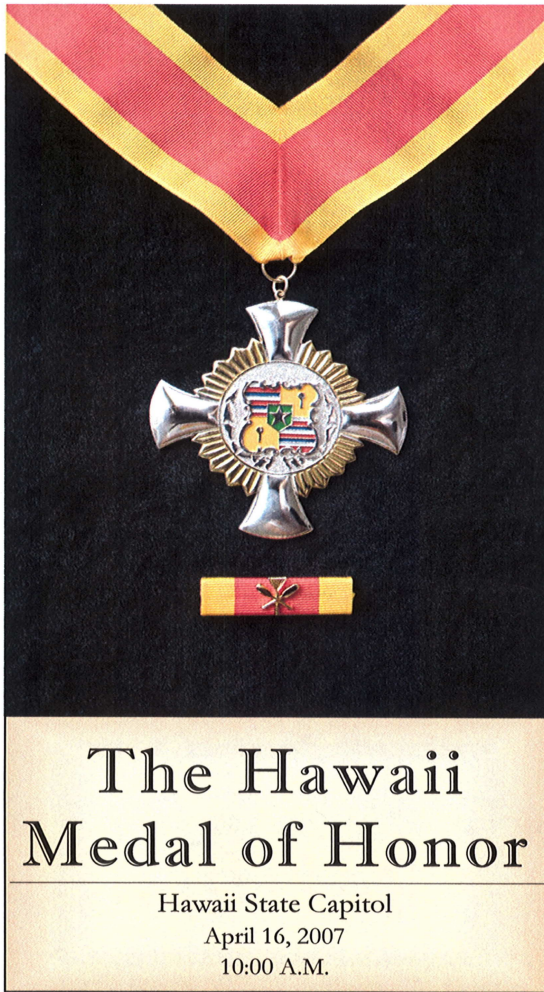

From House Bill 8, designated as Act 21, Session Laws of Hawaii of 2005:

“The purpose of this Act is to provide for a Hawaii Medal of Honor that would help express the deep appreciation and gratitude of the People of Hawaii to the loved ones of members of the military who sacrificed their lives in defense of our nation and its freedoms.”

SYMBOLISM OF THE HAWAII MEDAL OF HONOR

The Hawaii Medal of Honor was designed by Sergeant First Class Aaron Pollick from the Hawaii Army National Guard. This medal consists of the following six components, superimposed on each other:

Circle of Kalo Leaves: The kalo leaves represent the family or Ohana. The leaves are designed in an encircled fashion and represent the concept of Ohana, which we strive to embrace.

Coat of Arms: The Great Shield is the keystone of the design. The eight bars represent the eight major islands of the state of Hawaii. The kapu sticks, or Pulo'ulo'u, symbolize authority and protection. The star in the center of the medallion is the Star of Hawaii, the 50th star on the flag of the United States. This star also represents the honorees of this prestigious award.

Maltese Cross: The Maltese Cross represents the four directional axes of the globe, denoting Hawaii as the Crossroads of the Pacific.

Sun Rays: The irradiant sun is symbolic of the new era. Its position in the center of the Maltese Cross represents our sunny shores and warm hearts ever shining on all the corners of the world.

The Neck Drape: The neck drape is red and golden yellow in color. These colors symbolize the royal monarchy that once ruled these islands. The red represents courage and strength. The golden yellow depicts the honor that the recipients have brought to our islands.

Service Ribbon & Attachment: The service ribbon represents distinguished service. Its colors are identical to the colors of the neck drape. The attachment device at the middle of the ribbon is an ancient flag or puela of Hawaiian Chiefs. In olden times, the puela was raised above the sail of the ancient Hawaiians' canoes while at sea. Our puela signifies that the person receiving this medal is of high rank or honor.
