"In Washington, D.C., the Congress is about to pass a proposed amendment to the Trafficking Victims Protection Reauthorization Act of 2008 – to "establish a temporary victims' protection period." This is progress and it is heartening that our State is also taking action.

"Some concerns were heard in the Senate related to penalties which might be applied to consensual sex between adults.

Amendments to the Senate bill would probably not be enough to make the bill ineffective for exploited persons. I urge the Members' support."

Representative Finnegan's written remarks are as follows:

"Thank you, Mr. Speaker. I rise in strong opposition to these resolutions. I have concerns with the composition of the Convention on the Elimination of all forms of Discrimination Against Women (CEDAW). It has been reported that its language can be misinterpreted and used to pressure countries to force pro-life, healthcare professionals to do abortions in violation of their consciences. These types of misinterpretations by official agencies such as the U.N. CEDAW Committee condemn limitations on abortion, claiming that restrictions on abortion constitute discrimination against women. I believe that the CEDAW, if ratified would condemn many abortion-related laws enacted by this very body including partial birth abortions.

"Thank you, Mr. Speaker."

Representative Lee rose to speak in support of both measures, stating:

"In support of Stand. Com. Nos. 1183 and 1184 and just if I could make some brief comments. In 1999, a resolution to support CEDAW was included as part of the House Majority package, interestingly called Change. In 1993 a resolution requesting the Congress to pass CEDAW was passed on the Floor of this House, it came out of the International Relations Committee when Helene Hale was Chair. And here we are again passing a resolution asking Congress to pass CEDAW.

"It's just amazing to me that almost 10 years have gone by and the Congress of the United States and the Senate have not passed this. The conditions in the world for women have really gotten dramatically worse in some cases; I'd like to cite the cases of human trafficking and poverty around the world. So hopefully our resolution, though it's a small step, will help to realize this goal. Thank you."

Representative Meyer rose to speak in support of both measures with reservations, stating:

"Thank you, Mr. Speaker. On this measure, Stand. Com. Rep. 1183 and 1184, while there are many worthy provisions in this, the real sticking problem that I have is that the United Nations document calls for abortions for women at any time at all during a pregnancy and I don't think that is something that we should support. I stand with strong reservations."

Representative Pine rose to speak in opposition to both measures, stating:

"No vote. And I just wanted to rebut. The reason why our Congress of the United States, both Democrat and Republican, have not passed this, is because it does promote partial birth abortion to some people who are against the bill."

Representative Ching rose and asked that the Clerk record an aye vote with reservations for her on both measures, and the Chair "so ordered"

The motion was put to vote by the Chair and carried, and the reports of the Committees were adopted and H.R.
