#### Thursday, March 20, 2008

The House of Representatives of the Twenty-Fourth Legislature of the State of Hawaii, Regular Session of 2008, convened at 12:08 o'clock p.m., with Vice Speaker Chong presiding.

Representative Ryan I. Yamane introduced Chaplain Ronaldo Pascua of the Hawaii Army National Guard, who then delivered the invocation. The Roll was called showing all members present with the exception of Representatives Bertram, Manahan, Nakasone, Nishimoto, Sagum, Souki and Waters, who were excused.

On motion by Representative B. Oshiro, seconded by Representative Meyer and carried, reading of the Journals was dispensed with and the Journals of the Twenty-Second, Twenty-Third and Twenty-Fourth Days were approved. (Representatives Bertram, Manahan, Nakasone, Nishimoto, Sagum, Souki and Waters were excused.)

STATEMENT OF OBJECTIONS TO HOUSE BILL NO. 987

Honorable Members Twenty-Fourth Legislature State of Hawaii

Pursuant to Section 16 of Article III of the Constitution of the State of Hawaii, I am returning herewith, without my approval, House Bill No. 987, entitled "A Bill for an Act Relating to Police Officers."

The purposes of this bill are (1) to clarify the meaning of "acts done in the performance of the officer's duty as a police officer" for the purposes of determining if a police officer who is prosecuted or sued must be represented by an attorney provided by the county and (2) to specify that the police commission's request for a recommendation by the county attorney or corporation counsel regarding the entitlement of the police officer to counsel at county expense shall be responded to within seven working days.

Section 52D-8, Hawaii Revised Statutes, provides that whenever a police officer is prosecuted criminally or sued civilly for acts done in the performance of the officer's duty, the officer shall be represented at county expense or by the county. The amendment made by this bill will define the acts done in the performance of the officer's duty as a police officer to include any action while in a duty status or while the police officer is on duty, any action performed by

an off-duty police officer while effecting an arrest or performing any other police duty, and any action performed by the police officer while on special duty status.

As written, this bill is overly broad and could place the counties in a position that they would have to defend a police officer when he committed a criminal act. The bill very clearly provides that whenever there is a criminal case or civil case against an officer, and the acts the officer is claimed to have committed occurred while the officer was on regular or special duty, the counties must provide an attorney to represent the officer. Thus, an officer who, while on patrol, engaged in a drug deal or robbed a bank, would have an absolute entitlement to a county-paid attorney if criminally charged with possession of an illegal substance or bank robbery. As this bill is written, there are no exceptions -- so long as the officer is on duty, the officer gets a county-paid lawyer, regardless of the acts the officer commits.

We recognize the need for officers to be provided with legal representation when in the performance of their duties. However, there may be acts committed by a small minority of officers while in the performance of their duties that are not in the scope of an officer's authority as a police officer, i.e., activities such as the sale of narcotics, sexual assault, domestic violence, burglary. Officers should not be provided with legal representation in these or similar instances. Automatically affording officers legal representation would violate the trust bestowed by the citizens they are sworn to protect. Further, legal representation paid for by the individual counties in instances when a law enforcement officer commits criminal acts would blemish the reputation and integrity of all law enforcement officers and endanger the public's support in their Police Departments.

Additionally, the seven day timeline for a county's corporation counsel or county attorney to submit a recommendation to the police commission is, in the judgment of the counties, unrealistic and could cause the county police commissions to make decisions without proper recommendations and without the relevant investigative information. A proper investigation often takes weeks to complete.

We acknowledge that police officers' work places them in confrontational situations, which may lead to allegations of civil and criminal wrongdoing. We are sympathetic to the concerns expressed by police officers and by the State of Hawaii Organization of Police Officers, who are not confident that all deserving officers receive legal representation, and are concerned about the potential consequences of lawsuits and criminal charges and the effect on officers' morale and the manner in which they may carry out their duties. I understand the State of Hawaii Organization of Police Officers has worked with the counties over the past week to craft language that addresses the concerns of the counties, while ensuring representation for police officers when it is truly warranted.

I would support a bill that made it more likely that deserving officers would receive legal representation. I cannot support this bill with the serious language flaws described above.

For the foregoing reason, I am returning House Bill No. 987 without my approval.

"Mr. Speaker, I wanted to speak in opposition to Senate Bill 2334, SD 2. Thank you, Mr. Speaker. This bill repeals the exemption from civil service of the First and Second Deputy Sheriff. It requires the Deputy Sheriff for Law Enforcement and the Sheriff to be graduates of a law enforcement academy.

"Tm concerned that this bill would limit the ability of the Governor and the Director of Public Safety to appoint candidates of their choice to the positions. It is critical for the successful operation of any department that the leaders and the administrators work together as a unit. Therefore it is critical that the Governor and the Director of Public Safety have the opportunity and the capacity to select those administrators that will work well within the current system. Thank you, Mr. Speaker."

Representative Ching rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committees was adopted and S.B. No. 2334, SD 2, entitled: "A BILL FOR AN ACT RELATING TO PUBLIC SAFETY," passed Second Reading and was referred to the Committee on Finance with Representative Meyer voting no, and with

Representatives Bertram, Manahan, Nakasone, Nishimoto, Sagum, Souki and Waters being excused.

Representative Evans, for the Committee on Public Safety & Military Affairs presented a report (Stand. Com. Rep. No. 1282-08) recommending that S.B. No. 2828, SD 2, as amended in HD 1, pass Second Reading and be referred to the Committee on Finance.

Representative Thielen rose to speak in opposition to the measure, stating:

"Thank you, Mr. Speaker. I'm rising to speak against Standing Committee Report 1282 and Senate Bill 2828, which is relating to emergency powers under disaster relief.

"Mr. Speaker, this bill is either identical to or very similar to House Bill 2664, which restricts the Governor's powers. I would like to quote from the Attorney General on this matter and I quote, 'This bill would turn the clock on emergency management law in Hawaii back 57 years and significantly hamper the Governor's ability to respond to emergencies and disasters.' This was said by Attorney General Mark J. Bennett.

"Mr. Speaker, I would like to ask that my remarks on House Bill 2664 be inserted in the Journal in opposition to this bill, which shows the incorrect activity of this Legislature in doing this, in trying to rein in the Governor's powers. I would hope that Members would think seriously before letting this bill move forward.

"I believe that there's an editorial on this effect in the *Advertiser*. The *Honolulu Weekly* similarly has put in a piece on this matter. It makes me more than puzzled. It makes me be amazed that people can be so partisan in this body to try to rein in the well-used powers of Governor Linda Lingle. I think that our people out there who will bear the brunt of the action here in the Legislature, and the people will not be happy. Thank you"

Representative Ward rose to speak in opposition to the measure, stating:

"I rise in opposition. In continuation of the remarks from my colleague, I think if I was in the Majority, I would really think twice about voting for this bill. In fact if you want to take powers away from the Governor, go ahead, but don't do this one. This one goes against the people of Hawaii. This is the one where you have to be an Executive to execute decisions quickly and firmly. It's the difference between being on the Board of Directors, versus being the President of the company. You have to make decisions. You can't go to a committee. As they say, a committee is a horse designed as a camel, or a camel turns out to be a horse when it comes into a committee.

"And when the Governor, whose job is to execute, she can't refer to the Legislature as a reference point. Mr. Speaker, you have the prerogative as the Majority to do these kinds of things, but this one is probably the least wise of all. As I said it goes against the governed, not the Governor. It's against the people of Hawaii. And there's only one way to explain it, and that's what has been coined as IFL, the IFL-phobia. Not the fear of high towers, like the Eiffel Tower in Paris, but the irrational fear of Lingle is the only way to explain it Mr. Speaker."

Representative Rhoads rose to speak in support of the measure, stating:

"In support. Mr. Speaker, when we had this debate a few days ago, it struck me that the difference in opinion has to do with the definition of an emergency. One of the examples given by the Minority Party was homelessness on the Leeward Coast. Well there's

been homelessness on the Leeward Coast for many years. And yes, for those who are experiencing it, it is an emergency, just as for those who are involved in an automobile accident are part of an emergency that's bigger than just themselves. You have hundreds of automobile accidents every year, but it's been going on for 50 years. Is it still an emergency after 50 years?

"Like I say, it's an emergency to those that it's happening to, but in the broad scheme of things, it's not something we can resolve in five minutes or if somebody's rushed to the hospital everything's going to be okay. It's a policy decision about how to handle homelessness, and in that area the Legislature certainly has a role to play. Of course it's easier not to have a Legislature. Dictatorship is the most efficient form of government, but is it the best form? I would argue that it's not Mahalo."

Representative Meyer rose to speak in opposition to the measure, stating:

"Thank you Mr. Speaker. I'm rising in opposition to that measure. I would take exception to some of the things said by the previous speaker. In that the example of the homeless problem on the Leeward Coast, it was not just an emergency, it was a health and safety problem. It would not make any of us proud that it was allowed to get in the state that it was in because people simply looked the other way for so many years.

"And as far as health and sanitation, it was a problem for the residents of the Leeward Coast that they were now held out, they couldn't even use the public parks that were there for their pleasure and use. So I don't think there was any question this was an emergency. I think that's enough. Thank you."

The Chair then announced:

"Members, this measure will be going to the Finance Committee, so may we move on?"

Representative McKelvey rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

Representative Ching rose in opposition to the measure and asked that the remarks of Representative Meyer be entered in the Journal as her own, and the Chair "so ordered." (By reference only.)

"Mr. Speaker, on the same measure, I just wanted to declare a potential conflict. Some of my partners are shareholders in the Galbraith Trust and my wife's financial institution that she works at is the trustee for the trust. Thank you," and the Chair ruled, "no conflict."

Representative Yamane rose to speak in support of the measure, stating:

"Mr. Speaker, I am standing in support with brief comments. If we're really considering land acquisition in Turtle Bay, this would definitely qualify as well. Thank you."

Representative Meyer rose to speak in opposition to the measure, stating:

"Thank you, Mr. Speaker. I am rising in opposition to that measure. In addition to the liability of some of the agriculture lands, I'm concerned about Lake Wilson and the dam that created Lake Wilson. Thank you."

For example the current Civil Defense and Emergency Act, Chapter 128 HRS, I'm just not sure what this bill is going to do. So I'm going to vote with reservations."

Representative Marumoto rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committees was adopted and S.B. This bill would cover projects used on State or county lands, but they would cover private projects. So you'd have to come under the Little Davis Bacon Act, even if the lessee is a private entity operating a private business, and the lessee's operations are not funded by government revenues, nor are the leases entered for purpose of the lessee's constructing improvements to be used or occupied by governmental agencies.

"Unlike construction contracts for true public work projects, DLNR would have to act as a passive landlord in the leases that it manages and would not be able to dictate, oversee, or participate in the lessee's operations or management, let alone get involved in personnel issues and decisions. So as such it would be inappropriate, in fact well near impossible for DLNR to monitor and enforce any proposed wage and hour provisions in this business.

"The bill also requires a government agency leasing the land to be the contracting agency for the construction on the site. This requirement would impose an unreasonable burden on government agencies who act as passive landlords by obligating them to be bound by the terms of the construction contract for purely private purpose in which they have no interest or control, but for the fact it is situated on public land. This would effect every department that leases land and I think it's a very difficult burden that we would put on our State government. Therefore, I will be voting no."

Representative Thielen rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."
