I wish to put into the record that the Korean Veterans have spent many, many years taking care of the Korean and Vietnam War Memorial that's here on the Capitol grounds. They are getting very old and they really would like to not have to continue to do that because they are just getting older.

"The other thing they have brought to our attention is that there is a lot of homelessness, a lot of needles, and a lot of trash and garbage that they find. They've said that over the last few years it's been getting worse and worse. So that is why we have this Resolution today and hopefully our Sheriff's Department and our Department of Accounting and General Services will take really good care of that Memorial

"Again, I just want to thank the Korean Veterans for all they've done for us over these last years taking care of that memorial. Thank you."

And Mr. Speaker, it seems as though that because of it's location it seems to attract some people who sleep overnight. But now it's in dire need, as the speaker from the Big Island mentioned. Thank you."

During times of natural disasters or hurricanes, one of the first, if not the first action that takes place is to close the only roadway that physically connects us to the outside world. Now you have two options. First, locate your nearest shelter; and second, head for the mountains and find your own shelter.

"The existing emergency shelters are not sufficient. I believe that this measure is a simple request. Civilian use of the Lualualei Naval Magazine takes a common sense approach to a complex situation. There are three different entrances from the Waianae side of the Magazine which would assist those living in Waianae, Lualualei, Maili and Nanakuli. It is centrally located and entrances are easily accessible. Now that most if not all of the ammunition has been relocated, we should seriously look at reinventing this extremely important site for civilian use during times of emergency.

"Thank you, Mr. Speaker."

And I think if we have equity in that if we have other people by 2011 stop smoking, I think then it's fair. This is a group of individuals who are troubled. They are in a troubled incarcerated situation. To say that there is no smoking, I think is a bit above the board of which otherwise inhumane treatment would be given. And with that I have reservations."

Representative Brower rose to speak in support of both measures, stating:

"Mr. Speaker, in strong support. Thank you. We have a situation now in correctional facilities where prison guards have to light the cigarettes of inmates because inmates can't have matches or cigarette lighters. And some of these guards light anywhere from 50 to 100 cigarettes per shift. And the prison guards are telling us in news reports on TV that the inmates are purposely blowing the smoke back into their faces and they feel degraded.

"I've been following this bill. I that it has some good initiatives and one is to offer a program to help the inmates or anyone incarcerated quit smoking. Currently, we have a no smoking policy in our State prisons, but not at OCCC. I had the chance to visit there and see all the smoking that is going on. And I think what's

important about this measure is that it brings up an interesting question

"Currently we don't have smoking in State facilities. We don't have smoking in restaurants and other private sector businesses. Soon we may not have smoking on the beaches. And without this measure, the only legal place to smoke may be in prisons. So I think that just calls an interesting question to our society. Thank you, Mr. Speaker."

Representative Thielen rose to speak in support of the measure with reservations, stating:

"Mr. Speaker, I'd like to register my reservations on Stand. Com. Report No. 1431. And in this Mr. Speaker, there are two concerns that I have. One is that we need to be very careful about keeping a balance between the desire to increase Hawaii's agricultural base as a renewable energy resource, and food production. Those of us who have a chance to visit the Agricultural Day exhibits on the Fourth Floor, you know how important it is to keep land in rural agricultural production.

"The second thing that was brought up was by the Department of Planning and Permitting of the City and County of Honolulu. It was concerned that this ten percent of land should have to go through the special permit process to allow for discretionary review. And the reason that would happen is that if you allow ten percent of your agricultural land to be devoted to agricultural energy facilities, you can create buffering, visual, traffic safety and other issues. And therefore a special permit process can address those things and make sure that the land use is done appropriately. So I do have those concerns. I would ask Members look at this as they go into Conference on it. Thank you."

The motion was put to vote by the Chair and carried, and the report of the Committees was adopted and S.B. No. 2849, SD 1, HD 1, entitled: "A BILL FOR AN ACT RELATING TO AGRICULTURAL LANDS," passed Third Reading by a vote of 44 ayes, with Representatives Ching, Nakasone, M. Oshiro, Pine, Saiki, Takamine and Takumi being excused.
