The House of Representatives of the Twenty-Fourth Legislature of the State of Hawaii, Regular Session of 2008, convened at 12:06 o'clock p.m., with the Speaker presiding.

The invocation was delivered by Ms. Jeannin Russo of Representative Kyle T. Yamashita's office, after which the Roll was called showing all members present with the exception of Representatives Nakasone, M. Oshiro, Takai, Ward and Waters, who were excused.
