"Mr. Speaker, I rise in support of this measure as a Vietnam veteran. And I can't speak for all, but I know that the veterans have tried for more than ten years and have done a reasonably good job at maintaining the shine and the cleanliness of that Memorial. But I do think it's time now that DAGS take over. It'll be another couple of hours a week at most. It's pretty much self-maintaining. It's a beautiful addition to our Capitol and I think it's a beautiful way of extending it into the future. Thank you, Mr. Speaker."

Representative Waters, for the Committee on Judiciary presented a report (Stand. Com. Rep. No. 1605-08) recommending that S.B. No. 2825, SD 1, HD 1, as amended in HD 2, pass Third Reading.

Representative Caldwell moved that the report of the Committee be adopted, and that S.B. No. 2825, SD 1, HD 2, pass Third Reading, seconded by Representative B. Oshiro.

Representative Meyer rose to speak in opposition to the measure, stating:

"I'm standing in opposition to Stand. Com. Rep. No. 1605, Senate Bill 2825, Relating to Procurement. I will be voting no on this. This bill, in my estimation, is unnecessary as there are already provisions in the Procurement Code that calls for violators of the Code to be subject to administrative fines or removal from office. The punishment that this bill would impose just because the process takes longer than the bill's author would like, is unnecessary and would discourage the kind of dialogue that can improve the application of the Code.

"The bill in its current form, also inserts a provision requiring the Comptroller to become an ex-officio, non-voting member of the State Procurement Policy Board. I don't believe there's a basis in the bill's language or the Committee Report for taking away the Comptroller's vote. The State Procurement Code applies to State and county agencies. The State Procurement Policy Board adopts rules to implement the State Procurement Code. The Board has seven members, all with voting rights. Two members are government employees: one representing the counties; and one, the Comptroller, representing the State. The other five members are not State or county employees. If the Comptroller's vote is taken away, there will be only one vote representing the government agencies to whom the State Procurement Code applies. These are just some of the reasons I can't support the bill. Thank you, Mr. Speaker."

Representative B. Oshiro rose to speak in support of the measure, stating:

"Mr. Speaker, I rise in support. Very briefly, just to counter that last argument. If the Member would read the Standing Committee Report for the HD 1, 'as such, your Committee has amended this measure by deleting the section making the Comptroller an exofficio, non-voting member.' So that is no longer in the bill and so that argument is now moot.

"The second point is that this about corrective action. By definition, correction means that something was wrong. And if something is wrong, I don't see why we should have to wait longer than 30 days in order for any Chief Procurement Officer to make the correction. And 30 days seems to be a reasonable amount of time. Thank you."

Representative Marumoto rose to speak in opposition to the measure, stating:

"Mr. Speaker, I'm also in opposition to this measure. I was aware, yes, that the Comptroller's vote was restored. But nevertheless, the rest of the bill is very trying for the Department of Accounting and General Services and for the Procurement Office because they said 30 days is sometimes not enough time to resolve an issue amicably. And given enough time, they don't need to resort to instant penalties and fines. Thank you, very much."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and S.B. No. 2825, SD 1, HD 2, entitled: "A BILL FOR AN ACT RELATING TO PROCUREMENT," passed Third Reading by a vote of 39 ayes to 6 noes, with Representatives Ching, Finnegan, Marumoto, Meyer, Pine and Ward voting no, and with Representatives Bertram, Green, Morita, Nakasone, Souki and Thielen being excused.
