Representative Takai rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. I rise in support of Stand. Com. 1912. Thank you. Unfortunately, our good Member from Kihei is not here today, but he has been a champion of this effort ever since coming here Mr. Speaker. And although it doesn't look it when you look at me, I still absorb what he's talking about. And I do believe his mission in life to educate us, as well the people of the State in the area of vegetarian and vegan meals is appreciated.

"And at this time I'd like to request written comments entered into the Journal and I'm going to ask our Representative from Kihei to help me with it," and the Chair "so ordered."

Representative Takai's written remarks are as follows:

"Mr. Speaker, I rise in support of SCR 84.

"Over the past two years, I've grown to know and appreciate the efforts of our colleague from South Maui, the Representative from House District 11.

"I don't know of anyone else who has come into our body that has been able to shape public policy on an issue that wasn't considered just a few years ago.

"The Representative from South Maui is a leader who strongly believes that children and adults, as well, need to have the opportunity to choose more healthy eating habits.

"I asked the Representative from South Maui to give me a few comments about why he supports SCR 84, and why we as a body need to support this Resolution.

"Here are comments from Rep. Joe Bertram from South Maui:

SCR 84 requests the Department of Education and the Hawaii Public School Food Service to develop nutritionally-sound public school menu plans that include vegetarian and vegan meals.

Vegetarian (i.e. the plant-based diet) will not only address childhood obesity, it will also lead to a healthier community in the long run and a healthier planet.

A recent study, the biggest so far, confirmed lower obesity rates, as well as, a reduction in many diseases. Also the UN report on global warming identified methane from cows and the meat industry as a major contributor to global warming.

The main impediment to vegetarians is peoples' strong addiction to meat. Introducing kids to the possibility of vegetarian dishes can begin the slow evolution to a healthy, sustainable world.

"I urge our colleagues to head the advice from the Representative from South Maui and to support this Resolution. Thank you, Mr. Speaker."

Representative Ching rose to speak in support of the measure, stating:

"Thank you very much, Mr. Speaker. I also rise in strong support. Mr. Speaker, I've had as you know and some others may know the opportunity to understand diabetes on a much more personal scale this year. It's my understanding that this disease is the most epidemic disease in our State, and I know that we've passed Legislation also to acknowledge this.

"But I think that our local people, our Hawaii people don't always get the opportunity to make changes in their diet, I myself included. And now we have a new awareness of this disease which is somewhat preventable by diet. More and more dialysis centers will pop up, people will lose their lives, families will be crushed, and friends will be saddened. And I think that it's time that our Hawaii people, especially our children understand that a vegan diet can prevent many of these life-threatening diseases. Thank you Mr. Speaker."

Representative McKelvey rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. In strong support. Real briefly, my colleague from Kihei is not here so I will briefly stand in his stead. It's a passionate issue for him, not only because of the health concerns, but also because it evolves around choice, something that's been lacking. It was funny when I saw this because in 1992 when I was an aide in the State Senate, you couldn't even get a Resolution like this heard, so I really think that us adopting this today and moving this forward shows that this body is truly moving things forward in the State of Hawaii. So thank you, and thank you Members."
