## Friday, April 18, 2008

The House of Representatives of the Twenty-Fourth Legislature of the State of Hawaii, Regular Session of 2008, convened at 12:08 o'clock p.m., with the Speaker presiding.

Representative Har introduced the CCO Singers, Mr. Richard "Klunx" Ah Lee Sam, III, Ms. Lauren Moniz, and Ms. Jenni Panoncial, who then delivered the invocation in song. The Roll was called showing all members present with the exception of Representatives Bertram, Brower, Cabanilla, Manahan, McKelvey, Nakasone, Souki and Wakai, who were excused.

By unanimous consent, reading and approval of the Journal of the House of Representatives of the Fifty-Second Day was deferred.

Gov. Msg. No. 308, transmitting S.B. No. 1805, SD 1, without her approval and statement of objections relating to the measure as follows:

STATEMENT OF OBJECTIONS TO SENATE BILL NO. 1805

Honorable Members Twenty-Fourth Legislature State of Hawaii

Pursuant to Section 16 of Article III of the Constitution of the State of Hawaii, I am returning herewith, without my approval, Senate Bill No. 1805, entitled "A Bill for an Act Relating to Genetic Counselors."

The purpose of this bill is to require the Department of Health to establish a licensure program for genetic counselors, in order to ensure access to high quality genetic counseling services.

This bill is objectionable because the State Auditor conducted a sunrise analysis of a similar bill in 2006 and found that the licensing of genetic counselors is not necessary and does not meet the criteria for regulation under the Hawaii Regulatory Reform Act. The Auditor's analysis stated that establishing a licensing program is largely about title protection. It gives licensed individuals the ability to use the title but does not prohibit the practice by non-licensed practitioners. The Auditor considered cases of harm cited by supporters of licensing but noted, however, that the harm cited stemmed from those outside regulation. As a result, the Auditor concluded that licensing would have "no bearing on direct, commercial marketing of DNA testing and counseling, especially athome genetic self testing, which is a burgeoning industry."

There is no question that qualified genetic counselors can provide positive services to individuals with significant health issues. The argument, however, that licensing genetic counselors will protect those seeking services from incompetent or unscrupulous persons is not valid. The bill prohibits unlicensed individuals from using the title genetic counselor but it would not prohibit them from offering services. Should an individual in need of services seek additional knowledge about a counselor's qualifications, they could consult the American Board of Genetic Counseling which serves as the credentialing organization for the genetic counseling profession in the U.S. and Canada. Although well-intentioned, the licensing of genetic counselors by the State warrants more study and analysis by the Auditor as provided under Chapter 26H, Hawaii Revised Statutes. Finally, procedural flaws under Sections 15 and 16 of Article III of the State Constitution appear to have occurred in the passage of this bill.

For the foregoing reasons, I am returning Senate Bill No. 1805 without my approval.

Representative Finnegan rose in support of the measure with reservations, and asked that her written remarks be inserted in the Journal, and the Chair "so ordered."

Representative Finnegan's written remarks are as follows:

"Thank you, Mr. Speaker. I rise in support with reservations of H.C.R. 194 which requests the U.S. Navy to clear the coastline of lower Waipahu that is under its jurisdiction from invasive plant-life and excessive foliage for safety and aesthetic purposes. I am concerned with what we're asking the Navy to do. Requesting them to "clear" the area from invasive plant-life and excessive foliage may be asking them to do something they cannot do. I think we need to define "clear". I do support cleaning the area and ensuring the Navy does their part in maintaining a presentable appearance.

"Rainbow Bay is an example in my district where the Navy has done the responsible thing by trimming the mangrove and cleaning the area, making it aesthetically pleasing to look at. The Navy was restricted from completely removing the mangrove in the bay due to wildlife and eco-system concerns. Uprooting the plants would disrupt the habitat for fish and other wildlife of the bay. Before we send this type of request to Washington, we should make sure we have our ducks in a row. Thank you, Mr. Speaker."

The motion was put to vote by the Chair and carried, and the House agreed to the amendments proposed by the Senate to H.C.R. No. 194, and H.C.R. No. 194, S.D. 1, entitled: "HOUSE CONCURRENT RESOLUTION REQUESTING THE U.S. NAVY TO CLEAR THE COASTLINE OF LOWER WAIPAHU THAT IS UNDER ITS JURISDICTION FROM INVASIVE PLANT-LIFE AND EXCESSIVE FOLIAGE FOR SAFETY AND AESTHETIC PURPOSES," was Adopted, with Representatives Bertram, Brower, Cabanilla, Luke, Manahan, McKelvey, Nakasone, Souki and Wakai being excused.

Representative Meyer rose, stating:

"Mr. Speaker, I'm rising on a point of personal privilege. I noticed that four of our Members have been absent from the Chamber because they've gone a trip to the Philippines that was paid for by Hawaiian Airlines. I assume they asked you if this was ethical?"

The Chair responded, stating:

"Yes, and they did get a ruling and response from the Ethics Commission."

Representative Meyer: "I'm troubled because we have bills before us that deal with the airlines. One that would exempt fuel from the 4 percent excise, and another that would possibly give some loans. It seems that by taking these trips they're somewhat beholden to the airlines."

Speaker Say: "And you are personally aggrieved by the four individuals going on the trip?"

Representative Meyer: "Well I mean, I have read some accounting of it"

Representative B. Oshiro rose to a point of order, stating:

"Point of order. Mr. Speaker I believe the current speaker is out of order. That does not constitute a personal privilege under Masons Manual of the Legislative Procedures, section 222. It says, 'Questions affecting the rights, reputation and conduct of Members of the body in their respective capacity are questions of personal ..."

Representative Meyer: "Mr. Speaker, I am concerned about the reputation of the body."

Speaker Say: "Representative Meyer would you let ..."

Representative B. Oshiro: "May I continue? Under section 223 it says, 'Merely criticizing another Member's act in the House does not constitute a question of personal privilege.' Thank you very much."

Representative Meyer: "Mr. Speaker, I am not criticizing the action. I'm concerned about how this looks to our body, as much as I'm concerned about what it looks like for the four Members that went on the trip from the Senate.

"The airfare should be fairly expensive if they had to pay for it. One of the Senators said he would characterize it as a public/private partnership. I didn't know whether the House had agreed to pay for lodging, or for ground transportation, or if everything is on Hawaiian Airlines. I don't know. I know these things come up, but the fact that we have almost like emergency legislation that came up after Aloha Airlines had to give up their business here, Hawaiian Airlines will benefit from the bills that we're considering and that's a concern to me. And that's why I'm just bringing that up. Thank you."

Representative Waters rose to a point of order, stating:

"Point of order. Just to remind Members that the previous speaker voted against ethics reform, Senate Bill 945."

Representative Thielen rose, stating:

"Mr. Speaker, I rise personally aggrieved by that. I voted against that bill because it was a direct hit at our wonderful physician that would have been prevented..."

Speaker Say: "Representative Thielen. Representative Thielen, you are out of order."

Representative Thielen: "I will direct the remarks more to my personally being aggrieved, Mr. Speaker.

"Mr. Speaker there are a number of us in this body that voted against that measure because we looked at that bill, as amended at the last moment in the Judiciary Committee. We looked at it as an attack upon another Member. It would have prevented him from practicing his profession, which is a medical profession, and serving in the Legislature. That was the purpose of our no vote. Thank you."

Speaker Say: "Representative Meyer, for what purpose do you rise?"

Representative Meyer: "To rebut the Chair of Judiciary. I voted no on the ethics bill because it had nothing to do with this type of thing.

"One was to take care of people hiring their relatives. That didn't even do the job because it exempted anybody that's doing that now as long as that relative had been on the payroll for 12 months. And the other part of it, this \$10,000 threshold of accepting State money on a contract. I felt that was just aimed at one person. What about the people that are maybe earning \$8,000 or \$6,000 or \$5,000? We are all part-time legislators, and most of the people in this Chamber must

work at something besides being a legislator. It doesn't relate to this complaint that I have. Thank you."

Speaker Say: "Representative Meyer, if you want to file a complaint on the four Members that have gone on this particular trip, you may submit it to the Committee, the Standards of Conduct Committee. And for the Members of the House, your four Members did submit a request to me to be allowed to travel to the Philippines as part of a delegation made up of business executives, the media and our Senate counterparts."

Representative Meyer: "Well, another part of it that bothers me is this is a very busy time during the Legislative Session, and Conference Committees have already started. And in the Senate there were three Chairmen that went..."

Speaker Say: "Representative Meyer, the Chair has nothing to do with the Senate's operations."

Representative Meyer: "I realize that."

Representative Takai rose to a point of information, stating:

"Point of information, Mr. Speaker. I think you need to provide us with guidance in this Chamber, as to what constitutes a point of personal privilege. I think discussions like this need to be spelled out. I think there is a potential for abuse. I'm not saying that this is abusing it, but I just think that we need, as a body, some guidelines. Because I think we're slipping into what the other Chamber is doing regarding points of personal privilege, Mr. Speaker. Thank you."

Given that it does seem like there's a lot of stress in the Chamber, this may be a great opportunity for all of us."

Representative Thielen: "Thank you Mr. Speaker. I wanted to thank the Representative from District 18, the Niu Valley area for giving us an Earth Day printout. I think that's very helpful.

"For the Members that forgot about Natural Fiber Aloha Friday, there's an opportunity again next week. The real Earth Day is on Tuesday and I would hope that at least under a jacket, our male colleagues would be wearing natural fibers like our colleague from District 21 is doing today. He's come a long way. Thank you."
