STATEMENT OF OBJECTIONS TO SENATE BILL NO. 868

Honorable Members Twenty-Fourth Legislature State of Hawaii

Pursuant to Section 16 of Article III of the Constitution of the State of Hawaii, I am returning herewith, without my approval, Senate Bill No. 868, entitled "A Bill for an Act Relating to Boards and Commissions."

The purpose of this bill is to expressly except communications to state boards and commissions initiated by the Legislature and its committees from the requirement in section 26-35(a) (1), Hawaii Revised Statutes, that boards and commissions communicate with the Governor and the Legislature only through the head of the department to which the board or commission is administratively attached.

I believe communication between persons at all levels of the legislative and executive branches is vital to our ability to fulfill the responsibilities each of us is assigned by the Constitution and laws of the State.

It is my understanding that individual members of boards and commissions and their staffs testify regularly and respond to requests from individual members and committees of the Legislature in order to formulate state policy and enact laws to effectuate them. Boards and commissions also take official positions on bills pending before the Legislature and, when doing so, coordinate this testimony through the appropriate department and agency to which they are attached. Inasmuch as the means for the Legislature and executive branch boards and commissions to communicate with each other are already in place and, more importantly, are being used regularly, this bill is not needed.

For the foregoing reasons, I am returning Senate Bill No. 868 without my approval.

STATEMENT OF OBJECTIONS TO SENATE BILL NO. 2898

Honorable Members Twenty-Fourth Legislature State of Hawaii

Pursuant to Section 16 of Article III of the Constitution of the State of Hawaii, I am returning herewith, without my approval, Senate Bill No. 2898, entitled "A Bill for an Act Relating to the Agreement Among the States to Elect the President by National Popular Vote."

The purpose of this bill is to add a new chapter to the Hawaii Revised Statutes that will cause Hawaii to join an interstate compact or agreement among the member states to award their electoral votes to the national popular vote winner for the office of the President of the United States regardless of the popular vote winner in each member state.

Under this bill, Hawaii's four electoral votes would be awarded to the presidential slate that receives the most votes as determined by the national popular vote regardless of which candidate won the popular vote in Hawaii. Had this compact been in effect since statehood, in four elections Hawaii's electoral votes would have gone to a candidate whom the majority of voters in Hawaii did not want-Richard Nixon rather than Hubert Humphrey in 1968, Ronald Reagan rather than Jimmy Carter in 1980; George Bush rather than Michael Dukakis in 1988, and George W. Bush rather than John Kerry in 2004.

Given the potential under the interstate compact that Hawaii's electoral votes would be awarded in a manner that does not reflect the will of the majority of the voters in Hawaii, this bill would disenfranchise Hawaii's voters and is not in the best interest of the citizens of the State of Hawaii.

For the foregoing reason, I am returning Senate Bill No. 2898 without my approval.

In accordance with the Conference Committee Procedures agreed upon by the House of Representatives and the Senate, the managers on the part of the House recommended that the House agree to the amendments proposed by the Senate to H.B. No. 1978, H.D. 1, on the following showing of Ayes and Noes:

Representative Caldwell moved that H.B. No. 1978, HD 1, SD 1, pass Final Reading, seconded by Representative B. Oshiro.

Representative Thielen rose to speak in support of the measure with reservations, stating:

"Thank you, Mr. Speaker. Mr. Speaker I'm rising to speak with very serious reservations about this measure. The bill extends, for another three years, the prohibition against urinating or defecating within the boundaries of Downtown Honolulu. While no one wants that to occur, we also have to look at the responsibility of government.

"The Mayor of the City and County of Honolulu has not put up adequate restrooms in that area. People such as ourselves can walk and go into a restaurant, and if we have to use the facilities there we can do so. People that don't have that ability to go into a restaurant and pay for a meal, don't have adequate restrooms to be used. This is something that City government has not taken care of and we're continuing to criminalize a behavior while not affording the people any opportunities to have a facility to use in the Downtown area.

"I think the bill is still wrong, I think that at least we could have done a Resolution to the City to say they need to put up public restrooms in the Downtown urban core, and we didn't even do that. Thank you."

Representative Cabanilla rose to speak in support of the measure with reservations, stating:

"I'm standing in support, but I also would like to add that I share the concern of my colleague from Kailua because that's the same story with downtown Waipahu. We have two shopping centers there and there's no where you can use a public restroom. Thank you."

Representative Ward rose to speak in support of the measure with reservations, stating:

"Mr. Speaker, I rise with reservations. Mr. Speaker, Hawaii is not a Third World country; Downtown Honolulu, Waipahu or other places. We are not a Third World country. It's regrettable that we have to have a bill that says such basic hygienic and human standards have to be met

"I guess my WR is really 'with regret' that I will vote for the bill, but it seems as though having to have this on the books at this level is a little bit of a deterioration of the standard of who we think we are, and who we know we are except for some areas. And I know there are various reasons why, people with drugs and other difficulties, and with a lack of facilities have done that. But to bring to this level, to make it a formal decree through the law here in House Bill 1978, to me, is with regrets. Thank you."

Representative Belatti rose in support of the measure with reservations, and asked that the remarks of Representative Ward be entered in the Journal as her own, and the Chair "so ordered." (By reference only.)

Representative Rhoads rose to speak in support of the measure, stating:

"In support, Mr. Speaker. I think there are actually more public bathrooms in the Downtown area than the previous speakers give the area credit for. The Honolulu Police Substation is open 24 hours a day to anyone. I've asked them repeatedly, whether anyone can use the toilet, and I've been assured over and over and over again that they can. The River of Life will take anybody. They don't care what you look like. That's during the day from 9:00 in the morning, to 8:00 or 9:00 at night. There are public toilets in Aala Park. There are public toilets in all the Downtown government office buildings like our own where no one is turned away. I do agree to the extent that we need better signage for people to be pointed to the right place, and I have worked on that over the years as a member of the Downtown Neighborhood Board and also as a Member of the Legislature.

"I think those who live in the Downtown area are really sick and tired of having people *shishi* in the bus stops in front of their buildings, on the walls of their buildings, or in the staircases of the buildings. It's a problem and it is regretful that people don't have the common decency enough to do that. But before my predecessor, Representative Hiraki, passed this law in the first place, and there was really no legal impediment for anybody doing whatever they wanted, wherever they wanted. So that's why this is necessary. Mahalo."

Representative Meyer rose to speak in support of the measure with reservations, stating:

"Thank you, Mr. Speaker. I'm rising with reservations and would ask that the words of the speaker from Kailua be entered into the Journal as if they were my own. Another concern I have with this is that it makes this behavior in Honolulu a crime, but it's not a crime in Waipahu, or Kaneohe, or Kahaluu, or anywhere else. And I would wonder if this would pass Constitutional muster. Thank you."

Representative Berg rose to speak in support of the measure with reservations, stating:

"Thank you, Mr. Speaker. I rise with reservations as well, and would like to build on the comments from the Representative from Kailua. If we are able, next Session, to hold the counties more accountable to fulfilling their responsibilities relating to the Uniform Plumbing Code, I think that would deal with the problem, as opposed to the symptoms. Thank you."

Representative Brower rose to speak in support of the measure, stating:

"Mr. Speaker, in support of this landmark and visionary piece of Legislation. Sometimes there aren't bathrooms because people shouldn't be there. And even in areas where there are bathrooms, there still are problems of people relieving themselves outside of the bathrooms. So I think I see this is as a pilot project, and it is needed. Thank you."

The motion was put to vote by the Chair and carried, and the House agreed to the amendments proposed by the Senate to H.B. No. 1978, H.D. 1 and H.B. No. 1978, H.D. 1, S.D. 1, entitled: "A BILL FOR AN ACT RELATING TO PUBLIC ORDER," passed Final Reading by a vote of 49 ayes, with Representatives Nakasone and M. Oshiro being excused.

But that's my concerns, and that's why I'm in opposition."

Representative Yamane rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. I stand in strong support. And thank you to the previous speaker. I just wanted to say that during our discussions on some of the issues regarding moving forward with some of the needed harbor improvements, these issues will impact tourism and I think this is a positive step to looking forward to the future. Thank you, Mr. Speaker."

Representative Meyer rose in support of the measure with reservations, and asked that her written remarks be inserted in the Journal, and the Chair "so ordered."

Representative Meyer's written remarks are as follows:

"Mr. Speaker, I rise in support with reservations on the measure.

"Mr. Speaker, this Resolution before us is very different than the one we voted for on the Floor before it was sent to the Senate. The Resolution was originally strongly urging public and private entities to work together in good faith to complete the ongoing study entitled the "Hawaii Cruise Industry Study," intended to assess the current and potential impacts of the cruise industry on each island and the state until the year 2018.

"The amended Resolution now is requesting the Auditor to conduct an audit of the Aloha Tower Development Corporation, particularly with regard to its lawsuits relating to its development contracts, projects, and procurement practices, and the justification for its existence.

"I am concerned the Resolution before us was not given a thorough hearing on the House side. I was in support of the Cruise Industry Study, but now I have reservations on this Resolution because we were not able to openly discuss this amended Resolution with the Aloha Tower Development Corporation, the Auditor, or most importantly, the public.

"I am concerned when we amend Resolutions like we amended this Resolution without a proper hearing. It sets a bad precedent and we will erode the trust of the public. Mahalo."

The motion was put to vote by the Chair and carried, and the House agreed to the amendments proposed by the Senate to H.C.R. No. 245, HD 1, and H.C.R. No. 245, HD 1, S.D. 1, entitled: "HOUSE CONCURRENT RESOLUTION REQUESTING THE AUDITOR TO CONDUCT AN AUDIT OF THE ALOHA TOWER DEVELOPMENT CORPORATION, PARTICULARLY WITH LAWSUITS REGARD TO ITS RELATING DEVELOPMENT CONTRACTS. PROJECTS. AND PROCUREMENT PRACTICES, AND THE JUSTIFICATION FOR ITS EXISTENCE," was Adopted, with Representative Nakasone being excused.
