Wednesday, January 28, 2009

The House of Representatives of the Twenty-Fifth Legislature of the State of Hawaii, Regular Session of 2009, convened at 12:03 o'clock p.m., with Vice Speaker Magaoy presiding.

The invocation was delivered by Ms. Margaret Logotaeao, of Representative Bertram's office, after which the Roll was called showing all Members present with the exception of Representatives Berg, Say and Takumi, who were excused.

By unanimous consent, reading and approval of the Journal of the House of Representatives of the Fourth Day was deferred.

GOVERNOR'S MESSAGES

The following messages from the Governor (Gov. Msg. Nos. 217 through 219) were received and announced by the Clerk and were placed on file:

Gov. Msg. No. 217, dated January 26, 2009, transmitting the Report to the Twenty-Fifth Legislature, State of Hawaii, 2009, Pursuant to Section 326-25.5, Hawaii Revised Statutes, Requiring the Department of Health to Submit an Annual Report to the Legislature on Initiatives and Improvements in Kalaupapa Settlement and to Track Patient and Non-patient Costs Separately, Whenever Appropriate and Possible.

SENATE COMMUNICATION

The following communication from the Senate (Sen. Com. No. 4) was received and announced by the Clerk:

Sen. Com. No. 4, transmitting S.C.R. No. 2, entitled: "SENATE CONCURRENT RESOLUTION AWARDING THE HAWAII MEDAL OF HONOR TO UNITED STATES MILITARY SERVICE MEMBERS WITH HAWAII CONNECTIONS KILLED IN ACTION WHILE SERVING IN DANGEROUS, VOLATILE, AND UNSTABLE AREAS OF THE WORLD, INCLUDING IRAQ AND AFGHANISTAN," which was adopted by the Senate on January 26, 2009.

Representative B. Oshiro moved that S.C.R. No. 2 be adopted, seconded by Representative Evans.

Representative Takai rose to speak in support of the measure, stating:

"Mr. Speaker, I rise to speak in strong support of Senate Concurrent Resolution No. 2. It has been almost six years since the War on Terrorism began. While there continues to be much debate for and against this war, there is no debate about the tremendous sacrifices made by our service members and their families.

"Between March 29, 2003 and January 15 of this year, we in Hawaii have lost a total of 240 servicemembers, who have all sacrificed their lives while in the line of duty. This past year, we lost a total of 23 servicemembers. To pay a special tribute to these heroes and to their families, we passed House Bill No. 8 in 2005, which became Act 21. This Act created the Hawaii Medal of Honor.

"This special medal is awarded on behalf of all of us in the State of Hawaii to an individual who has been killed in action while serving our country as part of Operation Iraqi Freedom or Operation Enduring Freedom. Recipients of the Hawaii Medal of Honor include the members of the United States Armed Forces, the United States Military Reserves and the Hawaii National Guard, who are residents of the State of Hawaii, attended an educational institution in Hawaii, or were stationed in Hawaii by order of the United States Department of Defense.

"The Hawaii Medal of Honor will be awarded according to this Senate Concurrent Resolution to family representatives of these fine men and women at a ceremony held during a joint Legislative Session on Tuesday, March 31, 2009 at 2 p.m. this year in the Senate Chambers. Families from towns like Brockport, New York, and Jacksonville, Florida, to as far as Saipan, American Samoa, and the Marshall Islands will be invited to attend this ceremony.

"In the past six years, the War Against Terrorism has changed our world and our lives in a profound way. And ultimately Mr. Speaker, it's not about the politics, it's not even about the money, and it's not even about winning. I believe it's all about the families and their loved ones and what these brave men and women have given and sacrificed to our country. Thank you, Mr. Speaker."

Representative Pine rose to speak in support of the measure, stating:

"I also would like to speak in strong support. As a new military family through marriage, I can tell you that it's very rough for military families. And I just really want to thank the previous Representative for bestowing a great legacy of honor on this Chamber. It really means a lot to the families. And the sacrifices that the families make to serve their country is just as great. So thank you so much."

Representative Ward rose to speak in support of the measure, stating:

"Mr. Speaker, I also rise in strong support. As with the previous two speakers, either by service or by family who are veterans, I feel compelled as a Vietnam veteran to stand up in strong support.

"I feel, Mr. Speaker this measure is probably one of the most honorable things that will pass this desk on this Floor. And I think it's a good foreboding of what this Session will be like. I see it as the equivalent for honor to veterans as what the GI Bill was for education for veterans. It is simply a good, good measure. Thank you, Mr. Speaker."

The motion was put to vote by the Chair and carried, and S.C.R. No. 2 was adopted with Representatives Berg, Say and Takumi being excused.
