Representative Ching rose to speak in support of both measures, stating:

"Mr. Speaker, in support of Stand. Com. Reports 1583 and 1584. Mr. Speaker, the Falls of Clyde is one of the few remaining man-built jewels of old Hawaii. She was launched in 1878 from Scotland, named after an actual waterfall in the river that runs from Glasgow, Scotland, where she was built. The ship serves as a reminder of all the great contributions the Scots have made in Hawaii since their arrival in the 1700s. The beautiful Princess Kaiulani was the *hapa haole* daughter of Scot, Mr. Archibald Cleghorn and Princess Likelike, and Kapiolani Park's ironwood trees in Ainahau are symbols of that devotion of Mr. Cleghorn for his daughter, Princess Kaiulani.

"In 1900, an act of Congress allowed the ship to fly both the U.S. and the Hawaiian flags, and the Falls of Clyde serviced the residents of Hawaii by carrying sugar from Hilo to San Francisco.

"In 1963, it was rescued and returned to Hawaii, with the help of *Honolulu Advertiser's* columnist Bob Krauss, the maritime community, Hawaii's school children, and the U.S. Navy. Over the years, tens of thousands of people have toured the Falls of Clyde. She was named a National Historic Monument.

"In 2008, the Friends of the Falls of Clyde formed a non-profit to save her. The Falls of Clyde, with a wrought-iron hull at 265 feet long, weighing more than a thousand tons, is the last, the only surviving, fullyrigged, four-mast sailing ship remaining in the world. And, this has taken interest from a lot of people, including the royalty of Great Britain.

"The Falls of Clyde has a rich history. I ask that my colleagues recognize its importance as a sailing jewel of Hawaii. Thank you."

Representative McKelvey rose to speak in support of both measures, stating:

"Mr. Speaker, I stand in strong support."

The motion was put to vote by the Chair and carried, and the reports of the Committee were adopted and H.R. "Thank you, Mr. Speaker. I rise to speak in opposition to this bill. This bill started as, 'if somebody enters your home, and you feel threatened, you can kill them, dead.' But, it has expanded to, 'if you feel threatened anywhere, you can kill them, dead.'

"It's problematic, and because of that, even the law enforcement community, the police and the prosecutor came out in opposition. They don't want people going around shooting people who you feel would be a threat to you, even if they're not threatening you with deadly force. So, it's almost matching deadly force against what you think is dangerous.

"In fact, if you want to expand it, you can actually kill somebody dead, drag them onto your property, and say, 'Oh, the person was threatening me, and so I killed them dead.'

"So, because of those reasons, I rise to speak in opposition. Thank you."

Representative Morita rose in opposition to the measure and asked that the remarks of Representative Luke be entered into the Journal as her own, and the Chair "so ordered." (By reference only.)

Representative Hanohano rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

Representative Berg rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

Representative Belatti rose to speak in opposition to the measure, stating:

"Thank you, Mr. Speaker. I rise in opposition. Thank you. The effect of this bill is to essentially eliminate the duty to retreat. If that's the case, then we should just remove all of Section B. I'd also like to echo the words of the Representative from Pauoa, and register a strong opposition. Thank you."

The motion was put to vote by the Chair and carried, and report of the Committee was adopted and S.B. No. 350, SD 1, HD 1, entitled: "A BILL FOR AN ACT RELATING TO USE OF FORCE," passed Second Reading, and was placed on the calendar for Third Reading with Representatives Belatti, Berg, Hanohano, Luke and Morita voting no, and with Representatives Souki and Takai being excused.
