The House of Representatives of the Twenty-Fifth Legislature of the State of Hawaii, Regular Session of 2010, convened at 12:09 o'clock p.m., with Vice Speaker Magaoy presiding.

The invocation was delivered by Reverend John Heidel, Ph.D., of Interfaith Alliance Hawaii, after which the Roll was called showing all Members present with the exception of Representatives Cabanilla, Finnegan, Manahan and M. Oshiro, who were excused.

On motion by Representative Evans, seconded by Representative Pine and carried, reading of the Journal was dispensed with and the Journal of the Twenty-First Day was approved. (Representatives Cabanilla, Finnegan, Manahan and M. Oshiro were excused.)

STANDING COMMITTEE REPORTS

Representative Morita, for the Committee on Energy & Environmental Protection presented a report (Stand. Com. Rep. No. 812-10) recommending that S.B. No. 2709, SD 1, HD 1, as amended in HD 2, be referred to the Committee on Finance.

On motion by Representative B. Oshiro, seconded by Representative Evans and carried, the report of the Committee was adopted and S.B. No. 2709, SD 1, HD 2, entitled: "A BILL FOR AN ACT RELATING TO ENVIRONMENTALLY SENSITIVE PRODUCTS," was referred to the Committee on Finance, with Representatives Cabanilla, Finnegan, Manahan and M. Oshiro being excused.

Representatives Morita and McKelvey, for the Committee on Energy & Environmental Protection and the Committee on Economic Revitalization, Business, & Military Affairs presented a report (Stand. Com. Rep. No.

813-10) recommending that S.B. No. 2559, SD 2, as amended in HD 1, pass Second Reading and be referred to the Committee on Finance.

Representative B. Oshiro moved that the report of the Committees be adopted, and that S.B. No. 2559, SD 2, HD 1, pass Second Reading and be referred to the Committee on Finance, seconded by Representative Evans.

Representative Ward rose to speak in support of the measure with reservations, stating:

"Mr. Speaker, I rise with reservations. Two things about this bill, Mr. Speaker. One is that it's a good BYOB bill. Bring your own bag. Recycle, and keep the plastic out of the environment and the marine life.

"But the downside and the second thing is that it increases the cost of living for the poor. Those who spend the most on food are those who don't have the money. And this is going to increase the cost of living, however small you may think it is.

"When we add up what this Body has done on this Floor and what the Senate is doing, if you add all those small things up, it's equivalent to what used to be called, 'the last straw on the camel's back.' We are pushing our poor too much, and this pushes it for the sake of the environment which is a great cause, and which we've got to do. But it's the timing now that's the basic question. Is now the time to do this? Thank you, Mr. Speaker."

Representative Souki rose to speak in support of the measure with reservations, stating:

"Yes Mr. Speaker, and Members of the House. I wish to speak with strong reservations on this measure. The only reason that I'm not voting no on this measure is because it's not going to ban plastic bags, so that's a positive aspect of it.

"The rest of it doesn't quite seem logical or make any sense. The bag is plastic and yes, we have a lot of plastic out there. But if you go to the supermarket, a great number of other items are also in plastic and they create an even bigger problem than plastic bags. You go into the meat section and there's plastic. You go into the *pupu* and fish area, it's all plastic. You look at nachos, and potato chips, and etc. It's all plastic.

"When you combine them all, it really doesn't seem sensible at all. You're going to have a person pay a nickel more for a plastic bag when you have all the other plastic items remaining in the store. So I would want the Finance Committee, in their wisdom, to look at some of these items. Thank you, very much."

Representative Tokioka rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Marumoto rose to speak in support of the measure with reservations, stating:

"Mr. Speaker, I likewise have reservations and I couldn't agree more with the two speakers who already expressed their reservations. I would like to bring up an additional point in that this targets only supermarkets and not other retail establishments. Thank you."

Representative Shimabukuro rose to speak in support of the measure, stating:

"In very strong support, and just a brief rebuttal to the earlier comments in terms of cost. The whole point of the bill, or one of the big points is to have people avoid the cost by encouraging them to bring their own bags and their own containers which I think is a brilliant idea.

"Just on a personal note. So many times I find myself going home with all these bags thinking that I could have avoided this if I just brought my own bag. So I think it's just a win-win. We encourage people to bring their own bag. They don't pay the fee. We raise much needed State revenue in this time of fiscal crisis. And we avoid more trash going to the landfill, which is a huge issue for people on the Waianae Coast, and it should be for everyone in this State. Thank you."

Representative Pine rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Yamane rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

on Finance, with Representatives Cabanilla, Finnegan, Manahan and M. Oshiro being excused.

Representative Yamane, for the Committee on Health presented a report (Stand. Com. Rep. No. 819-10) recommending that S.B. No. 2267, SD 2, pass Second Reading and be referred to the Committee on Finance.

Representative B. Oshiro moved that the report of the Committee be adopted, and that S.B. No. 2267, SD 2, pass Second Reading and be referred to the Committee on Finance, seconded by Representative Evans.

Representative Marumoto rose to speak in opposition to the measure, stating:

"Mr. Speaker, I am in opposition to this bill. I guess the purpose is to ensure appropriate access for persons with disabilities and to assist in identifying design flaws by providing the Disability and Communication Access Board with the authority to charge a review process fee based upon the construction cost for review of construction plans prior to commencing with construction as part of the design and construction process.

"This is already required by law and the Disability and Communications Board already provides this service at no cost to people in the construction industry. But this will add considerable cost to construction. For projects of over \$10 million it will cost \$4,000, and \$1,000 for each additional \$10 million.

"So for an expensive project like West Oahu College or something of that size, they will have a lot more fees to pay before construction. The fees will be based on a graduated scale, but it is designed to cover the costs of staff. The Committee Report says a reasonable fee schedule will generate revenues sufficient to pay for the salaries of the staff conducting the review. So even though it's graduated, the fees may be changed or reduced by rule. Right now as it stands, it's extremely high and it's designed to cover the cost of this review board.

"The funniest thing I saw in the bill was that up to \$100,000, you would pay only \$200. But if you had no application, you'd still be paying \$50. I'm always joking that around here, we tax everything that moves. But I'm beginning to think this Session we're taxing everything that doesn't move too. When there's no application, we're charging \$50, so we're charging for something that doesn't even exist. I just want to point that out in this particular measure and I will be voting no."

Representative Pine rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Ching rose in support of the measure with reservations and asked that her written remarks be inserted in the Journal, and the Chair "so ordered."

Representative Ching's written remarks are as follows:

"Thank you, Mr. Speaker. I rise with reservations on S.B. 2267 SD2 – which allows the Disability and Communication Access Board to charge a fee to defray expenses of review of construction plans to ensure compliance with the law.

"While I support the mission and goals of DCAB, we must keep in mind the concerns of the building industry, as this measure directly impacts the economy. As stated by the Office of Housing and Community Development, "the requirement will result in increased costs to developers, which will be passed on to the homeowners, increasing the cost of housing, regardless of income level. [Instead] the Legislature should instead provide incentives, such as a reduction in fees and expedited review, to developers who encourage greater accessibility for people with disabilities in their developments." Thank you."

Representative M. Lee rose to speak in support of the measure, stating:

"I am in strong support."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and S.B. No. 2267, SD 2, entitled: "A BILL FOR AN ACT RELATING TO BUILDING DESIGN FOR PERSONS WITH DISABILITIES," passed Second Reading and was referred to the Committee on Finance, with Representative Marumoto voting no, and with Representatives Cabanilla, Finnegan, Manahan and M. Oshiro being excused.

Representative Yamane, for the Committee on Health presented a report (Stand. Com. Rep. No. 820-10) recommending that S.B. No. 2490, SD 2, as amended in HD 1, pass Second Reading and be referred to the Committee on Finance.

On motion by Representative B. Oshiro, seconded by Representative Evans and carried, the report of the Committee was adopted and S.B.
