The House of Representatives of the Twenty-Sixth Legislature of the State of Hawaii, Regular Session of 2012, convened at 12:06 o'clock p.m., with Speaker Say presiding.

The invocation was delivered by Representative Marcus R. Oshiro, after which the Roll was called showing all Members present with the exception of Representatives Coffman, Herkes, Kawakami, Riviere and Thielen, who were excused.

By unanimous consent, reading and approval of the Journal of the House of Representatives of the Thirty-Fifth Day was deferred.

Representative McKelvey, for the Committee on Economic Revitalization & Business presented a report (Stand. Com. Rep. No. 1149-12) recommending that S.B. No. 2780, SD 1, as amended in HD 1, pass Second Reading and be referred to the Committee on Finance.

On motion by Representative Chong, seconded by Representative Evans and carried, the report of the Committee was adopted and S.B. No. 2780, SD 1, HD 1, entitled: "A BILL FOR AN ACT RELATING TO THE DEPARTMENT OF ACCOUNTING AND GENERAL SERVICES," passed Second Reading and was referred to the Committee on Finance, with Representatives Cabanilla, Herkes, C. Lee, Luke, Marumoto, Saiki and Thielen being excused.

Representative Tsuji, for the Committee on Agriculture presented a report (Stand. Com. Rep. No. 1150-12) recommending that S.B. No. 2354, SD 1, as amended in HD 1, pass Second Reading and be referred to the Committee on Judiciary.

On motion by Representative Chong, seconded by Representative Evans and carried, the report of the Committee was adopted and S.B. No. 2354, SD 1, HD 1, entitled: "A BILL FOR AN ACT RELATING TO AGRICULTURAL COMMODITIES," passed Second Reading and was referred to the Committee on Judiciary, with Representatives Cabanilla, Herkes, C. Lee, Luke, Marumoto, Saiki and Thielen being excused.

Representative Keith-Agaran, for the Committee on Judiciary presented a report (Stand. Com. Rep. No. 1151-12) recommending that S.B. No. 2859, SD 1, as amended in HD 1, pass Second Reading and be referred to the Committee on Finance.

On motion by Representative Chong, seconded by Representative Evans and carried, the report of the Committee was adopted and S.B. No. 2859, SD 1, HD 1, entitled: "A BILL FOR AN ACT RELATING TO OPEN

GOVERNMENT," passed Second Reading and was referred to the Committee on Finance, with Representatives Cabanilla, Herkes, C. Lee, Luke, Marumoto, Saiki and Thielen being excused.

Representative Chang, for the Committee on Water, Land, & Ocean Resources presented a report (Stand. Com. Rep. No. 1152-12) recommending that S.B. No. 2742, SD 1, as amended in HD 1, pass Second Reading and be referred to the Committee on Finance.

On motion by Representative Chong, seconded by Representative Evans and carried, the report of the Committee was adopted and S.B. No. 2742, SD 1, HD 1, entitled: "A BILL FOR AN ACT RELATING TO THE HAWAII COMMUNITY DEVELOPMENT AUTHORITY," passed Second Reading and was referred to the Committee on Finance, with Representatives Cabanilla, Herkes, C. Lee, Luke, Marumoto, Saiki and Thielen being excused.

Representative Takai rose to disclose a potential conflict of interest, stating:

"Thank you Mr. Speaker. I realize I missed the vote on the first measure, but I wanted to, just for the record, to request as I've always done, a ruling on a potential conflict on Stand. Com. 1148, and just note that in the past I've been allowed to vote on this," and the Chair ruled, "no conflict."

Representative McKelvey rose, stating:

"Yes, Mr. Speaker, just a correction. On Number 6, Reports of Standing Committees, it shows Stand. Com. Rep. 1148-12 reporting from Finance, and referred to Finance. But it should be reported from ERB, to Finance, because I don't think Finance heard it twice."

Representative Awana, for the Committee on International Affairs, requested a waiver of the 48-hour advanced notice requirement for the purpose of hearing the following measures with decision making to follow:

H.R. No. 38; and H.C.R. No. 59.

"These measures urge the United Nations to grant Taiwan participation as an observer in the United Nations' Framework Convention on Climate Change Conference of the Parties Meeting. The reason for this waiver request, is to allow for greater participation for committee members and the public. Thank you, Mr. Speaker," and the Chair "so ordered."

Representative Cabanilla: "Thank you, Mr. Speaker. I just would like to announce, the combined Committees of Housing and Hawaiian Affairs will be reconvening for decision making on Senate Bill 3025, SD 2, in Room 325 this afternoon after the completion of the hearings of the Committees of Judiciary and CPC."
