"Mr. Speaker, on Stand. Com. 48, I rise with reservations. Mr. Speaker, as a former graduate teaching assistant at the University of Hawaii, it's very important that that position be maintained. And I cannot recall that my colleagues were dissatisfied with the pay. Maybe the work was a bit heavy, but in terms of getting organized I'm afraid that there may be a rippling effect.

"As you know, our office managers, at one point, were put in a bill similar to this, and then from office manager staff, suddenly collective bargaining became basically the tail wagging the dog in the Legislature.

"So, with this, Mr. Speaker, I do have reservations and I don't believe it would increase the academic wellbeing, nor the economic standing of

those graduate students. They have a vow of poverty to begin with, and being organized is not going to change that. Thank you."

Representative Fale rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Hanohano rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

These are backdoor ways to take money out of the working class people. And it's only a buck here, but it's a buck here, a buck there. In the last two days I've seen 3 one-dollar increases in various fees just in my Committee alone. So, we need to be mindful and figure out how to accomplish what we're trying to do through prioritization within the budgetary framework. Thank you, Sir."

But again, it's another fee increase and by the time we get done with session, registration might be up another \$5, \$6, maybe \$10. Those are the working people who have to pay for that. Thank you."

Representative Ward rose to speak in support of the measure with reservations, stating:

"Mr. Speaker, I have similar reservations in that my district is still recovering from sticker shock when we doubled it just a couple of years ago. So, with reservations, I think we have to tread very lightly on these increases."

Representative Fukumoto rose to speak in support of the measure with reservations, stating:

"Mr. Speaker, just reservations on this and just noting that I support the intent but I think my community is also very frustrated with the increases already. Thank you."

Representative Fale rose to speak in support of the measure with reservations, stating:

"Mr. Speaker, I raise the same concerns and if I may adopt the words of Representative Ward as my own," and the Chair "so ordered." (By reference only.)

Representative Hanohano rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 892, HD 1, entitled: "A BILL FOR AN ACT RELATING TO FUNDING FOR PARKING FOR DISABLED PERSONS," passed Second Reading and was referred to the Committee on Health, with Representative McDermott voting no, and with Representatives Carroll, Har, Oshiro and Takumi being excused.

Representative Johanson rose to speak in opposition to the measure, stating:

"Thank you, Mr. Speaker, in opposition with brief comments. I am actually not categorically averse to an increase in the minimum wage. And I think that's definitely something the Body should continue to consider to alleviate what is already our high cost of living on all of our constituents.

"What I do oppose in this measure, and I think is the most problematic section of this measure, is that it would cede legislative prerogative in the future to control or regulate minimum wage, because it ties automatically to increases based on the consumer price index, which would be determined annually by DLIR instead of this Body.

"So, because it reduces our prerogative legislatively, as well as exposes us, I believe, to an inability to control costs and plan for the increases that may end up resulting, I do have significant concerns with this measure. Thank you."

Representative Fukumoto rose in opposition to the measure and asked that the remarks of Representative Johanson be entered into the Journal as her own, and the Chair "so ordered." (By reference only.)

Representative Cheape rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

Representative Cabanilla rose to speak in support of the measure, stating:

"Mr. Speaker, as the leader of the Filipino Caucus, I want to be on record to say that I support all measures to increase the minimum wage. Thank you."

Representative Ward rose to speak in support of the measure with reservations, stating:

"Mr. Speaker, I do have reservations. We do need to increase, but we don't need a lock, if you will, on increasing it without any of our control. And if it gets out of hand, we're going to be responsible. I think we really have to look at locking that to the CPI. Thank you."

Representative McDermott rose to speak in opposition to the measure, stating:

"Mr. Speaker, I rise in opposition to this. Mr. Speaker, I would like to have the comments of the Minority Leader inserted as my own, but he's so articulate, no one would believe I ever said that. So, I have to make a few remarks. I've already asked Chamber of Commerce to come back with what are the entry-level positions paying out in the community right now for Burger King, Jack In The Box, McDonald's, and so on and so forth. These are folks in the private sector who generally set the minimum wage.

"We had this discussion 20 years ago and I found at that time that the minimum wage was below what they were offering to attract people. My sense is it's probably the same, it is an entry level wage, a training wage, so we need to address that. Also, the government does pay minimum wage for certain jobs and it's probably due for an adjustment.

"So, I support an increase in it, but it's just at what level. And the Representative from Hawaii Kai raised some concerns about the automatic CPI indexing, so at this time I'll vote no. Thank you."

Representative Hanohano rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Fale rose to speak in opposition to the measure, stating:

"Mr. Speaker, I would like to have the words of Representative Johanson inserted as my own, as well as to make these additional comments.

"I believe that this small increase in the minimum wage is putting a band-aid on a bigger problem and that we are not addressing the underlying, overarching issues that are challenging our economy. I don't want to throw out a few drops of water to my community that's dying of thirst out there, to just band-aid the issue to carry it over. My concern with this bill is that it's a band-aid on a wound that needs much more to be done to heal it. Thank you, Mr. Speaker."

Representative Yamashita rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Thielen rose to speak in support of the measure with reservations, stating:

"Thank you, reservations please. I am concerned about the tie-in to the CPI."

Representative McKelvey rose to speak in support of the measure with reservations, stating:

"Thank you very much, Mr. Speaker. With reservations. I just don't like the tie-in to the CPI, that's all. I support the underlying measure, though."

Representative Kawakami rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Lee rose to speak in support of the measure, stating:

"Thank you, in support. I'd just like to note that it's a great way to tie it to the CPI, because it's basically taking advantage of the free market and putting our faith therein. Thank you."

Representative Tokioka rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Evans rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Johanson rose to respond, stating:

"Yes, in rebuttal, and just for the Member's edification. Tying it to the consumer price index would be a market-based approach if the minimum wage were allowed to go down if consumer prices fell. But it does not do this. This bill only allows for automatic increases based in increases in the CPI, in case anyone was concerned."

Representative Rhoads rose to speak in support of the measure, stating:

"Mr. Speaker, in support. From my recollection, the CPI has only gone down twice in the last 15 years and once was by one-tenth of 1 percent and that was in '08 I believe, and then in '98 it was about the same. A healthy economy almost always inflates a little bit. And if for some reason the CPI adjuster gets out of control, it's not like this Body can't come back and say, 'Okay, we're going to reduce the minimum wage.'

"But as long as there is inflation, the minimum wage goes down by that percentage every year, which it has done since it went up the last time, which I believe was in '07. So, the minimum wage is worth significantly less than it was 6 or 7 years ago. Thanks."

Representative Ward rose to respond, stating:

"Mr. Speaker, just a brief rebuttal to how the market, which regulates why the wage now at Burger King and other places is above the minimum wage, is because of supply and demand. What we have and what we can get for what price. The market is much more trustworthy than CPI. The CPI is basically a formula of the government and it's a mechanical thing which can get many governments in trouble.

"I think the market entrusting that mechanism of supply and demand. And by the way, there's only 1.7 percent of our labor force of 600,000 people, 1.7 percent are in the minimum wage. So we're not talking about a huge amount of people. We're talking about a small amount, which many of us started out with minimum wage. But that was the training wage. That was to incentivize us to get up into the medium and then the top. And as Legislators, big salaries, accompanied by a vow of poverty that we have working here.

"The point is, Mr. Speaker, it's not the amount, it's where these wages accelerate people to become later in their life. And it's 1.7 percent of the people, and we need to watch over them but we don't need to lock in for the CPI. Thank you."
