## Thursday, March 28, 2013

The House of Representatives of the Twenty-Seventh Legislature of the State of Hawaii, Regular Session of 2013, convened at 12:10 o'clock p.m., with Vice Speaker Mizuno presiding.

The invocation was delivered by Speaker Emeritus Calvin K.Y. Say, after which the Roll was called showing all Members present with the exception of Representative Cabanilla, who was excused.

By unanimous consent, reading and approval of the Journal of the House of Representatives of the Thirty-Ninth Day was deferred.

## GOVERNOR'S MESSAGES

The following messages from the Governor (Gov. Msg. Nos. 249 through 255) were received and announced by the Clerk and were placed on file:

Gov. Msg. No. 249, dated March 22, 2013, transmitting proposed changes to the FB 2013-15 Biennium Budget for the Department of Accounting and General Services (DAGS).

- Adds 15 positions and \$665,000 in general funds for FY 14 and FY 15 for the Office of Information Management and Technology (OIMT) for administrative support required to implement the Enterprise Resource Planning (ERP) projects statewide.
- Reduces 13 vacant positions and \$665,000 in general funds for FY 14 and FY 15 to fund the newly created positions in OIMT.
- Adds \$197,500 in general funds for FY 14 to restore the six-month delay in hiring imposed on new positions on the OIMT staff.
- 4. Adds \$25,000,000 in interdepartmental transfer funds for FY 14 and FY 15 for OIMT.
- Adds \$100,000 in special funds for FY 14 and FY 15 to the Shared Services Technology Special Fund for salary restoration of the current staff.

Gov. Msg. No. 250, dated March 22, 2013, transmitting proposed changes to the FB 2013-15 Biennium Budget for the Department of Budget and Finance (B&F).

- 1. Adds \$25,000,000 in general funds for FY 14 to fund shortfalls in federal non-competitive grant amounts that are reduced in Federal Fiscal Year 2013 as the result of sequestration.
- 2. Adds a proviso to limit the use of the funds to address shortfalls in federal funding for non-competitive funds in Federal Fiscal Year 2013 by allowing B&F to transfer up to a total of \$25,000,000 to the affected department(s) and providing that the Legislature be notified of each transfer to the affected department(s) within ten days of the transfer.

# INTRODUCTION OF RESOLUTIONS (FLOOR PRESENTATIONS)

HONOLULU – Led by five awards from Waianae High School, public schools captured 16 of 17 awards won by Hawaii schools this month at the 10<sup>th</sup> Annual Student Television Network (STN) Convention in Los Angeles, Calif.
