Dear Governor Abercrombie:

Hawaii Government Employees Association - Unit 13 voted on April 30, 2013 to not ratify a proposed tentative agreement. The Administration provided, via Governor's Message 272, the estimated costs to fund increased salaries associated for the proposed tentative agreement. Included in the Governor's Message was funding for those employees who are considered exempt and excluded and not affiliated as unionized employees of the State of Hawaii.

For administrative purposes, salary increases and fringe benefits have previously been mirrored to those provided to Hawaii Government Employees Association - Unit 13 through finalized agreements. However, we recognize the Executive and Judiciary Branch authority to set salary increases for those employees who are exempt and excluded and not affiliated on a collectively bargained salary schedule.

In light of Unit 13 not ratifying a contract prior to the conclusion of the 2013 Legislature, in sending this bill to the Governor, we recommend that line-item veto power be exercised with respect to any funding attributable to Hawaii Government Employees Association - Unit 13 included employee costs, but allow for funding for those employees who are exempt and excluded and not affiliated on a collective bargained salary schedule at the Governor's prerogative.

Representative Oshiro rose to speak in support of the measure, stating:

"Mr. Speaker, I rise in support of this measure. Like the Finance Chair, I do concur with this decision. This is basically to correct the inadvertent error in the allocation of revenues or funds into the respective department or departments for certain pay adjustments to the excluded Unit 13 employees. This will allow them to receive the same pay increases as, I think, Bargain Units 2, 3 and 4, which were ratified by the respective HGEA units over the past week or so. I think 4% over two years.

"It is my understanding that the Governor does intend to send down the respective communication to this House informing us of his intention to line-item veto the other component. As we all know, Unit 13 did meet, pursuant to the organizational requirements of the collective bargaining statute, and as a group of covered employees, rejected the proposal and the amount of monies contained within this bill.

"So just to buttress the remarks of the Finance Chair and to make sure the record is clear, it is not the intent of this Legislature to appropriate any sums of money to that particular biennium contract, but instead it's merely done to accommodate an inadvertent error in our budgeting process, whereby we would not have provided sufficient funds to those excluded members whose pay are tied to Unit 13. Thank you, Mr. Speaker."

Mr. Speaker, this resolution, requesting the Governor to establish a working group to develop a conservation action plan to explore and identify conservation alternatives for the undeveloped portions of the Turtle Bay Resort property and surrounding lands with conservation or historic value, rose, Mr. Speaker, out of a bill that originally requested \$100 million to purchase this land that's mentioned here.

"Mr. Speaker, today the Kahuku schools were on lockdown because of a bomb scare that happened earlier this morning. There are issues that are directly related to the education system, to the schools that we have in my community, Mr. Speaker, that have a much higher priority than this measure and the origins of this measure right here.

"I continue to rise and state my reservations in regards to this, Mr. Speaker, because I can't emphasize enough the issues of poverty that afflict my community, how it shortens lives, how it causes unnecessary pain and suffering in my community, and to request that we look into the possibility of diverting tens of millions of dollars away from what I believe should be the priority in my community in addressing the almost 80% in a number of schools in my community of children in poverty whose families can't even afford the meals which they eat, Mr. Speaker.

"This is an issue that I think is overlooked too often. When we have special interest groups who have significant amounts of funding, who come in everyday to come and lobby for a particular effort, Mr. Speaker. The poor kids in my neighborhood whose parents barely make it by from day to day, they don't have some fancy lobbyist to come in and talk to the legislators here and give the concerns that are afflicting them and their families, Mr. Speaker.

"So my concern with this measure is that this has the potential of moving in the direction of diverting tens of millions of dollars of taxpayer money which we collect from people, including the widow that lives next door to me, and taking that to purchase this land, Mr. Speaker, which I think could very well be a good cause, but it needs to be put in its appropriate position on the priority list of the concerns that come out of my community. Those kids in poverty, and our senior citizens who are living on fixed incomes, in a time and place where the cost of living continues to rise with no foreseeable decrease in the near future, Mr. Speaker.

So I would like to have my strong reservations noted, Mr. Speaker, in regards to this measure, and I hope that with the limited resources and the economic situation which we find very challenging at this time, that we focus those resources where they would do the most good for those who are most in need, Mr. Speaker."

Representative Fukumoto rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

"But, Mr. Speaker, you know the military also, years ago, was not paying their fair share with the educational impact aid. With actions like in this reso, the federal delegation brought it to their mind, and now I think military aid is pretty much up to speed. So this is an important part of keeping our brothers and sisters alive, well and educated, but also not at the point where it sacrifices the people of Hawaii, their kids, their students and their medical facilities. Thank you, Mr. Speaker."

They had been forced to live in unbearable conditions for years because excessive feeding of birds by two neighbors created a flock of several hundred pigeons and other birds, resulting in constantly noxious odors, unsanitary conditions caused by feathers and excrement, and property damage to their houses and vehicles. They tried, without success, to resolve their problem through the courts and mediation, and so this measure is the result of their pleas to the Legislature to provide relief.

"Florence, Grace and several other neighbors devoted many hours to engaging in the legislative process to inform us of the need to approve HB619. I would like to acknowledge the assistance of Pearl City Senator David Ige, our House Judiciary Chair, and our colleagues in responding positively to their testimony. Our passage of HB619 will validate these citizens' trust in our legislative process to meet their urgent problems.

"Mr. Speaker, this measure is not so much an 'anti-pigeon' measure as it is a 'pro-people' one. It is a big step forward in ensuring that our citizens can enjoy their lives in peace, safety and clean conditions. I ask my colleagues to join me in supporting the passage of HB619. *Mahalo*."

The motion was put to vote by the Chair and carried, and H.B. No. 619, HD 1, SD 1, entitled: "A BILL FOR AN ACT RELATING TO FERAL BIRDS," passed Final Reading by a vote of 50 ayes, with Representative Takumi being excused.

#### ANNOUNCEMENTS

Representative Takai: "Thank you, Mr. Speaker, and thanks for this opportunity. On March 27th we had a very unique and special ceremony in the Senate Chambers where we recognized 19 fallen service members. It has been over 10 years since the war began on March 20th, 2003, and since then we in Hawaii have lost 320 service members.

"In fact, Mr. Speaker, many other states have followed our lead, and we recently received word that the State of Montana is very close to establishing their very own Montana award for valorous service. This makes Montana the 4th state to convey such honor. The State of Alaska has the Alaska Declaration of Honor, the State of New Hampshire has the New Hampshire Medal of Honor.

"So, Mr. Speaker, I wanted to thank you for giving me the opportunity to once again coordinate this year's Hawaii Medal of Honor ceremony, as well as the preparations prior. But it took many, many people, and I'd like to at this time acknowledge some of them.

"Id like to first thank all of our staff here in the Senate and House. First, the House Chief Clerk Brian Takeshita and his staff. Senate Chief Clerk Carol Taniguchi and her staff. The House Sergeant-at-Arms Kevin Kuroda and his staff. Senate Sergeant-at-Arms Ben Villaflor and his staff. Joan Yamaguchi of the House Majority Staff Office and her staff.

"We also had a beautiful reception following the ceremony, and I wanted to especially thank Marlene Uesugi from Senator Espero's office for coordinating this effort. A big *mahalo* also goes to the Senate Clerk staff who coordinated the check-in table. In addition, Gail Hanneman and the Girl Scouts of Hawaii provided the gifts of Girl Scout Cookies distributed to each of the families we honored. I wanted to thank our Members who hosted these families. The pairing of legislators with families enhanced and really helped these families. Thanks to Tammy Tengan and her staff from the House Print Shop for the beautiful certificates signed by each Member of the Legislature. This certificate accompanies every single medal that is appreciated by the families who receive them.

"We did receive a lot of support and assistance from the military, and I would like to recognize Elisia Lukasik from the US Pacific Command, who helped us with the coordinating of the ceremony participants, and Leighton Siu who helped us with protocol.

"I also wanted to mention some of the people who helped throughout the year in identifying the people that we recognized. From the Army, we had Ernestine Pratt, Chief Army Casualty Affairs Officer for the 25th Infantry Division, and from the Marines we had Peter Swainson and Chief Warrant Officer Alfred Sprung.

"Mr. Speaker, as you and the other Members know, the medal itself is beautiful, and I wanted to once again acknowledge Sergeant First Class Aaron Pollick from the Hawaii National Guard who came up with the initial design, which has come to symbolize much more than the medal itself. With that, a lot of other people participated, namely, Point Emblems, who minted the medal. Kent Untermann and Suzette Torres from Pictures Plus, who did the assembly and framing. Rose Lee, who helped us sew the ribbons. Ty and Cindy Tamanaha from Awardline, who helped us with the personalized plaques.

"I would also like to acknowledge those who helped us enrich the experiences for the families who travelled here to attend the ceremony. We worked very closely with the Pearl Harbor Historic Sites, the USS Bowfin Submarine Museum and Park, the Battleship Missouri Memorial, the Pacific Aviation Museum Pearl Harbor and the World War II Valor in the

Pacific National Monument. They came through with support for our families. The Halekoa Hotel, the Polynesian Cultural Center and Morris Visitor Publication came through as well, and we worked specifically with the Hawaii Lodging and Tourism Association who provided in some cases free hotel rooms, in other cases discounted hotel rates for the honorees' families. All of these organizations and entities helped us as we helped the families make this a very special visit to Hawaii.

"Many people have asked once again about the 'Olelo Broadcast, and I wanted to make mention at this time that Capitol TV once again will be graciously providing a DVD for each of our families, both present at the ceremony and those that didn't come. Also, they'll be providing a DVD to each one of us, Mr. Speaker."

"I also wanted to mention in the audience, this thing takes a lot of work, and it really takes a lot of work from the people in my office, and although she's not here, she's caring for her ill son, I wanted to mention Lisa Vargas Omo, our Office Manager. And Randy Yamamoto, Jan Kawano and Alice Kim from our office, if you could stand up and can we give them a hand.

"So, Mr. Speaker, at this time I'd like to ask you and the Members of the House to recognize everybody that I mentioned, and if we could give them a round of applause. Thank you, Mr. Speaker."

Representative Cachola: "Mr. Speaker and Members, I have some very good news and not so good news to announce. First, the good news. I attended the Speaker's party last night knowing that that date, yesterday, was our 45th wedding anniversary. You must have guessed how I got out of it and still smelling like a rose. Well, my wife called me and said, let's go to church and do the rosary and attend mass to thank all of the blessings that we have received. So I'd like to thank my wife, Mr. Speaker, and she doesn't know that I'm going to do this, and if I could request all Members to please give her a big round of applause? Thank you. Now you know why we lasted this long and still continuing.

"Now, the not so good news. I found out that Senate Bill 946, the Senate did not pass it. But you know what, I'll take it like a man. I'm always gracious of the outcome, because I know that something good will come out of it. They will see the light, that captive insurance will save us a lot of money. When we will have hard times, because the economy will not always be good, short of raising taxes, we will always look at innovative ways to save taxpayers money.

"Id like to thank all of you for participating in this debate, both the House and the Senate. I'd like to thank leadership, the Speaker, for giving me the chance by creating the special committee to address the unfunded liability. I'll assure you that I will continue looking at ways to save taxpayers money by addressing unfunded liability, and looking at innovative ways to do it. Mr. Speaker, thank you for that, and the leadership. I'd like to thank all of you. I'll be gracious of the outcome, as I said, hopefully next year will be a good year. Thank you, Mr. Speaker."

Representative Jordan: "Mr. Speaker, this might be a solemn request. At the appropriate moment may I have a moment of silence for a young man who chose to take his life. You see, Mr. Speaker, about two months ago there was an incident at my high school where one individual stabbed another individual, and this was an escalation of bullying over several years. One child decided to pick on another child, which ended up in a fight and one stabbing the other. The individual who stabbed the young man was sitting in jail awaiting his sentencing, and chose to take his life.

"See, Mr. Speaker, that's why we stand here. Those are so important for us to address. Now we lost an individual to pettiness. So at the appropriate moment, Mr. Speaker, can we have a moment of silence for Ikaika Andrade. Thank you."

At this time, the Members of the House of Representatives stood for a moment of silence in honor of the late Ikaika Andrade.

Speaker Souki then gave his closing remarks as follows:

"Alright, Members, before we conclude, I want to provide a few remarks. I've got about 20 pages, but I want to cut it down to 5, as a summary, recapitulation of what we did.

"We have come to the end of the 2013 Regular Session. To the leadership team, the Chairs, the Vice Chairs and each and every Member of the House, because of your unwavering commitment to do your best for the people of Hawaii, this was a productive session. Thank you all for working together and for doing a wonderful job. I would like to especially thank the Majority Leader Scott Saiki and the Finance Chair Sylvia Luke for your tremendous contributions and tireless efforts in moving us forward to this day.

"To our Minority Leader Aaron Johanson and the Minority Caucus, thank you for bringing your ideas and perspective to the table to help us craft legislation for all of Hawaii's people. Thank you.

"We began this session cautiously optimistic. Our economy was on the rise, tourism was strong, and unemployment was down. We needed to invest in programs and projects, and make strong investments in Hawaii's future.

"We committed to the strengthening of our number one industry by making significant investments in the future of Tourism. We made permanent the current TAT rate and increased funding to aggressively market our visitor industry as we compete with other travel destinations. We also kept the current level of support to the counties, giving them fiscal continuity. We passed a tax credit measure aimed at encouraging the presence of the film industry, which returns a significant amount of revenues to the state. Funding for capital improvements projects for state infrastructure will jumpstart economic growth on all islands.

"In education, to invest in our *keiki*, we are funding the expansion of the Open Doors Program to provide day care opportunities for preschool-aged children. To help provide funds for repair, maintenance, and additional classrooms and school facilities for our growing population, we have passed the 21st Century Schools bill to look at the responsible partnerships to generate much needed revenues for our public schools. But this will all be done with community and county input, and compliance with state and county requirements.

"Now, on the question of early education – preschool – the public will have the chance to voice their opinion through a Constitutional Amendment on whether public funds should be used by private early childhood education programs.

"In the quality of life, in this session we have reaffirmed our commitment to our *kupuna*, the homeless, a sustainable and clean environment, and local farming and feed industry. We are taking care of the needs today, and investing in our future.

"On fiscal responsibility, during the past economic crisis we had to borrow from the state's Rainy Day Fund and the Hurricane Relief Fund. We made a promise that when the economy improved, we would return that money. Well, not only are we keeping that promise, we are providing additional money to recapitalize those funds. And we have taken a big step in addressing the unfunded liability of our public workers.

"Finally, we listened to the resounding voice of the people and moved quickly to repeal the Public Land Development Corporation, known as PLDC.

"I would like to acknowledge Speaker Emeritus Say. I thank you for your years of leadership, fiscal restraint and know-how. You and your Finance Chair Marcus Oshiro laid the foundation for much of what we achieved this year.

"I would like to thank also the Senate President Donna Kim for her leadership team, the Senate Chairs and Members who worked with us and collaborated as we worked to craft legislation for the people of Hawaii. "To the permanent and session staff of the House, thank you for your professionalism and tireless efforts in supporting the work of the House.

"To the director and staff of the Legislative Reference Bureau, thank you for your important contributions to the House and the legislative process.

"Chief Clerk Brian Takeshita, Assistant Rupert Juarez and the staff of the Clerk's office, what would we do without you? Thank you. Excellent job.

"Sergeant-at-Arms Kevin Kuroda, Assistant Sergeant-at-Arms Lon Paresa and the Sergeant-at-Arms staff, thank you for managing our facilities and for your invaluable operational support.

"Chief Attorney Richard Dvonch and Special Counsel James Funaki, thank you always for your sound advice. HMSO Director Joan Yamaguchi, Assistant Director Rebecca Anderson, HMSO Operations Chief Jamie Go and the staff of HMSO, thank you for your research, drafting and committee support. You worked extremely hard, and it is appreciated.

"The Minority Office Director Rina Chung and your staff, thank you for your good work on behalf of the Minority.

"Finally, Nan Kalupahana and the Finance staff, the budget is a tremendous task. Congratulations and thank you for work well done.

"I am deeply grateful to all of you. It is an honor to serve as your Speaker, and I look forward to working together next session to serve the people of this state. Thank you and God bless you.

"We have our Senate counterparts waiting for us to end, so I need to conclude this pretty soon. Thank you for your applause, it brings a little tear to the eye. So, Members, as we conclude, I call on Representative Saiki."

Representative Saiki gave his closing remarks on behalf of the Majority as follows:

"Mr. Speaker, I'd like to just say that, on opening day I began my speech with acknowledgements, so I'd like to reiterate those acknowledgements today very briefly.

"First of all, thank you, on behalf of all of the Members, thank you to the residents of our respective communities who have given us this opportunity to represent them in the Legislature.

"Second, thank you to all of the legislative staff, and I know you mentioned all of the offices, for their work in enabling us to reach this day.

"Third, thank you to the Senate for their partnership this session. I know that for many of us it was a rookie year. I think we've learned from this work experience, and I know that next year will be even more productive. Thank you, especially, to the Senate President who enabled us to have a very civil and proactive working relationship throughout the session.

"Fourth, thank you to our colleagues across the aisle for all of their work and their steadfast belief in making this session and this system work.

"Finally, Mr. Speaker, thank you to the members of your Democratic Caucus. Each and every member of your caucus was diligent and worked really hard, in their own ways and in their own communities, to enable us to develop work product that I believe will benefit the entire State of Hawaii. So, thank you very much to everyone."

Representative Johanson gave his closing remarks on behalf of the Minority as follows:

"Thank you, Mr. Speaker. I would also be remiss if I didn't speak on behalf of the Minority Caucus. We wanted to start off by thanking you for your leadership and your vision. You've been steadfast and unwavering and most honorable.

"We also wanted to thank the leadership team of the House of Representatives. The Vice Speaker, the Majority Floor Leader and especially the Majority Leader. It has been a real privilege and an honor to work with all of you this session. To all of our Chairs, we thank you for the work that you've done. We think that there are many good pieces of legislation that emanated out of this Body that this entire Chamber, as well as the Senate, can be proud of.

"To my Minority Caucus, particularly the three new freshmen. You bring energy, camaraderie and fresh perspective, particularly the Minority Floor Leader, I couldn't have asked for a better co-pilot. But we would be nothing without our foundation. To the Representatives from Kailua and Ewa Beach, thank you for your mentoring, your ground work, and your patience with me in my first year.

"Especially to our Minority Leader Emeritus, none of this would have ever been possible without you. You really laid the foundation by training and mentoring, and in some cases employing some of us to be able to be here. It really has been a true privilege and an honor to serve as your Minority Leader. Thank you for the opportunity.

"Earlier, we committed to working hard to find common cause and common ground. As we adjourn today, I think this Chamber can be proud that we not only found common cause, but also achieved common ground. Thank you, Mr. Speaker."
