"P R O C L A M A T I O N

WHEREAS, under Section 16 of Article III of the Constitution of the State of Hawaii, the Governor is required to give notice, by a proclamation, of the Governor's plan to return with the Governor's objections any bill presented to the Governor less than ten days before adjournment sine die or presented to the Governor after adjournment sine die of the Legislature; and

WHEREAS, Senate Bill No. 909, entitled "A Bill for an Act Making Appropriations for Collective Bargaining Cost Items," passed by the Legislature, was presented to the Governor within the aforementioned period; and

WHEREAS, under Section 16 of Article III, the Governor may veto any specific item or items in any bill that appropriates money for specific purposes by striking out or reducing the same; and

WHEREAS, Senate Bill No. 909 appropriates money for specific purposes and certain appropriation items in that bill are unacceptable to the Governor of the State of Hawaii;

NOW, THEREFORE, I, NEIL ABERCROMBIE, Governor of the State of Hawaii, do hereby issue this proclamation, pursuant to the provisions of Section 16 of Article III of the Constitution of the State of Hawaii, giving notice of my plan to return Senate Bill No. 909 with my objections to certain appropriation items contained therein to the Legislature as provided by said Section 16 of Article III of the Constitution.

Gov. Msg. No. 1236, informing the House that on June 20, 2013, S.B. No. 909, SD 1, HD 1, CD 1, was line item vetoed with specific appropriation items stricken or reduced, and his official statement of objections to those specific appropriation items contained in the bill, as follows:

"EXECUTIVE CHAMBERS HONOLULU June 20, 2013

STATEMENT OF OBJECTIONS TO SENATE BILL NO. 909

Honorable Members Twenty-Seventh Legislature State of Hawaii

Pursuant to Section 16 of Article III of the Constitution of the State of Hawaii, I am returning herewith, without my approval, Senate Bill No. 909, entitled "A Bill for an Act Making Appropriations for Collective Bargaining Cost Items."

The purpose of this bill is to provide fund authorizations and appropriations for collective bargaining cost items for employees in unit 13 and its excluded counterparts, including salary increases and contributions to the Hawaii employer-union health benefits trust fund

negotiated between the State and the Hawaii Government Employees Association for fiscal biennium 2013-2015.

The amounts appropriated for state employees included in bargaining unit 13 were placed in the bill in anticipation of ratification by the unit 13 members of the public employers' last collective bargaining offer including pay raises. The state employees included in unit 13 failed to ratify the proposal and thus the employer and the exclusive representative remain in negotiations. It is a well settled labor law that the employer may not unilaterally implement a non-negotiated pay raise during negotiations. Therefore, to avoid the possibility of subsequent administrative actions that may constitute committing a prohibited practice under chapter 89, Hawaii Revised Statutes, I cannot approve those parts of the bill that would appropriate funds for such a pay raise.

Section 16 of Article III of the State Constitution provides that, "[e]xcept for items appropriated to be expended by the judicial and legislative branches, the governor may veto any specific item or items in any bill which appropriates money for specific purposes by striking out or reducing the same."

Because of the foregoing objections, pursuant to my line item veto authority, I have stricken by drawing a line through each of the appropriation amounts in sections 1, 9, and 13 of this bill.

For the foregoing reasons, I am returning Senate Bill No. 909 with the appropriations in sections 1, 9, and 13 stricken as set forth above.

This bill is objectionable because it requires the Division to collaborate with the Center, which the Division is already doing, and to collect data by requesting nurses to complete a Center survey, which the Division currently does by providing electronic links at both the beginning and end of its licensing renewal process. It is also unnecessary to tie the renewal of nursing licenses to the completion of a survey.

Pursuant to Section 16 of Article III of the Constitution of the State of Hawaii, I am returning herewith, without my approval, House Bill No. 988, entitled "A Bill for an Act Relating to Native Wildlife."

The purpose of this bill is to expand the use of the Environmental Response Revolving Fund ("the Fund") to, among other things, support the operations of an environmental disaster standby and response facility that shall be responsible for the recovery and rehabilitation of native wildlife affected by oil or fuel related disasters in the State of Hawaii.

This bill is objectionable because it is too narrow in scope and only allows the Fund to support the operations for a recovery and rehabilitation facility of native wildlife affected by oil related spills. If the goal of this bill is to provide funding for a specific facility, the grant appropriation process as provided under chapter 42F, Hawaii Revised Statutes, would be a more appropriate funding source. Additionally, section 128D-2, Hawaii Revised Statutes, currently allows the Fund to be used "[f]or oil spill planning, prevention, preparedness, education, research, training, removal, and remediation." This would allow for the rehabilitation of wildlife harmed by an oil spill, although the responsible parties typically pay for such response.

This bill is also objectionable because it expands the number of programs that draw from the Fund generated by the Environmental Response, Energy, and Food Security Tax pursuant to section 243-3.5, Hawaii Revised Statutes, commonly referred to as the "barrel tax," without increasing the barrel tax allocation to support the expansion. The Fund has been declining due in part to: (1) the rising cost of oil; (2) the switch to alternative energy sources; and (3) the aviation fuel exemption. The Fund is already being burdened by supporting environmental emergency response activities and approximately forty positions within the Department of Health and cannot support an additional program within the current allocation to the Department of Health.

Senate Bill No. 3, S.D. 1, H.D. 2, C.D. 1, entitled "A BILL FOR AN ACT RELATING TO THE OFFICE OF HAWAIIAN AFFAIRS" will become law without my signature, pursuant to Section 16 of Article III of the State Constitution.

The purpose of this bill is to make changes to the Office of Hawaiian Affairs election process by replacing the current special election process held in conjunction with the general election with a system of nonpartisan primary and general elections.

Although this bill will make Office of Hawaiian Affairs elections consistent with other nonpartisan elections, it will not likely resolve the issues of low participation and candidates being elected by a low margin. However, it is a step forward in narrowing the field through a primary election, thereby allowing the general election winner to reflect a larger portion of the votes and reflecting a larger representation of the majority.

For the foregoing reasons, Senate Bill No. 3, S.D. 1, H.D. 2, C.D. 1 will become law as Act 287, Session Laws of Hawaii 2013, effective July 9, 2013, without my signature.

Gov. Msg. No. 1394, dated July 8, 2013, informing the House that on July 9, 2013, pursuant to Section 16 of Article III of the State Constitution, the following bill became law without his signature, stating:

Senate Bill No. 1388, S.D. 2, H.D. 2, C.D. 1, entitled "A BILL FOR AN ACT RELATING TO THE RESEARCH CORPORATION OF THE UNIVERSITY OF HAWAII" will become law without my signature, pursuant to Section 16 of Article III of the State Constitution.

The purpose of this bill is to amend the composition of the Research Corporation of the University of Hawaii's Board of Directors, modify the procurement exemption for certain construction contracts, remove the University President as the President of the Research Corporation, and cap the Executive Director's salary.

The Research Corporation of the University of Hawaii (RCUH) is important to the University of Hawaii and to the State. RCUH facilitates the UH's ability to facilitate externally funded initiatives, such as federal grant programs, and to administer grants and contracts to support important research, development and training functions for the University and for the general welfare of the state. This legislation addresses RCUH's role and leadership to affirm the organization's focus.

However, the composition of the RCUH governing board set forth in this bill leaves gaps in describing the expected competencies of individuals, only naming the professional backgrounds of only three appointees and not identifying the characteristics of the other five members of the board, relying instead entirely on the good judgment of the appointing parties to select appropriate individuals and to ensure balance of the board in important qualities such as experience. We should hold all

appointing authorities, whether the Governor, President of the Senate, or Speaker of the House of Representatives, to a high standard in appointing individuals of competence, judgment, and integrity.

For the foregoing reasons, Senate Bill No. 1388, S.D. 2, H.D. 2, C.D. 1 will become law as Act 288, Session Laws of Hawaii 2013, effective July 9, 2013, without my signature.
