The House of Representatives of the Twenty-Seventh Legislature of the State of Hawaii, Regular Session of 2014, convened at 12:11 o'clock p.m., with Speaker Souki presiding.

The invocation was delivered by Representative Derek S.K. Kawakami, after which the Roll was called showing all Members present with the exception of Representatives Creagan, Oshiro and Yamashita, who were excused.

Representative Ward rose to speak in support of the measure, stating:

"Mr. Speaker, I rise in weak support. Mr. Speaker, this is a bill that divvies up the royalties, but as a venue to make a comment, this bill reminds us that the land that we own in fee simple doesn't really belong to us, because we could find gold, oil, geothermal energy, and it doesn't really belong to the people of Hawaii, Mr. Speaker.

"I'm not questioning the wisdom of those who write the constitution, but the fact that you do not have rights underneath your land is a rare exception in the United States, that's why there was the gold rush, that's why there were places in America that when people went to it, they found stuff in the ground and it incentivized them to move and to be entrepreneurial. In Hawaii, we have the best entrepreneurial cultures in the world, but because of things such as this prohibition of being able to have their own resources underneath their land as their own, this is a bit of a dicinocative.

"So, I think we're cutting the pie up here, it's deserved by the Department of Hawaiian Home Lands, it's on their land, but I don't think the state should own everything underneath the ground. But that's the way it is in the State of Hawaii. The state is the superior; the state is the one who owns all the resources because of the royalties that we have already in statute and the constitution. For those reasons, Mr. Speaker, I'm in support of this, but in weak support. Thank you."

It allows children the age of 14 to seek help outside their parent's purview. Now there are bad parents out there, I certainly understand that, and if there are, the social workers should get involved and it should be adjudicated through the court processes.

"Once a 14-year-old says, 'Well, I don't like mom and dad,' and they may choose to run away and seek shelter or a safe place because their parents are strict or something of that nature, I don't know what the recourse is, and I don't know what we're doing here. It seems to me, that although well-intended certainly, and admirable trying to help youth, we may be undermining parental rights. So that's my concern. Thank you."

Representative Fale rose in support of the measure with reservations and asked that the remarks of Representative McDermott be entered into the Journal as his own, and the Chair "so ordered." (By reference only.)

"Mr. Speaker, I stand in opposition. I'd like to make a few comments. The Chamber of Commerce is against this, and so are the electronics manufacturers. Again, a well-intended cause, but 80 percent of the population resides on the island of Oahu. If you really were serious about this, you'll work out a program with the city and have them collect it, take the precious metals out, and then they can burn the rest in H-POWER.

"This is part one of what I believe will be part two, which is then coming back next year and saying, the people who are tasked to do this, saying, 'we can't afford to do this.' And then we're going to put a tax, just like the bottle bill, a tax on every computer you buy, \$10 recycling tax. You only get that back when you turn it in.

"And so, it's a well-intended measure. There are precious metals and things of value in these CPUs. The city could extract those, help offset their cost of running the bulky item pick-up, and then burn the rest in H-POWER for fuel. So I stand in opposition as this is a bad business bill. Thank you."

Representative Awana rose in support of the measure with reservations and asked that the remarks of Representative McDermott be entered into the Journal as her own, and the Chair "so ordered." (By reference only.)

Representative Fale rose in opposition to the measure and asked that the remarks of Representative McDermott be entered into the Journal as his own, and the Chair "so ordered." (By reference only.)

Representative Lee rose to speak in support of the measure, stating:

"Thank you. In support, Mr. Speaker. Just very briefly, this measure is designed obviously to address the proliferation of heavy metal in our electronic devices, which is now going into our landfills. The issue is that those particular types of metals are extremely toxic, and as groundwater filters through our landfills, those toxins end up in our water table.

"There's also the issue in the neighbor islands, particularly with the current recycling program which we have, where communities in rural areas, remote areas in neighbor islands, and just neighbor islands in general, are unable to recycle their electronic waste. And the citizens there have very few options which, at this point, are limited in some cases to a mail-back. So if you want to get rid of your electronic device, you've got to box it up, pay to ship it off to some mainland facility.

"This is a big issue, but something that the electronics manufacturer's community is trying to resolve, I think in good faith with the state and coordination with the Department of Health, and the neighbor island counties, who are in support of taking proactive steps to fix our current program.

"Now, I'll note that the opposition from the manufacturers in large part to this point has been because of perceived mandates that they'd have difficulty meeting. What was done in the previous committee was changing those mandates to goals. So as long as you make an attempt, you're not going to be penalized for not collecting a particular weight of whatever it is you're trying to collect that you sell.

"In addition to that, we're ensuring that the Department of Health is able to fill in where manufacturing plans for recycling don't meet, don't pass muster and don't have support in neighbor island communities where there is no option for people to recycle. Department of Health will then be able to step in and collect those sorts of materials.

"So, happy to discuss this further, but in the meantime, it goes on to the next committee, so defer to that chair. Thank you."
