"Mr. Speaker, a no vote on this and just brief comments. This seems to go against the philosophy of this Body, trying to promote renewable energy, electric vehicles, get off fossil fuels. We're establishing a fee for electric vehicles, which already on average cost about \$5,000 more. So to offset that we give tax breaks and fees. I understand they're heavier and they tear up the roads a little bit more, but it seems that the Body made that decision years ago when they provided these incentives. So for those reasons, I vote no. Thank you."

Representative Fukumoto rose in opposition to the measure and asked that her written remarks be inserted in the Journal, and the Chair "so ordered."

Representative Fukumoto's written remarks are as follows:

"Mr. Speaker, I rise in opposition to Senate Bill 2324, SD 2, HD 1. This bill would impose a \$100 annual user fee on all electric cars.

"While I understand this bill is to help compensate for loss of taxes on the purchase of gasoline, I feel it is premature. I do not think the current number of electric cars on the road is high enough to affect our roadrepair-revenue. Furthermore, I don't believe this body should be increasing the costs of transportation in any form.

"Thank you, Mr. Speaker."

Representative Hanohano rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Fale rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Ward rose to speak in support of the measure with reservations, stating:

"Mr. Speaker, reservations and a brief comment. I think this tax is premature as the colleague from Ewa Beach noted. Let's see how many electric cars we can get on the road first. Right now we have a very small number, even though it's gaining momentum. If we start taxing them, it's going to be like the PV on our roof. If we take away the tax credits, people are going to stop putting PV on their roof. If we take away the incentive to get an electric car, we're not going to get the electric cars on the road. So I think this is premature. It's well taken. They use the roads, therefore they should help fix the potholes. But doing it now is not timely. Thank you, Mr. Speaker."

So this is the advanced technology, and it says, 'Hawaii, you're the place that we want to do this.' And we're simply to put up half of what I think they're asking to start it out, which is a small amount of money, because they're going to invest in their pilot about \$20 million. And then if that one works, they're going to go up to as much as \$200 million.

"So this is a job creator. It's an economic stimulus. And Mr. Speaker, they believe so strongly, next week they're going to be in town, and they want to brief as many people who are either in the UAV caucus or just interested in this new technology for what they have as a long haul perspective on Hawaii. Hopefully our colleagues will have the same way. This will go through, it will get funded, and we'll have the first laser communication station in the United States. Thank you, Mr. Speaker."
