The House of Representatives of the Twenty-Seventh Legislature of the State of Hawaii, Regular Session of 2014, convened at 12:08 o'clock p.m., with Vice Speaker Mizuno presiding.

The invocation was delivered by The Reverend Samuel Lawrence Domingo of Kilohana United Methodist Church, after which the Roll was called showing all Members present with the exception of Representatives Hashem and Ing, who were excused.
