Representative Ward: "Mr. Speaker, it's not the Hawaiian or the Indonesian thing to soak up all the credit for what took three years. We call it a courtship in marriage that after three years took place. But it's Representative Awana who got the ball rolling, Ronny Adhikarya, who I introduced earlier, who from Los Angeles and Jakarta got things rolling. Grateful to Representative Hanohano for coming yesterday, gracing us with her presence. We also had Representative Hashem and Senator Espero who showed up, and I'm thinking of others.

"Representative Cachola gave us the hardest time to get this Indonesian thing passed. So Romy, you did a good job.
