The House of Representatives of the Twenty-Seventh Legislature of the State of Hawaii, Regular Session of 2014, convened at 6:40 o'clock p.m., with Speaker Souki presiding.

The invocation was delivered by Mr. Mark Rosa of Representative Angus L.K. McKelvey's office, after which the Roll was called showing all Members present with the exception of Representatives Oshiro and Woodson, who were excused.

"I do, though, commend the 2013 Aloha Order of Merit Committee in making the tough decision for a final nominee, given all accolades and contributions for and on behalf of our state in consideration, between Mr. Kaleikini and former Governor George Ariyoshi."

Representative Ward rose in support of the measure and asked that his written remarks be inserted in the Journal, and the Chair "so ordered."

Representative Ward's written remarks are as follows:

"Mr. Speaker, I stand in support of SCR 88.

"Danny Kaleikini is one of Hawaii's finest performers. A true American success story, Danny Kaleikini is the son of a City and County refuse worker and a cocktail waitress. From his humble beginnings he was able to entertain American presidents, English royalty, and countless Hawaiian residents. Since retirement, he has continued to give back to his community as a member of several charitable organizations. I can think of no better man to be inducted into the Aloha Order of Merit."

FINAL READING

Representative Saiki moved to agree to the amendments made by the Senate to the following House Bills, seconded by Representative Cabanilla and carried: (Representatives Oshiro and Woodson were excused.)

No. 2482, HD 1, (SD 1) The Chair addressed the Clerk who announced that the record of votes for the appropriate measure had been received which indicated that the requisite number of House Conferees appointed had agreed to the amendments made by the Senate, and had cast affirmative votes to report said measure to the Floor for final disposition.

H.B. No. 1024, HD 1, SD 2:

In accordance with the Conference Committee Procedures agreed upon by the House of Representatives and the Senate, the managers on the part of the House recommended that the House agree to the amendments proposed by the Senate to H.B. No. 1024, HD 1, on the following showing of Ayes and Noes:

Ayes, 5 (Hanohano, Rhoads, Brower, Say and Fale). Noes, none. Excused, 1 (Belatti).

Representative Saiki moved that H.B. No. 1024, HD 1, SD 2 pass Final Reading, seconded by Representative Cabanilla.

Representative Kawakami rose in support of the measure and asked that his written remarks be inserted in the Journal, and the Chair "so ordered."

Representative Kawakami's written remarks are as follows:

"Mr Speaker, the original bill permanently removed the sunset date on an Act that protects our bravehearts: the lifeguards who put their lives on the line to protect our keiki, our kupuna, our locals and our visitors. Mr. Speaker, I would like to direct your attention to the committee report which made clear that, overwhelmingly, the testimony was in support, including testimony from the Attorney General, the Department of Land & Natural Resources, the Mayor of the City & County of Honolulu, the Mayor of the County of Hawaii, the Mayor of the County of Maui, the Mayor of the County of Kauai, the Council Chair of the Council of Maui, the Council Member of the 4th District of the City & County of Honolulu, the Kauai Fire Department, the Ocean Safety Bureau of the Kauai Fire Department, the Ocean Safety Division of the Honolulu Emergency Services Department, the Hawaii Fire Department, the Hawaii State Fire Council, the Honolulu Fire Department, the Kauai Visitors Bureau, the Kauai Lifeguard Association, the Hawaiian Lifeguard Association, the Injury Prevention Advisory Committee, Outrigger Hotels Hawaii, Waikiki Improvement Association, the Poipu Beach Resort Association, the Kauai Chamber of Commerce, and many individuals testified in support of this measure. There was only one individual who testified in opposition to this

"Mr. Speaker, this bill serves to protect the county lifeguards on four state beaches: Ke'e on Kauai, Makena on Maui, Hapuna on Hawaii Island, and Kaena Point on Oahu. Mr. Speaker, as the Representative of the 14th District, I see firsthand how large a role our lifeguards play in the protection of our state beaches. For example, on Ke'e Beach alone, in 2008, there were 44 rescues, 6,809 preventions, and zero deaths. In 2009, there were 52 rescues, 17,006 preventions, 132,740 beachgoers, and zero deaths. In 2010, there were 34 rescues, 13,488 preventions, 120,712 beachgoers, and zero deaths. In 2011, there were 33 rescues, 13,385 preventions, 107,988 beachgoers, and zero deaths. In 2012, there were 28 rescues, 16,572 preventions, 120,648 beachgoers, and zero deaths. In 2013, there were 42 rescues, 16,423 preventions, and zero deaths.

"Mr. Speaker, keep in mind these figures are for one beach. Mr. Speaker, with each prevention and rescue, our lifeguards prevent the heartbreak that parents, children, family and friends are dealt when losing someone to drowning. Mr. Speaker, this bill protects those who protect us. It is a means to return the favor. Although, I am pleased that this bill has moved forward, if only to extend the protection for three more years, Mr. Speaker, when this bill returns in two years, I hope the sunset date is removed and repealed and fulfills the original intent of the bill."

Representative Ward rose to speak in support of the measure with reservations, stating:

"Support with reservations, but it's a complaint, Mr. Speaker. This bill is all about our lifeguards, it's all about our state's liability and protection, and it's about kicking the can three years down the line, giving this sunset date only three years. Mr. Speaker, I think our lifeguards deserve better than this, this should be permanent. If there was enough time, this should be a floor amendment. It's worthy of that because this is something that we've taken up and we've not settled it, and it's not settled with this bill.

"I think because we are the most beautiful place in the world and our beaches always win number one, if we can't do this for our lifeguards, what is it saying about who we are and how we treat those people who watch these most beautiful beaches in the world? For those reasons, Mr. Speaker, it's a complaint. It's my 'with reservations' vote on this one. Thank you."

I've said this before and I'll say it again, I don't know when medical marijuana became a civil liberty issue, but for those reasons, Mr. Speaker, I unfortunately have to be opposed, because of the representation on the board. Thank you."
