

## THIRD DAY

Friday, January 23, 2015

The House of Representatives of the Twenty-Eighth Legislature of the State of Hawaii, Regular Session of 2015, convened at 12:09 o'clock p.m., with Vice Speaker Mizuno presiding.

The invocation was delivered by Mr. Mike Kockler of Representative Della Au Belatti's Office, after which the Roll was called showing all Members present with the exception of Representatives Cachola, Carroll and Ohno, who were excused.

By unanimous consent, reading and approval of the Journal of the House of Representatives of the Second Day was deferred.

Sen. Com. No. 4, transmitting S.C.R. No. 3, entitled: "SENATE CONCURRENT RESOLUTION STRONGLY OPPOSING THE UNITED STATES ARMY'S PROPOSED FORCE REDUCTION OF SCHOFIELD BARRACKS AND FORT SHAFTER BASES," which was adopted by the Senate on January 22, 2015.

Representative Saiki moved that S.C.R. No. 3 be adopted, seconded by Representative Evans.

Representative Ito rose in support of the measure and asked that his written remarks be inserted in the Journal, and the Chair "so ordered."

Representative Ito's written remarks are as follows:

"Mr. Speaker, I rise in strong support of this measure.

"Mr. Speaker, it is most important that, here today, we demonstrate our strong support of the men and women of the armed forces and the importance of partnerships such as what we have here; between the military, the private sector, and state and local government.

"We understand how important the military is to Hawaii. Members of the military are part of our communities, our *'ohana*, and in time of need, we have been always been able to count on them.

"The military activities also support our economy. In Hawaii, the military spends more than \$6.5 billion annually and has a total economic impact of \$14.7 billion.

"We need to step up, and be loud and clear about our support of the military in Hawaii and the important role the military plays in our communities.

"Partnership is the key to addressing some of the challenges the military faces in Hawaii.

"Mr. Speaker, I serve as the Co-Chair of the National Conference of State Legislature's Military and Veterans Affairs Task Force. In this role, I can see the limits put on defense spending by the Budget Control Act that result in a competition between states for military bases and activities. We must be at the forefront of this competition.

"Mr. Speaker, for these reasons I strongly support Senate Concurrent Resolution 3, and ask my colleagues to do the same."

Representative Oshiro rose to speak in support of the measure, stating:

"Thank you very much, Mr. Speaker. I'd like the remarks that I made on House Concurrent Resolution Number 3 on January 22nd, be entered in the Journal in support of Senate Concurrent Resolution Number 3. Thank you," and the Chair "so ordered." (By reference only.)

Representative Ward rose to speak in support of the measure, stating:

"Mr. Speaker, same request plus the fact that I would remind the Body that our first obligation as elected officials of the people is public safety. The safety of our people is key. That didn't come through yesterday, but I would add that to my remarks from yesterday. Thank you," and the Chair "so ordered." (By reference only.)

Representative McKelvey rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. In strong support. Same request as the Representative from Wahiawa, to have my remarks from yesterday entered into the Journal for today's measure. Thank you," and the Chair "so ordered." (By reference only.)

Representative Johanson rose in support of the measure and asked that his written remarks be inserted in the Journal, and the Chair "so ordered."

Representative Johanson's written remarks are as follows:

"I am in strong support of this concurrent resolution, and would like to reference my remarks submitted on January 22, 2015 for H.C.R. No. 3, House Concurrent Resolution Strongly Opposing the United States Army's Proposed Force Reduction of Schofield Barracks and Fort Shafter Bases."

Representative Woodson rose to speak in support of the measure, stating:

"Mr. Speaker, in strong support, with permission to enter written comments, please."

Representative Woodson's written remarks are as follows:

"Mr. Speaker, I rise in support of the resolution. There have been many credible and effective arguments that have been articulated as to the net positive socioeconomic benefits for maintaining troop and equipment at the current levels. However, there is also the argument to be made regarding security: security for our communities, security for our state, security for our country, security for our allies, and security for those in need around the globe.

"Hawaii is of great strategic importance geographically, and therefore it is of great geopolitical importance. Because Hawaii is located in what can be used as a natural pivot point into an Eastern hemisphere, it should maintain current military levels. In other words, Hawaii offers a strategic military advantage simply because of its prime location as it relates to the rest of the world. This is a unique asset that no other state can provide. Our military's presence in Hawaii—as a whole—makes our military more effective and therefore our communities, state and country more secure.

"We have an obligation. Because our military's capability is great, it is our responsibility to communicate strong support from this Chamber. Not only is our security at stake, but other countries and communities that would become even more vulnerable are at stake as well. We are the only country that can take on such a responsibility, so we must do everything we can to support the military and maintain their presence here. This is our burden. It is not about us or them; they are us."

Representative Matsumoto rose in support of the measure and asked that her written remarks be inserted in the Journal, and the Chair "so ordered."

Representative Matsumoto's written remarks are as follows:

"I am in strong support of this concurrent resolution, and would like to reference my remarks submitted on January 22, 2015 for H.C.R. No. 3, House Concurrent Resolution Strongly Opposing the United States Army's Proposed Force Reduction of Schofield Barracks and Fort Shafter Bases."

Representative Tokioka rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. In strong support, and may I have the same request as the Representative from Wahiawa. Thank you," and the Chair "so ordered." (By reference only.)

Representative Fukumoto Chang rose to speak in support of the measure, stating:

"Same request please," and the Chair "so ordered." (By reference only.)

Representative Tupola rose in support of the measure and asked that her written remarks be inserted in the Journal, and the Chair "so ordered."

Representative Tupola's written remarks are as follows:

"I stand in support of this resolution. A resolution is an official expression of the opinion or will of a legislative body.

"Our Legislative Body has not been invited to the congressional table to debate this issue or suggest amendments or changes. We are deciding as a Body to have an opinion on the federal decision.

"I represent Barbers Point which was vacated by the military in 1998, 16 years ago. This area has turned into a ghost town with roads that are not up to code, buildings that are vandalized, and properties that have not been absorbed by private or public entities. I believe that this decision will result in the same outcome as Barbers Point without proper planned funding from the State or City. This unplanned decision will impact the economy, jobs, schools, business and more. I believe that if the federal government is going to vacate the area, there should be some plan to 'leave it better than they found it,' by preparing the roads, drainage, housing, etc.

"My colleagues also mentioned that the military has provided first responder services for hurricanes and other natural disasters throughout the State that would have resulted differently without their aid. In an isolated land such as Hawaii, we need to think about the need for these emergency services, especially in an area I represent that was affected by Hurricane Iniki. My goal is to hold our first Wai'anae Emergency Preparedness Fair with an evacuation drill this June at Nanakuli High School. I am determined to give my area an emergency preparedness plan and equip my community members with more knowledge regarding emergency preparedness. I know that when a hurricane hits, the time to prepare has passed. Now is the time to prepare.

"I do not support the federal acquisition of Makua or other lands on the West Coast of O'ahu. I do not support live firing in Makua Valley. I do not support the military destroying natural resources in Hawaii. I do hope that Makua Valley and Maili Valley where I live will one day be given back to the people in those areas. I do hope that we can diversify our economy in the future without the strong dependency on the military. I do hope that the federal government officials will work more closely with state officials in the future to prepare us for such a decision."

Representative Jordan rose to speak in support of the measure with reservations, stating:

"Thank you, Mr. Speaker. In support with strong reservations. May I have permission to submit the comments I stated on the Floor on January 22nd, in regards to House Concurrent Resolution Number 3. Thank you very much, Mr. Speaker," and the Chair "so ordered." (By reference only.)

Representative Keohokalole rose to speak in support of the measure with reservations, stating:

"I rise in support with reservations, asking permission for my comments from yesterday to be entered into the Journal today. Thank you," and the Chair "so ordered." (By reference only.)

Representative LoPresti rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. I rise in support and I ask the same. Thank you," and the Chair "so ordered." (By reference only.)

Representative San Buenaventura rose to speak in support of the measure with reservations, stating:

"Support with reservations, and I would like to also incorporate my comments from HCR 3 from yesterday. Thanks," and the Chair "so ordered." (By reference only.)

Representative Ing rose to speak in opposition to the measure, stating:

"Same request, in opposition," and the Chair "so ordered." (By reference only.)

Representative Ichiyama rose in support of the measure and asked that her written remarks be inserted in the Journal, and the Chair "so ordered."

Representative Ichiyama's written remarks are as follows:

"I am in strong support of this concurrent resolution, and would like to reference my remarks submitted on January 22, 2015 for H.C.R. No. 3, House Concurrent Resolution Strongly Opposing the United States Army's Proposed Force Reduction of Schofield Barracks and Fort Shafter Bases."

Representative Yamane rose to speak in support of the measure, stating:
