

## SIXTH DAY

Thursday, January 29, 2015

The House of Representatives of the Twenty-Eighth Legislature of the State of Hawaii, Regular Session of 2015, convened at 12:10 o'clock p.m., with Vice Speaker Mizuno presiding.

The invocation was delivered by Bishop Soara I. Tupua, Jr., Senior Pastor of the Holy Hill of Zion Thy Dwelling Place, and his son Kekoa Tupua, after which the Roll was called showing all Members present with the exception of Representatives Carroll and Pouha, who were excused.

By unanimous consent, reading and approval of the Journal of the House of Representatives of the Fifth Day was deferred.

## ORDER OF THE DAY

INTRODUCTION OF RESOLUTIONS  
(FLOOR PRESENTATIONS)

The following resolution (H.R. No. 9) was announced by the Clerk and the following action taken:

H.R. No. 9, entitled: "HOUSE RESOLUTION RECOGNIZING SUZANNE MARINELLI ON THE OCCASION OF HER RETIREMENT FROM THE LEGISLATIVE REFERENCE BUREAU'S PUBLIC ACCESS ROOM," was offered by Representative Say.

Representative Say moved that H.R. No. 9 be adopted, seconded by Representative Evans.

Representative Say recognized Ms. Suzanne Marinelli for her work making the Public Access Room the most successful access room for the general public throughout the country, and thanked her for her work for the residents of Hawaii, guiding the public through the legislative process.

Representative Evans thanked Suzanne, the "plant lady," for making the public access room warm and welcoming for everyone.

Representative Oshiro acknowledged the accomplishments of the Public Access Room and Suzanne, reminisced of how she was one of the first friendly faces he met when he first came to the State Capitol as a newly elected legislator, thanked her for her work and her passion, and wished her the best in her new adventures.

Representative Jordan thanked Suzanne for her warm spirit and *aloha*, for being active in the community, going to neighborhood board meetings on Oahu and the neighbor islands and explaining the process and how citizens can participate in government, and recognized Suzanne as a professional artist who displays her own art during Art at the Capitol.

Representative Ward recognized Suzanne Marinelli as a great American for spreading democracy, for always being open and serving the public, and thanked and congratulated her for all her hard work.

Representative Tokioka, on behalf of the Kauai delegation, thanked her for all the times she has visited Kauai community centers and spoken with the residents on how to get involved.

Representative Say then introduced the honorees seated on the Floor of the House:
