Tuesday, February 10, 2015

The House of Representatives of the Twenty-Eighth Legislature of the State of Hawaii, Regular Session of 2015, convened at 12:09 o'clock p.m., with Speaker Souki presiding.

The invocation was delivered by Representative Linda Ichiyama, after which the Roll was called showing all Members present.

By unanimous consent, reading and approval of the Journal of the House of Representatives of the Twelfth Day was deferred.

**KA HUA 'ŌLELO O KA LĀ
HAWAIIAN WORD FOR THE DAY**

Representative Say presented *Ka Hua 'Ōlelo o Ka Lā*, the Hawaiian Word for the Day, as follows:

"Thank you very much, Mr. Speaker. Today's Hawaiian Word for the Day is *Ka'au*. For those of you who go hiking, we have the Ka'au Crater at the head of Palolo Valley in Honolulu. In the creation they said it was formed when Maui's, one of the gods, hook fell there after dropping *pohaku o Kauai* at Kaena Point. Perhaps named for the *Ka'auhelemaoa*, that's the supernatural chicken of Palolo that flew to *Helumoa*. *Ka'au*. Thank you."

ORDER OF THE DAY

REPORTS OF STANDING COMMITTEES

Representative Rhoads, for the Committee on Judiciary, presented a report (Stand. Com. Rep. No. 58) recommending that H.B. No. 346 pass Second Reading and be referred to the Committee on Finance.

Representative Saiki moved that the report of the Committee be adopted, and that H.B. No. 346 pass Second Reading and be referred to the Committee on Finance, seconded by Representative Evans.

Representative Jordan rose to speak in support of the measure with reservations, stating:

"Mr. Speaker, please note my reservations. Mr. Speaker, I do understand the importance of this measure and to increase fees upon our community, and it has been almost 10 or 14 years on some of these fees, but I would just like a little bit more information before I can totally support this measure. Thank you, Mr. Speaker."

Representative McDermott rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 346, entitled: "A BILL FOR AN ACT RELATING TO THE CIVIL PROCESS," passed Second Reading and was referred to the Committee on Finance, with Representative Jordan voting aye with reservations, and with Representative McDermott voting no.

Representative Rhoads, for the Committee on Judiciary, presented a report (Stand. Com. Rep. No. 59) recommending that H.B. No. 364 pass Second Reading and be referred to the Committee on Finance.

Representative Saiki moved that the report of the Committee be adopted, and that H.B. No. 364 pass Second Reading and be referred to the Committee on Finance, seconded by Representative Evans.

Representative McKelvey rose to speak in support of the measure with reservations, stating:

"Thank you, Mr. Speaker. Just note my reservations on this bill. Real quickly, I'm just concerned about the privacy implications and putting landlords in the position of having to act as enforcers of the law *vis-à-vis* a police state. Thank you."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 364, entitled: "A BILL FOR AN ACT RELATING TO NUISANCE ABATEMENT," passed Second Reading and was referred to the Committee on Finance, with Representative McKelvey voting aye with reservations.

Representative Rhoads, for the Committee on Judiciary, presented a report (Stand. Com. Rep. No. 60) recommending that H.B. No. 291, as amended in HD 1, pass Second Reading and be referred to the Committee on Finance.

On motion by Representative Saiki, seconded by Representative Evans and carried, the report of the Committee was adopted and H.B. No. 291, HD 1, entitled: "A BILL FOR AN ACT RELATING TO THE SMALL CLAIMS DIVISION OF THE DISTRICT COURT," passed Second Reading and was referred to the Committee on Finance.

Representative Rhoads, for the Committee on Judiciary, presented a report (Stand. Com. Rep. No. 61) recommending that H.B. No. 213 pass Second Reading and be referred to the Committee on Finance.

On motion by Representative Saiki, seconded by Representative Evans and carried, the report of the Committee was adopted and H.B. No. 213, entitled: "A BILL FOR AN ACT RELATING TO JURY DUTY," passed Second Reading and was referred to the Committee on Finance.

Representative Rhoads, for the Committee on Judiciary, presented a report (Stand. Com. Rep. No. 62) recommending that H.B. No. 180 pass Second Reading and be referred to the Committee on Finance.

Representative Saiki moved that the report of the Committee be adopted, and that H.B. No. 180 pass Second Reading and be referred to the Committee on Finance, seconded by Representative Evans.

Representative Ichiyama rose to disclose a potential conflict of interest, stating:

"Thank you, Mr. Speaker. May I have a ruling on a potential conflict? My spouse is a registered lobbyist," and the Chair ruled, "no conflict."

Representative Ichiyama continued, stating:

"Thank you, Mr. Speaker. Will this ruling apply to the remainder of this session?" and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 180, entitled: "A BILL FOR AN ACT RELATING TO LOBBYING CONTRIBUTIONS AND EXPENDITURES STATEMENTS," passed Second Reading and was referred to the Committee on Finance.

Representative Takayama, for the Committee on Public Safety, presented a report (Stand. Com. Rep. No. 63) recommending that H.B. No. 961 pass Second Reading and be referred to the Committee on Health.

On motion by Representative Saiki, seconded by Representative Evans and carried, the report of the Committee was adopted and H.B. No. 961, entitled: "A BILL FOR AN ACT RELATING TO COURT ORDERS TO PROVIDE MEDICAL TREATMENT FOR INMATES AND DETAINEES IN CORRECTIONAL FACILITIES," passed Second Reading and was referred to the Committee on Health.

Representative Hashem, for the Committee on Housing, presented a report (Stand. Com. Rep. No. 64) recommending that H.B. No. 445, as amended in HD 1, pass Second Reading and be referred to the Committee on Finance.

On motion by Representative Saiki, seconded by Representative Evans and carried, the report of the Committee was adopted and H.B. No. 445, HD 1, entitled: "A BILL FOR AN ACT RELATING TO TRANSIT-ORIENTED DEVELOPMENT," passed Second Reading and was referred to the Committee on Finance.

Representative Kawakami, for the Committee on Economic Development & Business, presented a report (Stand. Com. Rep. No. 65) recommending that H.B. No. 1158 pass Second Reading and be referred to the Committee on Labor & Public Employment.

On motion by Representative Saiki, seconded by Representative Evans and carried, the report of the Committee was adopted and H.B. No. 1158, entitled: "A BILL FOR AN ACT RELATING TO SUSTAINABLE BUSINESS CORPORATIONS," passed Second Reading and was referred to the Committee on Labor & Public Employment.

Representative Kawakami, for the Committee on Economic Development & Business, presented a report (Stand. Com. Rep. No. 66) recommending that H.B. No. 1343 pass Second Reading and be referred to the Committee on Public Safety.

Representative Saiki moved that the report of the Committee be adopted, and that H.B. No. 1343 pass Second Reading and be referred to the Committee on Public Safety, seconded by Representative Evans.

Representative Ichiyama rose to disclose a potential conflict of interest, stating:

"Thank you, Mr. Speaker. May I request a ruling on potential conflict, please? My spouse is a registered lobbyist for the Chamber of Commerce who submitted testimony in support of this bill," and the Chair ruled, "no conflict."

Representative Ichiyama continued, stating:

"Thank you. Will this ruling apply to the remainder of this session?" and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 1343, entitled: "A BILL FOR AN ACT RELATING TO PUBLIC SAFETY," passed Second Reading and was referred to the Committee on Public Safety.

Representative Kawakami, for the Committee on Economic Development & Business, presented a report (Stand. Com. Rep. No. 67) recommending that H.B. No. 895, as amended in HD 1, pass Second Reading and be referred to the Committee on Finance.

On motion by Representative Saiki, seconded by Representative Evans and carried, the report of the Committee was adopted and H.B. No. 895, HD 1, entitled: "A BILL FOR AN ACT RELATING TO PROCUREMENT OF PROFESSIONAL SERVICES," passed Second Reading and was referred to the Committee on Finance.

Representative Kawakami, for the Committee on Economic Development & Business, presented a report (Stand. Com. Rep. No. 68) recommending that H.B. No. 1328 pass Second Reading and be referred to the Committee on Transportation.

On motion by Representative Saiki, seconded by Representative Evans and carried, the report of the Committee was adopted and H.B. No. 1328, entitled: "A BILL FOR AN ACT RELATING TO THE DEPARTMENT OF BUSINESS, ECONOMIC DEVELOPMENT, AND TOURISM," passed Second Reading and was referred to the Committee on Transportation.

Representative Morikawa, for the Committee on Human Services, presented a report (Stand. Com. Rep. No. 69) recommending that H.B. No. 897, as amended in HD 1, pass Second Reading and be referred to the Committee on Judiciary.

On motion by Representative Saiki, seconded by Representative Evans and carried, the report of the Committee was adopted and H.B. No. 897, HD 1, entitled: "A BILL FOR AN ACT RELATING TO THE UNIFORM INTERSTATE FAMILY SUPPORT ACT," passed Second Reading and was referred to the Committee on Judiciary.

Representative Morikawa, for the Committee on Human Services, presented a report (Stand. Com. Rep. No. 70) recommending that H.B. No. 384, as amended in HD 1, pass Second Reading and be referred to the Committee on Finance.

Representative Saiki moved that the report of the Committee be adopted, and that H.B. No. 384, HD 1 pass Second Reading and be referred to the Committee on Finance, seconded by Representative Evans.

Representative McDermott rose in opposition to the measure and asked that his written remarks be inserted in the Journal, and the Chair "so ordered."

Representative McDermott's written remarks are as follows:

"I oppose this bill on fiscal grounds. The purpose of the bill is to help reduce youth violence and delinquency in the State by appropriating funds to the Department of Human Services to fund the operational costs of an organization providing therapeutic prevention and mental health programs for high risk youth.

"The bill appropriates monies from the General Fund. While I support the idea of reaching out to at-risk youth, I also find that this bill leaves two big and unanswered questions. First: What 'organization' will receive this money? Second: Why didn't the organization that wants this money submit a grant-in-aid application?

"We need transparency in government, and this bill does not provide it. Therefore, I must respectfully oppose this bill."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 384, HD 1, entitled: "A BILL FOR AN ACT RELATING TO YOUTH VIOLENCE," passed Second Reading and was referred to the Committee on Finance, with Representative McDermott voting no.

Representative Morikawa, for the Committee on Human Services, presented a report (Stand. Com. Rep. No. 71) recommending that H.B. No. 938, as amended in HD 1, pass Second Reading and be referred to the Committee on Finance.

On motion by Representative Saiki, seconded by Representative Evans and carried, the report of the Committee was adopted and H.B. No. 938, HD 1, entitled: "A BILL FOR AN ACT MAKING AN EMERGENCY APPROPRIATION FOR GENERAL ASSISTANCE," passed Second Reading and was referred to the Committee on Finance.

Representative Brower, for the Committee on Tourism, presented a report (Stand. Com. Rep. No. 72) recommending that H.B. No. 825, as amended in HD 1, pass Second Reading and be referred to the Committee on Consumer Protection & Commerce.

Representative Saiki moved that the report of the Committee be adopted, and that H.B. No. 825, HD 1 pass Second Reading and be referred to the Committee on Consumer Protection & Commerce, seconded by Representative Evans.

Representative McKelvey rose to speak in support of the measure with reservations, stating:

"With very serious reservations on this measure, Mr. Speaker. I just want to at least alert the Members, to bifurcate responsibility of this matter between the counties and the DCCA is very problematic and because DCCA is a special funded fee-generated program, you would be looking at possible double taxation. There's a lot of issues with this bill, so I would just like to note my serious reservations. Thank you."

Representative McDermott rose to speak in support of the measure with reservations, stating:

"Mr. Speaker, same measure, please. I'd like to echo the comments of the previous speaker. Reservations, grave reservations. Thank you."

Representative Jordan rose to speak in support of the measure with reservations, stating:

"Mr. Speaker, along with the Chair of the CPC Committee, I would like to record my reservations on this measure, please."

Representative Har rose in support of the measure with reservations and asked that the remarks of Representative McKelvey be entered into the Journal as her own, and the Chair "so ordered." (By reference only.)

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 825, HD 1, entitled: "A BILL FOR AN ACT RELATING TO TRANSIENT ACCOMMODATIONS," passed Second Reading and was referred to the Committee on Consumer Protection & Commerce, with Representatives Har, Jordan, McDermott and McKelvey voting aye with reservations.

Representative Tsuji, for the Committee on Agriculture, presented a report (Stand. Com. Rep. No. 73) recommending that H.B. No. 870, as amended in HD 1, pass Second Reading and be referred to the Committee on Higher Education.

On motion by Representative Saiki, seconded by Representative Evans and carried, the report of the Committee was adopted and H.B. No. 870, HD 1, entitled: "A BILL FOR AN ACT RELATING TO FOOD," passed Second Reading and was referred to the Committee on Higher Education.

Representative Tsuji, for the Committee on Agriculture, presented a report (Stand. Com. Rep. No. 74) recommending that H.B. No. 504, as

amended in HD 1, pass Second Reading and be referred to the Committee on Higher Education.

Representative Saiki moved that the report of the Committee be adopted, and that H.B. No. 504, HD 1 pass Second Reading and be referred to the Committee on Higher Education, seconded by Representative Evans.

Representative McDermott rose to speak in opposition to the measure, stating:

"Mr. Speaker, I'd like to cast a no vote and just note that this is a fee increase of 1,240%. Thank you."

Representative Ward rose to speak in support of the measure, stating:

"Mr. Speaker, I have reservations about this bill, but I'm going to call it a caveat. Because it's a good bill, but it's going to hurt the small guy. And from the small business point of view, the small guy is the one that really makes the baseline of our micro economy here in Hawaii. As the previous speaker said, it's a 12-fold increase. To get a license to do pesticide, it used to be \$25 a year, now it's a total of \$310 a year. Mr. Speaker, that's a pretty steep climb over just one short period. For those reasons, that's my caveat. Not reservations."

Representative Tupola rose to speak in support of the measure with reservations, stating:

"Thank you, Mr. Speaker. Please note my reservations on this bill. I'm also concerned that there was no testimony submitted from small businesses, and so we want to know, I want to know, how it's going to affect them and what their stance is on a 1,240% increase on all pesticide licenses. Thank you."

Representative Matsumoto rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Tokioka rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Jordan rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. In support. Although this measure says 2050, I think this is something we should start looking at, especially for communities like mine, where we've got individuals that run pesticides out of the back of a truck with no safety inspection, no licensing, and mix whatever they want, and then the Department of Health comes out and says that crop is no good. So I think we should support these measures to make sure we can have that enforcement for our small farmers out there. Thank you, Mr. Speaker."

Representative Fukumoto Chang rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Pouha rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 504, HD 1, entitled: "A BILL FOR AN ACT RELATING TO PESTICIDES," passed Second Reading and was referred to the Committee on Higher Education, with Representatives Fukumoto Chang, Matsumoto, Pouha, Tokioka and Tupola voting aye with reservations, and with Representative McDermott voting no.

Representative Tsuji, for the Committee on Agriculture, presented a report (Stand. Com. Rep. No. 75) recommending that H.B. No. 850, as amended in HD 1, pass Second Reading and be referred to the Committee on Higher Education.

"Mr. Speaker, please note my reservations on this measure. Mr. Speaker, although I support my local agriculture and possibly the fee reduction through my harbors, we also must recognize that \$57.5 million comes through my harbors, of which \$11.5 million goes to OHA for the committed requirement that we give to them for our public land monies. So with that, Mr. Speaker, I'm open to seeing the further discussion on this and I think we should take some of the comments from the Department of Transportation as this bill moves forward. Thank you very much, Mr. Speaker."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. Representative Tupola rose to speak in opposition to the measure, stating:

"Thank you, Mr. Speaker. I wanted to make comments about this bill and also cast a no vote. House Bill 1349 is changing the licensure for charter school teachers. So currently right now for a charter school teacher to go into the DOE, they do a probationary period of a year, if they were tenured.

"So this is talking about non-tenure teachers going into the DOE system from charter schools, and that it would be as if they were at the same level as somebody coming straight out of college. So the years that they taught at the charter school then wouldn't count towards their tenure at the DOE, which for some people it might be reasonable, but as a prior charter school teacher I believe that the years that you teach at the charter school should count towards the tenure and that we can make that ruling, so that charter schools can be treated equally to DOE schools instead of treating them as less than, possibly because they came from that school and weren't as certified. Because they also have to go through certification and accreditation programs, and I think that that should be taken into consideration before we decide that the ruling from charter to DOE will be different than from DOE to charter. Thank you very much."

Representative McDermott rose to speak in opposition to the measure, stating:

"A no vote, Mr. Speaker. It seems like we're creating two classes of teachers here, one we value, regular DOE teachers, more than charter school teachers. That's what it seems like to me, so a no vote, sir."

Representative LoPresti rose to disclose a potential conflict of interest, stating:

"Mr. Speaker, I ask for a ruling on a potential conflict of interest. My wife is a DOE teacher and also an HSTA member, and they offered testimony on this," and the Chair ruled, "no conflict."

Representative LoPresti continued, stating:

"Will that ruling stand for the remainder of the session, sir? Will this ruling apply to the remainder of the session on teacher issues, DOE teacher issues," and the Chair "so ordered."

Representative Kawakami rose, stating:

"Mr. Speaker, same request as the previous speaker," and the Chair "so ordered."

Representative Ito rose to disclose a potential conflict of interest, stating:

"Mr. Speaker, ruling on a potential conflict of interest. My daughter works for the teacher's union," and the Chair ruled, "no conflict."

Representative Ito continued, stating:

"Can the ruling also apply to me, as the Rep from Ewa Beach? I want the same deal as the Representative from Ewa and the Representative from Salt Lake."

The Chair then stated:

"Thank you very much."

Representative Takumi rose to speak in support of the measure, stating:

"Thank you very much, Mr. Speaker. Speaking in support of the bill. Normally I don't speak on Second Reading because this bill has a long way to go. In fact, the bill will be going to your Committee on Education

where we expect to have another discussion on this issue. But I wanted to correct some misassumptions about the bill.

"The bill in fact tries to correct the current inequity between charter school teachers and regular DOE teachers. For some reason, the previous speakers thought it would create an inequity. This is to correct that inequity.

"Here's the inequity, Mr. Speaker. Two teachers, both graduated, for argument's sake, from the College of Education at the University of Hawaii. One enters a public, regular public elementary school, Royal Elementary School, right up the street. Another teacher enters a charter school, Voyager Charter School. The teacher who enters Royal Elementary School has to serve on a probationary basis for three years before she can get tenure. The teacher at the charter school also has to serve three years at that charter school in order to get tenure.

"Herein lies the inequity in the current statute. If that teacher at that charter school after six months decides he doesn't really care to work at a charter school, transfers to a regular department school, he will only have to teach for another year, so a total of a year and a half, before he will be eligible for tenure.

"What this bill attempts to do is to say, the board, the department and the collective bargaining unit, in this case the HSTA, will sit down and come out with an agreement, which I think will be something like this. If that charter school teacher after teaching for six months in a charter school transfers to a regular public school, he will have to then teach on a probationary basis for an additional two and a half years. In other words, Mr. Speaker, both that charter school teacher and that regular DOE teacher will both have to teach on a probationary basis for three years.

"Mr. Speaker, we do want the charter schools to have the kind of flexibility and autonomy to flourish, because that was the original intent of charter schools. However, Mr. Speaker, I do believe there is a compelling state interest to ensure our children are all taught by teachers who underwent the same probationary period. Thank you very much."

Representative Pouha rose to speak in support of the measure with reservations, stating:

"Mr. Speaker, I rise with reservations. Being a former charter school teacher as well, I no longer am one, but my concern is that not every nuance of the situation is fully vetted yet, so my reservations are there."

Representative Ward rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 1349, entitled: "A BILL FOR AN ACT RELATING TO TEACHER TENURE," passed Second Reading and was referred to the Committee on Education, with Representatives Pouha and Ward voting aye with reservations, and with Representatives McDermott and Tupola voting no.

"I request a ruling on a potential conflict. I have a son that may benefit from this bill. Thank you," and the Chair ruled, "no conflict."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 174, HD 1, entitled: "A BILL FOR AN ACT RELATING TO HEALTH," passed Second Reading and was referred to the Committee on Consumer Protection & Commerce.

Representative Belatti, for the Committee on Health, presented a report (Stand. Com. Rep. No. 117) recommending that H.B. No. 576, as amended in HD 1, pass Second Reading and be referred to the Committee on Consumer Protection & Commerce.

On motion by Representative Saiki, seconded by Representative Evans and carried, the report of the Committee was adopted and H.B.
