HAWAIIAN WORD FOR THE DAY**

Representative McKelvey rose to speak in support of the measure with reservations, stating:

"Mr. Speaker, thank you very much. Just with serious reservations on this measure. Besides other concerns, I think there's a major nexus issue with this bill. Thank you very much."

Representative McDermott rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

Representative Onishi rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Matsumoto rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Ward rose to speak in opposition to the measure, stating:

"Mr. Speaker, I rise in opposition with a comment. Mr. Speaker, this asks for a 5% fee on the small guys that run these activity desks who then graduate into bigger things in the visitor industry. There's a few big boys in there, but to add 5% is to hurt the small guys, and I think with the process of the visitor industry, this is not healthy, it's not something that we need to increase the cost of visiting Hawaii. And for those reasons, Mr. Speaker, I vote no. Thank you."

Representative Fukumoto Chang rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Tupola rose to speak in opposition to the measure, stating:

"Thank you, Mr. Speaker. A no vote for me, too. I can't support a 5% increase for the activity desk. Thank you."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 1387, HD 1, entitled: "A BILL FOR AN ACT RELATING TO CONSERVATION AND RESOURCES," passed Second Reading and was referred to the Committee on Water & Land, with Representatives Fukumoto Chang, Matsumoto, McKelvey and Onishi voting aye with reservations, with Representatives McDermott, Tupola and Ward voting no, and with Representative Takumi being excused.

Representative Aquino, for the Committee on Transportation, presented a report (Stand. Com. Rep. No. 203) recommending that H.B. No. 1154 pass Second Reading and be referred to the Committee on Human Services.

Representative Saiki moved that the report of the Committee be adopted, and that H.B. No. 1154 pass Second Reading and be referred to the Committee on Human Services, seconded by Representative Evans.

Representative McDermott rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

Representative Fukumoto Chang rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

Representative Ward rose to speak in opposition to the measure, stating:

"Mr. Speaker, no vote, brief comment. Mr. Speaker, this adds insult to injury, and I'm going to call it 'middle class killer biller number one.' We have just increased the registration fee, the weight tax, and I think all of our constituents are a bit upset with the sticker shock that basically doubled what we pay to drive our vehicles.

"This adds \$1 for a great cause, it goes to the Disability Office, but if they are shortchanged, let us give them an appropriation. Let us give them their due. We should not be adding another insult to injury by putting another dollar on what otherwise is already an excessive fee. And if you recall some of the bills that were introduced, the Minority Caucus introduced a repeal or pulling back on those increases for the sake of the people of Hawaii that are just having too high of a cost of living, Mr. Speaker. So this is 'middle class killer biller number one.' Thank you."

Representative Tupola rose to speak in opposition to the measure, stating:

"Thank you, Mr. Speaker. A no vote for me and a comment. When I sat through the hearing, the Disability Office said that they were having a hard time maintaining it, and I have confidence that maybe between them and DOT they could work it out, but I can't support even one more dollar on the car registration fee that's really high right now. Thank you."

Representative Matsumoto rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 1154, entitled: "A BILL FOR AN ACT RELATING TO FUNDING FOR PARKING FOR DISABLED PERSONS," passed Second Reading and was referred to the Committee on Human Services, with Representative Matsumoto voting aye with reservations, with Representatives Fukumoto Chang, McDermott, Tupola and Ward voting no, and with Representative Takumi being excused.

Representative Kong rose to disclose a potential conflict of interest, stating:

"Mr. Speaker, ruling on a potential conflict of interest. I own a taxi company," and the Chair ruled, "no conflict."

Representative Tupola rose to speak in support of the measure with reservations, stating:

"Thank you, Mr. Speaker. Can you please note down my reservations. I do think Uber is a great idea, but I do think that the bill could be worked so that it could be fair for taxi drivers and for the Uber people. Thank you."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 270, HD 1, entitled: "A BILL FOR AN ACT RELATING TO THE RESIDENTIAL LANDLORD-TENANT CODE," passed Second Reading and was referred to the Committee on Judiciary, with Representative Takumi being excused.

Representative McKelvey, for the Committee on Consumer Protection & Commerce, presented a report (Stand. Com. Rep. No. 224) recommending that H.B. No. 281, as amended in HD 1, pass Second Reading and be referred to the Committee on Finance.

On motion by Representative Saiki, seconded by Representative Evans and carried, the report of the Committee was adopted and H.B. No. 281, HD 1, entitled: "A BILL FOR AN ACT RELATING TO INSURANCE," passed Second Reading and was referred to the Committee on Finance, with Representative Takumi being excused.

Representative McKelvey, for the Committee on Consumer Protection & Commerce, presented a report (Stand. Com. Rep. No. 225) recommending that H.B. No. 348, as amended in HD 1, pass Second Reading and be referred to the Committee on Judiciary.

On motion by Representative Saiki, seconded by Representative Evans and carried, the report of the Committee was adopted and H.B. No. 348, HD 1, entitled: "A BILL FOR AN ACT RELATING TO POWDERED ALCOHOL," passed Second Reading and was referred to the Committee on Judiciary, with Representative Takumi being excused.

Representative McKelvey, for the Committee on Consumer Protection & Commerce, presented a report (Stand. Com. Rep. No. 226) recommending that H.B. No. 925 pass Second Reading and be referred to the Committee on Finance.

On motion by Representative Saiki, seconded by Representative Evans and carried, the report of the Committee was adopted and H.B. No. 925, entitled: "A BILL FOR AN ACT RELATING TO INSURANCE," passed Second Reading and was referred to the Committee on Finance, with Representative Takumi being excused.

Representative Choy, for the Committee on Higher Education, presented a report (Stand. Com. Rep. No. 227) recommending that H.B. No. 451, as amended in HD 1, pass Second Reading and be referred to the Committee on Judiciary.

Representative Saiki moved that the report of the Committee be adopted, and that H.B. No. 451, HD 1 pass Second Reading and be referred to the Committee on Judiciary, seconded by Representative Evans.

Representative McDermott rose to speak in support of the measure with reservations, stating:

"Mr. Speaker, I stand in support with some reservations on this measure. First, I'd like permission to insert comments in the Journal. Again, I stand in support. I'd like to see it amended where anybody convicted of drugging a woman or assaulting her or taking advantage of her while she's unconscious, I would support chemical castration for that. If you don't think that's a deterrent, try telling a 24-year-old guy he's not going to have sex for the next five years. I think they'll certainly think twice.

"But as a father of two daughters, this is a very serious issue. They're entering this age where they're going to go to school. So the intent is well supported, Mr. Speaker, but it is problematic. The affirmed consent, I'm not sure what that is. I've read the bill. Short of exchanging permission slips, I'm not sure what that is.

"I think the bill misses the mark in the sense that it talks about treatment, sex education counseling, *et cetera, et cetera*, but the cause of this, Mr. Speaker, is booze and drugs. It's young people going out, drinking, getting stoned, partying, going out to the clubs, and losing control of their senses. Then they put themselves in positions to be victimized, and there are predators out there. I think one step that I'd be happy to work with the Health Chair is, on every sex ed program you have a predator protection module. We don't right now, not every one of them does. The good ones do, or some of them do. So I think protecting yourself against predators.

"The problem, Mr. Speaker, is that alcohol and drugs are always involved in these situations, all the time. And I don't think this measure pays enough attention to that. The underlying use of drugs and alcohol. If I had four drinks and took a couple tokes on a doobie, that affects me one way. A 90 pound girl does it, it totally affects her a different way.

"And then I'm not a lawyer so I could stand to be corrected on that, but it says, 'evidentiary standard of a preponderance of the evidence.' That seems

to be a lower standard of evidence, Mr. Speaker, for a criminal offense. But I'm not an attorney, so I don't know for sure.

"So I support the intent of this, but it seems rather restrictive in the sense that I don't know what affirmative consent is, reading it. And again, I go back to booze and drugs. That's what causes this, Mr. Speaker, all the time. I tell my own kids, if you're out somewhere at 2:00 in the morning with booze and drugs, nothing ever ever good happens. And we all have responsibilities for putting ourselves in positions where we could get in trouble. Don't drink and drive.

"So I think an education program about the dangers of booze and drugs, more focus on that, then you don't have these problems where people are taken advantage of. Thank you, sir."

Representative McDermott's written remarks are as follows:

"One rape is too many. No reasonable person wants any woman to suffer from sexual assault. We should devote more resources to prosecuting and policing against sexual assault. However, I do have additional concerns about this bill.

"*The Honolulu Star-Advertiser*, in an editorial dated February 13, 2015, made this observation about the current affirmative consent bills in the Legislature: 'Most problematic is the vague definition of what constitutes "affirmative consent." The bills never define it—they only say what it isn't.'

"Further, the bill finds that proving a case by a 'preponderance of the evidence' standard is sufficient to determine that an accused person has acted wrongfully. I would note that a finding of sexual assault misconduct could lead to the expulsion of the accused. An expulsion from one university will likely mean that the accused student will never again be able to attend another university. Given the possibility of such a scenario, universities used to employ a 'clear and convincing evidence' standard, which is a higher burden of proof. I'm not sure that it is a good idea to mandate the use of a lower standard.

"The lack of a definition of 'affirmative consent' and the implementation of a 'preponderance of the evidence' standard could diminish the due process rights of the accused. In times of crisis, it is not uncommon for policymakers to chip away at liberties for the sake of security. The bill essentially presents the argument that we are in a time of crisis—that is, that one out of every five female students is sexually assaulted while she is in college. Thus—the argument goes—drastic changes are needed for the safety and security of the women in the University of Hawaii system.

"But is that statistic true? The bill does not name a source for the one-in-five figure. The U.S. Department of Justice, however, in December of last year, released a report entitled *Rape and Sexual Assault Victimization Among College-Age Females, 1995–2013*. The data showed that among female students aged 18-24, the combined percentage of women who were victims of completed rape, attempted rape, sexual assault, or threat of rape or sexual assault was about 0.61% per year. If we do the math, this means that among women of that age who will attend college for four years, one out of forty-one will be sexually assaulted.

"The same DOJ report also showed that female college students aged 18-24 were about 16% less likely than non-college women of the same age group to be victims of rape or sexual assault. So on average, a university campus is actually safer than most other locations.

"Again, one rape is too many. So I do so support this bill, albeit with reservations. Since this is a work in progress, I look forward to a continued dialogue as the measure's language is amended."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 451, HD 1, entitled: "A BILL FOR AN ACT RELATING TO AFFIRMATIVE CONSENT," passed Second Reading and was referred to the Committee on Judiciary, with Representative McDermott voting aye with reservations, and with Representative Takumi being excused.

Representative Belatti, for the Committee on Health, presented a report (Stand. Com. Rep. No. 228) recommending that H.B. No. 1108, as amended in HD 1, pass Second Reading and be referred to the Committee on Consumer Protection & Commerce.

Representative McDermott rose to speak in support of the measure, stating:

"Mr. Speaker, I support the Health Chair with enthusiasm on this measure. She has done a fantastic job for the last several years being the clarion call voice in the wilderness trying to help these young kids, and I salute her for it. Thank you, sir."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 1108, HD 1, entitled: "A BILL FOR AN ACT RELATING TO HEALTH," passed Second Reading and was referred to the Committee on Consumer Protection & Commerce, with Representative Takumi being excused.

Representative Belatti, for the Committee on Health, presented a report (Stand. Com. Rep. No. 229) recommending that H.B. No. 726, as amended in HD 1, pass Second Reading and be referred to the Committee on Consumer Protection & Commerce.

Representative Aquino's written remarks are as follows:

"Mr. Speaker, with reservations on HB 1455, HD1. My reservations on this measure stems mainly from the policy change of increasing the patient to caregiver ratio from one-to-one to three-to-one.

"Mr. Speaker, I believe that any increase would create the possibility of mismanagement or distribution where it is not permitted. This concerns me since there are still ongoing discussions on dispensaries for safer access. Thank you."

Representative Cachola rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Belatti rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. In support with just a few brief comments. Mr. Speaker, I feel the need to stand up on this measure just to illuminate for individuals who might have reservations and opposition. The thing that you might be opposing is actually a very pro law enforcement bill. When you look at this measure and there's a limitation of the number of plants that can be on any single tax map key number. This measure, this provision, is designed to stop the very thing that many of us are afraid of, which is the proliferation of marijuana grower operations within our residential communities.

"Mr. Speaker, as an example, in April 2012, then Honolulu Police Department officer Michael Chu was arrested and charged by the federal government for, among other things, possession of between 10 to 20 marijuana plants that were found at this Mililani residence. His Mililani residential home. In August 2012 he pleaded guilty before a federal court to conspiring to cultivate 48 plants, and to possess with intent to distribute 49 pounds of processed marijuana. This measure shuts that down.

"We have heard in the multitude of testimony on medical marijuana, the police officers have a difficult time determining when they find plants

whether or not they're medical marijuana plants and whether or not the three or four patients entitle that house to have 4 times 7, 28 plants in a home. Well what this measure does is say, there will be only 14 plants on a tax map key. Now this measure is not going to make us popular among the advocates, but I hope it might make us popular amongst the law enforcement to whom we are providing a tool.

"Mr. Speaker, this is also possible because I want to commend the work of the Department of Health, who in one and one-half years' time, when the program was transitioned to them, they are now contemplating a system where they can tag each plant belonging to a medical marijuana patient. The Department of Health, in one and one-half years' time, has built up and is contemplating rules to do that to make this enforcement piece possible. So I just want to make sure that our Members know what they might be opposing, and what they might have reservations about. Thank you, Mr. Speaker."

Representative Fukumoto Chang rose in support of the measure and asked that the remarks of Representative Belatti be entered into the Journal as her own, and the Chair "so ordered." (By reference only.)

Representative Thielen rose in support of the measure and asked that the remarks of Representative Belatti be entered into the Journal as her own, and the Chair "so ordered." (By reference only.)

Representative Yamane rose to speak in support of the measure with reservations, stating:

In Puna, we have huge acreage, and people are poor, and people have multiple medical marijuana certificates living in the same area. Fourteen plants, which is really two certificates, prevents other medical marijuana holders from being in the same home, even if the acreage may be 20 acres or more. So to limit it to a TMK is extraordinarily difficult for us in Puna. Thank you."
