Thursday, April 9, 2015

The House of Representatives of the Twenty-Eighth Legislature of the State of Hawaii, Regular Session of 2015, convened at 12:08 o'clock p.m., with Speaker Souki presiding.

The invocation was delivered by Speaker Joseph M. Souki, after which the Roll was called showing all Members present with the exception of Representatives LoPresti, Tokioka and Ward, who were excused.

S.B. No. 211, SD 1, HD 1:

On motion by Representative Saiki, seconded by Representative Evans and carried, S.B. No. 211, SD 1, HD 1, entitled: "A BILL FOR AN ACT

RELATING TO FORENSIC IDENTIFICATION," passed Third Reading by a vote of 50 ayes, with Representative Tokioka being excused.

S.B. No. 214, SD 1, HD 1:

Representative Saiki moved that S.B. No. 214, SD 1, HD 1 pass Third Reading, seconded by Representative Evans.

Representative Thielen rose to speak in opposition to the measure, stating:

"Thank you, Mr. Speaker. I'm rising to speak against the bill and I'd like to explain why. Thank you, Mr. Speaker. The bill is establishing exclusive jurisdiction in the small claims division over cases in which the amount in controversy is \$1,000 or less, and with personal property the ceiling is up to \$5,000. It has an unintended consequence, I believe. By reducing the filing fee to \$35 in the small claims court from the regular claims filing fee, which is \$155, the State will automatically lose, according to the testimony from the Hawaii State Bar Association, the amount of \$471,240.

"Now, the problem is that the impact will be on the organizations serving indigents, and it will be a \$194,040 impact of less money, and that is because the State uses the indigent surcharge fee to fund those nonprofit organizations. And then in addition to that, last year the regular claims court adjudicated approximately 5,544 cases. Now all those cases are going to be forwarded to the small claims court division, which at this point in time, the State hasn't budgeted additional funds to support the new demand of cases. And also because the pro-bono organizations, the non-profit organizations, will be receiving less money to provide services for those in need such as human traffic victims, indigents, victims of sexual abuse, it's likely that they'll come to the Legislature next year asking for additional funds to run those support services.

"So it's an unfortunate impact, and I'm not sure it's been thought through clearly enough or provided for in the budget. I note that it's a House draft, so it looks as if there'll be a conference committee, and I would ask that the conference committee would look at the impact upon those pro-bono services that we rely upon so heavily to serve people in need. Thank you."

Representative Rhoads rose to speak in support of the measure, stating:

"In support. Just a quick note to add that there probably will be some monetary loss to the government, but for the service providers there'll also be quite a bit of gain because the procedures in small claims division are much simpler, there are no appeals, and if they have to go in and defend clients in that situation they're not going to spend as much time or money, and I think that's probably one reason that none of them testified against the bill. *Mahalo.*"

Representative San Buenaventura rose to speak in support of the measure, stating:

"In strong support. As a volunteer in self-help service centers in Hilo and in Puna, I see that the working poor, a lot of the working people who can't afford lawyers as well as those who cannot qualify for public defender or legal aide work, need access to justice. This allows them access to justice. And I'm sorry that some funds may be cut, but the access to justice issue, to me, supersedes that whatever funds is going to be for the indigent, because the working poor need help. Thank you."

The motion was put to vote by the Chair and carried, and S.B. No. 214, SD 1, HD 1, entitled: "A BILL FOR AN ACT RELATING TO THE SMALL CLAIMS DIVISION OF THE DISTRICT COURT," passed Third Reading by a vote of 49 ayes to 1 no, with Representative Thielen voting no, and with Representative Tokioka being excused.

S.B. No. 223, SD 1, HD 1:

On motion by Representative Saiki, seconded by Representative Evans and carried, S.B. No. 223, SD 1, HD 1, entitled: "A BILL FOR AN ACT RELATING TO THE OFFICE OF THE PUBLIC GUARDIAN," passed Third Reading by a vote of 50 ayes, with Representative Tokioka being excused.

S.B. No. 218, SD 1, HD 1:

On motion by Representative Saiki, seconded by Representative Evans and carried, S.B. No. 218, SD 1, HD 1, entitled: "A BILL FOR AN ACT RELATING TO ORDER OF SUCCESSION," passed Third Reading by a vote of 49 ayes to 1 no, with Representative Har voting no, and with Representative Tokioka being excused.

S.B. No. 1219, SD 2, HD 1:

On motion by Representative Saiki, seconded by Representative Evans and carried, S.B. No. 1219, SD 2, HD 1, entitled: "A BILL FOR AN ACT RELATING TO EMPLOYMENT SECURITY," passed Third Reading by a vote of 50 ayes, with Representative Tokioka being excused.

S.B. No. 419, SD 2, HD 1:

Representative Saiki moved that S.B. No. 419, SD 2, HD 1 pass Third Reading, seconded by Representative Evans.

Representative Jordan rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Ward rose to speak in support of the measure, stating:

"Mr. Speaker, I rise in support of the measure. Mr. Speaker, this bill gives a bit of transparency to the influence that neighborhood boards have. It allows them, if you will, to go to meetings, to become informed of what's going on in their community without having a sunshine law breach. I know that this is something unusual, but until we give them power to do something, they're only advisory and we are curtailing their advisory role by saying, hey, you can't have more than so many people at certain meetings lest you become offensive to the sunshine law.

"So, Mr. Speaker, I know that a good share, if not a majority of the Oahu Representatives on this Floor, cut their teeth at their neighborhood board. So I think we all know personally and have experienced this, even though the implementation of it has only been more recent more stringent. So for those reasons, Mr. Speaker, until we give the neighborhood boards power rather than just advisory kind of roles, I think we've got to relax, as this bill indicates, the way that we stringently restrict their participation in community events. Thank you, Mr. Speaker."

Representative Har rose to speak in support of the measure with reservations, stating:

"Thank you, Mr. Speaker. Please note my reservations and just brief comments. Thank you, Mr. Speaker. Based on the testimony of the League of Women Voters, the Civil Beat Law Center for the Public Interest, and in particular there was testimony from two neighborhood board commissioners, one was a gentleman by the name of Charles Zahn, who is a dear friend of mine, who is also a commissioner and a former Kapolei neighborhood board member who passed away yesterday, who was in opposition. For those reasons, I'm with reservations. Thank you."

The motion was put to vote by the Chair and carried, and S.B. No. 419, SD 2, HD 1, entitled: "A BILL FOR AN ACT RELATING TO NEIGHBORHOOD BOARDS," passed Third Reading by a vote of 49 ayes to 1 no, with Representatives Har and Jordan voting aye with reservations, with Representative Fukumoto Chang voting no, and with Representative Tokioka being excused.
