On motion by Representative Saiki, seconded by Representative Evans and carried, S.B. No. 1156, SD 1, HD 1, entitled: "A BILL FOR AN ACT RELATING TO STATUTORY REVISION: AMENDING OR REPEALING VARIOUS PROVISIONS OF THE HAWAII REVISED STATUTES AND THE SESSION LAWS OF HAWAII FOR THE PURPOSES OF CORRECTING ERRORS AND REFERENCES, CLARIFYING LANGUAGE, AND DELETING OBSOLETE OR UNNECESSARY PROVISIONS," passed Third Reading by a vote of 46 ayes, with Representatives LoPresti, McKelvey, Oshiro, Say and Tokioka being excused.

S.B. No. 569, SD 1, HD 1:

Representative Saiki moved that S.B. No. 569, SD 1, HD 1 pass Third Reading, seconded by Representative Evans.

Representative Kawakami rose in opposition to the measure and asked that his written remarks be inserted in the Journal, and the Chair "so ordered."

Representative Kawakami's written remarks are as follows:

"Mr. Speaker, when thieves are ripping off people, they are not worried about how many sacrifices those families had to make. They are not worried about how many hours those families had to work. They are not worried about the ripple effect of how many more sacrifices and how many more hours at work those families have to endure just to get back to where they were before they were victims. Why are we giving so much thought to making it easier for thieves to do what they do, which is put families in harm's way, steal, and create hardship?"

Representative Keohokalole rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Johanson rose in support of the measure with reservations and asked that his written remarks be inserted in the Journal, and the Chair "so ordered."

Representative Johanson's written remarks are as follows:

"I rise in support with reservations on SB 569, SD 1, HD 1, a measure relating to theft.

"I agree with the bill's intent to increase the minimum threshold value of stolen property or services for the offense of theft in the second degree from \$300 to \$750. This threshold has not been adjusted in 30 years, and the increase will align Hawaii with other jurisdictions across the nation as well as more appropriately place the offense within context of other crimes and their commensurate punishments.

"However, I do have concerns about the 2% automatic annual increase of the threshold amount. I worry that the annual adjustment will increase the penalty threshold beyond a reasonable amount necessary to deter the crime of theft. In continuing to raise the threshold automatically, we potentially risk diminishing the consequences of the crime and in so doing, risk protecting the public and its safety."

Representative Ward rose to speak in opposition to the measure, stating:

"Mr. Speaker, opposition, brief comments. Mr. Speaker, this is the shoplifter's dream card. It allows the CPI to keep every year 2% increase the amount of goods that they can steal. Why do we want to do this? I would ask anyone who knows exactly other than, well I think it says that it's going to take a threshold, which means that it would be less crowding of the courts.

"Mr. Speaker, well the ideal is to get rid of theft rather than encourage it and put an inflation. I mean there's some people who are on fixed incomes who would love to see a CPI for their pensions and CPI for other sources, but we're doing it here to benefit what otherwise is illegal behavior. I just don't get the logic and what we're intending to do and what the unintended consequences are of this if it perpetually gets 2% per year. Thank you, Mr. Speaker."

Representative Rhoads rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. In support. I'll just say that first of all, there's a separate statute that deals with shoplifting that this bill doesn't affect. We did check with the Honolulu Prosecutor's Office about how they charge shoplifting, and they said that they either use the shoplifting statute or they use the theft in the 4th degree, which this bill also does not affect.

"But the deeper question is, does it make sense to put somebody in jail for usually if you get a class C, a class C felony has a maximum of five years. Usually they don't get five years, it's usually more like a year and a half or two. But for each year of incarceration, it cost tens of thousands of dollars. I don't have the number off the top of my head, but at a minimum it's \$30,000. So currently if you steal \$301 worth of stuff, society will pay approximately at a minimum \$45,000 to keep that person incarcerated.

"So there is a balancing act here, and that's what we're trying to achieve, but no adjustment has been made since 1986. Thank you."

Representative Ward rose to respond, stating:

"Mr. Speaker, I would therefore, if I was in the amendment mood, I'd say let's lift it to \$1,000 and we could save \$4.5 million every year if we just raised it to where no one would get prosecuted. If the intent is to save money or to keep society as a rule of law, if you will, I think we're mixing the savings of money with actually protecting of vendors as well as the public from theft. For those reasons, Mr. Speaker, I think it's not a good policy. Thank you."

Representative Rhoads rose to respond, stating:

"Mr. Speaker, in support. It's still illegal to steal less than that amount, it's just not a felony, it's a misdemeanor, which can still put you in jail. I'm not arguing that this unclogs the court system at all, it won't, because people will still be charged. It's just whether it's worth \$45,000 or \$30,000 a year to keep someone in prison for stealing \$301. Like I said, it is a balance and people will differ on where that balance should be. But there are serious considerations here. Thanks."

Representative Tupola rose to speak in opposition to the measure, stating:

"Thank you, Mr. Speaker. In opposition. I think also on a different note is that it's also there's a sliding scale, so it's going to increase for inflation, I guess. So the ability to implement this for the HPD is going to get harder and harder because every year it's going to change if the threshold will change. So there's other concerns beside just the ones presented. Thank you."

The motion was put to vote by the Chair and carried, and S.B. No. 569, SD 1, HD 1, entitled: "A BILL FOR AN ACT RELATING TO THEFT," passed Third Reading by a vote of 31 ayes to 15 noes, with Representatives Johanson and Keohokalole voting aye with reservations, with Representatives Aquino, Choy, Cullen, DeCoite, Fukumoto Chang, Har, Kawakami, Kong, Matsumoto, McDermott, Pouha, Thielen, Tupola,

Ward and Yamane voting no, and with Representatives LoPresti, McKelvey, Oshiro, Say and Tokioka being excused.
