Representative LoPresti's written remarks are as follows:

"It's time sensitive and essential to do this study in order to determine solutions to save what little now remains of a once abundant *limu* and reef fish resource. *Limu* is important to the near shore marine environment as well as important to the native Hawaiian culture. *Limu* was once a significant part of the native Hawaiian diet providing much of the nutrients necessary for a strong and healthy body. *Limu* was used for medicine as well as being used in many cultural and religious practices.

"In July 2014, the then Governor, Mayors and legislators launched the Aloha+ Challenge, a series of targets for the State to reach in various sectors of sustainability, renewable energy and natural resource management, with local food and natural resource management being two of the benchmarks. This bill walks the talk of the Aloha+ Challenge."

Mr. Speaker, it's not enough to have given them autonomy, but to take the autonomy away in a rather belittling way.

"Mr. Speaker, we pay the big bucks to those people at the University. We would think that we could trust them. But in this bill it shows a total lack of trust. It shows a total lack of confidence in their administration. If

it's a shot across the bow because of the date of its implementation, I think that's well and good. But in terms of a substantive way of speaking from the Legislature, the town and the gown speaking together, I am not convinced that this is the best way to do it. Accountability, yes. But in terms of this micromanaging, no. For those reasons, Mr. Speaker, it's not well-founded. Thank you."

"I would like to express my strong reservations to HB 2235, HD 1, which authorizes the BLNR to transfer the operation, administration, management, and maintenance of Honokohau small boat harbor to a community-based board of Hawaii County, a public-private partnership, or a private organization.

"The Honokohau Harbor sits on and is ceded lands. As a condition of statehood, the State is mandated to hold the lands and income therefrom as a public trust and the most appropriate entity to manage this resource to fulfill this public trust purpose is DLNR. As one individual testifier knowledgeable of the Kaloko-Honokohau area stated, the Honokohau Harbor 'abuts the National Park, DHHL, and ceded lands. It is in a significant cultural and historical area. Private commercial parties simply want to put their own interests first and get money for the taking. Do not give it away.'

"I believe we must uphold the public trust responsibility, and thus have serious reservations with this measure."

"I am also concerned about this measure because of the testimony submitted by the Department of the Corporation Counsel of the City and County of Honolulu who states that 'the government cannot declare itself owner of private property by virtue of a resolution or other legislative act accepting the property when the owner has not gifted it (as evidenced by conveyance of a deed). The willingness of the State to accept a gift does not make the gift so.'

"Again, we must uphold the public trust responsibility, and therefore I have reservations with this measure."

"Mr. Speaker, I rise in opposition with a brief comment. Mr. Speaker, some of you will recall I spoke on second reading. I won't be duplicative, but I thought that this bill might be amended, because it suggests that there is a duplication of housing for the Native Hawaiians.

"Mr. Speaker, I think it distorts the reality, so that's one of the flaws of this bill, because the Native Hawaiians have the least amount of support for housing. Homelessness, DHHL, 27,000 people on the waiting list, et cetera. But the other flaw is that the people who are on the task force, it's missing two key agencies. First is Kamehameha Schools Bishop Estate. I don't see how you're going to talk about housing, or land, or anything of substance of an asset, without bringing them on to this task force. Secondly, the young and bright bushy tailed Hawaiians who know what's going on in all of the legal maze that we have housing, is the Native Hawaiian Legal Corporation. Mr. Speaker, they should also be on that.

"But the good thing about the bill, even though with those flaws, it does suggest that the Nelson decision by the circuit court is embedded in this bill, and that's a good thing, because that suggests the \$28 million that the State should be paying by the court order..."

"Representative, you are not speaking on the substance of the bill. Point of order."

Representative Ward: "Did I stray too much, Mr. Speaker?"

Speaker Souki: "You have strayed."

Representative Ward continued, stating:

"It is in the bill, Mr. Speaker. If you read the bill, it says the Nelson decision. That's all I wanted to say, Mr. Speaker. That's the best thing about the bill. But the other things hopefully will be amended by the Senate. Thank you, sir."

Representative Keohokalole rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. In support. I was going to only submit written comments to this, but in response to the multiple comments on this piece of legislation I felt compelled to speak on the floor. Mr. Speaker, the purpose of this legislation is to identify what duplicative services exist for the Native Hawaiian community in terms of housing, because there should be a lot of duplicative services.

"OHA's mission is to utilize its revenues for the betterment of all individuals of Native Hawaiian ancestry. The Department of Hawaiian Home Lands' mission is to provide homes for Hawaiians of 50% or more Hawaiian ancestry. In addition, we have multiple state agencies that serve the general public whose mission is to provide affordable housing to those who need it.

"We also have tasked multiple agencies with providing services to our homeless population, with the ultimate goal of preparing them to enter public housing or participating in state sponsored or aided affordable housing programs.

"With all of that support, Mr. Speaker, our own agencies have reported to us that the largest single group of homeless in Hawaii are Native Hawaiian families.

"Something is not adding up here, and we all know what it is. The question is, with all of that dedicated support, why do we have a housing problem in the Native Hawaiian community? Why don't we have a bunch of duplicative housing services for the Native Hawaiian community? Why can't we say, we've given so much housing support to the Native Hawaiian community that's not a problem anymore, so let's redirect some of that support to education for Hawaiians, or economic development for Native Hawaiians, or something else.

"The answer is, we don't know the answer to that question. And that is the purpose of this task force. We don't know how many people on the Department of Hawaiian Home Lands wait list are homeless, or waiting for public housing. We don't know how many of their successors or beneficiaries are homeless, or waiting for public housing. We don't know. And we don't know why the agencies don't know. And we don't know why they're not talking to each other. And we don't know why they're not working together.

"And so, if they can't talk to each other, and they can't work together, then we're going to force them to talk to each other, and we're going to force them to work together. To get these people off the streets, or out of their friend's or their family's garages, or out of the shadows and into housing so that we can redirect some of those resources that apparently are supposedly being duplicated amongst agencies to other individuals who need them. Thank you, Mr. Speaker."

Representative Pouha rose in support of the measure and asked that the remarks of Representative Keohokalole be entered into the Journal as his own, and the Chair "so ordered." (By reference only.)

Representative LoPresti rose in support of the measure and asked that the remarks of Representative Keohokalole be entered into the Journal as his own, and the Chair "so ordered." (By reference only.)

Representative McKelvey rose in support of the measure and asked that the remarks of Representative Keohokalole be entered into the Journal as his own, and the Chair "so ordered." (By reference only.)

Representative Ward rose to respond, stating:

"Thank you, Mr. Speaker. I think we are missing the reality of duplicative. If it's duplicative, they would be tripping over each other to get the housing and get the Hawaiians into the housing. The reality is, it's not. So let us not confuse political will with duplication or efficiency. Don't get me wrong. This is good that we're studying it, but the way the thing is worded is that there's so many people doing so many things, we don't know what is going on. And I don't believe that's the case, it's a lack of political will and it's a lack of resources.

"On top of that, if the good gentleman's testimony is true, why is OHA opposed to this bill? Why is DHHL opposed to this bill? The Hawaiians don't want it, because they know what's going on. It's a lack of resources and lack of political will. Mr. Speaker, that's the reality of Hawaiian housing in the State of Hawaii. Unfortunately. Thank you."

Representative Luke rose to speak in support of the measure, stating:

"Mr. Speaker, thank you. Mr. Speaker, in strong support. First of all, I would like to adopt the elegant words of the introducer of this bill. I think during the Finance briefings at the beginning of session it became quite clear that both DHHL and OHA do not speak for the general Native Hawaiians.

"Number one, DHHL continues to deny that people on their wait list are homeless. And one of the things that they need to recognize is they need to figure out who are the people on the wait list and figure out, okay, is there a mechanism to help these folks, and have services come together between OHA, the non-profits and DHHL to provide maximum service. And we can no longer have these types of barriers where it's 50%, 25%, or just Native Hawaiians. I think the Native Hawaiian community needs to come together.

"The last thing is, I don't think the two agencies are the best example, because I think there is a major disagreement on whether DHHL is doing their best to serve the Native Hawaiian community in the public, anyway.

"So this is a start, so this is a strong support for Native Hawaiians. Thank you."

Representative Ing rose to speak in support of the measure, stating:

"Mr. Speaker, just very quickly, in support. I'd like to adopt the words of the speaker from Kaneohe. And I just wanted to say really quickly that I think any bill that is aimed to reduce inefficiencies and duplications in any department should be applauded, especially by our friends across the aisle. We have a department, DHHL, that has a lot of land, not often a lot of money. We have a department, OHA, that often has a lot of money, not a lot of land. We have non-profits that have development capabilities and expertise, and it's about time that we get these people together and figure out how to best put Hawaiians back on their land. Thank you."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 2750, HD 1, entitled: "A BILL FOR AN ACT RELATING TO NATIVE HAWAIIANS," passed Third Reading by a vote of 47 ayes to 1 no, with Representative Ward voting no, and with Representatives DeCoite, Saiki and Tupola being excused.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 807-16) recommending that H.B. No. 1041, HD 2 pass Third Reading.

On motion by Representative Mizuno, seconded by Representative Evans and carried, the report of the Committee was adopted and H.B. No. 1041, HD 2, entitled: "A BILL FOR AN ACT RELATING TO HUNTING," passed Third Reading by a vote of 48 ayes, with Representatives DeCoite, Saiki and Tupola being excused.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 808-16) recommending that H.B. No. 2037, HD 1 pass Third Reading.

On motion by Representative Mizuno, seconded by Representative Evans and carried, the report of the Committee was adopted and

H.B. No. 2037, HD 1, entitled: "A BILL FOR AN ACT RELATING TO THE WORLD CONSERVATION CONGRESS," passed Third Reading by a vote of 48 ayes, with Representatives DeCoite, Saiki and Tupola being excused.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 809-16) recommending that H.B. No. 2617, HD 1 pass Third Reading.

On motion by Representative Mizuno, seconded by Representative Evans and carried, the report of the Committee was adopted and H.B. No. 2617, HD 1, entitled: "A BILL FOR AN ACT RELATING TO LAND USE," passed Third Reading by a vote of 47 ayes to 1 no, with Representative McKelvey voting no, and with Representatives DeCoite, Saiki and Tupola being excused.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 810-16) recommending that H.B. No. 2721, HD 1 pass Third Reading.

On motion by Representative Mizuno, seconded by Representative Evans and carried, the report of the Committee was adopted and H.B. No. 2721, HD 1, entitled: "A BILL FOR AN ACT RELATING TO LIPOA POINT," passed Third Reading by a vote of 48 ayes, with Representatives DeCoite, Saiki and Tupola being excused.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 811-16) recommending that H.B. No. 1683, HD 1 pass Third Reading.

On motion by Representative Mizuno, seconded by Representative Evans and carried, the report of the Committee was adopted and H.B. No. 1683, HD 1, entitled: "A BILL FOR AN ACT RELATING TO FAMILY LEAVE," passed Third Reading by a vote of 48 ayes, with Representatives DeCoite, Saiki and Tupola being excused.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 812-16) recommending that H.B. No. 1940, HD 1 pass Third Reading.

Representative Mizuno moved that the report of the Committee be adopted, and that H.B. No. 1940, HD 1 pass Third Reading, seconded by Representative Evans.

Representative Ward rose to speak in opposition to the measure, stating:

"Thank you, Mr. Speaker. I rise in opposition to this measure. Mr. Speaker, probably 70% of us on this floor are graduates of the University of Hawaii. Probably a lesser degree who were graduate assistants. I know the Representative of District 41 and myself were TAs or graduate assistants.

"What came very clear in the Finance Committee hearing on this measure was that the University, because these are students, Mr. Speaker. They get \$2,000 a month, and they are about to assume the position of either a PhD professor, or some elitist position, or a master's degree.

"Mr. Speaker, why we are organizing that group, it has been brought into question by the administration and I think by this body. And for that reason, with the grievances that they do have, what we need is a more efficient management at the University. We need to be able to handle the grievances, they need to get a management and organizational structure change. Because the grievances are primarily we don't get sick leave or we don't know how to handle when we're sick. Pretty small stuff, Mr. Speaker.

"But I think \$2,000 a month for a student who is doing probably hours, according to their own, other than the professor's hours, for their own time. I think this is going overboard in organizational effort. Thank you, Mr. Speaker."

Representative LoPresti rose to speak in support of the measure, stating:

"Mr. Speaker, in support. I just feel I have to rise, since I was mentioned. I was a grad student, I moved here on Christmas Day in 1999, Mr. Speaker. And I moved here to pursue the PhD at the University of Hawaii at Manoa. And when I got there, Mr. Speaker, the graduate students at UH had been talking about this issue for a long time.

"And there's been long standing grievances with graduate students at that institution and at many institutions across the United States, Mr. Speaker. I believe that this bill will help to give protection, desperately needed protections for this very vulnerable, unique workforce. Because they're not just students, Mr. Speaker, they're workers as well.

"The National Labor Relations Board has given athletes, student athletes, the right to unionize. And yet we recognize, or at least the NCAA tries to put as good a face on it as they can, that these are students first. And yet they can unionize. And yet we stand in the way of allowing very clear employees from unionizing.

"Without graduate students doing the work that they do at the University of Hawaii at Manoa and at other institutions, again, many departments would collapse. They would collapse, because they rely so heavily on the work and the very inexpensive labor that they provide. And I think it's far past time that we move this forward. Thank you, Mr. Speaker."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 1940, HD 1, entitled: "A BILL FOR AN ACT RELATING TO COLLECTIVE BARGAINING," passed Third Reading by a vote of 47 ayes to 1 no, with Representative Ward voting no, and with Representatives DeCoite, Saiki and Tupola being excused.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 813-16) recommending that H.B. No. 2009, HD 1 pass Third Reading.

Representative Mizuno moved that the report of the Committee be adopted, and that H.B. No. 2009, HD 1 pass Third Reading, seconded by Representative Evans.

Representative Ward rose to speak in support of the measure with reservations, stating:

"Mr. Speaker, with reservations. I have a very brief comment, Mr. Speaker. This is about the hoisting machine operators and their organization.

"Basically, what it takes is the executive director, and it puts his staff support into the bureaucracy. I don't have a problem with that except, Mr. Speaker, you remember what happened in New York City in Manhattan when that crane fell over? The people who certified or trained those people which this advisory board is in charge of, if we turn the whole process of accreditation, if you will, over to the bureaucrats, are we going to keep a safe Hawaii?

"Right now the state bird is rising again in Kakaako. We need to know that those places are safe, and I'm not convinced that this is the best way to keep safety in the construction industry. Thank you, Mr. Speaker."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 2009, HD 1, entitled: "A BILL FOR AN ACT RELATING TO HOISTING MACHINE OPERATORS," passed Third Reading by a vote of 45 ayes to 3 noes, with Representative Ward voting aye with reservations, with Representatives Har, Kong and Oshiro voting no, and with Representatives DeCoite, Saiki and Tupola being excused.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 814-16) recommending that H.B. No. 2012, HD 1 pass Third Reading.

Representative Mizuno moved that the report of the Committee be adopted, and that H.B. No. 2012, HD 1 pass Third Reading, seconded by Representative Evans.

Representative Say rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 2012, HD 1, entitled: "A BILL FOR AN ACT RELATING TO COLLECTIVE BARGAINING," passed Third Reading by a vote of 48 ayes, with Representative Say voting aye with reservations, and with Representatives DeCoite, Saiki and Tupola being excused.

"Mr. Speaker, the reason why I am going with strong reservations is that this particular measure is trying to help those individuals on the County of Maui. And the reason why I am going with reservations is because of the effective date, which is 2091.

"So I really don't know what the position of the House is as far as this particular measure in supporting those employees who may be out of a job come July 1st of this year. Thank you."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 2605, HD 1, entitled: "A BILL FOR AN ACT RELATING TO LABOR," passed Third Reading by a vote of 48 ayes, with Representative Say voting aye with reservations, and with Representatives DeCoite, Saiki and Tupola being excused.

Representative Mizuno moved that the report of the Committee be adopted, and that H.B. No. 2229, HD 1 pass Third Reading, seconded by Representative Evans.

Representative LoPresti rose to speak in support of the measure with reservations, stating:

"I have reservations on this bill, Mr. Speaker. In Finance Committee just the other day I had lots of questions about the portion of this bill that would give millions of dollars to the National Football League. We're throwing millions at millionaires with very dubious returns on that investment.

"I had asked at that time for the Hawaii Tourism Authority to provide the study that they claimed gave a six to one return on the investment. Six to one, Mr. Speaker. If that were true, I think we'd have a lot more competition for the Pro Bowl than we do. There is some but we'd have an awful lot more, because that's a great return on an investment.

"The problem, Mr. Speaker, is other I believe more objective studies show zero return on that investment. And I strongly support economic development, but I don't believe that we should throw millions at millionaires. I don't believe that the role of government is entertainment.

"I believe that we need to have better facts to determine whether or not we should be providing assistance to those that need it the least. Otherwise, the rest of the bill I like. I think we should try to have economic development in athletics, but I am just very dubious of that one particular event. Thank you, Mr. Speaker."

Representative Ing rose to speak in support of the measure with reservations, stating:

"In support with some reservations. My reservations stem from the fact that a lot of these major sporting events, especially here in Hawaii, is a big source of the human trafficking problem we have here, in particular sex trafficking of young women. Until we get that really squared away and fix the problem with law enforcement on that issue and pass some comprehensive sex trafficking legislation, I think this bill is premature, that we shouldn't necessarily be promoting those types of events. Thank you."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 2229, HD 1, entitled: "A BILL FOR AN ACT RELATING TO SPORTS," passed Third Reading by a vote of 48 ayes, with Representatives Ing and LoPresti voting aye with reservations, and with Representatives DeCoite, Saiki and Tupola being excused

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 824-16) recommending that H.B. No. 2049, HD 2 pass Third Reading.

On motion by Representative Mizuno, seconded by Representative Evans and carried, the report of the Committee was adopted and H.B. No. 2049, HD 2, entitled: "A BILL FOR AN ACT RELATING TO TRANSPORTATION," passed Third Reading by a vote of 48 ayes, with Representatives DeCoite, Saiki and Tupola being excused.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 825-16) recommending that H.B. No. 2250, HD 1 pass Third Reading.

Representative Mizuno moved that the report of the Committee be adopted, and that H.B. No. 2250, HD 1 pass Third Reading, seconded by Representative Evans.

Representative Say rose to disclose a potential conflict of interest, stating:

"Mr. Speaker, may I have a ruling on a potential conflict? My business is on Kalani Street. Thank you very much," and the Chair ruled, "no conflict."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 2250, HD 1, entitled: "A BILL FOR AN ACT RELATING TO HIGHWAYS," passed Third Reading by a vote of 48 ayes, with Representatives DeCoite, Saiki and Tupola being excused.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 826-16) recommending that H.B. No. 1892 pass Third Reading.

Representative Mizuno moved that the report of the Committee be adopted, and that H.B. No. 1892 pass Third Reading, seconded by Representative Evans.

Representative LoPresti rose in support of the measure and asked that his written remarks be inserted in the Journal, and the Chair "so ordered."

Representative LoPresti's written remarks are as follows:

"This is a common sense bill – the State should be a leader in accessible recycling. Think of how often people throw something recyclable in the trash simply because there is not a recycling container near it. Given the option to recycle conveniently, people will recycle conveniently. We are an island, we have limited resources and space and need to all do our part in a commitment to sustainability. There is literally not a downside to implementing this bill – it will only benefit the people of Hawaii and the earth. The earliest mass recycling program was born here, the 'Ban the Can' campaign organized by Ruth Webb in 1970. Let's continue to be a leader in green causes."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 1892, entitled: "A BILL FOR AN ACT RELATING TO RECYCLING," passed Third Reading by a vote of 48 ayes, with Representatives DeCoite, Saiki and Tupola being excused.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 827-16) recommending that H.B. No. 1983, HD 1 pass Third Reading.

Representative Mizuno moved that the report of the Committee be adopted, and that H.B. No. 1983, HD 1 pass Third Reading, seconded by Representative Evans.

Representative Jordan rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Lowen rose to speak in support of the measure with reservations, stating:

"Thank you, Mr. Speaker. With very strong reservations and just briefly a few comments. This bill basically undoes what we did last session with the cesspool tax credit, which created an incentive for people in the most environmentally sensitive areas, close to the shoreline wells or streams, to upgrade their cesspools. Scientific evidence shows unequivocally that cesspools have negative impacts in these sensitive areas.

"The cost of converting to a septic system or aerobic treatment unit is significant. Even with a \$10,000 tax credit, cost out-of-pocket would still be upwards of \$15,000 to \$25,000. And since the Department of Health has since scaled back their proposed rules, all these conversions are now voluntary, not mandated.

"Limiting eligibility for this credit by income will take away the incentive for some homeowners with cesspools in environmentally sensitive areas to convert their system. But at the same time, most lower-middle-income families will not be able to come up with the \$15,000 or \$25,000 out-of-pocket voluntarily. So the effect will be that very few people, if any, will use the program, and cesspools will continue to pollute our reefs, streams and drinking water wells.

"A better solution to democratizing the tax credit and make it available to more low- and middle-income families would be to further extend it to additional areas and offer it to those on large-capacity cesspool systems, which are already illegal under EPA rules, and mandated to be converted by federal law. Those are the families and homeowners that really need the financial assistance to comply with federal law.

"And finally, this would mean DOH would have to go back to the drawing board, create new rules for the program, and it would further delay the implementation of this program that all our constituents across the State are waiting for. Thank you, Mr. Speaker."

Representative Keohokalole rose to speak in support of the measure with reservations, stating:

"Thank you, Mr. Speaker. With reservations. I'd just like to mention that when it comes to cesspools, I'm dealing with this issue in my community for approximately two years. The Department of Health, Clean Water Branch has been investigating sewage bacteria outfalls in one of the lagoons that most of the streams in the Kahaluu, Waihee, Kaalaea community feed into.

"At a recent neighborhood board meeting in February, on February 10th, the Department of Health, Clean Water Branch indicated to the community that as a part of the testing, they've been regularly identifying human DNA markers in Mauka stream flows near cesspools.

"This is a really significant problem in my community, but it's also a problem for any community that has cesspools near active or even intermittent waterways, or near the ocean. I have maps that were provided to me by the Department of Health, Clean Water Branch that indicate the areas of this island and also the rest of the State that contain significant numbers of cesspools in our communities. I'd be happy to provide that for any other Representatives who are interested. But there are a ton of them on Oahu. That's all I have to say, thank you."

Representative Lee rose to speak in support of the measure, stating:

"Thank you, in support. I'd just like to point out, contrary perhaps to some of the perception earlier, that this program which currently exists offers a tax credit. This bill which we are debating today provides for a tax credit or rebate, giving the department an additional tool.

"Further, I'd like to note that the income requirement is blank in this bill as it goes to the Senate, so that is subject to further debate and further consideration. Thank you."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 1983, HD 1, entitled: "A BILL FOR AN ACT RELATING TO CESSPOOLS," passed Third Reading by a vote of 48 ayes, with Representatives Jordan, Keohokalole and Lowen voting aye with reservations, and with Representatives DeCoite, Saiki and Tupola being excused.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 828-16) recommending that H.B. No. 2528, HD 1 pass Third Reading.

Representative Mizuno moved that the report of the Committee be adopted, and that H.B. No. 2528, HD 1 pass Third Reading, seconded by Representative Evans.

Representative Lowen rose to speak in support of the measure with reservations, stating:

"Thank you, Mr. Speaker. Just slight reservations. Thank you."

Representative Cachola rose to speak in support of the measure with reservations, stating:

"I voted with reservations in Finance, so I'll do the same thing here. With reservations. Thank you."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 2528, HD 1, entitled: "A BILL FOR AN ACT MAKING AN APPROPRIATION FOR A SHOOTING FACILITY IN WEST HAWAII ON THE ISLAND OF HAWAII," passed Third Reading by a vote of 48 ayes, with Representatives Cachola and Lowen voting aye with reservations, and with Representatives DeCoite, Saiki and Tupola being excused.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 829-16) recommending that H.B. No. 2205, HD 1 pass Third Reading.

Representative Mizuno moved that the report of the Committee be adopted, and that H.B. No. 2205, HD 1 pass Third Reading, seconded by Representative Evans.

Representative Jordan rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 2205, HD 1, entitled: "A BILL FOR AN ACT RELATING TO CHARTER SCHOOLS," passed Third Reading by a vote of 47 ayes to 1 no, with Representative Jordan voting aye with reservations, with Representative Ward voting no, and with Representatives DeCoite, Saiki and Tupola being excused.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 830-16) recommending that H.B. No. 2267, HD 1 pass Third Reading.

On motion by Representative Mizuno, seconded by Representative Evans and carried, the report of the Committee was adopted and H.B. No. 2267, HD 1, entitled: "A BILL FOR AN ACT RELATING TO TECHNOLOGY IN SCHOOLS," passed Third Reading by a vote of 48 ayes, with Representatives DeCoite, Saiki and Tupola being excused.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 831-16) recommending that H.B. No. 2023, HD 1 pass Third Reading.

Representative Mizuno moved that the report of the Committee be adopted, and that H.B. No. 2023, HD 1 pass Third Reading, seconded by Representative Evans.

Representative Jordan rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Cullen rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Onishi rose to speak in support of the measure with reservations, stating:

"Mr. Speaker, with reservations and a short comment. Mr. Speaker, in the testimony of the DLNR, they already indicated that they have a procedure guide in order to effectuate the development of community-based fishing areas. And they already have a number of communities that are already in progress, using this guide. So I see this bill as being unnecessary. Thank you."

Representative Kawakami rose to speak in opposition to the measure, stating:

"Thank you, Mr. Speaker. In opposition. And I want to make it and I feel compelled to clarify my opposition so that it's not mischaracterized. I think that the intent of this bill is well-intended. What I'm opposed to is the process. And I can speak to this issue, because the only community-based subsistence fishing area in the State of Hawaii is on the beautiful island of Kauai, in Haena.

"So, a brief history. In 2006, former Representative Ezra Kanoho introduced the bill that became an act of law. Since 2006, prior to any rule-making process, the community of Haena held over eight years of community meetings on their own. Eight years and upward of 50 meetings were held prior to any rule-making process. Over eight years of work. That is the reason why it took so long for DLNR to enact rules.

"I think that if these communities want to create community-based subsistence fishing areas, they should embrace the very essence of that term and have it be community-based. And community-based means being inclusive, transparent and diligent. And I feel that this would rush that process. Thank you, Mr. Speaker."

Representative Ing rose to speak in support of the measure, stating:

"In support. So, yes, there are already quite a few communities. Big Island has at least three or four, Oahu probably three or four too. Maui, Molokai is definitely ready. They've been organizing, as a matter of fact. But there is a feeling out there that the Legislature may not be so supportive of their efforts. So I just wanted to clarify that.

"I met with David Sakoda, DLNR, we had lunch in the interim. And I told him, I'm thinking about doing this bill, I know you guys are doing it already, as the previous speaker has said, but just to reiterate our support, but also to, for one, get the discussion going about how long, what's the timeline really for these initiatives and if there's any more resources that the department needs in order to bring it into fruition. And he was like, well, we are going to oppose. And I go, I know, but it's for the discussion and to see where it goes.

"But the idea that there are five already and that it's likely that will happen by 2020, yeah, I agree with. But to put it into statute is important to me, because often through my committee, I am sure through other committees, Water & Land, DLNR will say, hey we don't need this bill because we're doing rules. We come back a year later, the rules haven't started. We come back another year from then, the rules still haven't started. So sometimes you've really got to make a timeline.

"Now Haena, it was really amazing what the community has done out there to organize themselves. The process set a template now. It's not a perfect template, DLNR has found some inefficiencies with that model, but the idea that future CBSFAs will take eight years I think is probably not true. It probably, because of all the work that was done for that first one, it should be a lot more efficient now.

"And let's say if this law does pass and three years from now this isn't happening, we could always say, hey, maybe we'll repeal this and extend it a little bit more. But in terms of commitment both from the department and from the Legislature, I think this speaks a lot to those communities who do know the breeding patterns, the tides like we don't. Because one size does not fit all. Thank you."

Representative Yamane rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Tokioka rose to speak in opposition to the measure, stating:

"Thank you very much, Mr. Speaker. No vote. I know it's a passionate issue, many people throughout the communities have approached us from both sides. And I think the Representative from the North Shore of Kauai summed it up best. And when you talk to the department and other people in the community, there's just not enough data on whether it works or not. So for those reasons, I'm a no vote. I understand the process and I understand the purpose, but at this time, because of the details, I have a no vote, Mr. Speaker."

Representative Aquino rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Morikawa rose to speak in opposition to the measure, stating:

"Thank you, Mr. Speaker. A no vote. My comment is that this would have impacted my district heavily, and I think the community really needs to have a say in what they want to do with their fishing areas. Thank you."

Representative Ward rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 2023, HD 1, entitled: "A BILL FOR AN ACT RELATING TO COMMUNITY-BASED SUBSISTENCE FISHING AREAS," passed Third Reading by a vote of 37 ayes to 11 noes, with Representatives Aquino, Cullen, Jordan, Onishi, Ward and Yamane voting aye with reservations, with Representatives Fukumoto Chang, Har, Ito, Kawakami, Kong, Matsumoto, Morikawa, Oshiro, Pouha, Say and

Tokioka voting no, and with Representatives DeCoite, Saiki and Tupola being excused.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 832-16) recommending that H.B. No. 2025, HD 1 pass Third Reading.

Representative Mizuno moved that the report of the Committee be adopted, and that H.B. No. 2025, HD 1 pass Third Reading, seconded by Representative Evans.

Representative Jordan rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Onishi rose to speak in support of the measure with reservations, stating:

"Mr. Speaker, with reservations. I'd like to also note that this is another area where there are already in place procedures and the processes that already address this. And so, again, I feel this is unnecessary law. Thank you."

Representative Takayama rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Ward rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Tokioka rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered." [Note: Representative Tokioka later changed his vote to a no vote.]

Representative McKelvey rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 2025, HD 1, entitled: "A BILL FOR AN ACT RELATING TO MARINE SPECIES," passed Third Reading by a vote of 42 ayes to 6 noes, with Representatives Jordan, McKelvey, Onishi, Takayama and Ward voting aye with reservations, with Representatives Har, Ito, Kong, Oshiro, Say and Tokioka voting no, and with Representatives DeCoite, Saiki and Tupola being excused.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 833-16) recommending that H.B. No. 1757, HD 1 pass Third Reading.

On motion by Representative Mizuno, seconded by Representative Evans and carried, the report of the Committee was adopted and H.B. No. 1757, HD 1, entitled: "A BILL FOR AN ACT RELATING TO HEALTH," passed Third Reading by a vote of 48 ayes, with Representatives DeCoite, Saiki and Tupola being excused.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 834-16) recommending that H.B. No. 2478 pass Third Reading.

On motion by Representative Mizuno, seconded by Representative Evans and carried, the report of the Committee was adopted and H.B. No. 2478, entitled: "A BILL FOR AN ACT RELATING TO THE AFFORDABLE CARE ACT SECTION 1332 STATE INNOVATION WAIVER," passed Third Reading by a vote of 48 ayes, with Representatives DeCoite, Saiki and Tupola being excused.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 835-16) recommending that H.B. No. 2707, HD 1 pass Third Reading.

Representative Mizuno moved that the report of the Committee be adopted, and that H.B. No. 2707, HD 1 pass Third Reading, seconded by Representative Evans.

Representative Cullen rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Fukumoto Chang rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Matsumoto rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Yamane rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Jordan rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Ichiyama rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Aquino rose in support of the measure with reservations and asked that his written remarks be inserted in the Journal, and the Chair "so ordered."

Representative Aquino's written remarks are as follows:

"Thank you, Mr. Speaker. I stand with some reservations on this measure. This bill is a work in progress and it tries to address access issues with the medical marijuana program.

"The main concern that I have is the bill's language regarding interisland transportation. Marijuana's current standing as a Schedule I substance makes this interisland movement prohibitive. Federal restrictions enforced by the Federal Aviation Administration and Transportation Security Administration would not allow this portion of the bill to happen. Because of this key concern, I cannot support this measure wholeheartedly. *Mahalo*."

Representative Cachola rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Johanson rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative McKelvey rose to speak in support of the measure with reservations, stating:

"Mr. Speaker, with reservations. And I'd like to actually explain why, if I may, just two seconds. I know this is a work in progress and I appreciate the hard work the Health Chair is doing in supporting the underlying bill, but there are several things that have appeared that require me to go with reservations, just so we track them out the rest of the session.

"The two big things for me actually have been, first of all is the tax breaks that have been given to the dispensary applicants potentially. You know, if you look through the list, Mr. Speaker, many of these individuals are very wealthy. Very, very, very wealthy. Billionaires, venture fund guys, movie stars, people with a lot of capital. And I think instead of giving them exorbitant tax breaks to try to keep the price of the product low, we should hopefully look at price controls for the product themselves. Let them eat the difference out of their luxury profit lines. If we're conterned and we want to make sure the prices don't escalate out of control, don't give them a break already that they're getting quite a lucrative line of business.

"The second thing has to do with the pilots thing in the bill, for lab testing. The question isn't a passenger bringing it on a plane and a pilot not knowing. The question is, if the pilot is taking something by law that they're required to take and then the FAA administratively strips their license later on because they are knowingly violating the federal law by shipping a controlled substance. Until President Clinton can get in and take care of that problem, this is a major challenge.

"And I think we also need to look at the caregiver provision in phasing it out for that very reason, because areas like Molokai could essentially be isolated without access to any dispensary or system because of this issue. Pilots will be forced to say, I'm not going to fly because I cannot risk my license, and I can completely support that.

"There's a lot of work to be done, and that's why I'm standing in reservations, and I hope that the Senate and the others can address these issues moving forward. Thank you."

Representative LoPresti rose to speak in support of the measure with reservations, stating:

"Thank you, Mr. Speaker. With reservations. I'd ask that the previous speaker's comments be entered into the Journal as if they were my own. He made some really good points on the first issue that I had not considered. I would only replace that hopefully President Bernie Sanders will fix that. Thank you," and the Chair "so ordered." (By reference only.)

Representative Ward rose to speak in opposition to the measure, stating:

"Mr. Speaker, I rise in opposition. Mr. Speaker, as we speak, the licensure process, the applications for those who want to do the dispensaries is in process. We are now shifting some of the criteria that they will be judged upon.

"For example, the greenhouses. That comes up in this bill. It has a different availability of edibles. Things that they may or may not be able to adjust to. That's one of my concerns about this bill.

"The other one is the advisory committee, which I did speak on second reading. The advisory committee is to monitor and to supervise, if you will, the safety and security of these places and monitor the quality of it. But, Mr. Speaker, in the bill it says this doesn't have to be in place until July 1. One whole year after the operation has been in effect. That's really inefficient. It seems foolish. What if they get off on the wrong track and the security and the other issues that this advisory commission is supposed to monitor, the horses are already out of the barn. So it doesn't make sense to have that

"Thirdly, what doesn't make sense is to have, instead of physicians, nurse or health practitioners do the prescriptions. Those, Mr. Speaker, I don't think are qualified the same way that physicians are, because it's the holistic, it's not only physical, it's the psychological, it's the whole package of the individual, not just the health practitioner.

"So Mr. Speaker, when you put these three things together, what you kind of get, you get a bit of grease thrown on to the slippery slope of what already is the rush to recreational marijuana. For those reasons, Mr. Speaker, this is not a good bill. I continue to vote no on this. Thank you."

Representative San Buenaventura rose to speak in support of the measure, stating:

"In support. As the Representative from Lahaina has pointed out, this is a work in progress. There are many things in this bill, as people have known my objections to, that I am not happy with. Such as, it limits the amount of greenhouses, instead including shade houses and open air areas.

"And the speaker from Lahaina is correct in that we are giving tax breaks to what should be a revenue generating issue. However, what we have learned by going to the mainland and by going to all of these dispensaries is that we need some kind of tracking and accountability. And by giving them these tax deductions, they are going to be required to write down the kind of tax deductions that they are claiming.

"We can then be able to track and account. And then later on, tax when appropriate. And as such, think of it as a work in progress, think of it as not necessarily a road to recreational marijuana, but as a road to more regulation and to being able to stamp out the black market. Thank you, Mr. Speaker."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 2707, HD 1, entitled: "A BILL FOR AN ACT RELATING TO MEDICAL MARIJUANA," passed Third

Reading by a vote of 38 ayes to 9 noes, with Representatives Aquino, Cachola, Cullen, Fukumoto Chang, Ichiyama, Johanson, Jordan, LoPresti, Matsumoto, McKelvey and Yamane voting aye with reservations, with Representatives Choy, Har, Kong, McDermott, Oshiro, Pouha, Say, Tokioka and Ward voting no, and with Representatives DeCoite, Kawakami, Saiki and Tupola being excused.

Representative Mizuno moved that the report of the Committee be adopted, and that H.B. No. 1735, HD 1 pass Second Reading and be placed on the calendar for Third Reading, seconded by Representative Evans

Representative Ward rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Thielen rose to speak in opposition to the measure, stating:

"Thank you, Mr. Speaker. I'd like to note my no vote at this point, and just quick comments. We are the most heavily taxed residents in the country, and now this bill is saying, okay, we're going to ask DBEDT to study the effects of Hawaii's 'low' property taxes, and I do the 'low' in quotations, to find out how to raise them. And it comes to a point, Mr. Speaker, where people just cannot afford to live here.

"I noted on this bill, there were more 'with reservations' than there were people in support of the bill, and that was wise. I just wish there had been more noes than people in support of the bill, and we could have stopped it here. Thank you."

Representative Ward rose to respond, stating:

"Mr. Speaker, I want to respond to that call and add a no vote to the particular measure. Thank you."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. "NELHA sits on and is ceded lands. As a condition of statehood, the State is mandated to hold the lands and income therefrom as a public trust. Thus, the operations of NELHA should not be exempt from bidding requirements in order to ensure that the greatest amount of revenue is derived from these lands."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. "Mr. Speaker, please note my reservations as well. I don't quite understand the bill, but it looks like we are trying to treat judges differently and I am not quite sure why. *Mahalo*."

Representative Oshiro rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Thielen rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Ward rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 2006, HD 1, entitled: "A BILL FOR AN ACT RELATING TO THE EMPLOYEES' RETIREMENT SYSTEM," passed Second Reading and was placed on the calendar for Third Reading, with Representatives Jordan, Oshiro, Rhoads, Thielen and Ward voting aye with reservations, and with Representatives DeCoite, Saiki and Tupola being excused.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 852-16) recommending that H.B. No. 1850, as amended in HD 1, pass Second Reading and be placed on the calendar for Third Reading.

Representative Mizuno moved that the report of the Committee be adopted, and that H.B. No. 1850, HD 1 pass Second Reading and be placed on the calendar for Third Reading, seconded by Representative Evans.

Representative Thielen rose to speak in opposition to the measure, stating:

"Thank you, Mr. Speaker. I'm rising to cast a very strong no vote, and I would like to just explain briefly. Mr. Speaker, for those of us in the House of Representatives that are struggling with a problem with illegal vacation rentals in our neighborhoods, those illegal vacation rentals that are taking away housing from the community, housing from people that should be our full time neighbors around the calendar year. Instead, we have these operations like Airbnb and others that are putting heavy pressure on local people to rent out on a short-term basis unpermitted by the city and county, illegal rentals.

"Unfortunately, although the bill is well intended, the bill wants to collect tax money from the illegal operators. But unfortunately, what the bill does is provides a shelter to those homeowners that are doing this, usually out-of-state homeowners that are doing this illegally.

"Some people are saying the bill was actually drafted by Airbnb or is similar to a model being promoted in other locations in the nation. It will keep the illegal property owners' name secret, people will not be able to get that. Tax money will be collected, but what it's going to do to our local neighborhoods, particularly on the windward side, on the neighbor islands, it's going to really harm them.

"And when people turn their properties into these short-term rentals, because they can make more money even though they are operating illegally, you're removing the housing properties from people that are desperately in search of housing. So, Mr. Speaker, I know the intent was good, let's grab the tax money, but you are going to see more and more of these illegal operators.

"I know we all, or I assume we all go door to door and talk to constituents. When I do that in certain areas of Kailua, there are what look like dead streets. No people there, other than sort of the welcome sign and the specially keyed lock so an out-of-state visitor can come in and stay for a couple of nights. But no little tricycles on the street. No community on the street. And you are seeing that pressure coming more and more and more.

"This bill was vehemently opposed by a number of neighborhood boards for that reason. And those are neighborhoods that are trying to stay residential, keep homes open for local people, keep the rentals there so people can stay and afford to live here.

"This is going to be a very, very damaging bill if it continues to move forward. So I cast a very strong no on second reading, and ask people to please look at this more carefully before next Tuesday. Thank you."

Representative LoPresti rose to speak in opposition to the measure, stating:

"Thank you, Mr. Speaker. I also have a no vote. I'd ask that the words of the previous speaker from Kailua be entered into the Journal as if they were my own," and the Chair "so ordered." (By reference only.)

Representative LoPresti continued, stating:

"But I'd like to add, because Ewa Beach is quite different from Kailua. We have a different problem, I believe. Many of the workers that are harmed by these illegal vacation rentals are in my district. They live in Ewa and Ewa Beach, throughout the Ewa Plain. I think anybody who, if there was a vacation rental in Ewa, they'd be really maybe surprised to spend most of their time in Hawaii in traffic.

"But most of my constituents spend a lot of their time in traffic trying to get to those jobs, and those jobs are becoming more and more rare, and are more and more in threat by these illegal rentals. And I believe that this bill may provide some legitimization to an industry that seems to go out of its way to hide illegal activity. And I find that very troubling.

"I'm also troubled by the fact that the increase of illegal vacation rentals I think is one of the low hanging fruits that we in government can address to address homelessness. Because there are places on Oahu, for example, where there are places where there are so many vacation rentals, and just across the street are homeless families living in tents because they can't find a decent rent just to live and house their children and themselves, Mr. Speaker.

"So with that, I feel compelled to cast a no vote, even on second reading. Thank you."

Representative Pouha rose to speak in support of the measure with reservations, stating:

"Mr. Speaker, just strong reservations for now. Thank you."

Representative McDermott rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

Representative Tokioka rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Matsumoto rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Kawakami rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Lee rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Har rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Brower rose to speak in support of the measure, stating:

"Mr. Speaker, in support. I think that Members may be clouding a few issues on this matter. And from my understanding, we have one situation where a national company is collecting a lot of revenue and not paying its fair share of taxes. So one issue of this bill will address that.

"Then there is another issue of should these properties be renting to visitors. And that's an issue, one, for our tax department to keep that property honest, in its fair share of property taxes or different type of class of taxes, and then our county zoning.

"So if you are in a neighborhood and you're unhappy that people are vacationing there and using your resources, then I think it's going to be a zoning issue on whether that's legal or not. Thank you."

Representative Cachola rose to speak in support of the measure with reservations, stating:

"Mr. Speaker, with reservations. I know that this bill is a work in progress. I made a recommendation in one of the hearings, I think in Finance, that we are going to amend one section of the bill, whereby Airbnb has to verify with the City and County of Honolulu that the property that's being used for vacation rental is legal. Otherwise, all they do is collect.

"And if they can work on that and tighten it up, I think there is a merit to this bill. At this point in time, the way it's worded, I'll be going with reservations. Thank you."

Representative McKelvey rose to speak in support of the measure with reservations, stating:

"I am with Romy, just wanted to make that for the record. Thank you."

Representative Kobayashi rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Ward rose to speak in opposition to the measure, stating:

"Mr. Speaker, a no vote with a brief comment to back up what the Representative from Kalihi just said. The issue is twofold. Taxation, one, which this addresses, but secondly it's permitting. And as the Representative said, it's coupling those two together. Making those, if they are collecting money, they can also collect the legality at the same time. And I'll be a no vote until that does become a couple, rather than singular."

Representative Lowen rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 1850, HD 1, entitled: "A BILL FOR AN ACT RELATING TO TAXATION," passed Second Reading and was placed on the calendar for Third Reading, with Representatives Cachola, Har, Kawakami, Kobayashi, Lee, Lowen, Matsumoto,

McKelvey, Pouha and Tokioka voting aye with reservations, with Representatives LoPresti, McDermott, Thielen and Ward voting no, and with Representatives DeCoite, Saiki and Tupola being excused.
