Representative Belatti, for the Committee on Health, presented a report (Stand. Com. Rep. No. 1441-16) recommending that H.R. No. 93 be adopted.

On motion by Representative Souki, seconded by Representative Evans and carried, the report of the Committee was adopted and H.R. No. 93, entitled: "HOUSE RESOLUTION RECOGNIZING THE MONTH OF SEPTEMBER AS SEPSIS AWARENESS MONTH IN HAWAII, AND THE THIRTEENTH DAY IN SEPTEMBER OF EVERY YEAR AS HAWAII SEPSIS DAY," was adopted, with Representatives Har, Ing, Kong, Luke, Saiki, Thielen and Tokioka being excused.

Representative Belatti, for the Committee on Health, presented a report (Stand. Com. Rep. No. 1442-16) recommending that H.C.R. No. 141 be adopted.

On motion by Representative Souki, seconded by Representative Evans and carried, the report of the Committee was adopted and H.C.R. No. 141, entitled: "HOUSE CONCURRENT RESOLUTION RECOGNIZING THE MONTH OF SEPTEMBER AS SEPSIS AWARENESS MONTH IN HAWAII, AND THE THIRTEENTH DAY IN SEPTEMBER OF EVERY YEAR AS HAWAII SEPSIS DAY," was adopted, with Representatives Har, Ing, Kong, Luke, Saiki, Thielen and Tokioka being excused.

Representative Rhoads, for the Committee on Judiciary, presented a report (Stand. Com. Rep. No. 1443-16) recommending that H.C.R. No. 127, as amended in HD 1, be adopted.

Representative Souki moved that the report of the Committee be adopted, and that H.C.R. No. 127, HD 1 be adopted, seconded by Representative Evans.

Representative McDermott rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

Representative Fukumoto Chang rose in support of the measure and asked that her written remarks be inserted in the Journal, and the Chair "so ordered."

Representative Fukumoto Changs's written remarks are as follows:

"Mr. Speaker, I rise in support of HCR 127, HD 1. Advocates have stated that decriminalizing the possession of illegal drugs will release low-level drug offenders from incarceration, thus reducing overcrowded jail and prison populations. As such, they have pushed decriminalization laws both in Hawaii and nationwide. However, I am concerned that enacting policy without understanding its wide-ranging impact is unwise. Therefore, I believe it is imperative that a study on the effects of decriminalizing illegal drugs is conducted before any policy measures are undertaken. I have very serious concerns with decriminalization, and I expect a study will reveal those dangers and caution against further legislative action. For this reason, I rise in support of HCR 127, HD 1. Thank you, Mr. Speaker."

Representative Pouha rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

Representative Matsumoto rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

Representative Ward rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

Representative Tupola rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

Representative Johanson rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

Representative Say rose in opposition to the measure and asked that his written remarks be inserted in the Journal, and the Chair "so ordered."

Representative Say's written remarks are as follows:

"Mr. Speaker, I rise in opposition to HCR 127, HD 1, which requests the Legislative Reference Bureau to study whether it would be feasible or wise

to decriminalize possession of small quantities of illicit drugs for personal use in Hawaii

"I personally feel that this study will open up a Pandora's box of more problems because of accessibility and usage by medical patients. Let us wait until the medical marijuana issue is addressed thoroughly before jumping into the fire. Evaluating and researching just the country of Portugal is very narrow and limited in scope to determine the validity of decriminalization of Class C felony drugs. Portugal is a European country, and maybe the United States of America (the Federal Government) should research or evaluate the idea, rather than a state. Conflicts with federal laws and state laws will also have to be addressed.

"And finally, I am also very concerned about the Drug Abuse that may occur in Hawaii. For these reasons, I oppose this House Concurrent Resolution. Thank you."

Representative Keohokalole rose in support of the measure and asked that his written remarks be inserted in the Journal, and the Chair "so ordered."

Representative Keohokalole's written remarks are as follows:

"In support. The purpose of this resolution is to take a look at a policy that has after 15 years showed to be a viable alternative to the US's over 40 year old war on drugs, which in this country has resulted in the highest rate of incarceration in the world and not ended drug use. Recent media reports indicate a heroin epidemic in the Northeast and Midwest that is reaching crisis level, and recent media reports have indicated a growing methamphetamine epidemic in metropolitan Los Angeles.

"In 2009, the conservative leaning think tank the Cato Institute published a review of the Portugal decriminalization system, and concluded:

[W]hile there is a widespread perception that [administrative] changes need to be made ... to make it more efficient and effective, there is no real debate about whether drugs should once again be criminalized. More significantly, none of the nightmare scenarios touted by preenactment decriminalization opponents—from rampant increases in drug usage among the young to the transformation of Lisbon into a haven for "drug tourists"—has occurred.

...Those data indicate that decriminalization has had no adverse effect on drug usage rates in Portugal, which, in numerous categories, are now among the lowest in the EU, particularly when compared with states with stringent criminalization regimes. Although postdecriminalization usage rates have remained roughly the same or even decreased slightly when compared with other EU states, drug-related pathologies—such as sexually transmitted diseases and deaths due to drug usage—have decreased dramatically. Drug policy experts attribute those positive trends to the enhanced ability of the Portuguese government to offer treatment programs to its citizens—enhancements made possible, for numerous reasons, by decriminalization.

"The study ultimately concluded that, 'judged by virtually every metric, the Portuguese decriminalization framework has been a resounding success. Within this success lie self-evident lessons that should guide drug policy debates around the world.' What are those lessons and what can we here in Hawaii learn? We are in a different part of the world with different issues and different laws. But our laws are not working. For those reasons, I stand in support."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.C.R. No. 127, HD 1, entitled: "HOUSE CONCURRENT RESOLUTION REQUESTING THE LEGISLATIVE REFERENCE BUREAU TO CONDUCT A STUDY ON THE FEASIBILITY AND ADVISABILITY OF DECRIMINALIZING THE ILLEGAL POSSESSION OF DRUGS FOR PERSONAL USE IN HAWAII," was adopted, with Representatives Johanson, Matsumoto, McDermott, Pouha, Say, Tupola and Ward voting no, and with

Representatives Har, Ing, Kong, Luke, Saiki, Thielen and Tokioka being excused.

At 12:52 o'clock p.m., Representative Souki requested a recess and the Chair declared a recess subject to the call of the Chair.

The House of Representatives reconvened at 12:52 o'clock p.m.

Representative McKelvey, for the Committee on Consumer Protection & Commerce, presented a report (Stand. Com. Rep. No. 1444-16) recommending that S.B. No. 2851, SD 1 pass Second Reading and be placed on the calendar for Third Reading.

On motion by Representative Souki, seconded by Representative Evans and carried, the report of the Committee was adopted and S.B. No. 2851, SD 1, entitled: "A BILL FOR AN ACT RELATING TO INSURANCE," passed Second Reading and was placed on the calendar for Third Reading, with Representatives Har, Ing, Kong, Luke, Saiki, Thielen and Tokioka being excused.

Representative McDermott rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and S.B. No. 305, SD 1, HD 1, entitled: "A BILL FOR AN ACT RELATING TO USE OF TOBACCO PRODUCTS AND E-CIGARETTES ON HAWAII HEALTH SYSTEMS CORPORATION PREMISES," passed Third Reading by a vote of 43 ayes to 1 no, with Representative McDermott voting no, and with Representatives Har, Ing, Kong, Luke, Saiki, Thielen and Tokioka being excused.
