Thursday, April 7, 2016

The House of Representatives of the Twenty-Eighth Legislature of the State of Hawaii, Regular Session of 2016, convened at 12:08 o'clock p.m., with Vice Speaker Mizuno presiding.

ORDER OF THE DAY

SUSPENSION OF RULES

At this time, the Chair stated:

"Members, please note that per Committee Referral Sheet Number 45, House Resolution Number 131 and House Concurrent Resolution Number 184 have been re-referred solely to the Committee on Economic Development & Business. The Committee on Higher Education waived its referral to these measures, and therefore it is appropriate for the House to consider action for adoption. We will be going through a series of three motions. The motion to suspend, motion to reconsider, and motion to adopt."

On motion by Representative Saiki, seconded by Representative Evans and carried, the rules were suspended to reconsider action previously taken on H.R. No. 131 and H.C.R. No. 184. (Representatives McDermott, Oshiro, Thielen and Tupola were excused.)

RECONSIDERATION OF ACTION TAKEN

On motion by Representative Evans, seconded by Representative Pouha and carried, the rules were suspended for the purpose of considering certain Senate Bills for Third Reading by consent calendar. (Representatives McDermott, Oshiro, Thielen and Tupola were excused.)

UNFINISHED BUSINESS

S.B. No. 2954, SD 2, HD 1:

Representative Saiki moved that S.B. No. 2954, SD 2, HD 1 pass Third Reading, seconded by Representative Evans.

Representative Ward rose to speak in opposition to the measure, stating:

"Mr. Speaker, in opposition, a few comments. Mr. Speaker, we have to keep guns out of criminals' hands, but we don't want to make those hands that have legal weapons into criminals, and unfortunately this bill seems to put people who are not criminals on a criminal list. So by association of the guilt by association, naturally you're going to be locked into that imagery. Plus, according to the data in the hearings, the Owners' Protection Act of 1986 says that there will not be a federal list of firearms. So this flies in the face of that.

"And for those who are thinking that, well, we're going to get some money out of the \$50 that this is going to bring in, it actually goes to the feds.

"And lastly, Mr. Speaker, I think that the Second Amendment is pretty clear, that these people who have arms have a right to do that. And the legislation that says that we're not going to have a national arms, can you imagine during the revolution when we were against the British and we had a list of all those who had weapons, the British would've beat us, we would've never been America, because we had the Second Amendment as part of what in our *psyche*, if you will, which now we have in law, keeps the citizens protected from their government, and if you will, the government protected from their citizens, because they have the right to bear arms.

"So this thing criminalizes a lot of people, and the other interesting thing is that we are the only state to do this. I mean, we like to be out in the forefront, but I think with these kinds of things we're actually going to be in the backyards of history on this one. Thank you, Mr. Speaker."

Representative Rhoads rose to speak in support of the measure, stating:

"Mr. Speaker, in support. In opposition to the previous speaker, I guess I should say. This doesn't criminalize anybody, all this does, all this bill does is allows our counties to take advantage of a federal program to do a rap back for arms purchases. It doesn't criminalize anybody. On the contrary, anybody who, this only catches people, the flag only goes up if a crime has been committed or other disqualifying matters, so that's just not correct.

"A statement was made that it conflicts with the federal, I forgot the technical name of it, the 1986 law. It doesn't. The federal government wouldn't be able to run the program if it did, and there are no legal or constitutional impediments to our counties going ahead and accepting the rap back program that the federal government has put out here for checking for background checks for gun purchases. It's one of the specific reasons that the rap back program was put into effect by the FBI. And we have the forms, I have a copy of the form if anybody would like to see it, gun checks are right there, so this is something that the federal government developed specifically for this purpose.

"I would also note that the counties already have the authority to do exactly the same thing as this bill does, they just have to do it manually. So it's practically not possible, but we do have the authority to do it already. Thank you."

Representative Ward rose to respond, stating:

"Mr. Speaker, the learned gentleman from downtown deserves a retort. And with his reputation that is impeccable, I would say he should never be put on a FBI most wanted list. Because he is an honorable gentleman. But when you get his name up to those, even though he hasn't committed a crime, I am giving you a parallel of what this bill does, it puts you on a list that is very suspect. If someone learns that the good gentleman from downtown is on the FBI most wanted list, they say, oh there must be something wrong with his character.

"Well, what this bill does is put these people with firearms on a list which otherwise is associated with very unsavory individuals, because those people on there are waiting to be dinged for criminal activity.

"I see the intent, I don't see any other state doing this, and it does fly in the face of a 1986 law that says we will not have a federal list of firearms. The rest of the states wouldn't put up with that. The spirit of the Second Amendment, the spirit of being an independent America, with your government knowing everybody who's got a weapon. That's what the 1986 law is about, and what the good gentleman will not admit that it does actually say.

"For those reasons, Mr. Speaker, this is not a good bill. We've got a policy that's working to the degree already, but why do we want to push it farther? And no one is following us. Even California, which does above and beyond the expectation for gun control. Or even on the East Coast. We have not got that. So why are we doing this? I have no idea. Thank you, Mr. Speaker."

Representative Rhoads rose to respond, stating:

"Mr. Speaker, still in support. Section 846-2.7, which is in the bill, has a list of 42 different groups of people who are subject to rap back, if those agencies decide to use them. And they are people who are not in any way considered to be. The Department of Health or its designee on operators of adult foster care homes. Department of Health prospective employees, persons seeking to serve as providers, or subcontractors in positions that place them in direct contact with clients.

"None of these people are in a suspect list. We just want to be sure that there is no one there who has committed a felony. And because of the sensitivity of the position, because of the sensitivity of owning a gun, they can cause a lot of damage. It's very good public policy to be sure that those who have committed felonies are at least checked to be sure that they still qualify under our gun control laws. And the good Representative from Hawaii Kai is incorrect about the 1986 law. Thanks."

Representative LoPresti rose to speak in support of the measure, stating:

"In support. I ask to enter comments into the Journal. And I would only add, and I mean this after careful consideration. If you're against this bill, essentially what you're against is against criminal background checks. You are against criminal background checks because *de facto* what it means is that you're against having a check on felons having access to firearms. And not having this law actually protects felons and ensures that felons will have firearms. Thank you."

Representative LoPresti's written remarks are as follows:

"On this particular measure, I feel that there may be some misrepresentation of the bill by some groups. It may be of interest to you to know that this bill is, in fact, supported by the Hawaii Rifle Association – they submitted testimony in support of the measure during the February 8th hearing, noting that it eased moving between counties without having to re-register firearms. Additionally, the NRA has not submitted testimony opposing the bill for any reason, at any of the three separate hearings

throughout February and March. Neither had NRA, to my knowledge, raised any questions as to the constitutionality of this measure.

"I certainly understand general concerns about limiting law-abiding citizens' ability to own a firearm, however, this bill in no way prohibits or prevents this. It only applies to convicted criminals (specifically felons), not law-abiding citizens. In other words, my understanding of the bill is that only those who have disqualified themselves from owning a gun by criminal conviction would be affected by SB 2954. It is already the case that such convicted individuals, by law, should self-report and either turn in or turn over to someone else firearms that were up to the point of conviction legally in their possession. Their ownership of a firearm was legal at one point but because of convicted felonious activity, their possession is no longer legal – this has been the law of the land for a very long time. Not surprisingly, many do not self-report and do not turn over firearms that are illegally possessed. This bill merely makes it possible for law enforcement to more efficiently know if someone may be illegally in possession of a firearm by virtue of a criminal conviction; it is important to note that law enforcement already has the legal ability and duty to do this, SB 2954 only gives them the human and technological resources to conduct such criminal background checks in a timely and efficient manner. Thus, to be clear, this bill merely provides law enforcement the awareness that they need to enforce current laws that they already enforce. Without this law, the illegal possession of firearms by convicted felons is practically ensured.

"There has been some spreading of misinformation that SB 2954 is in violation of federal law, but in fact it would utilize an existing federal program – offered by the federal government – to assist in criminal background checks. Again, the police already have the authority to do this, SB 2954 simply offers additional human resources and technology to improve and facilitate to continue to do what they already do."

Representative Ward rose, stating:

"Mr. Speaker, a point of personal privilege. I believe that he imputed motivation for my speaking. I am not against background checks. That is not the point. Background checks are there, they work, and there is no imputed..."

The Chair addressed Representative Ward, stating:

"I apologize, Representative Ward, I am looking at the rules relating to personal privilege. Members must relate to the person as a member of the body or relate to charges against their character that, if true, would incapacitate them from membership. I don't think that you have met the level. Thank you, though. Thank you, Representative."

The motion was put to vote by the Chair and carried, and S.B. No. 2954, SD 2, HD 1, entitled: "A BILL FOR AN ACT RELATING TO FIREARMS," passed Third Reading by a vote of 26 ayes to 21 noes, with Representatives Aquino, Choy, Cullen, DeCoite, Fukumoto Chang, Har, Hashem, Ito, Jordan, Kawakami, Kong, Matsumoto, McKelvey, Morikawa, Pouha, Say, Tokioka, Tsuji, Ward, Yamane and Yamashita voting no, and with Representatives McDermott, Oshiro, Thielen and Tupola being excused.

On motion by Representative Saiki, seconded by Representative Evans and carried, the report of the Committee was adopted and S.B. On motion by Representative Saiki, seconded by Representative Evans and carried, the report of the Committee was adopted and S.B. Representative San Buenaventura rose to speak in support of the measure with reservations, stating:

"With reservations. I'd like to note that there was consent with the witnesses in the hearing that I was attending that the exception for operations should be inserted into the bill, and I note that that exception was not put in. Both sides agreed that the surgeons needed the capacity of the latex gloves to be able to feel their instruments and to be able to be better at their surgery with it. Representative Ichiyama's written remarks are as follows:

"Thank you, Mr. Speaker. I rise in support of HR 55 and HCR 94. As the Representative for House District 32 – Salt Lake, Moanalua and Aliamanu – since 2010, I regularly receive concerns from constituents about traffic congestion in our neighborhood. For example, one family reports that they are unable to exit their driveway because of the traffic from Tripler Army Medical Center. Other residents express concerns about the traffic from Moanalua Valley to the Moanalua Freeway west-bound on-ramp, which was rated an 'F' in a recent traffic study. I also regularly hear about the congestion on Puuloa Road and Salt Lake Boulevard.

"Without question, traffic congestion negatively affects the quality of life for our area residents. I support HR 55 and HCR 94 as steps to solve these challenges."

Representative Johanson rose in support of both measures and asked that his written remarks be inserted in the Journal, and the Chair "so ordered."

Representative Johanson's written remarks are as follows:

"Mr. Speaker, on behalf of the communities that I represent, including the areas of Ft. Shafter, Moanalua Gardens, Red Hill, Aliamanu Military Reservation, and Mapunapuna, I rise in support of House Resolution 55 and House Concurrent Resolution 94, which offers the potential to help alleviate and address existing traffic congestion in the Aiea, Red Hill, Moanalua, Aliamanu, and Salt Lake areas – notably some of the worst points of congestion on the Island of Oahu.

"I believe that we owe it to our residents to prioritize addressing the traffic issues that have been ailing the surrounding communities for years. With the Moanalua Freeway running through my district on one side and the H-1 Freeway passing through it on the other side, my district plays an important and significant role in shouldering the transportation infrastructure needs for much of Central and Leeward Oahu commuters. It is a shared burden that our community has embraced. However, it also means that our communities are disproportionately impacted when anything adds to congestion and traffic on freeways and thoroughfares in our area.

"According to the 2015 American Highway Users Alliance's (AHUA) Report, the Ala Kapuna Overpass (Red Hill) section of Moanalua Freeway has the greatest congestion in the State of Hawaii, with delays totaling up to 607,100 hours for commuters. People living within the affected areas of Moanalua, Salt Lake, Red Hill, Aliamanu, and Aiea face crowded roads, increased travel time, and a lower quality of life due to the traffic issues within our neighborhoods.

"For too long, the State and City have not adequately coordinated a comprehensive traffic and congestion study and plan. House Resolution 55 and House Concurrent Resolution 94 correctly encourages both the State Department of Transportation and the City Department of Transportation Services to complete the long-overdue study as well as assessing the need for consideration of our communities' traffic and congestion issues in the Oahu Metropolitan Planning Organization's Transportation Improvement Projects.

"House Resolution 55 and House Concurrent Resolution 94 offers a potential solution to help address a key concern of many residents in my community: traffic and congestion."

"Thank you, Mr. Speaker. I am in strong support of HR 89/HCR 137.

"If passed, these resolutions would request the Hawaii Department of Education ('DOE') to affirm its commitment to uphold the tenets of Title IX of the Education Amendment Act of 1972, renamed the Patsy Takemoto Mink Equal Opportunity in Education Act ('Title IX').

"Title IX prohibits discrimination on the basis of sex in the administration of educational programs and activities. Title IX is vital to increasing educational opportunities for women and girls, fostering equality between men and women, and eliminating sex discrimination.

"In the 40 years since its passage, federal regulations and guidance issued by the United States Department of Education's Office of Civil Rights have constructed a robust framework for what educational institutions need to do in order to comply with Title IX. Yet many educational institutions across the country, including DOE, are failing to implement or do not adequately implement the requirements of Title IX.

"Discrimination on the basis of sex, particularly in the form of sexual harassment or violence, is still all too common in schools. Girls and young women cannot fully pursue their studies in environments where sexual harassment and predation from peers and staff is allowed to occur.

"A review of DOE's Title IX procedures and resources reveal substantial shortcomings, which fosters an environment where it is difficult for Hawaii's girls and women to learn and achieve their full potential.

"These resolutions address the shortcomings in DOE's Title IX compliance, and call on DOE to take specified actions, including developing strong policies and procedures and employing sufficient staff to properly monitor, analyze and resolve Title IX cases, to ensure that DOE students and employees are protected against sexual discrimination and all of our girls and young women have equal access to educational opportunities.

"Thank you very much, Mr. Speaker, for the opportunity to express my support of HR 89/HCR 137."

"Mr. Speaker, I am in strong support of HR 97/HCR 146, Requesting the Department of Education to Provide Equipment Necessary for a Full-Service Conventional Kitchen at Keaukaha Elementary School and to Provide Necessary Positions to Operate the Kitchen.

"The community and residents of Keaukaha have worked tirelessly with their legislators (especially Rep. Clift Tsuji) and the Department of Education to have this cafeteria built. The present language in the resolution is correct and a proviso was added in 2011 to show legislative intent for a Full-Service Conventional Kitchen.

"Please note that the following proviso was passed in Act 164, Session Laws of Hawaii 2011, Part V. Capital Improvement Program Provisos, Section 65:

(2) By amending Item G-49 to read as follows:
 "P90083 KEAUKAHA ELEMENTARY SCHOOL, HAWAII
 PLANS, DESIGN, CONSTRUCTION AND
 EQUIPMENT FOR A NEW CAFETERIA[-], INCLUDING A
 FULL-SERVICE, CONVENTIONAL KITCHEN TO BOTH
 PREPARE AND SERVE FOOD; GROUND AND SITE
 IMPROVEMENTS; EQUIPMENT AND APPURTENANCES.
 ... "

"This was the 'legislative intent' when the funding was included in the state budget – that the new Keaukaha Elementary School Cafeteria would continue to play the role of supporting both the school and community by confining to be a 'full-service' cafeteria.

"In light of this ongoing dispute between the community and the DOE, the legislators' support was sought in 2011. At that time, the legislators passed what became Act 164, which made clear that funding for the new school cafeteria would include, 'a full-service, conventional kitchen to both prepare and serve food'.

"Common sense dictates that this would include staffing positions and equipment necessary to 'prepare and serve food'.

"I would like to ask the Department of Budget and Finance, the Department of Education, and the Governor to please support this proviso and appropriations of the past. Thank you."

In 1995, the Legislature appropriated funds for the Leeward Bikeway – over 20 years ago. Bikeway construction has been delayed for far too long. Citizens should have been able to enjoy it for the past two decades, and there is no good reason for it to be put off any longer."

The motion was put to vote by the Chair and carried, and the reports of the Committee were adopted and H.R. "Thank you, Mr. Speaker. In strong support and may I request permission to enter written comments into the Journal? Thank you."

Representative Har's written remarks are as follows:

"Mr. Speaker, I rise in support of House Resolution Number 124, HD 1, and House Concurrent Resolution Number 174, HD 1. These resolutions seek to address the traffic nightmare that citizens of West and Central O'ahu face on a daily basis.

"Traffic congestion is a serious problem faced by cities around the country and throughout the world. It negatively impacts the quality of life for many residents of O'ahu, especially for working professionals and students commuting from outside the metropolitan Honolulu area. This is by far the most frequent and strongest complaint I receive from my constituents, and I applaud the Representative from Royal Kunia for seeking ways to mitigate the ongoing traffic crisis.

"Traffic congestion in Honolulu is consistently ranked as one of the worst in the nation, ranking second in a report by INRIX, a traffic information and driver services company. The countless hours that residents and visitors to the island spend in traffic should instead be spent shopping, dining, or with family. Worse than congestion and delays, increased traffic in Hawaii contributes to a rate of around 10,000 serious traffic accidents a year, resulting in between 120 and 150 fatalities and 8,000 to 12,000 individuals being seriously injured. Wasted time is only a piece of the puzzle, the safety concerns put lives at risk.

"The problems with traffic in Honolulu are particularly pronounced in weekday commutes between metropolitan Honolulu and the Leeward and Central areas of O'ahu. This problem will only worsen with the growth of Kapolei and the Ewa region, as recent economic forecasts predicting job growth in the Ewa market of more than 67,000 new jobs over the next decade and a half.

"An overhaul of the infrastructure has the potential to greatly improve quality of life for residents of West O'ahu, the results of which will be felt across the island. For this reason I stand in support of House Resolution Number 124, HD 1 and House Concurrent Resolution Number 174, HD 1. Thank you, Mr. Speaker."

Representative Cullen rose in support of both measures and asked that his written remarks be inserted in the Journal, and the Chair "so ordered."

Representative Cullen's written remarks are as follows:

"Mr. Speaker, I rise in support of HR 124/ HCR 174.

"This measure supports a collaborative resolution that will try to address our traffic needs in the leeward area of Oahu on different levels. I believe that the different agencies listed within the resolution need to improve their communication and collaboration as they consider new ideas to address

traffic. As stated in the resolution, traffic congestion negatively impacts the quality of life for many residents of Oahu. With that being said, I hope this resolution will continue to look at new solutions to address traffic, and connect and integrate current solutions and plans between the departments to improve the lives of the Leeward Oahu community."

The motion was put to vote by the Chair and carried, and the reports of the Committee were adopted and H.R. Representative Har rose to speak in support of both measures, stating:

"Thank you, Mr. Speaker. In strong support and may I request permission to enter written comments into the Journal? Thank you."

Representative Har's written remarks are as follows:

"Mr. Speaker, I stand in support of House Resolution Number 130 and House Concurrent Resolution Number 180. The intent of these resolutions is to address school overcrowding in my district and the surrounding area, which is a real problem for residents of West O'ahu and their children. Kapolei is one of the fastest-growing communities on O'ahu and in the State as a whole. Large numbers of young families with school-aged children are moving to Kapolei because of the relatively affordable housing in these areas. This growth creates economic prosperity for everyone, but only if public infrastructure can keep up.

"Due to the growth of West O'ahu, student enrollment is projected to increase at public schools. When overcrowding at public schools occurs, it adversely affects both teaching conditions for teachers and learning conditions for students. Because of overcrowding, there are reports of public school teachers who must teach classes that are startlingly large in size. This results in lower quality education and more at-risk students going underserved.

"The Legislature has appropriated \$10,000,000 as a lump sum to the Department of Education to address overcrowding in public schools. It would be admirable if this task force can use the resources provided to find a reasonable remedy for the situation. Addressing education shortfalls will have a profound effect on the future of West O'ahu, the island, and the State. For these reasons I stand in support of House Resolution Number 130 and House Concurrent Resolution Number 180. Thank you, Mr. Speaker."

Representative Cullen rose to speak in support of both measures, stating:

"Strong support, same request. Thank you."

Representative Cullen's written remarks are as follows:

"Mr. Speaker, I rise in support of HR 130/HCR 180.

"At this point, Mr. Speaker, the schools within Waipahu, Kapolei and Ewa are at or over capacity, and the projected population growth in Waipahu, Kapolei and Ewa will only add to this issue. The current schools will eventually reach maximum capacity, and the planned schools to be built in these areas are years away from addressing the current overcrowding issue. The community deserves a plan moving forward on how, as a state, we will address this issue.

"I hope this task force will look at funding mechanisms and design-build process for schools to address the length of time it takes to complete a project. These are just a few areas I hope they can look at among many others to improve our current process. If we do nothing, this issue will continue to negatively impact the quality of education for our students. Therefore, creating this task force will allow for a well-rounded discussion and create viable solutions to overcrowding."

Representative LoPresti rose to speak in support of both measures, stating:

"Strong support, same request. Thank you."

Representative LoPresti's written remarks are as follows:

"The Leeward side's population has grown at a rapid pace for the past decade, and continues to grow as more and more families settle in Ewa, Kapolei and Waipahu. James Campbell High School, the largest school in the State, is already crippling overcrowded, and projected enrollment numbers show that the problem will only continue to get worse in the coming years. The Department of Education needs to get in front of this issue before it becomes irreparable, and the first step in doing that is forming this task force."

The motion was put to vote by the Chair and carried, and the reports of the Committee were adopted and H.R. No. 130, entitled: "HOUSE RESOLUTION REQUESTING THE DEPARTMENT OF EDUCATION TO ESTABLISH A TASK FORCE TO CREATE A PLAN TO ADDRESS OVERCROWDING IN PUBLIC SCHOOLS IN KAPOLEI,

EWA, AND WAIPAHU," was adopted, with Representatives McDermott, Oshiro, Thielen and Tupola being excused; and

"Reservations, Mr. Speaker. Just a few comments if I may, Mr. Speaker. Mr. Speaker, my reservation on this particular measure is, this is a negotiating committee. I don't think they should've use those words, 'negotiating committee', because I don't think they're going to be negotiating anything at this point in time, since they're just going to be providing a report. Maybe they should have used the words 'working group'.

"I have a problem with the individuals that are on this particular negotiating committee. I see Senate President or the designee, House of Representatives Speaker, designee, Governor, designee, Chair Person of Office of Hawaiian Affairs.

"Apparently, this is a state and state agencies discussing revenues for beneficiaries. The problem is, Mr. Speaker, as I don't see any beneficiaries that will be on this working group. Although some people are under the conception that OHA represents all beneficiaries, I don't take that position, Mr. Speaker. I think we should at least have somebody that represents beneficiaries outside of a state agency, known as OHA, representing that voice at this particular table.

"That's what my reservation is at this point in time. Hopefully the Senate may add some adjustments to this. Thank you, Mr. Speaker."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.C.R. Representative Luke, for the Committee on Finance, presented two reports:

Representative Ward rose to speak in opposition to both measures, stating:

"Mr. Speaker, I rise in opposition with a brief comment. Mr. Speaker, this bill suggests that we should have a separate system of financing the Judiciary for the sake of their medical programs, for their retirement programs. The ERS, as you know, handles all of the state employees. Why we should separate one is, according to this bill, is because there's a conflict of interest if there is something that comes before the ERS to the Judiciary. How many times that's ever happened I'm not sure, but that seems to be a pretty lame excuse.

"The second thing is that there's about 82 people that would be covered in this separate section. And the cost to do that would be tremendous. And thirdly, Mr. Speaker, under the constitutional equal protection, all laws must be rationally related for the purpose of the bill, and I think it fails that test.

"It looks as though it's discriminating against one branch of government by trying to make it separate. It's stretching things a bit and makes it look petty, in fact I don't see any fiscal, constitutional or commonsense reason why are we doing this, unless there's something behind it that has, like maybe a kabuki play where you don't really see the characters, but you see them, and in this case it maybe petty politics in the background. Thank you, Mr. Speaker."

Vice Speaker Mizuno: "Representative Ward, if I may, these are resolutions, not bills, but thank you very much for your insight."

Representative Say rose in opposition to both measures and asked that his written remarks be inserted in the Journal, and the Chair "so ordered."

Representative Say's written remarks are as follows:

"Mr. Speaker, I rise in strong opposition to HR 106 and HCR 154, requesting the Legislative Reference Bureau to evaluate the establishment of separate medical and pension benefit plans for justices and judges. My testimony will make reference to the testimony submitted by the Legislative Reference Bureau (LRB).

"The LRB, in its testimony, stated that establishing separate medical and pension benefit plans solely for justices and judges would not be constitutionally or statutorily barred for persons who first enter service as a justice or judge after the establishment of such plans. According to Article XVI, Section 2 of the Hawaii State Constitution, current or past justices or judges would be barred from being transferred to such new plans.

"The testimony also stated that the establishment would not fulfill the intent of solving potential conflicts of interest, since after all justices and judges transition to the new plans, the same justices and judges would still be asked to preside over such cases.

"The LRB also stated that they lack 'specific expertise' in determining what would be deemed appropriate or commensurate medical or pension benefits plans that would attract qualified individuals to serve as justices or judges.

"For these reasons, I stand in strong opposition to these resolutions. Thank you."

Representative Luke rose to speak in support of both measures, stating:

"Thank you, Mr. Speaker. In support. So this actually is in response to the Dannenberg case. Dannenberg case was a case instituted by a retired judge. Because of the Dannenberg case and because all the five justices on the Supreme Court knew Judge Dannenberg, they recused themselves. So, it's going to be a continuous problem if we don't do a different type of ERS system, because the Supreme Court justices recused themselves because they said, okay, we're part of this system. So we need to create a different system so that we can have a finality on the Dannenberg case. Thank you."

The motion was put to vote by the Chair and carried, and the reports of the Committee were adopted and H.R. No. 106, entitled: "HOUSE RESOLUTION REQUESTING THE LEGISLATIVE REFERENCE BUREAU TO EVALUATE THE ESTABLISHMENT OF SEPARATE MEDICAL AND PENSION BENEFIT PLANS FOR JUSTICES AND JUDGES," was adopted, with Representatives Say and Ward voting no, and with Representatives McDermott, Oshiro, Thielen and Tupola being excused; and

"Mr. Speaker, in strong support and permission to submit comments into the Journal."

Representative Lowen's written remarks are as follows:

"Thank you, Mr. Speaker. In support. Hawaii Island has by far the largest per capita incidence of impaired and drunk driving offenses. Needless, tragic deaths occur every year because of this problem, and we should be doing everything we can to stop this from happening.

"This resolution is a step towards establishing DWI courts on Hawaii Island. DWI Court is a court dedicated to changing the behavior of the hardcore DWI offenders, with a model that uses accountability and long-term treatment to prevent repeat driving incidents. Many courts in other states have evaluated their programs and have shown successful results and significant reductions in repeat offences.

"Given that Hawaii Island has the worst problem in the State with drunk driving offenses, if establishing DWI courts is one way to reduce the number of drunk and impaired driving incidents, then we should move to do so as quickly as possible."

"Mr. Speaker, with reservations and a brief comment. Mr. Speaker, this resolution attempts to call for a constitutional amendment to make sure that corporations are not defined as people. I think that's probably well taken, but it's only half what we should be doing. Let me give a bit of a

history on campaign funding and spending. Because the Citizens decision made it where unlimited amounts of money can be spent by corporation. And what's missing and why this is a half a loaf, is that unions can also do that.

"In the beginning, there was campaign spending beginning in 1867, Mr. Speaker. First campaign spending law was in 1867. Government employees were trying to take dock workers for campaign funds, obviously to get their bosses reelected. Then in 1907, Congress passed no corporations will give money to campaign funds. In 1943, unions were forbidden from giving campaign funds to candidates. And then in 1976, Buckley v. Valeo, and this is where the Supreme Court really got involved, they said you cannot limit campaign spending. Campaign spending limits were lifted.

"But fast forward to 2012, when the Citizens United came, it said, corporations, and this is where most people miss it, colleagues, and unions can spend unlimited amounts of money. Now, this is an uncoordinated money, but it's unlimited from unions and corporations. This one is only hitting the corporations. Mr. Speaker, unions and corporations should be hit on this, because those are the big boys. Those are the ones who can really push the dial in these campaigns, with their millions of dollars.

"So I'm hoping with this reservation it makes people aware that it's just not the corporations, it's whoever is big out there and the kinetic energy, if you will, with their finances, can sway elections. So this is a half-a-loaf, but it should be both unions and corporations that we're aiming our legislation at. Thank you, Mr. Speaker."

Representative Lee rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. In support. And I actually ask to purchase an additional five minutes of speaking time this morning."

Vice Speaker Mizuno: "I guess that's so ordered."

Representative Lee: "Five dollars a minute? What's the going rate?"

Vice Speaker Mizuno: "I don't know what the fair market value is per minute going on right now."

Representative Lee: "It's my understanding, House Rules don't permit the purchase of additional speaking time."

Vice Speaker Mizuno: "Good point."

Representative Lee: "Thank you very much, Mr. Speaker."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.C.R. No. 29, entitled: "HOUSE CONCURRENT RESOLUTION URGING HAWAII'S CONGRESSIONAL DELEGATION TO PROPOSE AND PASS A PROPOSED AMENDMENT TO THE UNITED STATES CONSTITUTION CLARIFYING THAT CORPORATIONS ARE NOT PEOPLE WITH CONSTITUTIONAL RIGHTS, AND THAT UNLIMITED CAMPAIGN SPENDING IS NOT FREE SPEECH," was adopted, with Representative Ward voting aye with reservations, and with Representatives McDermott, Oshiro, Thielen and Tupola being excused.
