

## FORTY-FIFTH DAY

**Friday, April 8, 2016**

The House of Representatives of the Twenty-Eighth Legislature of the State of Hawaii, Regular Session of 2016, convened at 12:17 o'clock p.m., with Speaker Souki presiding.

The invocation was delivered by the Reverend John Heidel, retired Minister of the United Church of Christ, after which the Roll was called showing all Members present with the exception of Representatives DeCoite, Hashem, Kong, Oshiro and Thielen, who were excused.

And if everything that my colleague and others have said is true, there shouldn't be a \$250 license fee for this or \$2 an acre. That just doesn't fit. So I hope all of you let my colleague from Kailua know what I said today. Thank you."

"Thank you, Mr. Speaker. With reservations. Mr. Speaker, this is the bill that requires special event operators to collect information on the folks who are part of their organization and their event. And I think it's the most commonsense and practical means to collect the tax revenue that we're owed. However, my reservations stem from the fact that I believe we are asking private industry to do the work of the Department of Taxation. Thank you, Mr. Speaker."

Representative McKelvey rose to speak in support of the measure with reservations, stating:

"With reservations as well, Mr. Speaker. I would like the comments of the previous speaker entered into the Journal as if they were my own. Another point to bring out is it actually, obviously doesn't apply to non-profits, and it's basically incentivizing everybody to become a non-profit, which deprives the State of revenue, right? Thanks," and the Chair "so ordered." (By reference only.)

Representative Ward rose to speak in support of the measure with reservations, stating:

"Mr. Speaker, with reservations, a brief comment. Mr. Speaker, a few years ago, this body discerned the fact that DOTAX needed to get everybody a license, and everybody should have a license who does business in the State of Hawaii. So what we did was authorize them to do basically flea market raids. They would flash their badge and say, I want to see your GET tax license. And they were doing that. And now this is like almost the flea market police where it's saying, for you who are the organizers, you do our work, as the good Representative from Liliha said.

"Mr. Speaker, there's got to be a compromise as to how much we are pushing these small business entrepreneurs, while at the same time there are a few billion dollars' worth of the big fish out there who we're not going around and chasing, we're chasing these *manini* guys. So with that, Mr. Speaker, let's put it in perspective and know that the flea market police is not going to make the State rich. Thank you."

Representative Tupola rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Kobayashi rose to speak in support of the measure with reservations, stating:

"Mr. Speaker, with reservations. I'm looking at the definition again that exempts non-profits. The problem is that if a non-profit organization raises money, it is normally required to pay a GET tax. So, many non-profits from cultural groups, to even some schools, will organize an event that raises money for their entity, but they have to report GET tax. I think the clarification as to who is required to report would be helpful. Thank you."

Representative Choy rose to speak in support of the measure, stating:

"Mr. Speaker, in support. Mr. Speaker, as I listen to my colleagues, it's interesting to note that we are trying to collect our GE taxes from people who already owe GE taxes. This is not a new tax, we're just trying to do a compliance measure. So I'm really surprised that my colleagues would object to us having stricter laws in collecting our taxes. If we don't collect our taxes, I believe that we're going to end up raising taxes to cover the people who don't pay our taxes. So I stand in support of any measure that's going to help us collect our taxes. And it's not a new tax, it's just the right thing to do. Thank you, Mr. Speaker."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and S.B. "Mr. Speaker, in strong support.

"Mr. Speaker, this bill will ensure the continuance of a program that makes doing business in Hawaii a little easier. Mr. Speaker, I am reminded of the generations that came before us who worked and toiled the land tirelessly to create a better future for all of us. Now we have an opportunity to do the same for the generations to come.

"This grant program helps by providing aid for a sector of our economy that has great potential. The manufacturing industry on Kauai alone could utilize this grant program. From Kai Kini Bikinis, Kauai Kookie, Koloa Rum, Nani Moon Mead, and a slew of other manufacturers which provide local jobs, local products, and further help brand the State of Hawaii and the island of Kauai, this program will provide an economic boost to help expand businesses and hire more local workers.

"Mr. Speaker, the Kawakami family knows firsthand how challenging it is to manufacture in Hawaii. Our family has operated Kauai Kookie, the Big Save Value Centers, and the Menehune Food Mart convenience stores which provided the famous Lawai Manju and various *omiyage* items. It would be an honor to provide support to fellow manufacturers and help them expand and improve their operations. These are the reasons I stand in strong support of this measure."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and S.B. "Thank you, Mr. Speaker. Strong support and permission to insert written comments."

Representative Kawakami's written remarks are as follows:

"Mr. Speaker, in strong support.

"Mr. Speaker, this measure ensures we continue a beneficial program we created last session. Mr. Speaker, last session the House Committee on Economic Development & Business prioritized the creation of two programs. One was the manufacturing grant program and the other allowed the Small Business Innovation Research Program to issue grants to Phase 2 and Phase 3 applicants. You see, Mr. Speaker, we were funding Phase 1 projects but did not follow up on support for Phase 2, prototyping, and Phase 3, manufacturing, so these innovators, dreamers and entrepreneurs were coming up with these grand ideas but found themselves stuck on a treadmill and getting nowhere really fast. This measure allows these dreamers, innovators and entrepreneurs to cross the bridge and bring their ideas to fruition.

"I would like to end by saying that none of this would be possible without the support of the committee. I would like to personally thank the committee members Jimmy Tokioka, Isaac Choy, Lynn DeCoite, Clift Tsuji, Tom Brower, Ken Ito, Takashi Ohno, Justin Woodson, Richard Onishi, Romy Cachola, Gene Ward and Lauren Matsumoto. I would also be remiss if I didn't disclose that I think that I am the luckiest Chair in the House, not only because I have great committee members, but because I have the nicest vice chair in the world, Representative Sam Kong. This guy is the epitome of a people's person. I would also like to thank my hardworking staff who really helped carry me through the session, Ben

Viernes, Polly Phillips, Jason Young, and of course our team mom Ms. Gini Kapali. I am forever grateful. All of you have made a mark in my life and I am very fortunate our paths have crossed in this journey of life."

Representative McKelvey rose to speak in support of the measure, stating:

"Strong support, same request, if you please. Thanks."

Representative McKelvey's written remarks are as follows:

"The technology industry in Hawaii has grown over the past 10 years and has made significant strides towards achieving the goal of diversifying and stimulating Hawaii's economy.

"The measure provides the opportunity for the High Technology Development Corporation (HTDC) to continue to help level the playing field for Hawaii's technology companies, enabling them to compete on more even footing with mainland companies for these increasingly scarce and competitive Federal Small Business Innovation and Research (SBIR) Phase II research dollars and Phase III commercialization investments, and thereby be more successful in their Phase II Research and Development and Phase III commercialization efforts. The continuation of the SBIR Phase II and III grants is crucial for the maturation and commercialization of Hawaii's technology companies.

"Mr. Speaker, it should be noted that the HTDC has offered matching grants to SBIR awarded companies since 1989; as a result, Hawaii companies have attracted 20 federal dollars in return to the state plus commercialization funding for every dollar invested through this program. Further, it is part of HTDC's vision to create 80,000 new innovation jobs in Hawaii earning \$80,000 or more by 2030, salaries that can reduce the 'brain drain' and keep our local talent from having to move away from their home. Just last year, through Act 216, the Legislature appropriated \$2 million to expand the Hawaii SBIR program to include companies winning SBIR phase II and phase III awards.

"I support the objectives of the SBIR grants, for they represent the pioneering spirit of entrepreneurship that Hawaii should embrace as we look to the future.

"The objectives of the SBIR Phase II and III grants are:

- To support economic growth and the diversification of our economy;
- To support the growth of the tech industry and the creation of intellectual property and innovation in the State;
- To launch new ventures based on technology innovations; and
- To act as a bridge across the 'valley of death' and to assist in commercializing research discoveries for societal benefit.

"For these foregoing reasons, I support SB 3110, SD1, HD1."

I hope the conference committee can address those, because prevailing wage of course is a good thing, so all our workers get good salaries. Thanks."

"Mr. Speaker, I rise with reservations on SB 1311, relating to the exemption of licensing and certification in practicing behavior analysis. I support this bill because I believe we should provide greater support for the workers who provide for autistic students in Hawaii. I support the efforts to grow a workforce of licensed and certified professionals that can work with the autistic and behavioral needs students.

"However, I have reservations on this bill because I believe that these children deserve adequate and professional care. The lack of certification for these behavioral analysts that this bill accepts might be inefficient and detrimental to these students who have very specific needs. Also, allowing unlicensed behavioral analysts to engage in an otherwise specific (and certification required) job could lead to future liabilities for the State. It is for these reasons that I vote with reservations on this bill, SB 1311."

Representative Cullen rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Fukumoto Chang rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Pouha rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Kawakami rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

"Mr. Speaker, a no vote, please, brief comment. I'm not in favor of even a temporary, I guess, exemption from licensure for behavior analysis. I want to commend our chair, she asked some very good questions, and we have a department that is in desperate need of getting people who are licensed and qualified to take care of this population of children in our educational system that has been negligent for years. And so for that reason, I don't support this. Thank you."

Representative Tokioka rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Ward rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Morikawa rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Ichiyama rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Har rose in support of the measure with reservations and asked that her written remarks be inserted in the Journal, and the Chair "so ordered."

Representative Har's written remarks are as follows:

"Mr. Speaker, I rise in support of Senate Bill 1311, SD 2, HD 1, with reservations. The intent of the bill is to exempt licensed or credentialed practitioners from licensing requirements for the practice of behavior analysis. It specifically relates to autism treatment services pursuant to the Department of Education's Individualized Education Plan. My reservations stem from various testimonies provided to the House Committee on Consumer Protection and Commerce. The concerns raised by testifiers centered around the strain that will be placed on teachers, and the strong need for behavioral analysts in appropriately working with *keiki* who need these services.



"Teachers have come forward to speak directly to the need for behavioral analytic services in their defined capacity, and that the assumption of this bill going forward is that the teachers themselves can simply 'handle it.' According to the very powerful testimony provided to the committee, there is a strong understanding in the teaching profession that the education and experience required for teaching does not adequately equip teachers to deal with the demand for behavioral analytic services. Requiring them to do so can create many issues for both teachers and the most at-risk students in our schools.

"The need for behavior analysts has already presented itself, it is what has given rise to Senate Bill 1311. I am concerned that the language of the bill will not address the real need for the service, but instead hopes to address an arbitrary numerical requirement in place for department professionals who provide the service. The key here is that the service would not actually be provided. This is not a prudent solution, allowing the educational system to 'fulfil its legal obligations' but putting the burden of these obligations on the already-overburdened staff of the educational system and students in need. It also leaves neither with any recourse; students and parents cannot ask for redress as the State will have, under this bill, fulfilled its obligations, and teachers cannot appropriately provide for the most at-risk students, as the burden can be placed on them with impunity. All of Hawaii's children deserve the best from our educational system, and care needs to be taken to ensure that laws we pass provide the most for our *keiki*, and not just for state departments. The testimony heard on this measure leaves me with concerns as to where this will leave our state's schools.

"For these reasons I stand in support of Senate Bill 1311, SD 2, HD 1, with reservations. Thank you, Mr. Speaker."

Representative Choy rose in support of the measure with reservations and asked that his written remarks be inserted in the Journal, and the Chair "so ordered."

Representative Choy's written remarks are as follows:

"Mr. Speaker, I have reservations on this measure.

"Mr. Speaker, a license is a privilege or permission to perform a task. The privilege is given after meeting the requirements of licensure. These requirements usually include basic education, experience, and testing. It also includes the maintenance of competence through continuing education and relevant experience. Services performed by an unlicensed person circumvent the critical policy of consumer protection and consumer expectations, and therefore should never be tolerated, even for a temporary period."

Representative Aquino rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Ito rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."
