Representatives Takumi and Morikawa, for the Committee on Education and the Committee on Human Services, presented a report (Stand. Com. Rep. No. 1739-16) recommending that S.C.R. No. 153, SD 1 be referred to the Committee on Finance.

On motion by Representative Saiki, seconded by Representative Evans and carried, the report of the Committees was adopted and S.C.R. No. 153, SD 1, entitled: "SENATE CONCURRENT RESOLUTION REQUESTING THE DEPARTMENT OF EDUCATION TO CONDUCT A TWO-YEAR PILOT PROJECT TO IMPLEMENT CONTRACTS FOR SERVICES FOR STUDENTS WITH DISABILITIES ON A BLOCK BASIS IN ADDITION TO ON A ONE-TO-ONE BASIS," was referred to the Committee on Finance, with Representatives Fukumoto Chang, Har, Oshiro, Souki and Ward being excused.

Representative Takumi, for the Committee on Education, presented a report (Stand. Com. Rep. No. 1740-16) recommending that S.C.R. No. 110, SD 1 be referred to the Committee on Finance.

On motion by Representative Saiki, seconded by Representative Evans and carried, the report of the Committee was adopted and S.C.R. No. 110, SD 1, entitled: "SENATE CONCURRENT RESOLUTION REQUESTING THE DEPARTMENT OF EDUCATION TO AFFIRM ITS COMMITMENT TO UPHOLD THE TENETS OF TITLE IX OF THE EDUCATION AMENDMENT ACT OF 1972," was referred to the Committee on Finance, with Representatives Fukumoto Chang, Har, Oshiro, Souki and Ward being excused.

Representative Takumi, for the Committee on Education, presented a report (Stand. Com. Rep. No. 1741-16) recommending that S.C.R. No. 146, SD 1 be referred to the Committee on Finance.

Representative Saiki moved that the report of the Committee be adopted, and that S.C.R. No. 146, SD 1 be referred to the Committee on Finance, seconded by Representative Evans.

Representative Say rose to speak in support of the measure, stating:

"Mr. Speaker, in strong support with written comments."

Representative Say's written remarks are as follows:

"Mr. Speaker, in strong support of SCR 146, SD 1, Requesting the Department of Education to Work with a School of Architecture to Develop a Proof of Concept for the Planning and Designing of a Gymnasium at Anuenue School.

"Knowing that the Department of Education supports this resolution, I am in strong support also. Anuenue School was officially an elementary school in the back of Palolo Valley. With the consolidation of Anuenue School with Palolo Elementary School, Anuenue has since expanded into a K-12 Hawaiian Immersion School. Due to its physical site limitations, space to expand facilities is a significant challenge. And this also makes for a unique learning opportunity for students at the School of Architecture at the University of Hawaii. Knowing that the DOE is happy to work with the School of Architecture to develop and provide the framework of the master plan of a gymnasium, I wholeheartedly endorse this resolution. Thank you for the Opportunity."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and S.C.R. No. 146, SD 1, entitled: "SENATE CONCURRENT RESOLUTION REQUESTING THE DEPARTMENT OF EDUCATION TO WORK WITH A SCHOOL OF ARCHITECTURE TO DEVELOP A PROOF OF CONCEPT FOR THE PLANNING AND DESIGNING OF A GYMNASIUM AT ANUENUE SCHOOL," was referred to the Committee on Finance, with Representatives Fukumoto Chang, Har, Oshiro, Souki and Ward being excused.

Representative Takumi, for the Committee on Education, presented a report (Stand. Com. Rep. No. 1742-16) recommending that S.C.R. No. 154, SD 1, as amended in HD 1, be referred to the Committee on Finance.

On motion by Representative Saiki, seconded by Representative Evans and carried, the report of the Committee was adopted and S.C.R. No. 154, SD 1, HD 1, entitled: "SENATE CONCURRENT RESOLUTION REQUESTING A STUDY ON THE PER-PUPIL FUNDING SYSTEM FOR PUBLIC CHARTER SCHOOLS TO DETERMINE WHETHER THE SYSTEM FULFILLS ITS STATUTORY PURPOSE OF EQUALIZING OPERATIONAL FUNDING AMONG PUBLIC SCHOOLS," was referred to the Committee on Finance, with Representatives Fukumoto Chang, Har, Oshiro, Souki and Ward being excused.

Representatives Ing and Yamane, for the Committee on Ocean, Marine Resources, & Hawaiian Affairs and the Committee on Water & Land, presented a report (Stand. Com. Rep. No. 1743-16) recommending that S.C.R. No. 9 be referred to the Committee on Finance.

On motion by Representative Saiki, seconded by Representative Evans and carried, the report of the Committees was adopted and S.C.R. No. 9, entitled: "SENATE CONCURRENT RESOLUTION AUTHORIZING THE ISSUANCE OF A TERM, NON-EXCLUSIVE EASEMENT COVERING A PORTION OF STATE SUBMERGED LANDS AT HEEIA, KOOLAUPOKO, OAHU, FOR THE USE, CONSTRUCTION, MAINTENANCE, AND REPAIR OF THE EXISTING BOAT DOCK CONSTRUCTED THEREON," was referred to the Committee on Finance, with Representatives Fukumoto Chang, Har, Oshiro, Souki and Ward being excused.

Representatives Ing and Yamane, for the Committee on Ocean, Marine Resources, & Hawaiian Affairs and the Committee on Water & Land, presented a report (Stand. Com. Rep. No. 1744-16) recommending that S.C.R. No. 14 be referred to the Committee on Finance.

On motion by Representative Saiki, seconded by Representative Evans and carried, the report of the Committees was adopted and S.C.R. No. 14, entitled: "SENATE CONCURRENT RESOLUTION AUTHORIZING THE ISSUANCE OF A TERM, NON-EXCLUSIVE EASEMENT COVERING PORTION OF STATE SUBMERGED LANDS AT KAIPAPAU, KOOLAULOA, OAHU, FOR THE MAINTENANCE AND REPAIR OF THE EXISTING ROCK SEAWALL, AND FOR USE, REPAIR, AND MAINTENANCE OF THE EXISTING IMPROVEMENTS CONSTRUCTED THEREON," was referred to the Committee on Finance, with Representatives Fukumoto Chang, Har, Oshiro, Souki and Ward being excused.

Representatives Ing and Yamane, for the Committee on Ocean, Marine Resources, & Hawaiian Affairs and the Committee on Water & Land, presented a report (Stand. Com. Rep. No. 1745-16) recommending that S.C.R. No. 15 be referred to the Committee on Finance.

On motion by Representative Saiki, seconded by Representative Evans and carried, the report of the Committees was adopted and S.C.R. No. 15, entitled: "SENATE CONCURRENT RESOLUTION AUTHORIZING THE ISSUANCE OF A TERM, NON-EXCLUSIVE EASEMENT COVERING PORTION OF STATE SUBMERGED LANDS AT KANEOHE, KOOLAUPOKO, OAHU, FOR THE MAINTENANCE AND REPAIR OF THE EXISTING PIER, AND FOR USE, REPAIR, AND MAINTENANCE OF THE EXISTING IMPROVEMENTS CONSTRUCTED THEREON," was referred to the Committee on Finance, with Representatives Fukumoto Chang, Har, Oshiro, Souki and Ward being excused.

Representative Belatti, for the Committee on Health, presented a report (Stand. Com. Rep. No. 1746-16) recommending that S.C.R. No. 106 be adopted.

On motion by Representative Saiki, seconded by Representative Evans and carried, the report of the Committee was adopted and S.C.R. No. 106, entitled: "SENATE CONCURRENT RESOLUTION RECOGNIZING THE MONTH OF SEPTEMBER AS SEPSIS AWARENESS MONTH IN HAWAII, AND THE THIRTEENTH DAY IN SEPTEMBER OF EVERY YEAR AS HAWAII SEPSIS DAY," was adopted, with Representatives Choy, Fukumoto Chang, Har, Hashem, Ito, Johanson, Jordan, Kong, McKelvey, Oshiro, Say, Souki and Tokioka being excused.

Representatives Belatti and Morikawa, for the Committee on Health and the Committee on Human Services, presented a report (Stand. Com. Rep. No. 1747-16) recommending that S.C.R. No. 85, SD 1 be adopted.

Representative Saiki moved that the report of the Committees be adopted, and that S.C.R. No. 85, SD 1 be adopted, seconded by Representative Evans.

Representative McDermott rose to speak in opposition to the measure, stating:

"Thank you, Mr. Speaker. Opposition, please. First of all, I don't condone any sort of violence directed at anyone, particularly Planned Parenthood clinics. I think that is just deplorable and I think that those folks who engage in that sort of behavior are terribly, terribly sick and should be put in jail, Mr. Speaker.

"But this goes beyond that, Mr. Speaker. Planned Parenthood is responsible now for writing most of the sex ed curricula across the country. I have proven on this House Floor that that material is grossly inaccurate. For example, the anus as a genital. In fact, it's so pervasive, if you google anus as a genital, you will find it come up under Google, because they've gotten it into all the schools. But that's medically inaccurate.

"Their approach to sex ed with young women and sexuality education and counseling actually encourages sexual activity. In fact, the Pono Choices program, which they wrote, tells 10-year-old children, 10 years old, that you're ready when you decide you're ready. And Planned Parenthood was the, quote unquote, 'medical expert' for that program.

"By encouraging early onset of sexual activity, and that is what they do, they're increasing the number of partners and the risk of HIV, HPV and chlamydia. They do nothing to say, delay your sexual activity. Quite the opposite, they encourage early sexual activity.

"We know they don't perform mammograms, although that was touted for years, they perform mammograms. They don't perform any mammograms. They do give referrals for other services, but the main thing they do is terminate pregnancies. And there is no limit. We are here today to celebrate an organization that believes you should be able to abort a child the fifth month, the sixth month, the seventh month, the eighth month, right up to the moment it comes out of the birth canal.

"There are no limits with Planned Parenthood. It's an organization, they talk about the videos in this resolution. Well, what the video showed, of course you're going to edit them because you can't show eight hours of video straight on a news broadcast. But these videos were reviewed by Coalfire, forensic analysts, and they found that they were not deceptively edited. Planned Parenthood hired its own forensic firm, Fusion GPS, which has ties to the Democratic Party, to look at the videos. They too found, quote, no widespread evidence of substantive video manipulation.

"So the selling of baby body parts, I'm sorry, fetal tissue for research. The laughing about when you ship a brain, you have to keep it in the severed head of the baby in order not to damage the brain so the researcher, when they get it, can work on this brain in the baby's head. And they were laughing, you have to warn the researcher because they'll open the box and they'll see a baby's head and they'll freak out. And that was quite a moment of jocularly for the Planned Parenthood employees.

"It is an organization that has its roots in racism. Margaret Sanger did not like African Americans. Last year in New York City more black babies were aborted than born. Congratulations, Margaret Sanger, you've accomplished your dream.

"Here are some quotes from Margaret Sanger, the founder of Planned Parenthood. The most merciful thing that a family does to one of its infant members is to kill it. Quote, birth control must lead ultimately to a cleaner race."

Representative Tupola rose to yield her time, and the Chair "so ordered."

Representative McDermott continued, stating:

"Quote, we should hire three or four colored ministers, preferably with social-service backgrounds, and with engaging personalities. The most successful educational approach to the Negro is through a religious appeal. We don't want word to go out that we want to exterminate the Negro population. Quote, eugenic sterilization is an urgent need. We must prevent the multiplication of bad stock. Quote, birth control itself, often denounced as a violation of natural law, is nothing more or less than the facilitation of the process of weeding out the unfit, of preventing the birth of defectives or of those who will become defectives.

"This is a racist. This is who founded Planned Parenthood. By the way, I'll point that Pono Choices was directed at children of color. Asians, Pacific Islanders. Just an aside.

"The imbalance between the birth-rate of the unfit and the fit is the greatest menace to civilization, and the most urgent problem today is how do we discourage the over-fertility of the mentally and physically defective. She's got a big heart. Quote, our failure to segregate morons who are increasing and multiplying, a dead weight of human waste, an ever increasing, unceasingly spawning class of human beings who never should have been born at all.

"Quote, the undeniably feeble-minded should, indeed, not only be discouraged but prevented from propagating their kind. Quote, the procreation of the diseased and feeble-minded should be stopped. Quote, the marriage-bed is the most degenerating influence of the social order. Mandatory sterilization for the insane and feeble-minded is the answer. Nice lady. Real sweetheart.

"So how does Planned Parenthood violate the law? These are just as of January 2016 this past year, Ohio records show multiple Planned Parenthood facilities appear to be illegally dumping aborted fetuses in landfills. The Ohio Planned Parenthood were also steam-cooking the aborted baby bodies before dumping them. This is a great organization, I'm so glad we're really celebrating today."

Representative Evans rose to a point of order, stating:

"Mr. Speaker, a point of order. We're talking about another state instead of this resolution is about the Hawaii Planned Parenthood."

At 12:00 o'clock p.m., Representative McDermott requested a recess and the Chair declared a recess subject to the call of the Chair.

The House of Representatives reconvened at 12:01 o'clock p.m.

At this time, the Chair stated:

"Members, before we continue, I just wanted to read off, and we're not going to take away your time as I read this off. Quickly, Rule 27.7 provides, 'it is not the person but the measure that is the subject of debate, and it is not allowable to arraign the motives of a Member, but the nature or consequences of a measure may be condemned in strong terms.'

"At this point, the current speaker has not attacked any Member in this body, and the floor speech is focused on the merits of the bill, so the current speaker will be allowed to continue. Representative McDermott."

Representative McDermott continued, stating:

"Thank you, Mr. Speaker. And by the way, I love most of the people in this chamber, I really do. I have affection for many of them. And I know many of them care about me, they just don't like my politics. And I understand that, that's okay. We're here in the marketplace of ideas to discuss this measure. I didn't go looking for it, it was brought to the floor, it talks about the videos and it talks about Planned Parenthood both locally and nationally as well. So I am just trying to point out that this organization has a record.

"First of all, I'd like to ask, comments to the Journal, please, to make it a little briefer. I hate to cheat the Members out of the opportunity to hear, but I will make it a little briefer.

"But across the country, they have violated laws. And they treat the child with such disrespect. Six months, you've seen the videos. There are things that their own people said they weren't widely doctored. There are things that just boggle the mind of a human being. We care more about stray dogs in this facility, this building, than we do about aborted babies. And I can understand intellectually how someone at two weeks or four weeks is, if they're fuzzy about whether that's a person. But when you get to four months and five months and six months, then it's beyond question.

"But we celebrate the killing of children. We celebrate it. That's what this is. This is a totally immoral measure in my view, as we're celebrating, affirming a tragic event. Abortion is never happy. It's never fun. I have yet to talk to a woman who said, I had an abortion, it was a blast. It's a tragic, tragic event and I feel for the women, but I also feel for the children. It's tragic. And here we are celebrating it, affirming it, saying it's the greatest thing since sliced bread."

Representative Pouha rose to yield his time, and the Chair "so ordered."

Representative McDermott continued, stating:

"Here we are affirming it, saying it's the greatest thing since sliced bread. And boy, if you don't agree with this, there's something wrong with you. I remember when Bill Clinton said that abortion should be safe, legal and rare. And he won the presidency. But where is the rare component now? It's abortion on demand, any time, any place. We have Kapiolani women and children's hospital. If a woman goes in there with a preemie at five months, the doctors are in the operatory, sleeves rolled up, doing everything they can to try and save that child, to try and keep it alive. In the incubator, hooking it up, neonatal, fetology, all this advanced medicine comes to bear to save the life of that child. And they are successful 20 weeks and beyond. The next operatory over there is a girl who is five and a half months, two weeks further along, and she's having an abortion. That's a child.

"Mr. Speaker, we thank Planned Parenthood, we should thank them because a 13-year-old can get an abortion in this town without talking to her mother or father. Thank you, Planned Parenthood. In Pono Choices, the anus is a genital. Thank you, Planned Parenthood.

"They do nothing to discourage young sexual activity, in fact quite the opposite, they promote sexual behavior. They do nothing to say, wait, wait, wait, you'll be better off if you wait. We know you won't wait until marriage, but that's the gold standard, but try and wait. You don't tell them at 10 years old to begin. But that's what Planned Parenthood does.

"And if anybody wants documentation, go to my website, ohanapolicygroup.com. All my reports are there, fully footnoted and documented. And who do you think wanted sex ed in kindergarten? Kindergarten. You don't go in Ewa Beach and tell the local people, we think your kids need sex ed in kindergarten. Two words come to my mind, dirty lickings. That is what Planned Parenthood does, that's what they push. No boundaries, no rules, no restriction.

"Mr. Speaker, this is a terrible, terrible organization. They do things behind your parent's back. Come get birth control without talking to mom and dad. I could read what they did in Florida, Pennsylvania, South Carolina, Missouri, Colorado, Kentucky, you've seen it. Girls go in and they were raped. They were raped. A victim of violence. Planned Parenthood doesn't report it. What if they were a victim of incest? Planned Parenthood doesn't report it. The girl goes back home and is victimized again and again. So this thought that we're trying to help them by making them more sexually active and not reporting anything, it's just horrible, horrible, horrible.

"And so, I am going to insert more comments in the Journal, Mr. Speaker, but I've spoken plenty enough. Thank you for your kindness and thank the Floor Leader over there for her kindness as well. Thank you."

Representative McDermott's written remarks are as follows:

"Mr. Speaker, I rise to oppose any resolution that supports and affirms Planned Parenthood. It has long been troubling to many Americans that the nation's largest abortion network, performing over a third of all abortions, receives over half a billion taxpayer dollars a year. This concern has rightly grown in recent years for Americans overwhelmingly oppose public funding of abortion.

*The most recent revelations about Planned Parenthood's willingness to traffic in fetal tissue from abortions to alter methods not for any reason related to women's health but to obtain more "intact" organs is the latest demonstration of callousness toward women and their unborn children that is shocking to many Americans.<sup>1</sup>*

"According to a Reuters Poll, federal funding for Planned Parenthood dropped 20 points from 54% to 34% after respondents learned more about Planned Parenthood's abortion policies and procedures. Planned Parenthood performs over 330,000 abortions each year with its \$1.2 billion-dollar budget.

"Planned Parenthood describes itself as the 'most trusted provider of reproductive health care.'<sup>12</sup> This is only true if you define 'health care services' as abortion.<sup>3</sup> The fact is, 'women's health needs – including heart disease (the number one killer of women), cancer, diabetes, and other non-sexual health concerns – are a larger concern for the majority of US women.'<sup>4</sup>

"When it comes to women's health, community health centers and rural health clinics do a far better job in caring for women than does Planned Parenthood.

"Consider the following statistics:<sup>5</sup>

#### Facilities in the US

- Planned Parenthood – fewer than 700 facilities (31 states have fewer than 10 clinics)
- Community Health Centers – more than 9,000 (located in 98% of Congressional Districts)

#### Number of patients served (men and women)

- Planned Parenthood – 2.7 million patients
- Community Health Centers – 21 million patients

#### Pap Tests

- Planned Parenthood – 378,692
- Community Health Centers – 1,787,256 tests

#### Mammograms

- Planned Parenthood – ZERO
- Community Health Centers – 424,376

#### Abortion

- Planned Parenthood – 327, 653
- Community Health Centers – ZERO

"Planned Parenthood claims that its 'health centers provide a wide range of safe, reliable health care' and that 'caring physicians, nurse practitioners, and other staff take time to talk with clients.'<sup>6</sup> It also claims that it helps to reduce the number and spread of sexually transmitted infections (STIs) through testing and treatment.

"Very few of its clinics actually provide primary care, and unless a woman is getting an abortion, most never see a physician. 'Typically, she would see a nurse. In most states, prescriptions for medication are written in the name of the local Planned Parenthood's medical director – who the woman never sees.'<sup>7</sup>

"Planned Parenthood says that its services prevent unintended pregnancies through contraception.<sup>8</sup> It does not tell women what that means.

*Most women rightly believe that pregnancy begins when the sperm penetrates the egg and a new human being is created. Planned Parenthood, however, uses an obscure 1965 medical definition that defines pregnancy as beginning at implantation in the womb.<sup>9</sup>*

"This means that most of the products that Planned Parenthood sells as contraceptives work, at least some of the time, by killing a new human being rather than preventing creation. The birth control pills that Planned Parenthood pushes on women have been identified by the World Health Organization as a Group 1 carcinogen.<sup>10</sup> Does Planned Parenthood realize that cancer is the second highest cause of death in American women? If so, does this sound as if they really care about women's health?

"Planned Parenthood does not like to talk about the fact that it is the number one provider of abortions in America. 'Complications from abortion include future risk of premature birth, low birthrate; higher risk of

maternal death, increasing with each abortion; links to mental illness, and sterility.'<sup>11</sup> Do Hawaii's legislators still think that Planned Parenthood is the healthy choice for women in our state?

"Planned Parenthood likes to brag that they help 'reduce the spread of sexually transmitted infections (STIs).'<sup>12</sup> 'Yet, scientists have known that the birth control pill (and similar products) actually increases the spread of STIs through lowering the woman's immune system.'<sup>13</sup> If Planned Parenthood were really serious about lowering the spread of STIs, it would be getting women off the pill and teaching abstinence-based sex education to teens as opposed to working behind the scenes with legislators and/or school boards to get rid of it in state after state and replacing it with their pornographic sex ed programs.

"Planned Parenthood's president, Cecile Richards, misled the public when she testified at a Congressional hearing in September 2015 saying that if her organization were defunded, it would mean that millions of women would not have access to mammograms. In 2012, Planned Parenthood issued a press release that read, 'Planned Parenthood helps women nationwide get access to mammograms, as part of the range of health care Planned Parenthood health centers provide to nearly three million people a year.'<sup>14</sup> On September 15, 2015, Ms. Richards indicated that Planned Parenthood does not provide mammograms. They have no mammogram machines at any of their abortion clinics or other locations and refer out for mammograms.<sup>15</sup>

"Planned Parenthood claims to screen for cervical cancer. The major risk factor for cervical cancer is the human papilloma virus (HPV). Young girls who start having sex at a very young age and with many partners are much more likely to get and stay infected with HPV.<sup>16</sup> 'Since Planned Parenthood encourages young people to explore their sexuality, this is the cause of the problem, not the solution.'<sup>17</sup>

"Planned Parenthood is not a health organization. It is in the sex business and it makes its money off of luring young people into sexual lifestyles that are not healthy. It profits off the misery of others and destroys lives.

"Planned Parenthood covers up statutory rape. According to Alliance Defending Freedom (ADF), they 'frequently and flagrantly disregard mandatory sex abuse reporting laws' and 'with the evidence of their crimes covered up and destroyed, predators are free to continue abusing their child victims.'<sup>18</sup>

"Here is a summary of the cases ADF found and compiled in their 2015 report:<sup>19</sup>

#### "Arizona

"A 23-year-old man who impregnated his 12-year-old foster sister took her to a Planned Parenthood clinic for an abortion days before her 13th birthday, and returned with her for a second abortion six months later. The clinic did not notify authorities of the case until five days after the second abortion, and the girl won a settlement from a subsequent lawsuit against the clinic.

"In a second still pending case, a 15-year-old girl's mother took her to a Planned Parenthood for an abortion, and says she notified the clinic her daughter had been sexually assaulted. The mother later told investigators the clinic employee told them it wasn't worth the 'hassle' to report the assault and recorded it as consensual. The man who allegedly carried out the assault was later charged with sexual assault against a number of other minors.

"Ohio

"A girl impregnated by her father, who had been abusing her for four years, went to a Planned Parenthood clinic for an abortion when she was 16, and told an employee she had been raped. The clinic did not report her case to police, and she was abused for another one and a half years. Her father was later prosecuted and incarcerated, and the clinic settled a civil lawsuit on behalf of the girl.

"California

"Before 61-year-old Andrew King was convicted of sexually abusing scores of young girls over decades while working as a swim coach, one of his 14-year-old victims went to Planned Parenthood for an abortion. The clinic did not alert the authorities and only learned of King's pattern of sexual assault after a different victim brought charges.

"A man convicted for raping his 13-year-old stepdaughter brought her to a Planned Parenthood clinic for an abortion in order to conceal his crime when she started putting on weight. The clinic did not report the case to authorities, but referred the girl for a late-term abortion that required a surgical procedure.

"A man prosecuted for sexually abusing his daughters impregnated his 13-year-old daughter, who went to a Planned Parenthood clinic in 2010 for an abortion. About six months later the girl returned to the clinic for a second abortion, and the doctor implanted an intrauterine device to stop her from getting pregnant. The clinic did not report either case, and authorities arrested the man only after the girl's older sister went to the police.

"Connecticut

"A 41-year-old man who kept a 14-year-old girl locked in a small room in his home, where he regularly raped her, brought her to a Planned Parenthood clinic for an abortion under a fake name. The clinic did not report suspected statutory rape, and the girl was held captive for a year until police found her while investigating the man. He was later convicted and incarcerated.

"A 21-year-old man convicted of sexually abusing a 14-year-old girl, who was his girlfriend at the time, became pregnant three times in six months. She got abortions at a Planned Parenthood clinic each of those times, but the clinic allegedly did not report the first statutory rape and abortion to authorities.

"Colorado

"A man who had been abusing his stepdaughter for seven years took her to a Planned Parenthood clinic for an abortion when she was 13. Although the man who brought her to the clinic did not share the girl's last name, and wanted her to get a form of birth control she wasn't comfortable with, Planned Parenthood did not notify the child's parents or report the case to police. The man was later prosecuted and incarcerated, and Planned Parenthood settled a civil suit from the child.

"Minnesota

"A 42-year-old father was prosecuted for sexually assaulting his son's 14-year-old girlfriend — having her sleep over when the son wasn't home and grooming her by driving her to and from school and buying her things, such as Victoria's Secret underwear. He also took her to Planned Parenthood to get birth control, but the clinic allegedly did not report the case to authorities.

"As all 50 states have mandatory reporting laws regarding suspected sexual abuse that typically includes statutory rape, Planned Parenthood was sued directly for failing to report such abuse.<sup>20</sup> This begs the question – How many young girls have been taken to Planned Parenthood centers as a result of abuse? And instead of getting the help they needed, how many of them had their lives destroyed because proof of abuse was covered up?

"One of the most powerful and recent investigations into Planned Parenthood's willingness to cover things up was the undercover investigations regarding sex trafficking of young girls.

*Planned Parenthood was caught coaching a man and woman, posing as a pimp and a prostitute, to obtain abortions, STD testing and birth control for their underage female sex slaves. Staffers instructed the "sex traffickers" to tell the girls to lie about their ages and the ages of their "boyfriends." They even coached the undercover operatives on how to receive discounts on birth control and abortions, and advised which facilities had less stringent standards. Once again, Planned Parenthood was caught on tape covering up abuse—showing they were more than willing to break state and federal laws in order to continue profiting from abortion, even if it meant driving young women back into the arms of their abusers.<sup>21</sup>*

"Does this sound like an organization that really cares about women?"

"Planned Parenthood Targets Minority Women

"And let us look at minority women. Planned Parenthood facilities across the nation engage in racial targeting for abortions.

"Planned Parenthood's founder, Margaret Sanger, was a woman who had a clear and forceful hatred towards minorities, and her views continue to infiltrate the organization to this day.<sup>22</sup>

- African-Americans have a disproportionate number of abortions according to their population in the United States.<sup>23</sup>
- African-American women are 4.8 times as likely as non-Hispanic white women to have an abortion and the African-American population is the only population in the country that is in decline.<sup>24</sup>

"Racist Roots of Planned Parenthood<sup>25</sup>

"Margaret Sanger was obsessed with eugenics and racism. She was present at the first World Population Conference in Geneva in 1926. That same year, she was present at a Klu Klux Klan rally in Silver Lake, New Jersey and recounted this event in her autobiography. 'I accepted an invitation to talk to the women's branch of the Ku Klux Klan ... I saw through the door dim figures parading with banners and illuminated crosses ... I was escorted to the platform, was introduced, and began to speak ... In the end, through simple illustrations I believed I had accomplished my purpose. A dozen invitations to speak to similar groups were proffered' (Margaret Sanger, 'An Autobiography,' Page 366).

"In a letter to Clarence Gable in 1939, Sanger wrote: 'We do not want word to go out that we want to exterminate the Negro population, and the minister is the man who can straighten out that idea if it ever occurs to any of their more rebellious members' (Margaret Sanger commenting on the 'Negro Project' in a letter to Gable, Dec. 10, 1939). The objective of this 'project' was to infiltrate the black community by presenting birth control as a health option for women.

"Her own words and television appearances leave no room for parsing. For example, she wrote many articles about eugenics in the journal she founded in 1917, the Birth Control Review. Her articles included 'Some Moral Aspects of Eugenics' (June 1920), 'The Eugenic Conscience' (February 1921), 'The Purpose of Eugenics' (December 1924), 'Birth Control and Positive Eugenics' (July 1925) and 'Birth Control: The True Eugenics' (August 1928), to name a few.

"Margaret Sanger's Telling Racist Quotes:

- "While I personally believe in the sterilization of the feeble-minded, the insane and syphilitic, I have not been able to discover that these measures are more than superficial deterrents when applied to the constantly growing stream of the unfit. They are excellent means of meeting a certain phase of the situation, but I believe in regard to

these, as in regard to other eugenic means, that they do not go to the bottom of the matter." ("Birth Control and Racial Betterment," Feb. 1919, The Birth Control Review).

- "Eugenics without birth control seems to us a house builded upon the sands. It is at the mercy of the rising stream of the unfit" ("Birth Control and Racial Betterment," Feb. 1919, The Birth Control Review).
- "Stop our national habit of human waste." ("Woman and the New Race," 1920, Chapter 6).
- "By all means, there should be no children when either mother or father suffers from such diseases as tuberculosis, gonorrhoea, syphilis, cancer, epilepsy, insanity, drunkenness and mental disorders. In the case of the mother, heart disease, kidney trouble and pelvic deformities are also a serious bar to childbearing. No more children should be born when the parents, though healthy themselves, find that their children are physically or mentally defective." ("Woman and the New Race," 1920, Chapter 7).
- "The main objects of the Population Congress would be to apply a stern and rigid policy of sterilization and segregation to that grade of population whose progeny is tainted, or whose inheritance is such that objectionable traits may be transmitted to offspring[;] to give certain dysgenic groups in our population their choice of segregation or sterilization." ("A Plan for Peace," 1932).
- In a 1957 interview with Mike Wallace, Sanger revealed: "I think the greatest sin in the world is bringing children into the world — that have disease from their parents, that have no chance in the world to be a human being practically. Delinquents, prisoners, all sorts of things just marked when they're born. That to me is the greatest sin — that people can — can commit."

"This line of thinking from its founder has left lasting marks on the legacy of Planned Parenthood. For example, 79% of Planned Parenthood's surgical abortion facilities are located within walking distance of black or Hispanic communities.<sup>26</sup>

"Sanger's hatred of African American (i.e., she saw them as 'unfit') continues to influence the culture and the rise in the number of minority abortions. Contrary to the public's belief that Planned Parenthood is helpful and supportive of family planning and the health of the mother and child, recent news and research show that the roots of its foundation have continued to show disdain for minorities that its founder saw as 'unfit.'<sup>27</sup>

"The Centers for Disease Control and Prevention's Abortion Surveillance report revealed that between 2007 and 2010, nearly 36% of all abortions in the United States were performed on black children, even though black Americans make up only 13% of our population.<sup>28</sup> A further 21% of abortions were performed on Hispanics, and 7% more on other minority groups, for a total of 64% of U.S. abortions tragically performed on minority groups. Margaret Sanger would have been proud of the effects of her legacy.<sup>29</sup>

#### "Planned Parenthood's Continued Targeting of Minorities"<sup>30</sup>

"Lila Rose, 19-year-old sophomore at UCLA and editor of The Advocate, exposed the truth about Planned Parenthood through legally recorded calls to facilities in seven states. Clinics in Ohio, Oklahoma, Idaho and New Mexico have all been captured on tape willfully accepting donations from a donor that designated the money be spent to abort a black child. These videos which are the audios of the calls, <http://www.youtube.com/watch?v=pgf5m1QoCOU> and <http://www.youtube.com/watch?v=4iQhCv00dZY>, attest to the fact that Planned Parenthood has no problem taking money earmarked for a specific race. The below transcripts of the New Mexico and Ohio calls been

provided by The Advocate.<sup>31</sup>

#### • New Mexico:

Donor: Um, can I make the donation specifically for a minority group?

Planned Parenthood: Like a specific group, or color...or a group of...

Donor: Yeah, yeah, I mean like, I want the abortion to be to be for an African American baby?

Planned Parenthood: Okay.

Donor: ...and I was wondering if that could be possible?

Planned Parenthood: The exact amount we charge right now is \$450 for an abortion

Donor: Okay, \$450

Planned Parenthood: Mhm, and, um, we can definitely designate it for an African American.

Donor: Wonderful, Um

Planned Parenthood: Yeah

#### • Ohio:

Donor: When I underwrite abortions, does that apply to minorities too?

Planned Parenthood: If you specifically wanted to underwrite an abortion for a minority person, you can target it that way. You can specify that is how you wanted it spent.

Donor: Ok, yeah, because there's definitely way too many Black people in Ohio, so I'm just trying to do my part.

Planned Parenthood: Ok, whatever.

Donor: Well Blacks especially need abortions too, so that's what I'm trying to do.

Planned Parenthood: Well, for whatever reason, we'll accept the money.

Donor: Ok great, thank you.

"Reverend Clenard H. Childress Jr., head of the LEARN (Life Education and Resource Network) project stated 'every 3rd abortion in America is on Black women. It is the most common surgical procedure performed on Afro-American women.'<sup>32</sup>

#### "Black Pastors Demand Smithsonian Remove Statue of Planned Parenthood's Margaret Sanger"

"In August, 2015, a group of African American pastors wrote the taxpayer funded Smithsonian and asked them to remove a statue of Margaret Sanger because as they explained, she was far from a champion for their race because of her ties to eugenics. Today, Planned Parenthood continues Sanger's work by placing 79% of their abortion facilities near minority neighborhoods. Tragically, since 1973, approximately 13 million black babies have been killed in abortions.<sup>33</sup> The truth is, what the Klu Klux Klan could only dream about, the abortion industry is doing right now and funded with taxpayer money.<sup>34</sup>

#### "Planned Parenthood's Deception and Death"<sup>35</sup>

"While Planned Parenthood boasts that abortion procedures at their facilities are safe, evidence exists to indicate that is far from the truth.

"There is no way to know how many complications from abortion actually occur at Planned Parenthood clinics because there are few mandatory reporting requirements for abortion providers, who are known to often skirt the laws or under-report.

"What is known about Planned Parenthood abortion abuses are just the tip of a very large iceberg. The truth about illegal and dangerous operations has been discovered through research and eyewitness accounts and gleaned through court and newspaper accounts.

"This includes the following:

- Death of Tonya Reaves on July 20, 2012, from hemorrhage caused by a perforation of her uterus during a second trimester abortion at a Planned Parenthood clinic in Chicago, IL.
- Planned Parenthood of Illinois — the same place where Tonya Reaves died — settled a case involving Medicaid billing fraud committed by its medical director, abortionist Caroline Hoke, one week after the Reaves family filed suit against Planned Parenthood.
- Criminal charges against Planned Parenthood in Kansas for illegal late term abortions and manufacturing evidence.
- Documented 16 medical emergencies at Planned Parenthood abortion centers from January, 2011 through October 2012.
- The webcam abortion pill scam in Iowa that prompted Federal legislation as well as laws banning the dangerous practice in at least seven states.

"Planned Parenthood Under Investigation for Fraud"<sup>36</sup>

"Planned Parenthood receives hundreds of millions of our tax dollars in funding, but they're alleged to have filed more than 500,000 false, fraudulent, or ineligible Medicaid claims - charges that carry fines of more than \$5.5 billion. Planned Parenthood receives over \$500 million from taxpayers and paid out \$4.3 million to settle a case alleging fraud. Michael J. Norton, Alliance Defending Freedom Senior Counsel and former U.S. attorney has stated, 'Americans deserve to know, especially in economic times like these, if their hard-earned tax money is being funneled to groups that are misusing it; compliance with the law should not be sacrificed for the sake of Planned Parenthood's bottom line. They have taken advantage of the American taxpayer for too long.'<sup>37</sup>

"Planned Parenthood Indoctrinates Children and Promotes its Extreme Sexual Views on Youth

The Planned Parenthood Federation of America (PPFA) has, since 1970, pushed for sex education in public schools. In 1986, its president, Faye Wattleton, stated that PPFA had established a goal of getting kindergarten through twelfth grade sex education mandated in every school district in the nation. Planned Parenthood sees sex education as a way of indoctrinating our children with PP's philosophies-philosophies that include the acceptance of abortion and deviant sexual practices, philosophies that are in direct opposition to the teachings of most churches in this country.<sup>38</sup>

"According to their own website, 'Planned Parenthood is the largest provider of comprehensive sex education in our communities. Each year, Planned Parenthood affiliates reach 1.5 million young people and parents with effective sex education and outreach in programs run by professional educators and youth peer educators.' [Emphasis theirs.]

"Its website also states that they provide 'young people with positive messages about sex and sexuality as natural, normal parts of life.' This means that there is no such thing as right or wrong when it comes to childhood sexuality. Planned Parenthood is teaching a truly radical philosophy of sexuality to our children.

"As quoted from the EXCLAIM! Young People's Guide to Sexual Rights, Planned Parenthood states: 'young people are sexual beings. They have sexual needs, desires, fantasies and dreams. It is important for all young people around the world to be able to explore, experience and express their sexualities in healthy, positive, pleasurable and safe ways.

This can only happen when young people's sexual rights are guaranteed.' [Emphasis mine.]

"And further: 'Sexual rights are human rights related to people's sexuality. Like everyone else, all young people are entitled to them and they are necessary for the development and well-being of all people and societies in which they live. However, discrimination, stigma, violence, fear, ignorance and some cultural and traditional beliefs threaten people's sexual rights.'

"Should our schools instruct even the very young they have a 'right' to have sexual pleasure, including the how-to's of vaginal, oral, and anal sex, and 'genital rubbing'? Should same-sex and opposite sex partners be casually promoted as equivalent options for kids?

"Planned Parenthood is actually indoctrinating kids into engaging in terribly destructive sexual activity—by describing it, exploring it, and removing all boundaries or moral guides. Planned Parenthood is additionally teaching our kids that their parents have nothing to say about their children's sexual activities.

"You may recall, Mr. Speaker, that after parents contacted me about the now infamous *Pono Choices*—the program that teaches middle school students about same-sex relationships and oral and anal sex—that I attempted to get copies of the entire curriculum from the state Department of Education (DOE), but incredibly, my request was denied. I then approached the University of Hawaii, which received, in partnership with Planned Parenthood, almost a million dollars in a teen pregnancy prevention grant to develop and implement the program. Once again I, as a State Representative for the voters in my district, was turned down. At the time, the DOE spokeswoman told reporters that 'the curriculum is sensitive in nature and can be misinterpreted.'

"Sensitive, indeed! To again quote from PP's EXCLAIM! Proclamation, parents are violating young people's sexual rights by interfering with their children's choices.

"As Planned Parenthood's noxious sex education continued to rocket across the country at unprecedented rates—propelled by millions of dollars in Obamacare PREP grants—those who bore the greatest responsibility for the oversight of children's education were being denied the opportunity to know what their children will be taught in these taxpayer-funded programs.

"And do not presume to think that the voters in my district have forgotten how Planned Parenthood tried to influence the State's Legislature to mandate comprehensive sexuality (CSE) education for the children in the State of Hawaii and when they failed to obtain their objective legislatively, they worked behind the scenes to push the State Board of Education (BOE) to make a policy change. Abstinence-based sex education was removed despite the overwhelming opposition of a good number of caring and involved parents. So, no, I do not think the State should be considering any resolution that would in effect 'affirm' Planned Parenthood.

"And how many of my fellow legislators are aware that in 2012, Hawaii Free Press printed *Undercover Video Catches Hawaii Planned Parenthood Offering Sex Selective Abortions*.<sup>39</sup> These undercover videos showed two of Hawaii's Planned Parenthood clinics (Honolulu and Maui) advising undercover investigators on how to procure a sex selective abortion of a baby girl because she wanted a boy instead. Video also showed a Planned Parenthood Maui Clinic worker counseling Live Action's undercover journalist to wait for a late term abortion to double-check that the baby is actually a girl before killing her.<sup>40</sup>

"SCR 85/SR 56 Resolution

"SCR 85/SR 56 states that Planned Parenthood has 'been under attack in recent months' and makes reference to 'a series of manipulated and misleading videos.' While it is true that the organization has been under

increased scrutiny, it is simply not true that the videos were deceptively edited.

"There have been two different independent expert investigations into the videos and both concluded that the videos were substantially accurate. Coalfire, an internationally recognized digital forensic firm that works for Fortune 500 companies, looked at the videos.<sup>41</sup> Their own forensic analysis showed that the videos were not deceptively edited. Planned Parenthood hired its own independent analysts, who also verified that there was no widespread evidence of substantive video manipulation."<sup>42</sup>

"Planned Parenthood is on the ropes and reeling from months of being exposed for the sickeningly evil practice of selling aborted baby body parts. They have, however, made a number of stunning admission about its abortion and baby harvesting practices according to American Center for Law and Justice:<sup>43</sup>

First, Planned Parenthood admits that "abortion" is a "core" service, meaning it is one that "every affiliate is required to provide."

Second, as a result of the investigative journalists exposing Planned Parenthood's baby harvesting practice, the abortion giant admits that at least 4 of its 59 national affiliates have suddenly stopped all baby harvesting. One can only wonder why.

Third, according to Planned Parenthood, it just lost at least 33% of baby harvesting business because it just lost a key buyer when StemExpress recently cut ties with Planned Parenthood.

Fourth, while Planned Parenthood attempts to downplay its involvement in baby organ harvesting and employs numerous accounting gimmicks in its letter, the evidence Planned Parenthood admits to is that nearly 20% of its affiliates, which could amount to over 100 affiliates, have been involved selling murdered babies for parts over the last five years alone.

Fifth, Planned Parenthood claims it has advised all clinics of the federal law banning the sale of aborted babies and the expansive loophole in the law that allows for extensive "reimbursement." However, this supposed policy was issued in "May 2015," just three months ago, near the end the Center for Medical Progress's undercover investigation – and one can presume likely after Planned Parenthood got wind it was about to be exposed.

Sixth, Planned Parenthood also admits that it receives "\$60 per tissue specimen." \$60 for every dead baby part sold can add up quickly.

Seventh, Planned Parenthood makes this shocking assertion about federal law: "The federal rules relating to consent and timing and method of abortion when the donated tissue is used for federally funded fetal transplantation research are therefore not applicable to any recent fetal tissue donations in the United States."

What this means is that Planned Parenthood is boldly asserting that federal law requiring the informed consent of the woman and requiring no alteration in the timing and method (how the abortion is performed) is "not applicable" to Planned Parenthood.

As absurd as this sounds, Planned Parenthood may have just found another massive loophole in the law to exploit the bodies of the babies it has killed for financial gain at the expense of the health and safety of the women in the hands of its supposed "care."

We know from the videos that Planned Parenthood abortionists change the procedures; they will "crush" here and "crush" there and alter the presentation of the abortion to ensure they get intact (read: more financially valuable) babies.

Eighth, and worse yet, Planned Parenthood goes on in their letter to Congress to state that they "voluntarily" required both informed consent and disallowed any alteration. We've seen the consent form and we've heard the abortionists discussing issuing them in the

videos. What this means is Planned Parenthood is violating its own informed consent forms – which is called medical malpractice.

We also know that after women refuse to give consent, Planned Parenthood may still sell the baby parts.

Ninth, Planned Parenthood claims that only "1%" of its businesses sell murdered baby parts (note that 1% of Planned Parenthood's reported \$1.145 billion dollars in annual affiliate revenue would be \$11.45 million dollars). Sound familiar to its now discredited (even by the mainstream media) 3% lie about abortion "services"?

"The Center of Medical Progress' recent expose' of Planned Parenthood's dissecting and selling live baby body parts after intact birth expulsion from the womb has indeed caused a national scandal. There is shocking video footage available which shows top Planned Parenthood executives discussing the sale of baby body parts, saying that it is a 'valid exchange' and that clinics can make a 'fair amount of income' doing it.<sup>44</sup> While Planned Parenthood likes to claim that these horrific videos have all been 'edited,' the truth is that all of them have been released in unedited form.<sup>45</sup> There is no getting around the things that have actually been said by multiple Planned Parenthood executives. Nobody was putting words in their mouths.

"A Quick And Easy Guide To The Planned Parenthood Videos"<sup>46</sup>

"Here's what they show:

#### 1)Planned Parenthood Uses Partial-Birth Abortions to Sell Baby Parts

This 9-minute-video with more than 3 million views on YouTube features Dr. Deborah Nucatola, Planned Parenthood's senior director for medical services, munching on a salad and sipping wine while she admits to altering abortion procedures in such a way that baby body parts can later be sold to human organ buyers. Laws prohibit altering abortion procedures for organ procurement.

"We've been very good at getting heart, lung, liver, because we know that, so I'm not gonna crush that part," Nucatola tells actors posing as organ traffickers. "I'm gonna basically crush below, I'm gonna crush above, and I'm gonna see if I can get it all intact."

#### 2)Second Planned Parenthood Senior Executive Haggles Over Baby Parts Prices, Changes Abortion Methods

This video features Dr. Mary Gatter, who at the time the video was filmed was serving as the president of the Planned Parenthood Medical Directors Council. In this video, she haggles over the payment for human body parts from aborted fetuses. While negotiating a price, she says she doesn't want to be the first person to name a price, because "the person who throws out the figure first is at a loss."

#### 3)Human Capital – Episode 1: Planned Parenthood's Black Market in Baby Parts

This video features Holly O'Donnell, a former StemExpress technician who harvested the parts from the aborted babies at a Planned Parenthood clinic. This is the first video to really explore how the organs are procured.

#### 4)Planned Parenthood VP Says Fetuses May Come Out Intact, Agrees Payments Specific to the Specimen

This video features Planned Parenthood Rocky Mountains VP & Medical Director Savita Ginde discussing the practice of procuring baby parts as well as how to avoid media scrutiny of their organ harvesting.

Toward the end of the video, the cameras get inside the abortion

clinic's pathological laboratory. Medical assistants are heard and seen cracking skulls, and extracting brains. "Here's some organs for you," a Planned Parenthood employee said. "Here's a stomach, kidney, heart." A medical assistant exclaims: "And another boy!"

5) Intact Fetuses "Just a Matter of Line Items" for Planned Parenthood TX Mega-Center

This video features Planned Parenthood Gulf Coast Research Director Melissa Farrell trying to negotiate a business agreement with investigators posing as organ buyers. She also tells them that some abortionists harvest body parts for their own research. They discuss how they could defend increased payments for more valuable organs even though the law only permits payment for costs. "It's all just a matter of line items," she says.

This video also features employees of a Gulf Coast clinic pulling a 20-week-old twin baby out of the freezer, and graphically sifting through second trimester body parts. An employee holds up a liver and lungs as the technician gushes over how intact the organs are. A large severed limb is also pulled out of the dish where the other mangled remains lay. It is in this section of the video that we hear about the Planned Parenthood Federation's encouragement of fetal organ harvesting.

6) Human Capital – Episode 2: Inside the Planned Parenthood Supply Site

This video once again features former StemExpress procurement technician Holly O'Donnell. O'Donnell worked in Planned Parenthood clinics in California. In this video she explains how the procurement works and the cooperation between Planned Parenthood and Stem Express. Planned Parenthood provides the organ buyers with a list of what operations are being performed. Women are supposed to give consent for donating the body parts of their children. But, O'Donnell says, their organs were regularly harvested without the informed consent of the mothers.

7) Human Capital – Episode 3: Planned Parenthood's Custom Abortions for Superior Product

This is the video that the media claim doesn't exist. It's absolutely horrifying. It combines clips from previous videos we've already seen, such as some of the statements of Planned Parenthood officials, with the claims of others in the baby organ procurement business. But the centerpiece is the first-person testimony of O'Donnell explaining how a late-term baby boy was aborted, how she didn't know if he was technically alive or not since the heart was beating. She says she harvested his brain by cutting his head open beginning at the chin. She describes how afterwards she had difficulty shoving him into a container because he was so big. She says it was the hardest experience she ever had. O'Donnell describes harvesting the boy's body parts with her colleague:

"... its nose was very pronounced, it had eyelids, and its mouth was pronounced. And then since the fetus was still intact, she said, 'okay, well, this is a really good fetus, and it looks like we can procure a lot from it. We're going to procure brains.'"

While she's talking about this, footage of another aborted later-term baby kicking his legs in a dish is shown. Later we see a picture of yet another boy who was born premature and died in his parents' arms.

8) Planned Parenthood Baby Parts Buyer StemExpress Wants "Another 50 Livers/Week"

This video features Planned Parenthood organ buyer StemExpress's CEO Cate Dyer talking about "consistent growth" in the industry. She says, "Planned Parenthood has volume because they're a volume institution." Asked what would make her happy, she says "another 50 livers a week." She says they work with almost triple digit numbers of clinics. They discuss intact cases, though the company later claimed it was just referring to intact organs, not entire bodies.

Dyer also discusses the lack of sanitary conditions at some clinics, which makes it difficult to get human organs that are not contaminated.

9) Planned Parenthood Baby Parts Vendor ABR Pays Off Clinics, Intact Fetuses "Just Fell Out"

This video features Perrin Larton, the procurement director for Advanced Bioscience Resources (ABR), a California-based non-profit organ middleman. She tells an undercover journalist that pro-lifers are making business difficult for baby organ traffickers.

Larton notes that while there have been federal limits on embryonic stem cell lines, taxpayer-funded research on aborted baby parts has gone on for decades.

"Fetal got lost in the mix," she said. She said that they sent fetal tissue to the National Institutes of Health even though the tissue was gleaned from abortion.

This video features graphic discussions of how abortionists shred body parts and tear the baby apart in the womb.

10) Planned Parenthood Exec: Baby Parts Sales "A Valid Exchange," Can Make "A Fair Amount of Income"

Though this video featuring discussions with a wide range of Planned Parenthood executives isn't graphic, it is in some ways the most troublesome for Planned Parenthood. That's because this video shows that Planned Parenthood encourages the fetal organ trade at the very highest levels. They discuss how exchanging money for tissue is valid. Deb VanDerhei, the national director of the Consortium of Planned Parenthood Abortion Providers claims that some colleagues generate a great deal of income on the sale of human organs from aborted babies. Dr. Carolyn Westhoff, senior medical advisor for Planned Parenthood Federation of America, doesn't shy away from specific discussions of the human organ trade, specifying which human organs buyers are interested in, such as eyes, brains and gonads. "Certainly everything we provide," she says.

"All of these videos show a despicable, callous disregard for the law, human life, and women. The selling of baby body parts is against the law and Planned Parenthood knows it, which is why they have hired a public relations firm to run damage control and filed huge, expensive lawsuits to silence the undercover videographers.<sup>47</sup> Planned Parenthood knows that it has a public relations nightmare on its hands and it is doing its utmost to try to preserve its carefully crafted public image. Being caught red handed coyly negotiating prices for baby body parts is not something they want the public to see, but the truth remains – Planned Parenthood sells dead baby parts. This is a fact that has not been even remotely debunked.<sup>48</sup>

"SCR 85/SR56 also suggests that Planned Parenthood has been subjected to numerous investigations 'that have failed to reveal any wrongdoing by Planned Parenthood.' While it is true that Planned Parenthood has been under increased scrutiny by state and federal authorities that since the release of the Center for Medical Progress videos, to suggest that they are innocent of any wrongdoing is simply not true. This is just another Planned Parenthood talking point that bears little resemblance to the brutal reality of what they do. Since the video expose', Planned Parenthood has broken the law or been fined in eight states.<sup>49</sup>

"Planned Parenthood has also been caught in a slew of illegal activity, including the cover-up of child sexual abuse and sex-trafficking, as investigations by Live Action reveal. Undercover tapes also expose how the corporation routinely lies to women and the American public, is willing to abort babies based on sex or race, and promotes dangerous sexual practices to children.<sup>50</sup>

"In recent years a number of Planned Parenthood's own employees have filed whistleblower lawsuits claiming Planned Parenthood has defrauded state and federal governments.<sup>51</sup> In 2011, Americans United for Life issued a full report, *The Case for Investigating Planned Parenthood*, that documents these and other problems with Planned Parenthood (e.g., misuse of federal health care and family planning funds, failure to comply

with parental involvement laws, failure to report criminal sexual abuse, etc.)<sup>52</sup> In this report, Americans United for Life documents the known and alleged abuses by Planned Parenthood, including:

"Misuse of federal health care and family planning funds. State audit reports and admissions by former employees detail a pattern of misuse by some Planned Parenthood affiliates.

"Failure to report criminal child sexual abuse. Substantial and still-developing evidence indicates that many Planned Parenthood clinics fail to report all instances of suspected abuse, and instead advise minors and their abusers on how to circumvent the mandatory reporting laws.

"Failure to comply with parental involvement laws. Some Planned Parenthood affiliates exhibit a pattern and practice of violating and circumventing parental involvement laws.

"Assisting those engaged in prostitution and/or sex trafficking. Some Planned Parenthood clinics have demonstrated a willingness to partner with pimps or sex traffickers to exploit young women instead of safeguarding their health and safety.

"Dangerous misuse of the abortion drug RU-486. Planned Parenthood's admitted disregard for the FDA's approved protocol puts profits above women's lives and safety.

"Misinformation about so-called 'emergency contraception,' including ella. Planned Parenthood boasts of its role in the approval of a new drug ella, yet provides considerable misinformation about the drug.

"Willingness to provide women with inaccurate and misleading information. Some Planned Parenthood affiliates continually demonstrate a disregard for women's health and safety through their willingness to provide inaccurate and misleading information regarding fetal development and about abortion's inherent health risks.

"Willingness to refer to substandard clinics. Some Planned Parenthood affiliates put the lives and safety of women and girls at risk by associating with substandard abortion providers.

"In addition, this report documents the efforts of Planned Parenthood and its affiliates to defeat legislation intended to protect women and families, and to overturn common-sense federal and state laws, further enriching their 'bottom-line' with attorney fee awards.

"In September, 2015, Alliance Defending Freedom (ADF) submitted a report to Congress identifying waste, abuse and potential fraud by Planned Parenthood and its 59 separate affiliates and noted that while Planned Parenthood receives hundreds of millions of our tax dollars in funding, they are also alleged to have filed more than 500,000 false, fraudulent or ineligible Medicaid claims.<sup>53</sup>

"As of March 30<sup>th</sup>, Florida became the 12<sup>th</sup> state to have voted to defund Planned Parenthood since the undercover video scandal.<sup>54</sup> Other states include Alabama, Arkansas, Kansas, Louisiana, New Hampshire, North Carolina, Texas, Utah, Ohio, Mississippi.<sup>55</sup> Perhaps this is why Planned Parenthood is so anxious for at least one state to 'affirm' them. Pollsters have already seen a 5 percentage point drop in their favorability rating compared to what it was before the undercover videos were released.<sup>56</sup>

"SCR85/SR56 mentions nearly 'seven thousand violent acts against abortion providers' since 1977, but ignores the widespread 'violence' (e.g., brutal beating, attacks, vandalism, etc.) and other crimes perpetrated against pro-life activists, a sample of which can be seen documented here:

"The proposed resolution does not mention the 'violence' perpetrated upon the innocent human beings that are aborted each year. Planned Parenthood has committed over 7 million abortions since 1970.<sup>57</sup> By definition, these too are 'violent acts' as the brutality of abortion is, by Planned Parenthood's own admission, the violent killing of a human life.<sup>58</sup>

"SCR85/SR56 contains language regarding the 'eleven murders of individuals associated with abortion care' but neglects to mention that Planned Parenthood kills over 300,000 human beings a year.<sup>59</sup> These too are 'individuals' and among the most vulnerable and defenseless of all human beings. As the nation's largest abortion provider, Planned Parenthood has made its living by ending the lives of the most vulnerable among us and thereby denying millions of Americans their most basic and fundamental right: the right to life.

"Planned Parenthood would no doubt like you to buy into the 3% figure that they like to tout when saying that abortion is but a small part of what they do. This talking point is nothing more than an overly-tired phrase that they like to use to underplay the significance of abortion in its business model. Equating abortion to another 'service' no different than handing out birth control pills is an accounting gimmick used to create a deceptive view of what it does. The *Washington Post* actually took the time to push past Planned Parenthood's nonsense and called the 3% figure misleading and cautioned the public to be wary of this figure. Quoting *National Review's* Rich Lowry, the *Washington Post* notes:<sup>60</sup>

*Such cracked reasoning could be used to obscure the purpose of any organization.*

*The sponsors of the New York City Marathon could count each small cup of water they hand out (some 2 million cups, compared with 45,000 runners) and say they are mainly in the hydration business.*

*Or Major League Baseball teams could say that they sell about 20 million hot dogs and play 2,430 games in a season, so baseball is only .012 percent of what they do.*

*Supporters of Planned Parenthood want to use its health services as leverage to preserve its abortions, as if you can't get one without the other.*

*Of course, this is nonsense.*

"The fact is, abortion has a tremendous impact on Planned Parenthood's bottom line. Take the lowest possible price for approximately 320,000 abortions, and Planned Parenthood makes millions.

"Instead of affirming and supporting Planned Parenthood, there should be legislation to redirect taxpayer funds to health care groups that provide comprehensive care to families. American taxpayers must not be forced to fund Planned Parenthood's abortion empire and its many abuses, including the illegal profiting from the sale of baby body parts and the horrific practice of allowing infants that are born alive to die so that their organs can be harvested.

"As an elected official, I represent all the people and I cannot in good conscience neglect the unborn. A public servant cannot legitimately ignore an entire segment of the public that is being destroyed. This is not a matter of views (i.e., 'I'm personally opposed to abortion but can't impose my views on others.') This is about violence. The law is supposed to protect human life despite the 'views' of those who would destroy it.

"To those who would say that the government should not be involved in such a personal decision, I would suggest that the government got 'too involved' in abortion when it claimed to have the authority to deprive some human beings of their right to life. The Declaration of Independence asserts that government exists to *secure the rights* already bestowed by the Creator. Moreover, when somebody's 'choice' destroys somebody else's life, that choice is no longer merely a personal, private matter.

"I strongly support women's rights and women's health, and it is because I am so supportive of these things that I will not support any resolution to 'affirm' Planned Parenthood. And it is for this reason that I would strongly suggest that you and the other Members of this body first consider examining the evidence, which is more plentiful than ever, that abortion is destructive of women's health, and listen to the growing voices of those who have been harmed by abortion. That is also why you should examine how the abortion industry, through unregulated and dangerous clinics, continues to deceive and exploit women before you go and promote a resolution to affirm Planned Parenthood.

"As a husband and father of eight, I must stand up for even the smallest of children. Abortion is not about beliefs, it's about bloodshed. Those who need protection need it despite the disagreement with others. When victims are oppressed, we don't sit back and 'agree to disagree' with the oppressor. Rather, we intervene to save the victim.

"As a Catholic politician who practices his faith, I am a believer in the dignity and sanctity of all life. I believe that life is a precious and fragile gift and that it is sacred and inviolable. Pope John Paul II's *Evangelium Vitae*<sup>61</sup> calls on everyone, politicians included, to find solutions to today's problems that respect life. We are to welcome, nourish and support the dignity of every human being.

"Mr. Speaker, abortion can never be separated from Planned Parenthood. Thus, I in good conscience, could never support a resolution that seeks to affirm an organization that profits off of the death of the most innocent among us. No matter how many 'services' Planned Parenthood says it provides, nothing changes the fact that almost 900 preborn children die each day in America's largest abortion chain.

If one is opposed to the intentional taking of innocent human life, one can't turn around and praise Planned Parenthood for the other things it does. That's like excusing child labor in the 1800s and 1900s by saying, "I'm opposed to child labor, but those textile companies do produce nice clothes."<sup>62</sup>

"As legislators we need to look at Planned Parenthood's actual record and examine the truth as opposed to simply buying into all of its talking points and rhetoric. Before committing the State to a resolution that seeks to 'affirm' them for the 'services' they provide, we should seriously consider that they are presently under Congressional investigation for illegally selling the body parts of aborted babies.

"Just yesterday, April 20, 2016, three former federal prosecutors testified that a federal investigation is warranted into whether a California medical procurement company and abortion clinics are illegally profiting from aborted fetal tissue.

"Based on my review of the exhibits, a competent, ethical federal prosecutor could establish probable cause that both the abortion clinics and the procurement business violated the statute, aided and abetted one another in violating the statute, and likely conspired together to violate the statute," said Brian P. Lennon, a former federal prosecutor in Michigan and Virginia.<sup>63</sup>

"Former U.S. prosecutor Brian Lennon told Congress Wednesday "there is proof without a reasonable doubt" abortion clinics and a procurement company illegally profited from the sale of aborted fetuses."<sup>64</sup>

"Again, Mr. Speaker, how can we even consider a resolution to affirm an organization that is, in all likelihood, engaged in illegal criminal activity? And what about our responsibility as a body to defend and promote the life of every human being? The very well-being of society depends on the respect for life. We must respect, defend and promote the dignity of every human person.

"Finally, Mr. Speaker, while I may stand alone and in the minority on this issue, I would argue that truth is never determined by a majority vote. In the end when all is said and done, each of us is personally accountable to our Creator for protecting and defending human life. And absolute respect for every innocent life also requires the exercise of conscience, which is why I cannot support this resolution.

"*Evangelium Vitae* (The Gospel of Life) was issued over 20 years ago as a pressing appeal addressed to each and every person in the name of God to respect, protect, love and serve every human life. This document is no less relevant today. It calls upon all of us to be mindful of the serious threats to the very meaning and value of human life. The document notes how ethical relativism is becoming the basis for rejecting universal moral norms, and as these start to become obscured by government, the democratic system itself will be shaken in its foundation.

"Our country was founded on the recognition of certain basic moral principles, among which is that the right to life is unalienable, is bestowed by the Creator, and is to be protected by the government. The very greatness of America depends on her adherence to this truth.

"You see, Mr. Speaker, our nation is an experiment in self-governance. Whether this experiment succeeds or fails depends on our faithfulness to the values that have long helped societies survive. Again, truth is not up for a vote, and no majority can make what is wrong into something that is right. People cannot govern themselves if they have lost the sense of right and wrong.

"Seeking to give special recognition by the State 'affirming' Planned Parenthood when it is an organization founded by the elitist bigotry of Margaret Sanger, is offensive to me. In her eyes, the sign of a large family is a sign of being 'unfit.' As a father of eight, I reject this notion that people are somehow the equivalent of livestock to be controlled and/or manipulated all in the name of human betterment.

"This ethic of control continues to be imposed on our country and in much of the developing world by Sanger's followers who make up Planned Parenthood.

Former PPFA president Pamela Maraldo insisted in 1993 that "Planned Parenthood has never strayed from the fundamental principles she [Sanger] espoused or from her determination to confront the glaring social and health needs of the day."<sup>65</sup>

"I am equally offended that a resolution is being proposed to affirm an organization that was founded by a racist. It is no secret that Margaret Sanger habitually referred to blacks and Jews as 'bad stock.' Dr. Alveda King, a public figure in her own right as well as the niece of Dr. Martin Luther King Jr., openly stated:

*The most obvious practitioner of racism in the United States today is Planned Parenthood, an organization founded by the eugenicist*

*Margaret Sanger and recently documented as ready to accept money to eliminate black babies.*<sup>66</sup>

"King knows that while about 13% of Americans are black, more than one-third of all abortions are administered to black women.<sup>67</sup> Statistics show that 79% of Planned Parenthood abortion facilities are strategically placed in low-income minority neighborhoods.<sup>68</sup> Since 1973, abortion has wiped out over 25% of the black population, and statistics show that for every two African American women that get pregnant, one will abort.<sup>69</sup> Is this really the type of organization that the State of Hawaii should be proposing a resolution to affirm?"

"Lives matter, Mr. Speaker. All lives. And I think that it behooves us all to remember that there can be no true democracy without the recognition of every person's dignity and without respect for his or her rights.

"I invite everyone to read *Evangelium Vitae* and reflect upon it. Fundamentally, it notes that democracy is a 'system' and as such is a means, not an end. That means that it basically stands or falls based on the values that it embodies or promotes. If our state motto, *Ua mau ke ea o ka 'āina i ka pono*, is said to reflect the character and beliefs of the citizens of our state, then let us honor life and not be used as a pawn by Planned Parenthood who is looking to score political points with some sort of public relations stunt. I respectfully request that we honor the people we were elected to represent, Mr. Speaker."

Representative San Buenaventura rose to speak in support of the measure, stating:

"I stand in strong support. Planned Parenthood has been attacked, as the Representative in Ewa has stated. And it is high time that we point out the successes that Planned Parenthood has in this community. It is because of Planned Parenthood that Hawaii now has the lowest number of teenage pregnancies, lower than it's ever been since 1990s. It is because of Planned Parenthood that poor teens now have a future, rather than resort to back-alley abortions. In fact, right now we don't even hear about back-alley abortions. It's because of Planned Parenthood.

"Planned Parenthood has made it easier for teens to know that they have a place that they can go to without having to resort to wire hangers. Without having to resort to self-abortion, self-abuse. And the teen health of Hawaii since Planned Parenthood has been in Hawaii shows that. That teen health pregnancies, every child should be a wanted child. And that's what Planned Parenthood promoted and that's what Planned Parenthood's success is. Thank you."

At 12:09 o'clock p.m., Representative Saiki requested a recess and the Chair declared a recess subject to the call of the Chair.

The House of Representatives reconvened at 12:09 o'clock p.m.

Representative Tupola rose to speak in opposition to the measure, stating:

"Thank you, Mr. Speaker. In opposition. With the current state of the investigation of selling of baby body parts as well as many other concerns, I can't support this resolution at this time. But I do want to note that there's a lot of good organizations here in Hawaii that we haven't ever recognized. A lot of non-profits, a lot of hospitals, a lot of health care providers that are also doing very, very admirable things for our communities and for our people.

"And I think granted that there might be some good within this, I feel like we should stay relevant to our communities and acknowledge these

before stepping forward to acknowledge and celebrate possibly something that has still a lot of unanswered questions for a lot of the public who are concerned about the selling of baby body parts as well as the illegalities of what that includes. And so for those reasons, in opposition. Thank you."

Representative Lee rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. In support. Thank you. I really want to commend this organization for helping our local population, especially avoid unnecessary abortions and loss of life, both of child and mother. I think it's obvious that whether the law allows for that or not, it's going to happen in our society. And we should be proud to have an organization working to try and avoid that on the front-end, allowing alternatives for family planning, and on the back-end making sure that the mother's health is protected.

"And with that I just ask to insert the executive summaries from seven state investigations, three congressional investigations, and the findings of a Texas grand jury, that all find no wrong doing at Planned Parenthood. Thank you."

Representative Lee submitted the following:

"Growing List Of State And Federal Investigations Clear Planned Parenthood Of All Wrongdoing

U.S. Dept. Of Health And Human Services: There Are "No Known Violations Of The Country's Fetal Tissue Laws." In response to an inquiry by Republican Sens. Joni Ernst (Iowa) and Roy Blunt (MO), the Department of Health and Human Services told Congress that they "know of no violation of [tissue] laws in connection with the research done at our agencies":

The Obama administration says there are no known violations of the country's fetal tissue laws among government researchers or the companies that supply the tissue.

"Currently, we know of no violation of these laws in connection with the research done at our agencies," Jim Esquea, assistant secretary for legislation at HHS, wrote in a letter to Sens. Joni Ernst and Roy Blunt, obtained by POLITICO. "Furthermore ... we have confirmed that HHS researchers working with fetal tissue obtained the tissue from non-profit organizations that provided assurances to us that they are in compliance with all applicable legal requirements.

[...]

HHS has gotten re-affirmations from government researchers and government-funded researchers that their tissue procurement is done in accordance with the tissue laws. And it got assurances from the companies that provide that fetal tissue to researchers at NIH and FDA that they are obtaining the fetal tissue and organs in compliance with federal laws, the letter says. [*Politico*, 8/16/15]

Massachusetts: Investigation Reveals Planned Parenthood Is "Fully Compliant With State And Federal Laws." Massachusetts Attorney General Maura Healey announced on July 29 that her office has found "no evidence" of wrongdoing by Planned Parenthood after an investigation was concluded:

Attorney General Maura Healey says her office has found no evidence that the Planned Parenthood League of Massachusetts is operating the sort of fetal tissue donation program highlighted in a series of undercover videos released by a national anti-abortion group in recent weeks.

Healey's office conducted the review at the request of state Representative James J. Lyons Jr., an Andover Republican who cited a Center for Medical Progress video that showed a Planned Parenthood official discussing how the group provides fetal parts to medical researchers over lunch at a Los Angeles restaurant.

[...]

"Over the past week, my office has conducted a thorough review and found that Planned Parenthood League of Massachusetts' health care centers are fully compliant with state and federal laws regarding the disposition of fetal tissue," Healey said in a statement. "Although donation of fetal tissue is permissible under state and federal law,

PPLM does not have a tissue donation program. There is no evidence that PPLM is involved in any way in the buying or selling of tissue. As such, our review is complete." [*The Boston Globe*, 7/29/15]

Indiana: Planned Parenthood Cleared Of Any Wrongdoing In The Handling Of Fetal Tissue. On July 30, the Indiana Department of Health cleared Planned Parenthood clinics in the state of any wrongdoing after they were "unable to find any non-compliance with state regulation":

Gov. Mike Pence, a Republican, on July 16 ordered an investigation of Planned Parenthood facilities in Indianapolis, Bloomington and Merrillville to see if organs from aborted fetuses were being sold. He was among a number of conservative lawmakers around the country who have called for investigations after an anti-abortion group circulated a video it made secretly showing some of its national officials discussing how they obtain organs from aborted fetuses for research. Planned Parenthood, the nation's largest provider of abortions, has said its donations of fetal tissue for research are legal.

The Indiana Department of Health said in a statement Thursday that an investigation found no evidence of any laws being broken. Health department inspectors investigated the Indiana facilities on July 21.

Letters from the health department to the three Indiana facilities dated Tuesday and released to the media by Planned Parenthood said the agency had completed its investigation into the Planned Parenthood facilities that perform abortions in Indiana. The letters said the agency was "unable to find any non-compliance with state regulations. Therefore, no deficiencies were cited." The letters say the complaint is closed. [Associated Press, 7/30/15]

South Dakota: No "Evidence Of Illegal Activity" In South Dakota At Planned Parenthood Clinic. South Dakota Attorney General Marty Jackley determined that there was "no evidence of illegal activity" at the one Planned Parenthood clinic in the state:

The state Health Department says it hasn't received any reports or evidence that the sale of fetal tissue has occurred in South Dakota since the department started regulating abortion facilities in 2006.

[...]

Spokeswoman Jennifer Aulwes says the organization doesn't have a program in the state for the legal donation of fetal tissue from terminated pregnancies and says it follows state and federal laws.

Attorney General Marty Jackley says he contacted the Health Department in mid-July about the issue. Jackley says there's no evidence of illegal activity. [KDLT News, 8/12/15]

Georgia: Department Of Public Health Finds Planned Parenthood "Complied With The Law." After a review into the state's abortion providers, the Georgia Department of Public Health "concluded an investigation" and found that Planned Parenthood and other clinics "are all complying with the law":

State public health investigators have concluded that Planned Parenthood Southeast and four other abortion providers are properly disposing of fetal tissues after abortions.

The commissioner of the Department Public Health, Dr. Brenda Fitzgerald, told Gov. Nathan Deal in a letter Wednesday that her agency had completed the inquiry that Deal ordered last month after videotapes surfaced of national Planned Parenthood officials talking about harvesting fetal remains.

Fitzgerald wrote: "As you know, Georgia law requires that licensed abortion clinics (or a medical disposal service provider with whom they have contracted) to bury or cremate fetal remains following the termination of a pregnancy. DNA or genetic testing can and does take place in certain cases, such as if a rape has occurred or there was an abnormality in the pregnancy."

She said the abortion providers reviewed by her investigators are all complying with the law. [*The Atlanta Journal-Constitution*, 8/12/15]

Pennsylvania: "No Evidence" Of Wrongdoing By "Any Planned Parenthood" In Pennsylvania. As *The Hill* noted, Pennsylvania became the fifth state to find no wrongdoing by Planned Parenthood. Pennsylvania Secretary of Health Karen Murphy noted that the Pennsylvania state health department "has never found a violation of the

Abortion Control Act provisions regarding the procurement or use of fetal tissue":

Pennsylvania has found no wrongdoing by Planned Parenthood in the state after a review, according to a letter from the state health department.

"Although donation of fetal tissue is lawful under the Abortion Control Act and federal law, our review has found that Planned Parenthood facilities in Pennsylvania do not participate in this practice," Pennsylvania Secretary of Health Karen Murphy wrote in a letter to a state legislator. "Moreover, there is no evidence that any Planned Parenthood site in this Commonwealth is involved in the buying or selling of fetal tissue."

Murphy said Planned Parenthood has contracted with "appropriate vendors to properly dispose of tissue."

"Since 2011 when the Department instituted annual and random unannounced surveys of Planned Parenthood facilities in Pennsylvania, the Department has never found a violation of the Abortion Control Act provisions regarding the procurement or use of fetal tissue," Murphy adds. [*The Hill*, 8/21/15]

Florida: Planned Parenthood Cleared Of Mishandling Fetal Remains By Florida's Agency For Health Care Administration. Florida's Agency for Health Care Administration (AHCA) was ordered by Republican Gov. Rick Scott to investigate whether Florida Planned Parenthood locations illegally sold fetal tissue. The AHCA concluded its investigation on August 5 finding there was "no evidence of the mishandling of fetal remains at any of the 16 clinics we investigated across the state," however it was later revealed Scott's staff rewrote press releases about the investigation to remove sentences the AHCA staff wished to include that emphasized this finding. [*Media Matters*, 9/14/15; *Politico Florida*, 9/2/15]

Missouri: "No Evidence That Planned Parenthood's St. Louis Clinic ... Engaged In Unlawful Activity." Missouri Attorney General Chris Koster announced September 28 that the state's investigation "found no evidence that Planned Parenthood's St. Louis clinic mishandled fetal tissue or engaged in unlawful activity," as Reuters reported:

An investigation in Missouri found no evidence that Planned Parenthood's St. Louis clinic mishandled fetal tissue or engaged in unlawful activity, Attorney General Chris Koster's office said on Monday.

Koster's office had launched an investigation after an anti-abortion group released videos over the summer alleging that Planned Parenthood in other states illegally sold fetal tissue.

"The evidence reviewed by my investigators supports Planned Parenthood's representation that fetal tissue is handled in accordance with Missouri law," Koster said in a news release. "We have discovered no evidence whatsoever to suggest that Planned Parenthood's St. Louis facility is selling fetal tissue." [Reuters, 9/28/15]

Washington State: "No Evidence To Support Claims That The Organization Sells Fetal Tissue Or Performs Illegal Partial-Birth Abortions." Washington State Attorney General Bob Ferguson released a 48-page memo detailing the results of his office's investigation into whether Washington Planned Parenthood affiliates were performing partial-birth abortions or selling fetal tissue for profit. As *The Spokesman-Review* reported, the investigation "found no evidence to support" the allegations:

Planned Parenthood clinics in Washington do not sell fetal tissue and do not perform partial-birth abortions, conservative lawmakers were told Monday.

Responding to requests from 38 state representatives and 13 state senators, Washington Attorney General Bob Ferguson said he assigned two of his attorneys to investigate their concerns about the organization after national reports of "trafficking in human body parts." That review found no evidence to support claims that the organization sells fetal tissue or performs illegal partial-birth abortions, and Ferguson called such unfounded allegations troubling. [*The Spokesman-Review*, 11/16/15]



Kansas: Planned Parenthood "Exonerated" As Kansas Medical Board Announces "No Action" Will Be Taken Following "Careful Review." The Associated Press reported on January 14 that the Kansas State Board of Healing Arts, "after completing an investigation into whether illegal sales of fetal tissue are occurring after abortions" announced it was "taking no action" against a Planned Parenthood clinic. In a letter sent to Planned Parenthood of Kansas and Mid-Missouri, board disciplinary attorney Dan Riley stated that after "careful review of the investigative materials" the board had concluded "no further action would be taken at this time." The investigation followed a 2015 order from Republican Gov. Sam Brownback to investigate Planned Parenthood after the release of the deceptively-edited CMP videos. State Senator Laura Kelly (D) described the announcement as an "exonerat[ion]" of Planned Parenthood. [Associated Press, 1/14/16]

Michigan: "There Is No Evidence To Date That Illegal Practices Are Occurring" At Planned Parenthood. In July 2015, Republican Sen. Phil Pavlov demanded an investigation "to determine whether or not any Michigan-based facilities have participated in the horrifying sale of babies' body parts." NPR reported that in October, "the two departments handling the investigations issued a statement" concerning the findings of their work. They concluded that "there is no evidence to date that illegal practices are occurring." [NPR, 1/28/16]

Nevada: Attorney General Conducted Investigation And "Is Satisfied That The Nevada Offices Aren't Donating Tissue From Aborted Fetuses." Nevada Attorney General Adam Laxalt said in December 2015 that he had officially closed the investigation in December 2015, nothing that he was "satisfied that the Nevada offices aren't donating tissue from aborted fetuses." [Associated Press, 12/2/15]

Ohio: Investigation By Attorney General "Found No Evidence That Planned Parenthood Clinics In Ohio Sold Fetal Tissue." Following the release of the deceptively edited CMP videos, Ohio Attorney General Mike DeWine opened an investigation into the practices of Planned Parenthood clinics in the state. In December 2015, DeWine announced that his office had "found no evidence that Planned Parenthood clinics in Ohio sold fetal tissue." According to Cleveland.com, although DeWine cleared Planned Parenthood of "the original subject of the probe" he still alleged that Planned Parenthood had violated Ohio state code in its disposal of fetal tissue. [Cleveland.com, 12/11/15]

South Carolina: Investigation Into Planned Parenthood "Revealed No Criminal Wrongdoing" And That "No One Had Broken The Law." In August 2015, the South Carolina Legislative Oversight Committee opened an investigation into Planned Parenthood and its relationship with state agencies. The committee closed its investigation on March 10 after finding that "no one had broken the law," according to *The Post and Courier*. The committee concluded that the investigation had "revealed no criminal wrongdoing" after learning that "the Department of Health and Human Services does not directly provide state funding to Planned Parenthood or other abortion providers," *The Post and Courier* reported. The report instead revealed that none of the abortions covered by Medicaid in the state had been performed by Planned Parenthood since at least 2011. Rep. James Smith (D-SC) said that although the investigation was merely "a McCarthy-style witch hunt," he was pleased that "in the end, Planned Parenthood was completely vindicated." [*The Post and Courier*, 3/10/16]"

"Texas Grand Jury:

Harris County's investigation

Harris County, Texas grand jury empaneled to investigate whether Planned Parenthood was illegally selling fetal tissue cleared the group of wrongdoing, instead indicting two anti-abortion activists behind the undercover recordings.

"We were called upon to investigate allegations of criminal conduct by Planned Parenthood Gulf Coast," Harris County District Attorney Devon Anderson said. "As I stated at the outset of this investigation, we must go where the evidence leads us. All the evidence uncovered in the course of this investigation was presented to the grand jury. I respect their decision on this difficult case.""

Representative Evans rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. In strong support. I'd like the words of the Representative from Puna in the Journal as if my own," and the Chair "so ordered." (By reference only.)

Representative Evans continued, stating:

"I just wanted to add a few comments about how people make statements generalizing about this important issue, which is really an individual issue. When you talk about Planned Parenthood, it's also about men and women making decisions about their family. I think Planned Parenthood sends a really strong message, especially to people who really need to think about family, family planning. So I do think it's for all of us.

"I want to share a story, because again, it's very individual. In 1970, I left Illinois and went to Seattle with a suitcase and I stayed at the Salvation Army. But I became 18 years of age and I had a boyfriend I'd had for many, many years, and I was very concerned about my future and what was going to happen to me. And I had no money, so I went to Planned Parenthood and I talked to them about my concerns and what do I need to do. I had a lot of great counseling, it was affordable, it was accessible healthcare for me, someone who didn't have money, didn't have the ability to have a family doctor. The other thing I wanted to point out to people is I didn't have parents that ever had a discussion about family planning and about sexuality. And they didn't, for some reason, it was not something they ever wanted to talk about.

"But the point is, is that it's so individual, and I am personally offended by people making statements that just generalize all women and generalize all of us and our decisions. Because you know, planning your family and your sexuality and your own identity is so individual. It's the person. So I think making this, Planned Parenthood has offered to people who have no money and have no support from family, it's there for them. I think it's played a huge role, and I think it needs to continue. And for that reason, I strongly support this resolution. Thank you."

Representative Morikawa rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. Strong support. I'd like to incorporate the words from the Representative from Puna, and I have a couple comments. Because if not for Planned Parenthood, I probably wouldn't be here today. Thank you," and the Chair "so ordered." (By reference only.)

Representative Belatti rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. In strong support. Very briefly, Mr. Speaker. For over 50 years, Planned Parenthood of the great Northwest and the Hawaiian Islands has provided vital medical care and education for our communities here in our islands. Planned Parenthood offers cancer screenings, pregnancy testing, counseling, treatment for STDs, preventative healthcare, birth control, and yes, abortion services. Planned Parenthood ensures that everyone has access to high-quality healthcare, and acquires the knowledge to enable individuals to make healthy decisions about their lives.

"I appreciate the comments of the good Representative from Ewa Beach and Waianae. Because yes, on the issue of abortion services, we will disagree. And I also appreciate that the Representative from Ewa Beach stands against violence. But it is because of this violence that I think it's important that we reaffirm our support for Planned Parenthood here in Hawaii.

"In the last year alone across the nation Planned Parenthood has dealt with numerous arson attacks, vandalism, and most recently in Colorado Springs, Colorado, November 2015, which left three dead, nine injured, and an entire community terrorized.

"These attacks have been extreme and hostile to the healthcare providers and patients. As leaders, we can reaffirm our support for Planned Parenthood here in our state and continue to show our support for the health services they provide in Hawaii. Everyone has the right to access to

health services without fear of violence and hostility when visiting a Planned Parenthood. Thank you, Mr. Speaker."

Representative LoPresti rose to speak in support of the measure, stating:

"Strong support. I ask that the words of the Health Chair and the EEP Chair be entered into the Journal as if they were my own, as well as the documents referred to by the Representative from Waimanalo. Thank you," and the Chair "so ordered." (By reference only.)

Representative Matsumoto rose in opposition to the measure and asked that her written remarks be inserted in the Journal, and the Chair "so ordered."

Representative Matsumoto's written remarks are as follows:

"Mr. Speaker, I rise in opposition to SCR 85. This resolution asks the Legislature to support Planned Parenthood and denounce the violent behavior directed at the organization.

"I do not condone violence nor do I believe any organization, its workers, or its patients should undergo physical or verbal assault for providing or receiving medical treatment. The attacks and other atrocities that occur against individuals for working or seeking treatment at Planned Parenthood is a horrific wrong in society. Violence against any organizations and persons must stop, not just violence at Planned Parenthood specifically.

"Planned Parenthood should not be singled out for celebration when so many grey areas and unknowns regarding their operations persist—not just in the media, but also in practice. Women, men, and young people visiting these clinics are looking for help – help that can be provided there but may also be provided elsewhere or in other ways. These organizations should be forthright and clear with them and the public on its practices.

"While I support an end to violence at Planned Parenthood and other organizations, I cannot support this resolution as a celebration of the works of Planned Parenthood. I do not support its practice of performing abortions and believe this is not the time for this resolution when other organizations also provide life-saving medical treatment, counseling, and care for Hawaii's residents. Rather, it is a time for clarity, transparency, and honesty. This will result in better care and ultimately Hawaii residents will be better for it.

"Thank you, Mr. Speaker."

Representative Pouha rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

Representative McDermott rose to respond, stating:

"Second time, sir. Still in opposition. I think violence against Planned Parenthood clinics is terrorism. Unacceptable. Unacceptable. And if we catch them, I will nail them up to the barn door. I don't have a problem with that. But Mr. Speaker, one of the comments that was made is that because of Planned Parenthood, the teen pregnancy rates have gone down.

"The gentlelady is referring to the latest data available, and that is based on the abstinence-based sex education programs, which as of last June were voted out of the DOE and now it's comprehensive sex ed, which is not comprehensive in nature because it doesn't talk about delay or waiting. Those programs have not yet hit the public schools, because they didn't buy the books for them yet.

"So they're still operating on the abstinence-based programs, which she said are working. They've driven the teen pregnancy rate down. But Planned Parenthood doesn't want any notion of telling young people to delay their sexual gratification. If you're 10 years old, in Pono Choices they tell you, you decide when you're ready, and that the anus is a genital, which is medically inaccurate. I have proven they provide medically inaccurate information. Medically misleading information.

"That is why we have an epidemic of HPV. And it only gets worse, because they tell them, if you want to start early, go ahead, just make sure your partner has a condom. But telling a 15 or 16-year-old to make sure your partner has a condom, unless they use it correctly and consistently every time, it's as if they never used it at all. And by the way, against HPV, a condom is about as effective as putting a rain coat on and going swimming in the Pacific Ocean and hoping not to get wet. Because sex is messy.

"Then we don't talk about chlamydia, which sexually active young girls can get and as often have no symptoms and renders them sterile. You won't find that in the Planned Parenthood sex ed programs, because they don't want anyone to know. And they omit the elevated risk profiles of all these various sexual behaviors and diseases. They don't articulate them, because they don't want the kids to freak out and not engage in early sexual activity. They encourage, encourage early sexual activity, and I dare someone to find something contrary to that in the Hawaii materials that is not that way. Thank you."

Representative Ward rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

Representative Ing rose to speak in support of the measure, stating:

"Very quickly, in strong support. I'd like to adopt the words from the Chair of Health, the Vice Chair of Judiciary, and the Chair of Human Services," and the Chair "so ordered." (By reference only.)

Representative Ing continued, stating:

"I just wanted to note in the interest of human life that if not for Planned Parenthood and access to safe healthcare for abortions, in particular, before Roe, thousands of women died every year because of unsafe, illegal abortions. So in the interest of saving lives, this is why we need to support Planned Parenthood in any way we can."

Representative Rhoads rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. In support. I would like to adopt the words of the Representative from District 51," and the Chair "so ordered." (By reference only.)

Representative Rhoads continued, stating:

"Also, I just point out that all the studies indicate that abstinence-only doesn't work. It just doesn't work. Human beings are built to have sex and they start having sex as soon as they know what it is, if you don't counsel them otherwise and help them to avoid the worst consequences of doing so. Obviously, there are pluses and minuses to having sex.

"I'd also point out that from the legal perspective, abortions are still a constitutional right, despite the fact that we've had one of the most conservative supreme courts in the history of the United States over the last 15 to 20 years. Abortion is still a constitutional right. *Mahalo*."

Representative Saiki rose, stating:

"Mr. Speaker, I'd like to call for the question, but please permit written comments. Thank you."

At this time, Representative Saiki called for the previous question.

The motion was put to vote by the Chair and carried, and the report of the Committees was adopted and S.C.R. No. 85, SD 1, entitled: "SENATE CONCURRENT RESOLUTION AFFIRMING SUPPORT OF PLANNED PARENTHOOD, RECOGNIZING ITS VITAL ROLE IN PROVIDING HEALTH CARE, AND DENOUNCING VIOLENCE TOWARDS ABORTION PROVIDERS AND THEIR PATIENTS," was adopted, with Representatives Matsumoto, McDermott, Pouha, Tupola and Ward voting no, and with Representatives Choy, Fukumoto Chang, Har, Hashem, Ito, Johanson, Jordan, Kong, McKelvey, Oshiro, Say, Souki and Tokioka being excused.
