

## TWENTY-SECOND DAY

**Wednesday, February 22, 2017**

The House of Representatives of the Twenty-Ninth Legislature of the State of Hawaii, Regular Session of 2017, convened at 12:09 o'clock p.m., with Vice Speaker Mizuno presiding.
