Friday, March 3, 2017

"Strong support, Mr. Speaker. I think this is the only bill that tends to save hundreds of millions of dollars every year. So I hope that we will be able to do that. Most of the bills that we have are funding bills. We don't have that

much money to go around. Hopefully by passing this bill out, we will have hundreds of million dollars saved to fund other programs. Thank you."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 887, HD 1, entitled: "A BILL FOR AN ACT RELATING TO UNFUNDED LIABILITIES," passed Second Reading and was placed on the calendar for Third Reading, with Representatives Ichiyama, McDermott and Nakashima being excused.

Like other states that have been saving a lot of money, hopefully if we pass this feasibility study, we'll find out that it might be good for the State of Hawaii and different counties. Thank you."

Representative Tupola rose to speak in opposition to the measure, stating:

"Thank you, Mr. Speaker. In opposition. I think with this I'm concerned because it targets low-income families. The responsible agency said that they wouldn't be able to report back if and how it affected small businesses or low-income families.

"But on top of it, I ask to see AT&T, Sprint and Verizon's annual fees that were acquired for pre-paid cellular service, and if we are even one-fiftieth of what their annual income, if we are even close to that, which we're not sure, we would only generate about \$27,000 a year.

"And again, currently the fund is actually in a surplus, and in 2009, the Federal Communications Commission reported that we were one of 10 states that actually use this fund to balance our state budget, because it was in a surplus, a \$16 million surplus.

"So in general I oppose all new taxes and fees, but especially one that we're not really sure how it's going to affect everyone, and we're not sure how much it's going to collect. Thank you."

"I'd like to submit written comments in strong support."

Representative Cachola's written remarks are as follows:

"Currently, most Filipino veterans of World War II who are living here in Hawaii are in their 90s. These brave Filipino soldiers were young men when they fought side-by-side with U.S. armed forces in the Pacific Theatre. They played a vital role in the Allied victory and helped to bring about an end to World War II.

"Now in their twilight years, the numbers of these Filipino veterans are slowly dwindling, and thoughts have turned to where their final resting place will be. They have petitioned relatives to join them in Hawaii, but due to decades of delays, veterans have passed away without family members at their side.

"The dying wish of some Filipino veterans was to have their remains returned to the Philippines for burial with their families. This body has provided for several measures to honor their final wishes, the most recent being House Concurrent Resolution No. 23, which was adopted by the Legislature in 2016.

"House Concurrent Resolution No. 23 requested Congress to amend federal law that would allow funds to bury eligible Filipino-American veterans of World War II in a federal or state veterans' cemetery to instead be used to transport their remains to the Philippines and for burial services in their homeland.

"However, as of this date, Congress has yet to take any action on this measure.

"Burial grants for Filipino veterans are statutorily established under Hawaii Revised Statutes Chapter 363, but funding for the provision of these grants has been non-existent.

"HB 1420, HD 1 appropriates funds to the Office of Veterans Services for the provision of burial grants for World War II Filipino-American veterans. For this measure to take effect, federal funds must be available and they also must be eligible Filipino-American veterans of World War II living in the State.

"I urge my colleagues to join me in voting in support of HB 1420, HD 1 and recognizing the importance of these veterans' sacrifices. Let us honor their final wishes of being buried in their homeland where many of these veterans only have family members who reside in the Philippines."

"So I would like to see this modified to the degree that it acknowledges that maintenance is the issue, which is obviously costly. But this list would be well-intended if it included that requirement within it. Thank you."

Representative Lowen rose to speak in support of the measure, stating:

"In support. Just pointing out, this bill would only apply to landscaping at state facilities. Some plants like bromeliads are very high-maintenance, it's difficult to keep up with maintaining them in a way that doesn't allow mosquitoes to breed."

"But to me, it assumes that there's going to be a polemical, adversarial, really knock-down, drag-'em-out, and I don't think that's what we should, at a policy level, be connoting that if you're going to get a divorce, you're going to be enemies.

"There should be a way to allow it to be proceeding peacefully, but this one sets it up to where there's confrontation built into the system, and I'm not sure that that's a good policy. For that reason, I'll be voting no. Thank you."
