

THIRTY-THIRD DAY

Monday, March 20, 2017

The House of Representatives of the Twenty-Ninth Legislature of the State of Hawaii, Regular Session of 2017, convened at 12:06 o'clock p.m., with Speaker Souki presiding.

The invocation was delivered by Reverend Alan Urasaki of Honpa Hongwanji Hawaii, after which the Roll was called showing all Members present with the exception of Representatives Ichiyama, LoPresti and McKelvey, who were excused.

By unanimous consent, reading and approval of the Journal of the House of Representatives of the Thirty-Second Day was deferred.

Representative Brower, for the Committee on Housing, presented a report (Stand. Com. Rep. No. 1149) recommending that S.B. No. 611, SD 1, as amended in HD 1, pass Second Reading and be referred to the Committee on Consumer Protection & Commerce.

On motion by Representative Saiki, seconded by Representative Evans and carried, the report of the Committee was adopted and S.B. No. 611, SD 1, HD 1, entitled: "A BILL FOR AN ACT RELATING TO FIRE SPRINKLERS," passed Second Reading and was referred to the Committee on Consumer Protection & Commerce, with Representatives Choy, Har, Ichiyama, McKelvey and Tokioka being excused.
