"With reservations, just a quick comment. It's going to CPC, I've no doubt that they'll address some of these concerns, but one of them was having primary care physicians be the afterthought by having pharmacists prescribe first. It's just making sure that whatever the woman is currently taking doesn't conflict with the contraceptive, making sure that she's healthy.

"And secondly was the concern that it'll perhaps discourage or maybe decrease the amount of women that are going in for cervical exams, making sure that they're healthy.

"So again, I don't doubt that CPC will take up those same concerns and try to mend the bill. But recently we've been discussing a lot of things that make pharmacies almost into urgent cares, which, if we are going in that direction, maybe we should just have a PCP, a primary care physician there, then we might actually avoid some of these problems. But, again, with just reservations until I see the final. Thank you."
