

SIXTEENTH DAY

Monday, February 12, 2018

The House of Representatives of the Twenty-Ninth Legislature of the State of Hawaii, Regular Session of 2018, convened at 12:04 o'clock p.m., with Vice Speaker Nakashima presiding.

The invocation was delivered by Representative Linda Ichiyama, after which the Roll was called showing all Members present with the exception of Representatives Ing, Quinlan and Souki, who were excused.
