It's saying if you're, it's prohibiting liquor consumption for bathers, swimmers within 1,000 yards of any beach, and what it's aimed at is the flotillas that end up being kind of drunken. So, I think the bill is much better put together at this point. Thank you."

So I'm just doing the reservation to say, until that final measure comes before us on the final day for vote, I'm concerned. Don't broaden it. Keep it focused on this special project, and that does make sense then. Thanks."

"Thank you, Mr. Speaker. I rise in support with slight, slight reservations. I want to be very clear, I support the intent of this measure, I think it is absolutely laudable. This is a Women's Legislative Caucus measure. I think my biggest concern though is, we always talk about the devil is in the details.

"I would draw the body's attention specifically to Walgreens's opposition. The fact of the matter here is that here in Hawaii we do not have any drug enforcement agent sanctioned facilities, which would dispose of these medications. Pharmaceutical waste that is generated by pharmacies cannot be destroyed in any other way. In addition, it would be against federal law for Walgreens to ship pharmaceutical waste for disposal.

"So, as this bill moves on to the Committee on Consumer Protection & Commerce, I hope that we can find some resolution to this, because I think this is a wonderful measure. Many of us know that twice a year the Attorney General's Office has the take back drug initiative. So this would be very convenient for many of our residents, including our, most importantly, our *kūpuna*. But right now I think, again, we just have an issue with how we're going to get there with respect to enforcing this bill. So for those reasons, I'm with very slight reservations. Thank you, Mr. Speaker."
