Representative McDermott thanked the honoree for his service and recognized his work motivating and encouraging other injured veterans to overcome the stress, fear and anxiety of traumatic injuries and approach their situations with positivity and a spirit of enthusiasm, and introduced the honoree who was seated on the Floor of the House:

Senior Airman Brian Kolfage, USAF, Ret., Purple Heart Recipient.

Representative LoPresti honored SrA Kolfage, graduate of Kaimuki High School and the most severely wounded airman in history, who lost both legs and his right hand from a rocket attack in the Iraq War, for the hope and inspiration he gives other wounded warriors as a mentor and motivational speaker, and recognized him for his years of honorable service and sacrifice.

Representative Ward, on behalf of Vietnam veterans, thanked the honoree for his service and sacrifice.

Representative Tupola thanked SrA Kolfage for his example and for inspiring others, and recognized his wife, Ashley, for being a strong example of how to stand by and support veterans and active military who have gone through trials.

The motion was put to vote by the Chair and carried, and H.R. No. 215 was adopted, with Representatives DeCoite, Fukumoto, Har, Lowen, Nakashima and Souki being excused.

"In the hearing it was basically a face-off between the young people who said, don't pass this, it's too premature to do it, and to the older people who testified and said, you probably should do this, and it was a confusion between blockchains, of which probably nobody understands what it is, including many of us, and actually the gambling, and even one of the members of the committee said he almost lost \$10,000 by virtue of bitcoin.

"So Mr. Speaker, I think us passing this is a bit premature, it needs to be studied more, it needs to be put in its proper perspective, because there's no regulation of it, there's no real total place that it fits in the present macro and microeconomic environment, even though one of the testifiers said he bought a car with bitcoin somewhere in Honolulu, and other things that are going on of which we have no idea what it is. So with those, Mr. Speaker, I reserve this as a no for the time being. Thank you."

Representative Choy rose to speak in support of the measure, stating:

"Mr. Speaker, in support. I'd like to invite my friend from Hawaii Kai to read the bill. Thank you."

Representative Cachola rose to speak in support of the measure with reservations, stating:

"Mr. Speaker, with reservations. I know that my colleague over there said that I almost lost \$10,000 in a week's time, but I was smart enough not to buy or invest. That's how volatile this currency is. So, with reservations. Thank you."

Representative Tupola rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

This authorizes the Agribusiness Development Corporation to enter into contracts with private businesses to remove select municipal solid waste, glass, food and green waste from the waste stream. The Agribusiness Development Corporation seems to have been operating without oversight from the Legislature. It's of a concern to me. I think an audit of them is well overdue. I know that we don't receive reports from them, understand what they're doing. We hear discussion from the former Ag Chair, who heads the ADC, we hear from him at committee hearings, but there's a great deal that we don't know about what is going on. So I think it's not wise to move ahead and give more work to that organization until we audit them and find out exactly what is happening. Thank you."

But creating these buffer zones in areas where we don't know how big these are and then saying that schools can't be there, when we know on the west side because of how big and how fast we've grown, we need schools all the time, everywhere, this would really affect us. Thank you."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and S.B. No. 2304, SD 2, HD 1, entitled: "A BILL FOR AN ACT RELATING TO TOBACCO," passed Second Reading and was referred to the Committee on Consumer Protection & Commerce, with Representative Tupola voting no, and with Representatives DeCoite, Fukumoto, Har, Holt, Nakashima, Souki and Tokioka being excused.

Representative Ing, for the Committee on Ocean, Marine Resources, & Hawaiian Affairs, presented a report (Stand. Com. Rep. No. 1209-18) recommending that S.B. No. 2717, SD 2, as amended in HD 1, pass Second Reading and be referred jointly to the Committee on Energy & Environmental Protection and the Committee on Water & Land.

Representative Yamane, for the Committee on Water & Land, presented a report (Stand. Com. Rep. No. 1215-18) recommending that S.B. No. 2525, SD 2, as amended in HD 1, pass Second Reading and be referred to the Committee on Labor & Public Employment.

No. 2525, SD 2, HD 1, entitled: "A BILL FOR AN ACT RELATING TO THE HAWAII COMMUNITY DEVELOPMENT AUTHORITY," passed Second Reading and was referred to the Committee on Labor & Public Employment, with Representative McKelvey voting aye with reservations, with Representatives Cullen, Lowen, Thielen and Tupola voting no, and with Representatives DeCoite, Fukumoto, Har, Holt, Nakashima, Souki and Tokioka being excused.

Representative McKelvey, for the Committee on Higher Education, presented a report (Stand. Com. Rep. No. 1216-18) recommending that S.B. No. 2319, SD 2, as amended in HD 1, pass Second Reading and be referred to the Committee on Judiciary.
