

THIRTY-THIRD DAY

Monday, March 19, 2018

The House of Representatives of the Twenty-Ninth Legislature of the State of Hawaii, Regular Session of 2018, convened at 12:04 o'clock p.m., with Vice Speaker Nakashima presiding.

The invocation was delivered by Mr. Lawson Fernandes of the Office of Representative Nadine K. Nakamura, after which the Roll was called showing all Members present with the exception of Representatives DeCoite, Gates, Har and Souki, who were excused.

By unanimous consent, reading and approval of the Journal of the House of Representatives of the Thirty-Second Day was deferred.

ORDER OF THE DAY

INTRODUCTION OF RESOLUTIONS (FLOOR PRESENTATIONS)

The following resolution (H.R. No. 217) was announced by the Clerk and the following action taken:

H.R. No. 217, entitled: "HOUSE RESOLUTION CONGRATULATING THE WINNERS OF THE HAWAII: NEXT 50 CONTEST," was jointly offered by Representatives Nakashima, Belatti, Gates, Holt, Ichiyama, Johanson, Kobayashi, LoPresti, Matsumoto, Nakamura, Ohno, Quinlan, Todd, Woodson and Creagan.

Representative Belatti moved that H.R. No. 217 be adopted, seconded by Representative Gates.

Representative Belatti shared how the Hawaii: Next 50 Contest, inspired by former Governor George Ariyoshi's book, "Hawaii: The Past Fifty Years, The Next Fifty Years," tasks students to read the book and gain insight into the events that shaped Hawaii during its first 50 years of statehood, and propose creative and innovative solutions to promote the healthy Hawaii we want to see in the next 50 years, and introduced judges and sponsors of the contest who were seated in the gallery:

The motion was put to vote by the Chair and carried, and H.R. No. 217 was adopted, with Representatives Choy, DeCoite, Har and Souki being excused.

REPORTS OF STANDING COMMITTEES

Representative Mizuno, for the Committee on Health & Human Services, presented a report (Stand. Com. Rep. No. 1218-18) recommending that H.C.R. No. 35 be referred to the Committee on Consumer Protection & Commerce.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and H.C.R. No. 35, entitled: "HOUSE CONCURRENT RESOLUTION REQUESTING THE AUDITOR TO ASSESS BOTH THE SOCIAL AND FINANCIAL EFFECTS OF PROPOSED MANDATED HEALTH INSURANCE COVERAGE THAT REQUIRES INSURERS, HOSPITAL

AND MEDICAL SERVICES PLANS, AND HEALTH MAINTENANCE ORGANIZATIONS TO PROVIDE COVERAGE FOR MEDICAL PROCEDURES TO ELIMINATE OR PROVIDE MAXIMUM FEASIBLE TREATMENT OF PORT-WINE STAINS," was referred to the Committee on Consumer Protection & Commerce, with Representatives Choy, DeCoite, Har, Kobayashi and Souki being excused.

Representative Mizuno, for the Committee on Health & Human Services, presented a report (Stand. Com. Rep. No. 1219-18) recommending that S.B. No. 2796, SD 1 pass Second Reading and be referred to the Committee on Finance.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and S.B. No. 2796, SD 1, entitled: "A BILL FOR AN ACT RELATING TO THE POLICY ADVISORY BOARD FOR ELDER AFFAIRS," passed Second Reading and was referred to the Committee on Finance, with Representatives Choy, DeCoite, Har and Souki being excused.

Representative Brower, for the Committee on Housing, presented a report (Stand. Com. Rep. No. 1220-18) recommending that S.B. No. 2531, SD 1 pass Second Reading and be referred to the Committee on Finance.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and S.B. No. 2531, SD 1, entitled: "A BILL FOR AN ACT RELATING TO THE ISSUANCE OF SPECIAL PURPOSE REVENUE BONDS TO ASSIST WITH SPRINKLER RETROFITS," passed Second Reading and was referred to the Committee on Finance, with Representatives Choy, DeCoite, Har and Souki being excused.

Representative Brower, for the Committee on Housing, presented a report (Stand. Com. Rep. No. 1221-18) recommending that S.B. No. 2783 pass Second Reading and be referred to the Committee on Judiciary.

Representative Belatti moved that the report of the Committee be adopted, and that S.B. No. 2783 pass Second Reading and be referred to the Committee on Judiciary, seconded by Representative Morikawa.

Representative McDermott rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

Representative Tupola rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

Representative Ward rose to speak in support of the measure, stating:

"Support with an important footnote, Mr. Speaker. The section on the bill that impacts low-income housing, public housing, there's a strong correlation between ones' low income and ones' propensity to smoke. Therefore, if you're low income and you're prone to smoke, and the cost of cigarettes is as it is, this is not only a regressive position to put them in, but sometimes that's their hold onto social facilitation, *et cetera*.

"Having smoked for a couple of years, or decades, I know that it facilitates social as well as psychological well-being. To put it to the low income who have sometimes not all the hope that others, I just think we should be aware. I'm not trying to be sympathetic or mushy or syrupy, I just want us to know that these are the people who are hooked on that, and sometimes that's all they have to rely upon for the sake of the moment, that they are doing such things. A lot of us here have smoked, a lot of us have got over it. Hopefully this will help them get through the smoking addiction, but when we target those the way we're targeting in this bill, it hurts. And I'm sure there's some feedback that will be forthcoming.

"For those reasons, Mr. Speaker, I support this. Smoking is not good, but to know the group that we're hitting, just like when we passed the GE tax, we say, oh this is so regressive, the poor people are going to get hurt by it. Just so we know as a footnote, that's going to hurt some of these people here. Thank you."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and S.B. No. 2783, entitled: "A BILL FOR AN ACT RELATING TO THE HAWAII PUBLIC HOUSING AUTHORITY," passed Second Reading and was referred to the Committee on Judiciary, with Representatives McDermott and Tupola voting no, and with Representatives Choy, DeCoite, Har and Souki being excused.

Representative Evans: "Thank you, Mr. Speaker.
