The House of Representatives of the Twenty-Ninth Legislature of the State of Hawaii, Regular Session of 2018, convened at 12:04 o'clock p.m., with Speaker Saiki presiding.

"Thank you, Mr. Speaker. In support. Really briefly, today in our aviation caucus we briefly talked about this issue, and one of the bigger issues around the noise problem that we're having is that in 2000, there was a National Environmental Policy Act enacted, where every state had to have an air tour management plan, and we've never actually finished that in our state. We started conversations in 2005, but we still don't have it. We have kind of a map over where the volcanoes are and random lines drawn over where helicopters should go, but if we actually address that issue then we can actually address some of the noise issues of people flying in areas where there's residential homes.

"And so in Stand. Com. Report 183 it outlines exactly what the root of that problem is, and I think that addressing that as one of the main issues will help us to find some of these noise issues that we're having. As well, I have an airport in my district, and so it's the same thing, helicopters, planes, and so I think starting with the air tour management plan and finishing it is going to be very key in us resolving this issue. Thank you."

At Halawa as well as OCCC they want ones that are outside of the actual prison grounds so that there's less harm done when children are taken into those facilities. But the bigger issue is that they don't have somebody that can actually run these programs. And so they said that they've tried to start this family visitation thing, but every year they drop it because nobody can actively organize it every year. And so I think building that into this would be really key, so that if there are visitation programs, there's actually a visitation coordinator or somebody over these places that we're suggesting that we build at all of these public facilities. Thank you."

One of the issues that a lot of social workers that have come up to me and talked to me about is that their caseload, which this is trying to address that. So the only thing which I hope we get to resolve is that there's actually more caseworkers and not just more case supervisors, because out in our side, that's what the case has been. A lot of the money is going to more and more supervisors, and yet our social workers still have as much as 58 kids on their caseload. One person visiting 58 kids and their families. And so I appreciate that this is doing a pilot project in a very necessary area, but I'm hoping the money goes all the way down to the root level where we need it, which is more caseworkers, not staff members or administrators. Thank you."
