On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and S.B. No. 229, SD 1, HD 1, entitled: "A BILL FOR AN ACT RELATING TO VECTOR CONTROL," passed Second Reading and was referred to the Committee on Finance, with Representatives Fukumoto, Johanson, Lee, Souki and Todd being excused.

Representatives Brower and Ing, for the Committee on Housing and the Committee on Ocean, Marine Resources, & Hawaiian Affairs, presented a report (Stand. Com. Rep. No. 1303-18) recommending that S.B. No. 2424, SD 2 pass Second Reading and be referred to the Committee on Finance.

Representative Belatti moved that the report of the Committees be adopted, and that S.B. No. 2424, SD 2 pass Second Reading and be referred to the Committee on Finance, seconded by Representative Morikawa.

Representative Ward rose to speak in support of the measure, stating:

"Just a brief comment, Mr. Speaker. In support. It's been over 100 years and there's only 9,700 or so homesteaders. There are 203,000 acres that have been set aside, and as the latest statistic from DHHL, there are 44,000 people on the waitlist.

"The point is, this is a creative way of getting housing on the Hawaiian home lands. I know infrastructure's been a big problem, but so has housing costs and the amount of people who qualify for a mortgage. And I know some people think that this may be the nose of the camel into the tent, and tiny houses may go into other parts of the community, but this is strictly for the Hawaiian homestead, and it's something, Mr. Speaker, has and is becoming a really, really, really big broken promise that Prince Kuhio in 1921 in Congress said that, because of the loss of the land and the dignity, we will return the Hawaiians to the land.

"Now, we're to the point where we haven't, and we've got tiny houses as one of the options, and I just encourage everybody to say, let's get on with the housing crisis in the Hawaiian community, before we can solve even the others. Thank you, Mr. Speaker."

The motion was put to vote by the Chair and carried, and the report of the Committees was adopted and S.B. No. 2424, SD 2, entitled: "A BILL FOR AN ACT RELATING TO HOUSING FOR NATIVE HAWAIIANS," passed Second Reading and was referred to the Committee on Finance, Representatives Fukumoto, Johanson, Lee, Souki and Todd being excused.

Representatives Brower and Mizuno, for the Committee on Housing and the Committee on Health & Human Services, presented a report (Stand. Com. Rep. No. 1304-18) recommending that S.B. No. 2401, SD 2, as amended in HD 1, pass Second Reading and be referred to the Committee on Finance.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committees was adopted and S.B. We have another bill that was giving an incentive to the City and County if they set up a short-term rental process. This appears to me to be another enabling measure for the City and County to go ahead and identify more of these short-term rentals. And I think we've got to be very careful of what we do.

"I'm sure in your district you have grandparents who are bemoaning the fact that their grandchildren can't find affordable rentals or possibly even an affordable home to buy, and that's because the people, primarily 80% of them from out-of-state, are descending upon our residential market, snapping up the houses and turning them into short-term rentals. So, it's a serious problem. I think it's a major concern, I wish we would address it straight on through some creative measures, and this is not one of those creative measures. Thank you."

Representative McDermott rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

Representative Ward rose to speak in opposition to the measure, stating:

"Mr. Speaker, a no vote, brief comments. Mr. Speaker, if there was the political will in the counties, they could do this without our help. This is kind of an encourage them, which is good. But if there was a way of sharing data between what's legal and what's taxable, and what the data is in the city level and what the data is at the state level, this Airbnb, huge giant in the room, this giant elephant in the room would go away. And this is kind of like sneaking around to the sides of it. It's not the right way to go, but it's really in the cities and counties and the islands that the ball should be in their court in resolving the situation. Thank you."

Representative San Buenaventura rose to speak in support of the measure with reservations, stating:

"Reservations, strong reservations for different reasons. I'd like to note that this allows the county to create disclosures during the time of conveyancing, not at the time when the contracts are occurring. So, conveyancing is a time when contracts have already been signed, and it's just a question of transferring the property after a sale has occurred, transferring the property from one to another. I believe this is a very dangerous precedent of allowing government interference into contracts between private parties, and for that reason, strong reservations."

Representative McKelvey rose in support of the measure with reservations and asked that the remarks of Representative San Buenaventura be entered into the Journal as his own, and the Chair "so ordered." (By reference only.)

Representative Tupola rose in opposition to the measure and asked that the remarks of Representative San Buenaventura be entered into the Journal as her own, and the Chair "so ordered." (By reference only.)

Representative Matsumoto rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Quinlan rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and S.B.
