

**FORTY-SECOND DAY**

**Tuesday, April 3, 2018**

The House of Representatives of the Twenty-Ninth Legislature of the State of Hawaii, Regular Session of 2018, convened at 12:06 o'clock p.m., with Speaker Saiki presiding.

The invocation was delivered by Ms. Kauai Lucas of the Office of Representative Gregg Takayama, after which the Roll was called showing all Members present with the exception of Representatives Holt and Lee, who were excused.

By unanimous consent, reading and approval of the Journal of the House of Representatives of the Forty-First Day was deferred.

Representative Ward moved that H.R. No. 228 be adopted, seconded by Representative Tupola.

Representative Ward honored Kahu Kekuna for a lifetime of service founding the Hawaii Chapter of Young Life, serving the students of Kamehameha Schools, and acting as Senior Pastor at Kawaiahao Church from 2004-2017, recognized him as the embodiment of the aloha spirit,

Representative Mizuno thanked Kahu Kekuna for all he has done by providing words of wisdom, sharing his compassionate heart and love with believers and non-believers, and providing support for the most needy.

Representative Har shared a personal story from when her law firm was representing Kawaiahao Church, and how Kahu Kekuna was able to bridge the gap between being Hawaiian and Christian with grace, dignity, character and integrity, and thanked him for his service.
