The House of Representatives of the Thirtieth Legislature of the State of Hawaii, Regular Session of 2019, convened at 12:02 o'clock p.m., with Speaker Saiki presiding.

The invocation was delivered by Pastor Josh Marocco of King's Chapel Oahu, after which the Roll was called showing all members present with the exception of Representatives McDermott, Say, Thielen, Todd and Tokioka, who were excused.

By unanimous consent, reading and approval of the Journal of the House of Representatives of the Eighth and Ninth Days was deferred.
