Most of us here watch the Super Bowl. We saw from the aerial helicopter shots as they zeroed in on the stadium, what did we see? We saw the Mercedes-Benz logo. My office found, through research, that there was \$328 million that they gave for 30 years of advertisement.

"Mr. Speaker, I would plead with the authors and this body to do public-private sector exploration, at least, to see if we can leverage money. We may not have a Mercedes-Benz sponsor here, but there are so many other corporations that would love to get their name in front of Aloha Stadium. Hawaiian Airlines, Cutter Ford, you name it, they will come. But I think we should leverage the funds the way that they do on the mainland. Staples, Gillette, there are so many different places that have used that.

"So, I just say as an encouragement to the authors as well as the conference committee that it will probably go to, that naming rights be included as part of this package for the funding, rather than just an appropriation. Thank you, Mr. Speaker."

Representative Cabanilla Arakawa rose to speak in support of the measure, stating:

"Mr. Speaker, in support and I just want to make a comment that I am in very strong support to decrease the tax liability of the citizens. Thank you."

Representative Wildberger rose to speak in opposition to the measure, stating:

"Would you please record a no vote for me? I have a brief comment. I'd like to share some thoughts about HB 1326. East Maui *kalo* farmers and East Maui residents who've had the streambeds on their properties are battling corporate interests for their constitutionally protected right to water access for two decades. This body has an opportunity to end the complicit support of these plantation era predatory practices.

"While we talk about improving transparency and accountability in our governance with the budget process, at the same time we witness the wholesale giveaway blank check in explicit subversion of the public trust and our state's constitution by participating in the unconscionable diverting and dumping of over 90 million gallons of water a day without a modicum of stream restoration. *E ola i ka wai*. Water is life. There is enough water for all of our uses. Let us not abdicate our *kuleana* to represent all interests. Thank you, Mr. Speaker."

Representative Yamane rose to speak in support of the measure, stating:

"Mr. Speaker, in support. But members and colleagues, I wanted to note for the bill before you that there were unintentional errors made during the drafting process of the recommendations made in the Water, Land, & Hawaiian Affairs committee that affected HB 1326, HD1.

"Members, the recommendation was to extend the sunset for an additional seven-year period, which includes, members, the annual application process for the permits, which means that there was a technical language change that needed to be changed from three to seven. Also, members, the recommendation of the Chair was to make this bill effective upon July 1, 2019, which was not reflected as well in the bill.

"So, as this measure moves forward through the process, Mr. Speaker, I would like to request the consideration for the next committee to please

consider the amendments and technical language change that was stated by the Chair of the Water, Land, & Hawaiian Affairs Committee regarding the extending the allowable holdover period to be consistent and applicable. Thank you, Mr. Speaker."

Representative Onishi rose in support of the measure and asked that the remarks of Representative Yamane be entered into the Journal as his own, and the Chair "so ordered." (By reference only.)

Representative Tokioka rose to speak in support of the measure, stating:

"Mr. Speaker, I'd like the same request as the Representative from Hilo. And thank the Chair of Water, Land for working on this very sensitive and important subject. Thank you," and the Chair "so ordered." (By reference only.)

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 1326, HD 1, entitled: "A BILL FOR AN ACT RELATING TO WATER RIGHTS," passed Second Reading and was referred to the Committee on Finance, with Representative Kitagawa voting aye with reservations, with Representatives Eli, McKelvey, Perruso and Wildberger voting no, and with Representatives Aquino, DeCoite, Nakamura, Quinlan and Thielen being excused.

Representative Yamane, for the Committee on Water, Land, & Hawaiian Affairs, presented a report (Stand. Com. Rep. No. 788) recommending that H.B. No. 1209, HD 1, as amended in HD 2, be referred to the Committee on Finance.
