The House of Representatives of the Thirtieth Legislature of the State of Hawaii, Regular Session of 2019, convened at 12:03 o'clock p.m., with Vice Speaker Nakashima presiding.

The invocation was delivered by Lieutenant Governor Josh Green, after which the Roll was called showing all members present with the exception of Representatives McKelvey, Ohno, Quinlan and Todd, who were excused.

In 2018, the MeToo movement went global in India, France, China and South Korea, where women joined the conversation demanding change. Also in 2018, Alexandria Ocasio-Cortez became the youngest woman elected to the US Congress.

"The 2019 theme for International Women's Day is 'think equal, build smart, innovate for change.' They're using the hashtag BalanceForBetter, which is meant to encourage gender balance around the world.

"Do we need to continue to recognize International Women's Day after 100 years? I think we do. Women are still not getting equal pay, women are disproportionately represented in government, and women's access to education around the world is still a challenge.

"I'll share a couple of statistics. The US workforce is 47% women, the ratio of women to men in the US military is one in six, the percentage of families where a wife earns at least \$30,000 more than her spouse is 9.7%, and women with children under 18 comprise 70% of a US labor force. I look forward to continuing the important work on gender disparity with my colleagues. Thank you very much, Mr. Speaker."
