The House of Representatives of the Thirtieth Legislature of the State of Hawaii, Regular Session of 2019, convened at 12:02 o'clock p.m., with Vice Speaker Nakashima presiding.

The invocation was delivered by Isi Nau, President of the Mililani Hawaii Stake of The Church of Jesus Christ of Latter-day Saints, after which the Roll was called showing all members present with the exception of Representatives Belatti, Holt, Tokioka and Yamane, who were excused.

By unanimous consent, reading and approval of the Journal of the House of Representatives of the Thirty-Fifth Day was deferred.

"Mr. Speaker, same request with a brief comment. Mr. Speaker, this is a solution in search of a problem. We have no problem with our voting, it's only when there's a close one, and I think this is confusing, as I spoke on the first crossover. Even the Elections Office didn't know how to describe what was all of this sophisticated first, second, third choice, and the amount of money that we're going to pay for it.

"So, on behalf of the minority, I think if this is going to benefit the majority, I think they have to think twice. It's going to confuse people, it's going to be retrofitting something that doesn't need fixing. Thank you, Mr. Speaker."

Representative Kong rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

Representative Matsumoto rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

Representative San Buenaventura rose to speak in support of the measure, stating:

"In strong support. This version of ranked-choice voting is really a watered-down version of the one I introduced on the House bill version. What this actually does, if people actually try to learn it, it basically ensures that the best possible Republican candidate goes against the best possible Democrat candidate.

"And I gave a really short course on ranked-choice voting. Let's give an example, using a Republican example. The lieutenant governor's race, in the Republicans you had Jeremy Low, you had Steve Lipscomb, and you had Marissa Kerns. Marissa won by only 32%. It was basically divided almost evenly among three of them. If the Republicans had ranked-choice voting, the people who voted for Jeremy Low, their voice wouldn't count, but their second choice, if their second choice was not Marissa Kerns then it would have gone to Steve Lipscomb and you would have gotten over 50% of the Republican vote for a popular Republican candidate.

"But the way it is right now, we actually have only a plurality that goes against a plurality. So, our Democratic lieutenant governor also only got 31%, because that one was divided among six or so strong candidates. If the remainder of those candidates, if you don't count the lowest one and you just divided them up with a second ranked-choice, we may end up having had Jill Tokuda as our lieutenant governor.

"But we know when we go in to the general election, it would be the best possible Democrat candidate versus the best possible Republican candidate. And that doesn't necessarily mean that the people who ended up winning the primary wasn't the best possible candidate, but we don't know unless we had the ranked-choice voting. And as such, it is the most fair way to do it.

"And contrary to what was said earlier, I believe the League of Women Voters as well as the County Clerk was able to elucidate how ranked-choice voting works. And yes, there is going to be, as shown from the comments earlier, there is going to be a short lesson on it. But everyone, really every European country who has done it, they enjoy it and they can't see any other way of having voting. And it's about time, at least for our special elections, that we should attempt it. Thank you."

Representative McKelvey rose to speak in support of the measure, stating:

"In support, Mr. Speaker, and would like the words of the previous speaker in regards to the lieutenant governor's race entered into the Journal as if they were my own. Thank you," and the Chair "so ordered." (By reference only.)

Representative Ward rose to respond, stating:

"Mr. Speaker, second time, if I may. Mr. Speaker, the good Representative from Puna states her point very well, except incorrectly. The implication that some of us on this floor were not the ones that the people of Hawaii sort of chose from District 1 to District 51, I would take issue with.

"And when you're in a race, Mr. Speaker, some of us were in track, the one who crosses the line or the one first past the post wins. Since the Greeks, the Romans, and the Brits, and the Europeans, except for some recent sophistication with the Australians and others, the first past the post has been the standard in elections and democracies heretofore.

"If we want to get sophisticated, we've got to say, well look, you people who are out there voting for us, you're not educated enough, we've got to train you on this new system, we've got to pay another half a million dollars, is penny wise and pound foolish, Mr. Speaker. Why are we going to make more sophisticated what otherwise is simple?

"Lastly, Mr. Speaker, I would say Europe is not a model for democracy. America is the model, America is the gold standard for democracy, and whatever they're doing in Europe or Venezuela or all these other places that have very sophisticated voting is, I think, playing with folly. Thank you."

Representative Thielen rose to speak in opposition to the measure, stating:

"Thank you, Mr. Speaker. I'm standing to cast a no vote on 1563 and 1564 and say a few words. Mr. Speaker, if the members could refer to the Hawaii Sea Level Rise Vulnerability and Adaptation Report, and just note that global sea level rise will occur at 3.2 feet, and they're saying, now. So, this doesn't mean in decades henceforth, but now. And as we keep giving sea wall and revetment easements, even though they're revocable easements, we're letting people continue to harden the shoreline, and that's not the way to deal with sea level rise. Thank you."

Representative Perruso rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

Representative Wildberger rose to speak in opposition to the measure, stating:

"Thank you, Mr. Speaker. Standing in opposition for 1563 and 1564 with a brief comment. We have a need to manage our shorelines, and care and thoughtfulness given to our ag lands with carefully crafted policy to address impacts of sea level rise and not making patchwork decisions on individual private properties benefitting individual investors or residents possibly to the detriment of our public resources.

"In 1980, the Senate in Hawaii passed a bill that the governor cannot only make comments and permissions to alter shoreline, and said that the Legislature also must weigh in on that. So, I just want to reiterate that we really need cogent and specific sea level rise policy statewide, and discourage the single reactionary-type measures for individuals. *Mahalo*."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.C.R. No. 9, entitled: "HOUSE CONCURRENT RESOLUTION AUTHORIZING THE ISSUANCE OF A TERM, NON-EXCLUSIVE EASEMENT COVERING A PORTION OF STATE SUBMERGED LANDS AT KANEOHE, KOOLAUPOKO, OAHU, FOR THE EXISTING PIER AND SEAWALL, AND FOR USE, REPAIR, MAINTENANCE OF THE AND EXISTING IMPROVEMENTS CONSTRUCTED THEREON," was referred to the Committee on Finance, with Representatives Perruso, Thielen and Wildberger voting no, and with Representatives Belatti, Cabanilla Arakawa, Holt, Tokioka and Yamane being excused.

Representative Yamane, for the Committee on Water, Land, & Hawaiian Affairs, presented a report (Stand. Com. Rep. No. 1564) recommending that H.C.R. No. 10 be referred to the Committee on Finance.

Representative Morikawa moved that the report of the Committee be adopted, and that H.C.R. No. 10 be referred to the Committee on Finance, seconded by Representative Johanson.

Representative Thielen rose in opposition to the measure. [Note: See Stand. Com. Rep. No. 1563, H.C.R. No. 9, for remarks.]

Representative Wildberger rose in opposition to the measure. [Note: See Stand. Com. Rep. No. 1563, H.C.R. No. 9, for remarks.]

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.C.R. No. 10, entitled: "HOUSE CONCURRENT RESOLUTION AUTHORIZING THE ISSUANCE OF A TERM, NON-EXCLUSIVE EASEMENT COVERING A PORTION OF STATE SUBMERGED LANDS AT KANEOHE, KOOLAUPOKO, OAHU, FOR THE EXISTING PIER, SEAWALL, AND EAVE, AND FOR USE, REPAIR, AND MAINTENANCE OF THE EXISTING IMPROVEMENTS CONSTRUCTED THEREON," was referred to the Committee on Finance, with Representatives Thielen and Wildberger voting no, and with Representatives Belatti, Cabanilla Arakawa, Holt, Tokioka and Yamane being excused.
