

## THIRTY-SEVENTH DAY

Friday, March 22, 2019

But the subsequent generations of the lessees will be here saying, wait a minute, my great grandfather, my grandmother, my parents, and now me have been leasing this property, don't take it away from us, it should be ours, we've had it for 99 years. And I've seen those kinds of things happen in this building.

"So, what we're actually doing in 99 years, we're granting the fee simple interest in state land. I don't think that's a good idea, I don't think it's a good policy, and I would wish that members would rethink that. And I know the objective is to get housing out there. Mr. Port said, do that, but rent it, rent it and don't do it with a lease for 99 years. Three-year lease, fine, it can be renewed, five-year lease even. But 99 years, don't kid yourself, you're granting the fee interest. Thank you."

Repeat, the Hollywood of the Pacific. We have a phenomenal environment, phenomenal people who are running this business, and phenomenal wages that the employees get. It's really an unrealized growth industry of which, if there's anything, Mr. Speaker, that's lacking in this 2019 session, it's economic development and pushing economic issues. We've got all the other issues, but we haven't done the economic ones.

"So, because of that I have reservations in that the cap should go up and the cap should not go down, and I'm afraid because it's blank, that it may go down. For those reasons, Mr. Speaker, I stay with reservations. Thank you."

Representative McKelvey rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. In support. And I would invite the previous speaker to read the committee report and the numbers in there should assuage his concerns as to the support being sought through the measure. Thank you."

And by banning the most appealing aspect of vaping could discourage the adults that truly need it to quit combustion cigarettes. So, it's like removing the fact of tobacco, while we're still doing the cigarette, the nicotine. But, two minus one is one, and one is better than two. So, by banning the flavor of the cigarette is equal to burning down the barn just to kill the mice. Thank you, Mr. Speaker."

Representative D. Kobayashi rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

Representative McDermott rose to speak in opposition to the measure, stating:

"No vote, Mr. Speaker, and just a brief comment. I hate to rely on anecdotal data, but I know people who have quit smoking natural cigarettes, getting rid of the tar and those other things, and gone to vaping, and they

actually like some of these flavors, pineapple and other things. It's already illegal for kids to get. I mean, the law is the law, they can't get it, they're not supposed to vape, they're not supposed to smoke. They're getting it. Taking the flavor away is only going to penalize adults. So, thank you, sir."

Representative Kong rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Ward rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Todd rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Gates rose in support of the measure with reservations and asked that his written remarks be inserted in the Journal, and the Chair "so ordered."

Representative Gates's written remarks are as follows:

"While I support the intent of this bill, I foresee potential issues if this legislation were to pass. The possible creation of a black market for flavored e-liquid and the potential loss of work for hundreds of individuals are some of these potential issues. For these reasons I must support with reservations. Having flavored vape regulated is the only way that we can assure the quality and safety of the product. If flavored vape became a product sold on a black market, the health risk to those who would indulge in this illegal vape would be immense."

Representative San Buenaventura rose to speak in support of the measure with reservations, stating:

"With reservations, specifically for the criminal portion of this bill. Thank you."

Representative McKelvey rose to speak in support of the measure with reservations, stating:

"Same request, comments as the previous speaker."

Representative Holt rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Lee rose to speak in support of the measure, stating:

"Thank you, in support. I just note that I got a call from one of the principals at one of the schools in my district the other day and asked for some action on this issue. Because ultimately what they found was about 1/3 of the student at their school were regularly vaping, and it's an elementary school in Waimanalo. And what they found was, because of the nature of the flavors of these sorts of items, they're basically being bartered and traded like you would baseball cards or Pogs or anything in the past. And the challenge is, because of that, there's sort of a universal adoption amongst all cliques, amongst age groups, amongst whether you're a cool kid or not or whatever it is, it's ubiquitous.

"And the challenge is for every person, and I respect the fact that, I think some of our colleagues have mentioned, vaping does offer an alternative to traditional cigarettes. But for every adult who switches out, we're enabling dozens of kids to become hooked. And that is the challenge here. So, this measure provides one means to limit that adoption, especially amongst our youth, which we're seeing at schools around the state. I think that's something that's worth discussing. Thank you, Mr. Speaker."

Representative Wildberger rose to speak in support of the measure, stating:

"Mr. Speaker, in strong support. The statistics show that very small percentage of vapers are actually adults, and most are school-aged children. *Mahalo.*"

Representative Takumi rose to speak in support of the measure, stating:

"Mr. Speaker, in support. In response to the colleague who mentioned about these are adults buying these products and children should not get ahold of it, that's a well taken approach, but keep in mind that the FDA banned flavored tobacco, flavored cigarettes back in 2007. Adults were purchasing chocolate camels or whatever the case may be, and the only exception was for menthol cigarettes. Thank you."

Representative Matayoshi rose in support of the measure and asked that the remarks of Representative Lee be entered into the Journal as his own, and the Chair "so ordered." (By reference only.)

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and S.B. On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and S.B. No. 812, SD 1, HD 1, entitled: "A BILL FOR AN ACT RELATING TO THE DEPARTMENT OF COMMERCE AND CONSUMER AFFAIRS," passed Second Reading and was referred to the Committee on Finance, with Representatives Quinlan and Yamane being excused.

Representative Lee, for the Committee on Judiciary, presented a report (Stand. Com. Rep. No. 1694) recommending that S.B. No. 335, SD 2, as amended in HD 1, pass Second Reading and be referred to the Committee on Finance.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and S.B. No. 335, SD 2, HD 1, entitled: "A BILL FOR AN ACT RELATING TO PUBLIC MEETINGS," passed Second Reading and was referred to the Committee on Finance, with Representatives Quinlan and Yamane being excused.

Representative Lee, for the Committee on Judiciary, presented a report (Stand. Com. Rep. No. 1695) recommending that S.B. No. 1077, SD 1, HD 1, as amended in HD 2, be referred to the Committee on Finance.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and S.B. No. 1077, SD 1, HD 2, entitled: "A BILL FOR AN ACT RELATING TO HAWAII STATE AND CONTRACTED CORRECTIONAL FACILITIES," was referred to the Committee on Finance, with Representatives Quinlan and Yamane being excused.

Representative Lee, for the Committee on Judiciary, presented a report (Stand. Com. Rep. No. 1696) recommending that S.B. No. 1353, SD 3, HD 1, as amended in HD 2, be referred to the Committee on Finance.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and S.B. No. 1353, SD 3, HD 2, entitled: "A BILL FOR AN ACT RELATING TO INDUSTRIAL HEMP," was referred to the Committee on Finance, with Representatives Quinlan and Yamane being excused.

Representatives Mizuno and Lowen, for the Committee on Health and the Committee on Energy & Environmental Protection, presented a report (Stand. Com. Rep. No. 1697) recommending that S.B. No. 235, SD 1, as amended in HD 1, pass Second Reading and be referred to the Committee on Finance.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committees was adopted and S.B. No. 235, SD 1, HD 1, entitled: "A BILL FOR AN ACT RELATING TO THE DEPARTMENT OF HEALTH," passed Second Reading and was referred to the Committee on Finance, with Representatives Quinlan and Yamane being excused.

Representative Mizuno, for the Committee on Health, presented a report (Stand. Com. Rep. No. 1698) recommending that S.B. No. 813, SD 2, as amended in HD 1, pass Second Reading and be referred to the Committee on Finance.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and S.B. No. 813, SD 2, HD 1, entitled: "A BILL FOR AN ACT RELATING TO THE DEPARTMENT OF HEALTH," passed Second Reading and was referred to the Committee on Finance, with Representatives Quinlan and Yamane being excused.

Representative Mizuno, for the Committee on Health, presented a report (Stand. Com. Rep. No. 1699) recommending that S.B. No. 549, SD 1, as amended in HD 1, pass Second Reading and be referred to the Committee on Consumer Protection & Commerce.

Representative Belatti moved that the report of the Committee be adopted, and that S.B. No. 549, SD 1, HD 1 pass Second Reading and be referred to the Committee on Consumer Protection & Commerce, seconded by Representative Morikawa.

Representative Okimoto rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Ward rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and S.B. No. 549, SD 1, HD 1, entitled: "A BILL FOR AN ACT RELATING TO HEALTHY BEVERAGES FOR CHILDREN," passed Second Reading and was referred to the Committee on Consumer Protection & Commerce, with Representatives Okimoto and Ward voting aye with reservations, and with Representatives Quinlan and Yamane being excused.

Representative Mizuno, for the Committee on Health, presented a report (Stand. Com. Rep. No. 1700) recommending that S.B. No. 1033, SD 2, as amended in HD 1, pass Second Reading and be referred to the Committee on Finance.

Representative Belatti moved that the report of the Committee be adopted, and that S.B. No. 1033, SD 2, HD 1 pass Second Reading and be referred to the Committee on Finance, seconded by Representative Morikawa.

Representative Okimoto rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

Representative D. Kobayashi rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Ward rose to speak in opposition to the measure, stating:

"Mr. Speaker, no vote with a brief comment. Mr. Speaker, this is a bill that keeps kind of coming back in that it's for midwives. And like many of the things that we pass in this building, the data is so, so lacking. That we want to license midwives, but in terms of the data that says this is dangerous and people are injured and there's infant mortality rates that are exceptional. Mr. Speaker, none of that stuff exists. But there's a whole body of citizens out there that look with expectations that we're not going to put them out of business.

"And Mr. Speaker, because there are so many different amendments that came, and I know the chairs have done their best job to stick in a task force. But I was quoted having said that there was a drop-dead issue in here, and it was misinterpreted to mean that when you have a sunset, that it drops dead. But unless I'm mistaken, there's something in here that says, if you are a midwife now and don't go through this bill in three years, you're out of business. Mr. Speaker, I think that's going to create chaos in the community. And there's a huge community out there that does midwifery.

"For those reasons, Mr. Speaker, I think we have to listen more closely and obviously keep public health in mind. But until there's data that says that this is an endangerment, why are we bothering these people continually and upsetting what otherwise is an equilibrium which from the very beginning of birthing, from the old testament when Hebrew women gave birth so quickly that the pharaoh couldn't even catch up with them. So, I think the practice is long established, and we should let it alone, unless we have data that says otherwise. For those reasons, I'm a no. Thank you."

Representative Perruso rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Tokioka rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Wildberger rose to speak in opposition to the measure, stating:

"Standing in opposition please, Mr. Speaker. I keep asking questions about this bill, and now having read the committee report that came out, the bill references that a person may practice midwifery without a license to practice if the person is acting as a birth attendant on or before July 2023. That's in the bill, which makes it sound like if you've been practicing, then you continue to do so.

"However, in the committee report, it specifically says in item number four, 'adding provisions allowing for the continued practice of birth attendants who are not midwives through July 1, 2023.' So, anyone who is not a midwife, who does not have a license, will not be allowed to continue to practice, according to the committee report, in 2023, in spite of the very front of the committee report saying the purpose of this measure is to exempt traditional midwives from licensure requirements.

"So, there's too many contradictions with this information. And with the Midwives Alliance of North America, one of the 2,000 pages of opposition testimony submitted to the committee, 'in principle, MANA supports state licensure for midwives, and would be writing a letter of support for the SB 1033 if it were a well-crafted bill. We are, however, writing in opposition to the legislation as proposed due to multiple flaws which will create undue restrictions on the right to use the title "midwife" and will have the potential to single out traditional and Indigenous midwives as inadequate and undereducated care providers, ultimately creating inequities for childbearing people in Hawaii.'

"I ask my colleagues to remember our rural communities don't have access to care, and I think that our nation is built on concepts of freedom of choice. Thank you."



Representative Cabanilla Arakawa rose to speak in opposition to the measure, stating:

"Thank you, Mr. Speaker. I'm also in opposition of this bill because I have the same concern with the previous speaker. I was reading the bill and I was totally lost on what it was trying to do. Thank you."

Representative Matayoshi rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Har rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative DeCoite rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative San Buenaventura rose to speak in support of the measure with reservations, stating:

"With reservations. I'd like to note that there were many discussions regarding this bill. And my reservations, and with still a support for it, is based on the fact that the chairs did a fine line to still allow for licensed midwives but allow for the non-licensed midwives to continue to practice as birth attendants. And so long as they do not advertise themselves as licensed midwives, they can continue to do so.

"So, really what we did was, my understanding is we crafted, we allowed midwives who are practicing midwifery now to just get a license and be allowed to then advertise themselves as licensed midwives. But birth attendants, they can still do so, so long as they don't advertise themselves as licensed midwives. It's a fine line, but it allows for people to continue to practice, and traditional customary practices shall continue. That's my understanding, that's why I vote with it, but I also understand the concerns of my community that they be allowed to do that, and that's the only reason I have some reservations."

Representative Todd rose to speak in support of the measure, stating:

"In support. Just wanted to note that you can't get paid to cut hair in our state without being licensed. Thank you."

Representative B. Kobayashi rose to speak in support of the measure with reservations, stating:

"Mr. Speaker, in support with very slight reservations. It was my understanding that there would be a distinction between the term 'midwife' and 'licensed midwife' or 'certified midwife.' Under this bill, the title of 'midwife' would not be allowed beginning July 1, 2020. And so, I think that the while the bill as a whole is much better than prior versions, I think that that one small flaw should be pointed out.

"The other thing is that what was added to the bill, which was good, was that there was an exemption for administering care to one's spouse, domestic partner, parent, sibling, or child. I think that those categories could perhaps be enlarged a bit. Thank you."

Representative Nakamura rose to speak in support of the measure, stating:

"In support. I wanted to ask that the words of the Chair from Puna be used as my own. I also wanted to thank the Representative from Aliamanu who helped to craft this bill. What it does, it bifurcates this process. So, there's one process for certified and professional midwives and then there's a second process to be determined. And I want to really acknowledge the Commission on the Status of Women who have stepped up to say that they will help to facilitate that discussion, that everyone says has not taken place, and to develop a process for birth mothers, cultural practitioners, and others who have tremendous value in our communities. So, in support," and the Chair "so ordered." (By reference only.)

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and S.B. No. 1033, SD 2, HD 1, entitled: "A BILL FOR AN ACT RELATING TO THE LICENSURE OF MIDWIVES," passed Second Reading and was referred to the Committee on Finance, with

Representatives DeCoite, Har, B. Kobayashi, D. Kobayashi, Matayoshi, Perruso, San Buenaventura and Tokioka voting aye with reservations, with Representatives Cabanilla Arakawa, Okimoto, Ward and Wildberger voting no, and with Representatives Quinlan and Yamane being excused.

Representative Lee, for the Committee on Judiciary, presented a report (Stand. Com. Rep. No. 1701) recommending that S.B. No. 921, SD 2, as amended in HD 1, pass Second Reading and be referred to the Committee on Finance.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and S.B. No. 921, SD 2, HD 1, entitled: "A BILL FOR AN ACT RELATING TO THE DEPARTMENT OF THE ATTORNEY GENERAL," passed Second Reading and was referred to the Committee on Finance, with Representatives Quinlan and Yamane being excused.

Representative Lee, for the Committee on Judiciary, presented a report (Stand. Com. Rep. No. 1702) recommending that S.B. No. 192, SD 1, HD 1, as amended in HD 2, be referred to the Committee on Finance.

Representative Belatti moved that the report of the Committee be adopted, and that S.B. No. 192, SD 1, HD 2 be referred to the Committee on Finance, seconded by Representative Morikawa.

Representative Okimoto rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Say rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

Representative Ward rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

Representative Har rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and S.B. No. 192, SD 1, HD 2, entitled: "A BILL FOR AN ACT RELATING TO BAIL," was referred to the Committee on Finance, with Representative Okimoto voting aye with reservations, with Representatives Har, Say and Ward voting no, and with Representatives Quinlan and Yamane being excused.

Representative Lee, for the Committee on Judiciary, presented a report (Stand. Com. Rep. No. 1703) recommending that S.B. No. 1047, SD 1, HD 1, as amended in HD 2, be referred to the Committee on Finance.

Representative Okimoto rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."
